## **Introduction to Mercury Business Availability Center**

Welcome to Mercury Business Availability Center. Before you install Mercury Business Availability Center or read any other Mercury Business Availability Center documentation, it is recommended that you read this short introduction to Mercury Business Availability Center, which includes a description of the new concepts that are a result of Mercury Business Availability Center's alignment with ITIL, starting from version 6.0.

### **About Mercury Business Availability Center**

Mercury Business Availability Center helps companies to optimize the performance and availability of applications in production and proactively resolve problems when they arise, thus assisting critical production applications to perform as required and deliver business results.

Mercury Business Availability Center helps customers model their business processes and services by providing a framework for mapping the complex and dynamic dependencies between applications and their supporting infrastructure. Mercury Business Availability Center helps customers optimize business availability by proactively detecting problems in order to prioritize problem resolution based on business impact and service level compliance.

Mercury Business Availability Center consists of an integrated set of applications for real-time performance and availability monitoring from a business perspective, service level management, end-user management, system availability management, and custom reporting. Mercury Business Availability Center is based on a common foundation of shared workflow, administration and reporting services, shared assets, and expertise.

Mercury Business Availability Center helps customers to reduce mean time to detection (MTTD) and end-user downtime by proactively detecting application performance and availability problems—assisting in escalation of problems to the right department at the right priority, as well as isolation and resolution of performance problems before service-level objectives are breached. This helps organizations toward the goal of the maximization of value of IT operations and reduction of Total Cost of Ownership (TCO) of IT infrastructure.

## Alignment with ITIL

Several new concepts in Mercury Business Availability Center come as a result of the alignment with the Information Technology Infrastructure Library (ITIL) methodology. ITIL is the most widely accepted methodology for IT service management in the world. In fact, it is quite possible that your organization is already following the ITIL methodology.

### What is ITIL?

Originally developed by the Office of Government Commerce, a branch of the British Government, ITIL is a cohesive set of well-defined best practices for IT processes drawn from the public and private sectors internationally. ITIL best practices aim to provide the following benefits:

- Improved communications between IT, businesses, and customers
- Increased IT productivity
- Reduced IT costs
- Better management of risk
- Higher levels of customer satisfaction

## **ITIL in Mercury Business Availability Center**

Mercury Business Availability Center introduces the concept of the Mercury Universal Configuration Management Database (CMDB). The Mercury Universal CMDB stores information on services, their components or configuration items, details about configuration item attributes, the history of each configuration item, and details of the relationships between configuration items. A configuration item (CI) is a component that makes up a part of the IT environment. A CI can be a line of business, business process, application, server hardware, or a service that is provided by your IT organization. A CI can also be a logical container that includes multiple CIs. A CI Type (CIT) is the type of each CI within the IT environment.

## **The IT Universe Concept**

If you provide an application to your company's employees to manage their own retirement accounts, then you are also providing a service. Let us call this service "Employee Self Help." To provide this service, you create an application that runs on a server and connects to a database. In your environment, you may provide many such services that depend on many applications and databases that utilize a variety of server and network hardware. All these services, applications, and hardware are interconnected to form what is called in Mercury Business Availability Center the IT universe.

In Mercury Business Availability Center, you start by defining a model of your company's IT Universe. To manage your company's IT Universe model, you create service views (views). Views enable you to divide up the IT Universe model into logical entities for monitoring. The IT universe model then becomes the foundation for the management functions provided by Mercury Business Availability Center applications.

Having a defined model of the organization's IT universe can then help you, for example, to see what application is being monitored by which Business Process Monitor, or to determine whether a server problem, detected by SiteScope, affects other CIs as well—for example, whether the Employee Self-Help service described above suffered service outages due to a problem with its database server.

Applying these new Mercury Business Availability Center concepts can help you to more efficiently and effectively manage and deliver IT services to your end users and customers.

The Mercury Business Availability Center platform consists of proprietary servers, data collectors, and scripting tools, as well as third-party servers such as database and mail servers. These components run the Mercury Business Availability Center business user and administrator applications. ## The Mercury Business Availability Center Architecture

The Mercury Business Availability Center architecture is made up of servers, data collectors, scripting tools, and third-party servers and components that you set up in the enterprise network environment.

### Mercury Business Availability Center Servers

Mercury Business Availability Center is powered by a set of servers that are responsible for facilitating system management, data handling, reporting, and alerting. You install the following Mercury Business Availability Center servers on one or more Microsoft Windows or Sun Solaris machines in your enterprise network environment:

- ▶ **Centers Server.** Responsible for running the Mercury Business Availability Center applications, reporting, and the Administration Console.
- ▶ **Core Server.** Responsible for receiving data samples from the data collectors, distributing the data to the relevant Mercury Business Availability Center components, and supporting the Bus.
- ▶ **Data Processing Server.** Responsible for aggregating data, running the Business Logic Engine, and controlling the Mercury Universal CMDB.

## Mercury Business Availability Center Data Collectors

Mercury Business Availability Center data collectors are responsible for collecting performance data from various points throughout the infrastructure, as well as from external locations, and feeding it into a central repository. The data collected by Mercury Business Availability Center data collectors is used to monitor and analyze the performance of your business applications and IT infrastructure.

You install the following data collectors to machines in your enterprise network environment or remote locations:

- ▶ **Business Process Monitor.** Emulates the end-user experience by running transactions and collecting availability and response time data.
- ▶ **Client Monitor.** Tracks the user experience as perceived by key personnel or clients, as they use your application, and collects “last-mile” availability and response time data.
- ▶ **SiteScope.** Collects key performance measurements on a wide range of back-end infrastructure components, including Web, application, database, and firewall servers.
- ▶ **Real User Monitor.** Measures the end-user experience of real users from a network/server perspective, by monitoring real user traffic and collecting network and server performance data in real time.

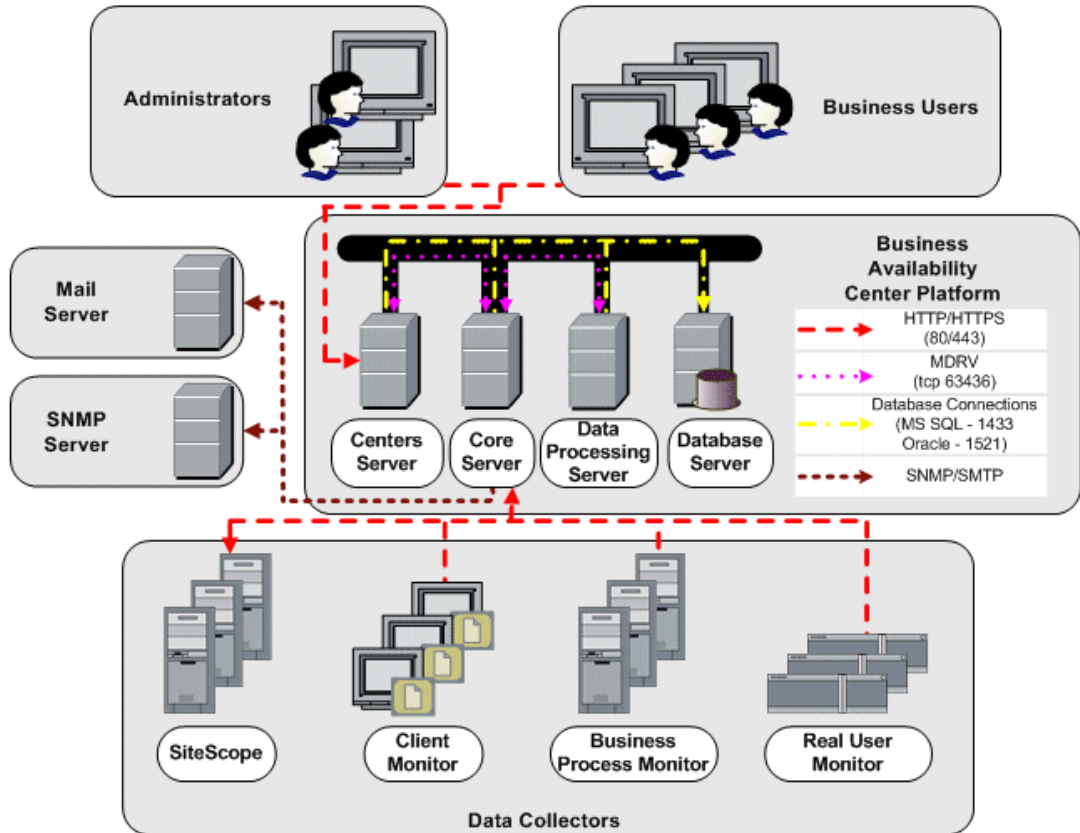
## **Third-Party Servers and Components**

For full functionality, Mercury Business Availability Center requires connection to a database server and a mail server. The database server is used to store system-wide and management-related data, which includes administrative settings and customer-configured information, as well as profile data, which includes data collector settings and collected measurements. The mail server is used to send alerts and scheduled reports to designated recipients. Optionally, connection to an SNMP server might be implemented to receive SNMP traps sent by the Mercury Business Availability Center alerting mechanism.

In addition, Mercury Business Availability Center supports integration of data—to third-party Enterprise Management Software (EMS) tools using Mercury Business Availability Center's Generic Data Engine API and EMS adapters, and from EMS tools via SiteScope Integration Monitors.

## Overview of Applications

The applications that run on the Mercury Business Availability Center platform can be categorized as follows:

<b>Dashboard</b>	Select to open the Dashboard application, a real-time dashboard for viewing performance and availability metrics from a business perspective. For details, see <i>Using Dashboard</i> .
<b>Service Level Management</b>	Select to open the Service Level Management application to proactively manage service levels from a business perspective. Service Level Management provides IT Operations teams and service providers with a tool to manage service levels and provide service level agreement (SLA) compliance reporting for complex business applications in distributed environments. For details, see <i>Using Service Level Management</i> .

Menu Option	Description
<b>End User Management</b>	Select to open the End User Management application, used to monitor applications from the end user perspective and analyze the most probable cause of performance issues. For details, see <i>Using End User Management</i> .
<b>System Availability Management</b>	Select to open the System Availability Management application, used for complete system and infrastructure monitoring as well as event management. For details, see <i>Using System Availability Management</i> .
<b>Diagnostics</b>	If a licensed version of Mercury Diagnostics is installed, select to open the Mercury Diagnostics application, to gain end-to-end visibility and comprehensive diagnostics for Java 2 Enterprise Edition (J2EE), .NET-connected, Siebel, SAP, Oracle, and other complex environments. For details, refer to the Mercury Diagnostics documentation accessed from the Help menu in Mercury Business Availability Center.
<b>Problem Management</b>	Select to open the Problem Management application, used for triaging and isolating problems identified by Mercury Business Availability Center. For details, see <i>Using Problem Management</i> .
<b>Application Performance Lifecycle</b>	Select to open the Application Performance Lifecycle application, used to assist in constructing load tests based on real-user transaction data collected by the Real User Monitor. For details, see <i>Using Application Performance Lifecycle</i> .

<b>Mercury Business Availability Center for Siebel</b>	Select to open Mercury Business Availability Center for Siebel diagnostics tools. For details, see “Using the Mercury Business Availability Center for Siebel Solution” in <i>Application Administration</i> .
<b>Mercury Business Availability Center for SOA</b>	Select to open Mercury Business Availability Center for SOA reports. For details, see “Using the Mercury Business Availability Center for SOA Solution” in <i>Application Administration</i> .



## Administrator Applications

Administrators use the Administration Console to administer the Mercury Business Availability Center platform and applications. In addition, administrators use Mercury scripting tools to create the scripts that are used by Business Process Monitor and Client Monitor to collect data for monitored applications.

- **Administration Console.** The Administration Console consists of several sections, organized by function. You access each functional area from the Admin menu. You select from the following menu options:

<b>Platform</b>	Select to open the Platform Administration pages, which provide complete platform administration and configuration functionality. For details, see <i>Platform Administration</i> .
<b>CMDB</b>	Select to open the CMDB Administration pages, where you build and manage a model of your IT universe in the CMDB. From CMDB Administration, you manage the discovery process and the adapter sources that are used to populate the IT universe model with configuration items (CIs), the templates for creating CIs, and the viewing system for viewing the CIs in Mercury Business Availability Center applications. You can also manually create CIs to add to the model. For details, see <i>Working with the CMDB</i> .
<b>Monitors</b>	Select to open the Monitor Administration pages, where you configure and administer data collectors and their monitors. For details, see <i>Working with Monitor Administration</i> .
<b>My BAC</b>	Select to open the My BAC configuration pages, where you manage portal modules (including portlets), and set viewing permissions. For details, see <i>My BAC Administration</i> .

Menu Option	Description
<b>Dashboard</b>	Select to open the Dashboard Administration pages, where you attach Key Performance Indicators (KPIs) to CIs, define CI status alerts, define the custom and geographical maps, and customize the repositories. For details, see <i>Application Administration</i> .
<b>Service Level Management</b>	Select to open the Service Level Management Configuration pages, where you create service level agreements (SLAs) and build services that link to the data that Service Level Management collects. For details, see <i>Application Administration</i> .
<b>End User Management</b>	Select to open the End User Management Configuration pages, where you configure transaction order and color settings and report filters. For details, see <i>Application Administration</i> .
<b>Diagnostics</b>	Select to open the Mercury Diagnostics configuration page, where licensed Mercury Diagnostics users connect to an installed Diagnostics server and configure Mercury Diagnostics. For details, refer to the Mercury Diagnostics documentation installed with the product.
<b>Personal Settings</b>	Select to access the Personal Settings tab, which enables personalization of various aspects of Mercury Business Availability Center including menus and password. Note that Personal Settings are available to all users. For details, see <i>Platform Administration</i> .

- **Scripting tools.** Mercury Business Availability Center scripting tools enable you to record the end-user actions that represent the key business transactions whose performance you want to monitor using the Business Process Monitor or Client Monitor. You save the transactions in recorded scripts. The table below describes the scripting tools that are available. For additional information on Business Process Monitor scripting tools, including script recording tips, see *Script Recording Tips*.

Tool	Description
<b>Mercury Virtual User Generator (VuGen)</b>	Enables you to record scripts for a large variety of protocols. This is the recommended tool for recording Business Process Monitor scripts. You download VuGen from the Downloads page, accessed from the Setup and Maintenance tab in Platform Administration. For details on using VuGen, see <i>Using Mercury Virtual User Generator</i> . For information on using Mercury LoadRunner scripts in Mercury Business Availability Center, contact Mercury Customer Support.
<b>Client Monitor Recorder</b>	Enables you to record scripts for use with Client Monitor. For details on using the Client Monitor Recorder, see <i>Using Client Monitor Recorder</i> .
<b>QuickTest Professional</b> (for use with Windows-based Business Process Monitor only)	Enables you to record scripts for Web-based applications that include Java applets and ActiveX. For details on using QuickTest Professional, refer to the documentation installed with the product.

The servers must have a user account with administrative rights to the database server(s) upon which you set up the management database (and later, profile database).


To maximize the performance of machines on which you install servers, it is recommended that they be dedicated to Mercury Business Availability Center and not run other applications.

## Accessing Mercury Business Availability Center

You access Mercury Business Availability Center using a supported Web browser, from any computer with a network connection (intranet or Internet) to the Mercury Business Availability Center servers. The level of access granted a user depends on the user's permissions. For details on granting user permissions, see "Configuring User Permissions" in *Platform Administration*.

## Logging In

You log into Mercury Business Availability Center from the login page.

**To access the Mercury Business Availability Center login page and log in:**

- 1** In the Web browser, enter the URL **http://<server\_name>/MercuryAM** (**mercuryam** can also be used), where **server\_name** is the name or IP address of the Mercury Business Availability Center server. If there are multiple servers or if Mercury Business Availability Center is deployed in a distributed architecture, specify the load balancer or Centers Server URL, as required.

Customers running previous versions of Mercury Business Availability Center (formerly Topaz) can still use bookmarks set to access the URL **http://<server\_name>/topaz**.

- 2** Enter the login parameters (login name and password) of a user defined in the Mercury Business Availability Center system, and click **Log In**. After logging in, the user name appears at the top right, under the top menu bar.

Initial access can be gained using the default superuser login parameters: Login Name=**admin**, Password=**admin**. It is recommended that the system superuser change this password immediately to prevent unauthorized entry. For details on changing the password, see “Changing the User Password” in *Platform Administration*.

For details on creating users in the Mercury Business Availability Center system, see “User Management” in *Platform Administration*.

## Logging Out

When you have completed your session, it is recommended that you log out of the Web site to prevent unauthorized entry.

### To log out:

Click **Logout** at the top of the page.

## Enabling Automatic Login in the Login Page

When automatic login is enabled from the login page, the next time the user enters the URL to access Mercury Business Availability Center, the login page does not open, the login name and password do not have to be entered, and the default page that is set to open for the user opens automatically.

### To enable automatic login:

- 1** In the Mercury Business Availability Center login page, select the option to **Remember my login name and password for 14 days**.
- 2** When completing your session, do not click **Logout** at the top of the page, but simply close the browser window.

Logging out disables the automatic login option and the login name and password must be entered when again accessing Mercury Business Availability Center.

## Guidelines for Using Automatic Login

Keep the following in mind when using this option:

- Using the **Logout** option at the top of the Mercury Business Availability Center page cancels the option. If a user has logged out, the next time the user logs in, the Login page opens and the user must enter a login name and password. This can be useful if another user must log in on the same machine using a different user name and password.
- Automatic login can be enabled for a specific period of time (the default is 14 days). After that period of time has elapsed, the option must be selected again to enable it.
- This option could be considered a security risk and should be used with caution.

- ▶ You can configure this option and modify the default values in Infrastructure Settings. To access the relevant settings in Infrastructure Settings, select **Admin > Platform > Setup and Maintenance > Infrastructure Settings > Foundations > Security**. In this context, you can:
  - ▶ Completely remove this option from appearing in the login page by setting the **Enable automatic login** value to false (true is the default value).
  - ▶ Customize the number of days to enable the option by editing the **Days to remember login** value to the desired number of days (14 is the default value).

For details on using the Infrastructure Settings page, see “Infrastructure Settings” in *Platform Administration*.

## Using the Automatic Login URL Mechanism

You can use a special URL, containing several parameters including login name and password, to access Mercury Business Availability Center and automatically log in. Note that, though convenient, this method is not secure since the password is not encrypted in the URL.

### To access Mercury Business Availability Center and log in using the automatic login mechanism:

In the Web browser, enter the URL

**http://<server\_name>/topaz/TopazSiteServlet?autologin=yes&strategy Name=Topaz&requestType=login&userlogin=<loginname>&userpassword=<password>&createSession=true**, where **server\_name** represents the name of the Mercury Business Availability Center server, and **loginname** and **password** represent the login name and password of a user defined in Mercury Business Availability Center.

To enable direct entry to Mercury Business Availability Center, bookmark this URL.

## **Limiting Access by Different Machines Using the Same Login Name**

Mercury Business Availability Center can be accessed using the same login name from different machines. The number of machines accessing Mercury Business Availability Center using the same login name can be limited using the Infrastructure Settings page.

To modify the value in Infrastructure Settings, select **Admin > Platform > Setup and Maintenance > Infrastructure Settings > Foundations > Security**. Set the **Maximum machines per login name** value to the number of machines that can access Mercury Business Availability Center using the same login name. The default value is zero (0) which enables limitless logins.

If the maximum value has been reached when a user tries to log into Mercury Business Availability Center, the user receives a login error message and is unable to log in.

### **Feature Limitation**

In certain network configurations where multiple clients are funneled through a default gateway or proxy server, the IP resolved to Mercury Business Availability Center is that of the gateway or proxy server and not the IP of the client. As a result Mercury Business Availability Center treats each client as coming from the same IP. Since this feature does not limit the number of logins from the same machine (IP), the feature enables all the clients to log into Mercury Business Availability Center, even though they originate from different IPs.

## Using Direct Login to a Specific Page

Direct Login is a mechanism to easily guide another user to a specific target page in Mercury Business Availability Center. Direct Login creates a URL with user name, password, and information about the target page. You can send this URL by e-mail, SMS, and so forth to another user.

Depending on how you configure Direct Login, the receiver accesses the page using his own user name and password, your user name and password, or another user's user name and password. The receiver bypasses the Mercury Business Availability Center login page because the URL supplies the user name and password information.

### To configure direct login to a specific page:

- 1 Go to the page in Mercury Business Availability Center that you want to send to the receiver.
- 2 Select **Admin > Link to this page**. The **Link to this page** dialog box opens.

- 3** Select the method that the receiver uses to access the target page:
  - ▶ Choose **No credentials** if the receiver should use his own user name and password to access the page.
  - ▶ Choose **My credentials** if the receiver should use your user name and password to access the page.
  - ▶ Choose **Use credentials** and fill in **Login name** and **Password** if the receiver should use the user name and password you supply here. There is no default user account, like **guest** in Microsoft Windows, so you must fill in both fields.
- 4** Click **Create link**. The URL is written in the Link box. The user name and password are encrypted so that no login information is revealed.
- 5** Click **Copy to clipboard**.
- 6** Click **Cancel** to close the **Link to this page** dialog box.
- 7** Open a new e-mail message and paste the clipboard contents into the message area. Publish the URL via e-mail, SMS, and so forth to the receiver with instructions to click the URL.
- 8** When the receiver clicks the URL, one of the following scenarios occurs:
  - ▶ If **No credentials** was chosen in step 3, the receiver is first sent to the Mercury Business Availability Center login page. There is no limit to the number of login retries. After successfully logging in to his own account, he is automatically sent to the target page.
  - ▶ If **My credentials** or **Use credentials** was chosen in step 3, the receiver is sent to the target page without logging in.

## Limitations

Direct Login is operational only in reports, Dashboard, and the configuration pages of specific views.

- ▶ The user name sent in the URL must be an account with sufficient privilege to access the target page. If the account does not have sufficient privilege, the receiver is sent to the page above the target page.

For example, you want to direct the receiver to the Infrastructure Settings page. You configure Direct Login, however, with **Use Credentials** of a regular user. When the receiver uses this URL, he is sent to the Setup and Maintenance page and he cannot access Infrastructure Settings.

- ▶ Direct Login does not verify the user name and password sent in the URL. Verification is done only when the receiver tries to access the target page. If the user name and password are not correct, or the user account has been deleted, the receiver is sent to the Mercury Business Availability Center login page to log in normally. Once he is logged in, he does not proceed to the target page. There is no informational message about the reason for the Direct Login failure.

## Security Notes and Precautions

- ▶ The user name and password in the URL are encrypted so that no login information is ever revealed.
- ▶ Sending encrypted information by e-mail still entails a security risk since the mail system can be breached. If the e-mail is intercepted, access to Mercury Business Availability Center is given to an unknown party.
- ▶ Do not use the URL from Direct Login as a link in any Web page.
- ▶ The receiver has all privileges of the user name he was given in the URL. Once the receiver accesses the target page, he can perform all actions permitted to that user name anywhere in Mercury Business Availability Center.

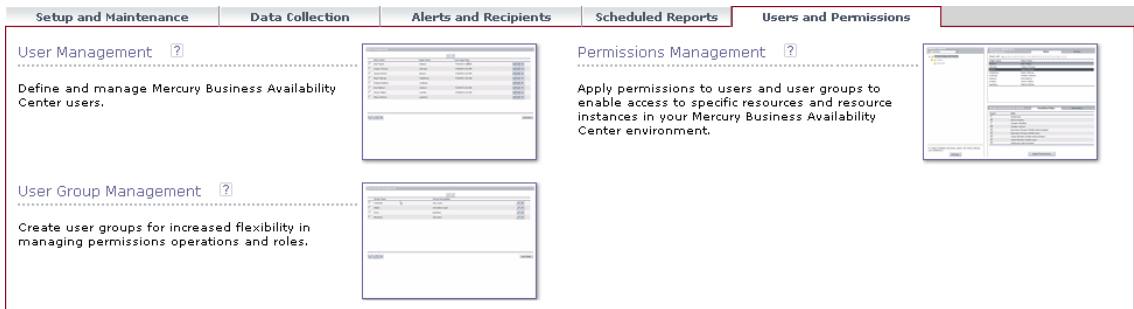
## Navigating Mercury Business Availability Center

Mercury Business Availability Center runs in a Web browser. You move around Mercury Business Availability Center using the following navigation functions:

- ▶ **Site Map.** Enables quick access to all top-level contexts in the Applications menu or the Administration Console. The site map is the first page that opens, by default, after logging into Mercury Business Availability Center. If the default page after login is changed, you can access the site map by clicking the Site Map link, either in the top menu or from the Help menu.
- ▶ **Top menu bar.** Enables navigation to the applications, Administration Console pages, and help resources. The top menu bar also includes a link to the site map and the Logout button.



- ▶ **Tabs.** Enable navigation to various contexts within a particular area of Mercury Business Availability Center, for example to different types of reports within an application, different views within a report, or different administrative functions within the Administration Console. In certain contexts, tabs are used to distinguish between functions; in other contexts tabs are used to group logically similar functions or features together.
- ▶ **Tab main menus.** Enable navigation from a tab front page to various contexts related to the tab. Tab main menus appear when selecting a tab that represents a category containing several contexts, for example, report types or administrative settings. Tab main menus include a description and thumbnail image of each tab context.





- **Tab controls.** Assist in navigation from any context related to a tab to any other of the tab's contexts. To open the tab main menu, click the tab name.



To quickly jump to another context related to the tab, move your mouse pointer over the tab and click the down arrow that appears to open the tab dropdown menu. Click a tab menu option to move to that context.



- **Breadcrumbs.** Enable returning to previous pages within a multi-level context by clicking the appropriate page level. For example, in the following breadcrumb trail, you would click **Breakdown Summary** to return to the Breakdown Summary report:

**Note:** The Web browser **Back** function is not supported in Mercury Business Availability Center. Using the **Back** function does not always revert the current context to the previous context. To navigate to a previous context, use the breadcrumb function.

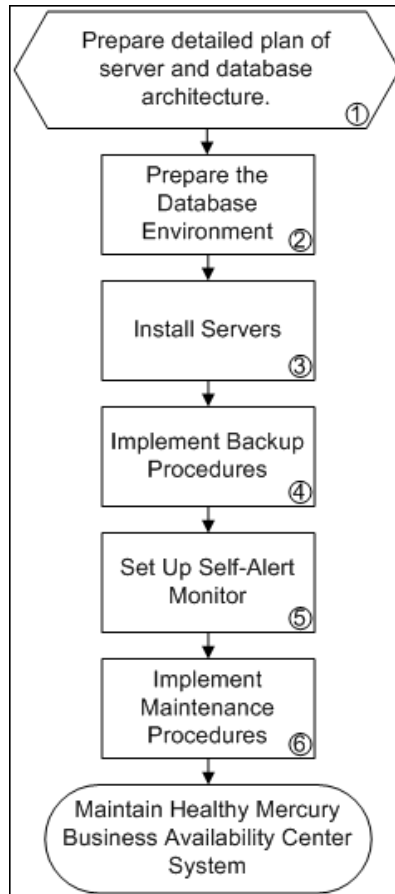

## How Do I Build and Maintain My Mercury Business Availability Center System?

The flowchart below describes the process recommended to set up and maintain a Mercury Business Availability Center system. Note that the term database in this section refers to both MS SQL Server databases and Oracle Server user schemas. The numbered elements are referenced in the table on the following page, which provides additional details about the steps and a reference to more information.

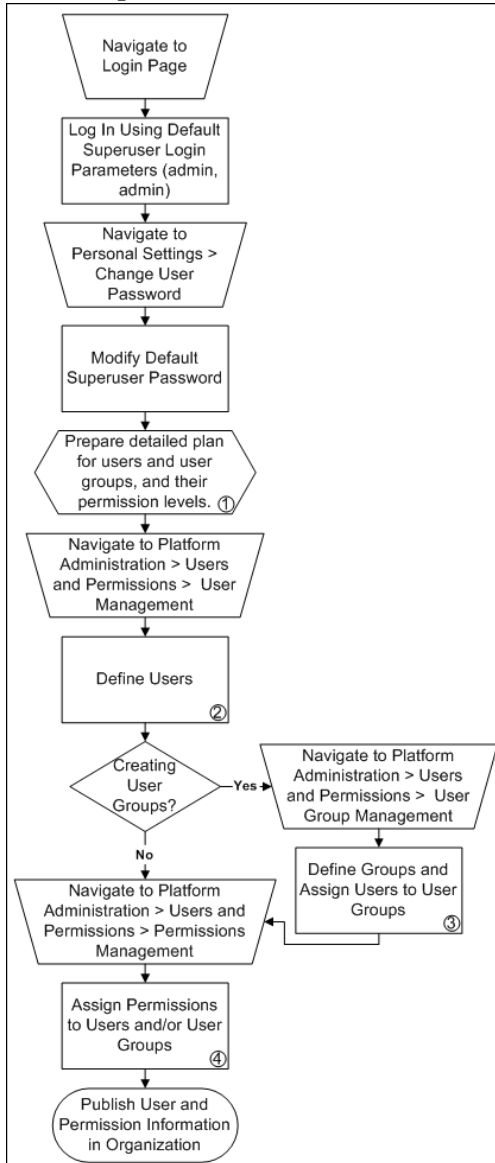


Ref. No.	Comment
1	Map out the Mercury Business Availability Center server and database architecture that will be required, based on organizational requirements, expected system capacity requirements (considering load factors such as data input and application usage), high availability and system failover requirements, and security requirements.
2	Set up the database server that will be used with Mercury Business Availability Center. Establish procedures for database backup and maintenance, including backup of management, profile, and LDAP databases and a data purging policy. Optionally, manually create the Mercury Business Availability Center management and profile databases. For more information, see <i>Preparing the Database Environment</i> .
3	Install Mercury Business Availability Center servers and connect to the management database. Server installation must take into account planned high availability and failover strategies (including load balancing, backup servers, and so forth). Consider installing a separate staging system to use for testing configuration changes, patches, backup and restore procedures, and so forth. For more information, see <i>Deploying Servers</i> .
4	Implement a backup process whereby key configuration files that contain data not stored in the database are automatically backed up daily (for more information, see “File Backup Recommendations” in <i>Deploying Servers</i> ). In addition execute database backup plans. It is also recommended to create procedures for restoring resources and test those procedures on a staging system.

5	Set up Mercury Self-Alert Monitor (via SiteScope) to monitor the health of Mercury Business Availability Center servers. For more information, see “Mercury Self-Alert Monitor” in <i>SiteScope Administration</i> .
6	<p>Implement ongoing maintenance procedures that will enable the system to run smoothly and will minimize issues during future upgrade. For example:</p> <ul style="list-style-type: none"> <li>▶ Create run books that instruct personnel how to perform server maintenance procedures as well as how to proceed in the event of system failure or server downtime.</li> <li>▶ Track customization and configuration changes that you make (such as those made in configuration files or in the Infrastructure Settings Manager), in case you need to roll back at a later time.</li> <li>▶ If you install private patches keep track of them, and when upgrading make sure your Mercury representative knows about them and can confirm how the upgrade will affect their status. <b>Tip:</b> Private patches should be installed on a staging system before being deployed to production.</li> <li>▶ Troubleshoot problems by accessing log files and searching for errors (for more information, see “Mercury Business Availability Center Logs” in <i>Reference Information</i>). Use the Knowledge Base on the Mercury Customer Support Web site (support.mercury.com) to search for answers to issues that may come up.</li> </ul>

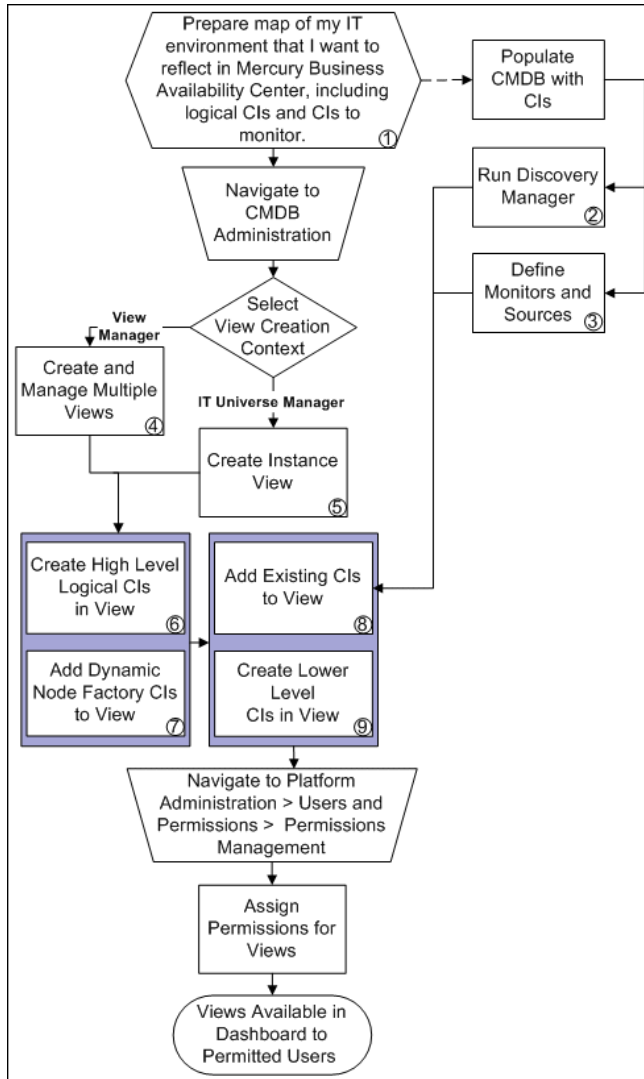

1	<p>Map out the required users and user groups and their relevant permission levels before defining them in Mercury Business Availability Center. For example, in a spreadsheet enter the following information:</p> <ul style="list-style-type: none"> <li>▶ a list of all staff who will be required to administer the system, as well as the end users who will be accessing Dashboard and reports. Gather appropriate user details such as user names, login names, initial passwords, and user time zones. Although not needed to define users, at this stage it might be useful to also collect user contact information such as telephone number, pager, or e-mail address (contact information is required for Mercury Managed Services customers).</li> <li>▶ if categorization of users into modes (operations and business) is required, specify into which user mode to categorize each user. For more information, see “KPIs for User Modes” in <i>Platform Administration</i>.</li> <li>▶ if groups of users will require similar system permissions, a list of user groups and the users that should belong to each group.</li> <li>▶ the permissions each user or user group will require. To aid in this process, review the Permissions Management page to learn about the different contexts and resources for which permissions can be granted. For more information, see “Configuring User Permissions” in <i>Platform Administration</i>.</li> </ul>
2	<p>Define new users as per requirements or planned specifications. For more information, see “User Management” in <i>Platform Administration</i>.</p>
3	<p>Define user groups (General tab) and assign users to them (Users tab) as per requirements or planned specifications. For more information, see “User Group Management” in <i>Platform Administration</i>.</p>
4	<p>Assign role-level or operation-level permissions to individual users (Users tab) or user groups (Groups tab) as per requirements or planned specifications. Keep the following tips in mind:</p> <ul style="list-style-type: none"> <li>▶ Superuser, Administrator, System Modifier, and System Viewer roles can only be applied to the Business Availability Center resource, which refers to the whole Mercury Business Availability Center system and appears at the top level in every context.</li> <li>▶ Business Process Monitor, Client Monitor, and SiteScope roles can be applied to specific, related resources in the Monitors context. These roles are useful when assigning permissions to users and administrators responsible for specific data collectors.</li> <li>▶ Operation-level permissions are applied, in any context, to resources below the Business Availability Center resource level.</li> <li>▶ To assign a user permissions on a subresource, you must provide the user with at least View permissions on the selected resource's parent.</li> </ul> <p>For more information, see “Configuring User Permissions” in <i>Platform Administration</i>.</p>

## How Do I Reflect My IT Environment in Mercury Business Availability Center?

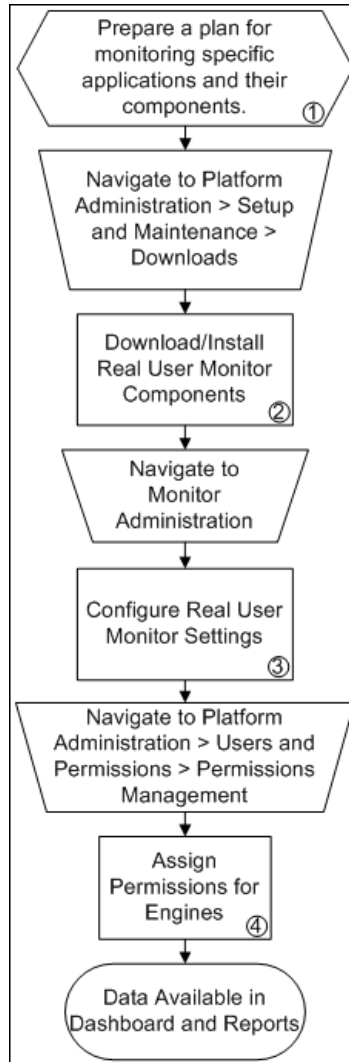

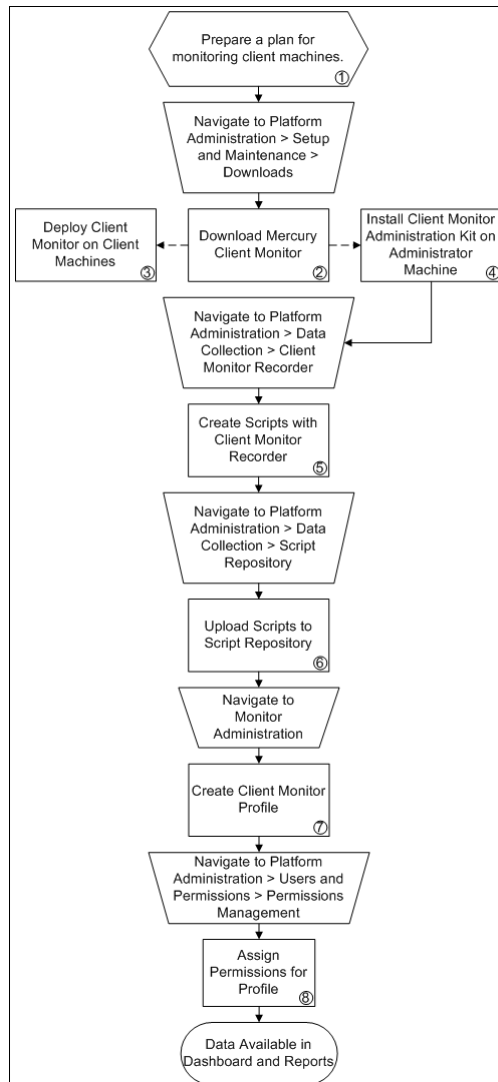

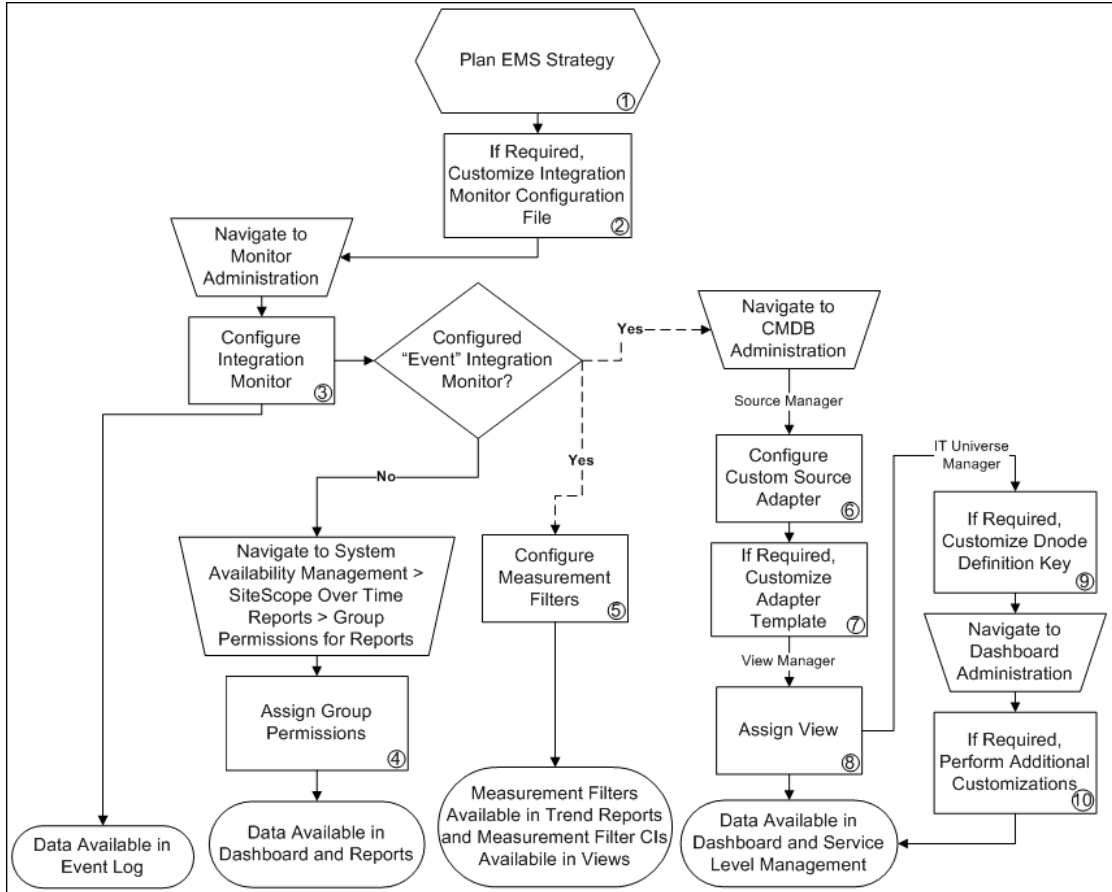

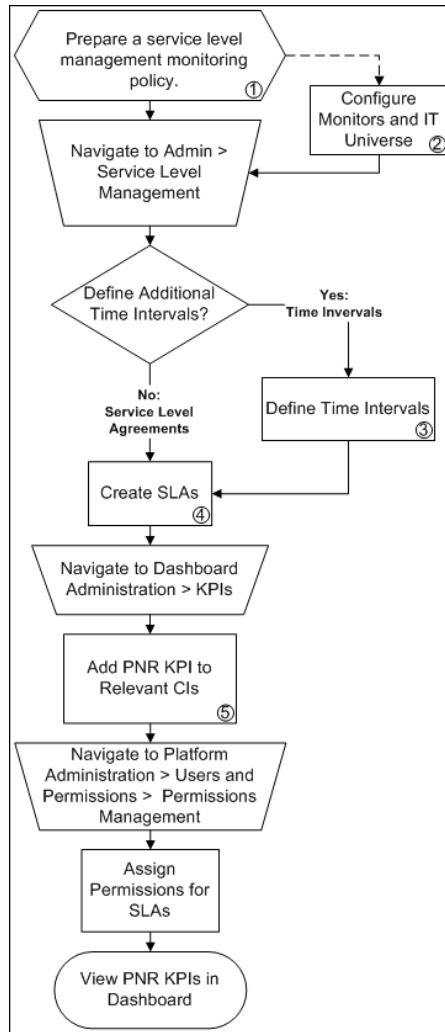

After business hours (that is, 5:00 PM to 9:00 AM), ensure that users can access the site within 10 seconds for 95% of the time.</li> <li>▶ Ensure that the average round-trip transmission between a UUNET-designated Hub Router in the IT department and a UUNET-designated Hub Router in the finance office in the Chicago metropolitan area will take 120 milliseconds or less during business hours and 150 milliseconds or less after business hours.</li> </ul> <p>For more information, see "Service Level Agreements (SLAs)" in <i>Application Administration</i>.</p>

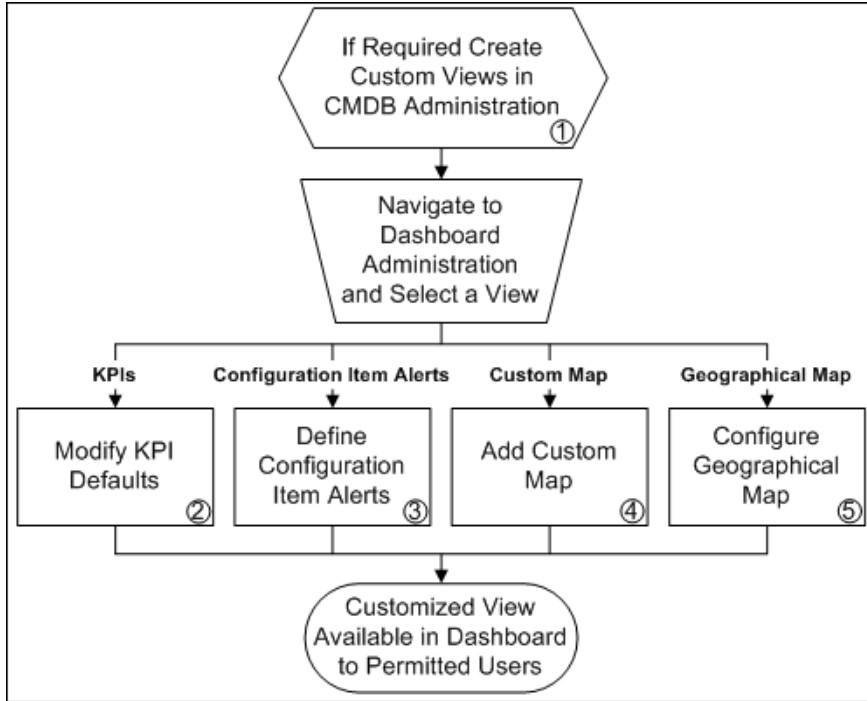

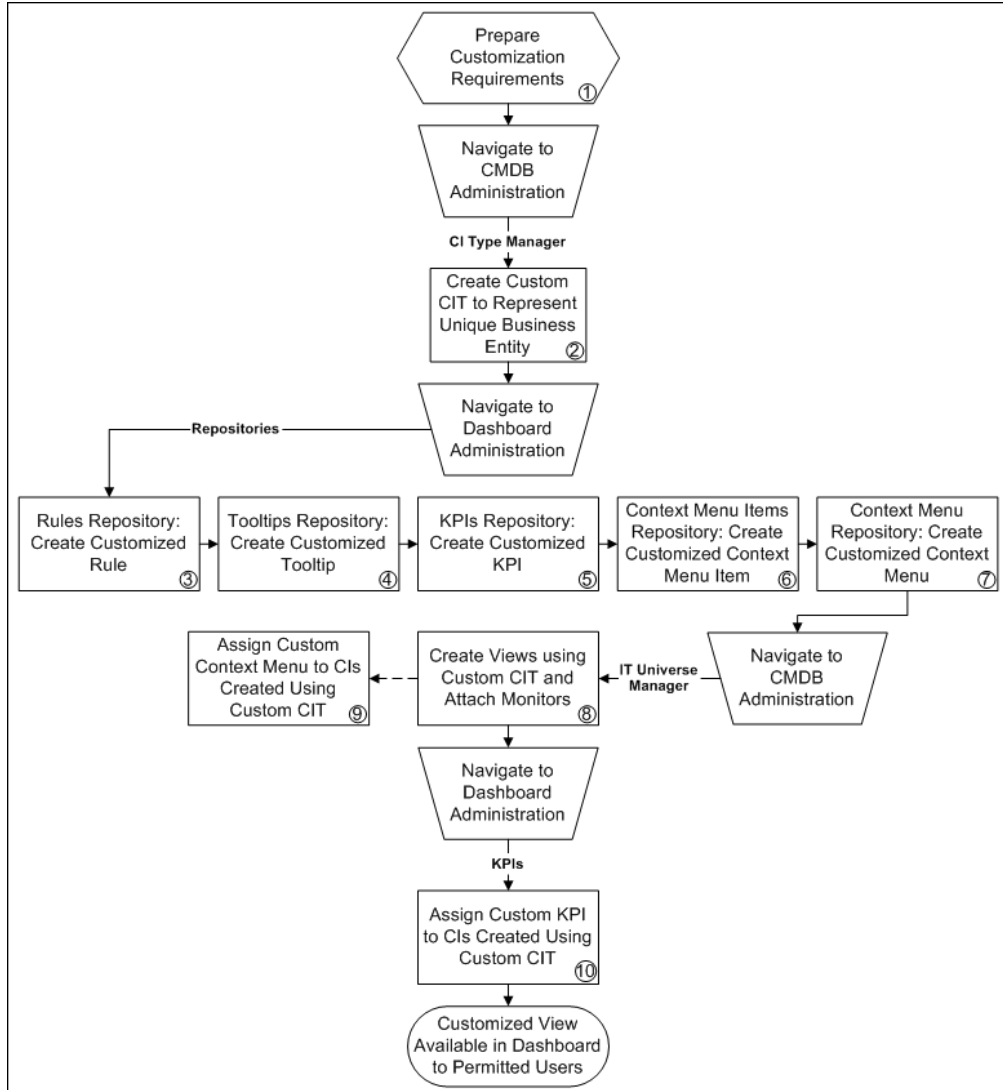

For example, Business Process Monitor, Real User Monitor, Client Monitor, and SiteScope monitor CIs that you configure in Monitor Administration all have default KPIs.</p> <p>Note that CIs with default KPIs that are placed under other CIs in a view generally propagate their KPIs upward to the parent CIs.</p> <p>You may want to modify the business rule (or its properties) used by a KPI. Alternatively, you may want to modify or delete a KPI associated with a higher level CI in a view if the KPI originated from a lower level CI, was propagated upward, and is not appropriate for the higher lever CI (for example, if you want to only see performance and not availability). 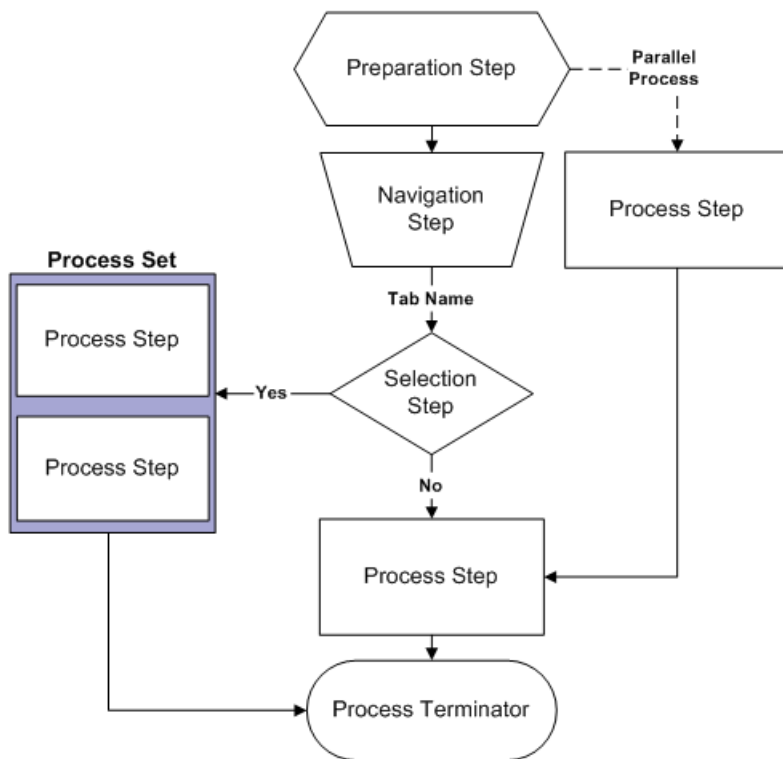

2	In the CI Type Manager, the company's Mercury Business Availability Center administrator adds a new logical CI type called Cruise Ship to the Business folder. In the Attributes page, she adds a new editable attribute, <code>ship_serial_number</code> , and marks the <code>data_name</code> attribute as the key attribute (since it serves as a unique identifier for each ship).
3	In the Business Rules repository, the administrator creates a customized rule to deal with the dollar impact of ship system non-availability by cloning the Impact Over Time Rule, renaming the cloned rule to Ship Impact Over Time Rule, and editing the <code>DollarImpactFactor</code> parameter to 1000 (to represent a dollar loss of \$1,000 per hour).
4	In the Tooltips repository, the administrator edits the description of the new tooltip associated with newly created Ship Impact Over Time Rule that appears in the Custom Tooltips section to say: Dollar loss due to no availability on ship system
5	In the KPIs repository, the administrator creates a customized KPI to monitor the dollar impact of ship system non-availability by cloning the OT Impact KPI, renaming the cloned KPI to Ship OT Impact, and modifying the selected applicable rules—clearing Impact Over Time Rule and selecting Ship Impact Over Time Rule.
6	In the Context Menu Items repository, the administrator clones the Go to Report item, renames the cloned item Go to Ship, selects the Dashboard generic URL pre-processor class, edits the value of the URL parameter to the desired URL address, and selects the Open window post-processor class.

7	In the Context Menus repository, the administrator clones the Group Menu, renames the cloned item Ship Group Menu, and edits Ship Group Menu to add Go to Ship as a new item in the Go to Report menu item list.
8	In IT Universe Manager, the administrator creates a new instance view called Cruise Ship Fleet, and adds a Cruise Ship CI for each ship in the fleet. She attaches relevant SiteScope and Business Process Monitors that were previously configured to monitor ship systems.
9	When adding Cruise Ship CIs to views, the administrator assigns the Ship Group Menu as the context menu for the CIs. The menu will then be visible in Dashboard views.
10	After creating views that include the Cruise Ship CIs, in the Dashboard Administration KPIs tab the administrator assigns the new KPI Ship OT Impact to the Cruise Ship CIs. This KPI will then be visible in Dashboard views to users with appropriate permissions on the views.

## Working with the Documentation Library

The Documentation Library is an online help system that describes how to deploy, administer, and use Mercury Business Availability Center. You access the Documentation Library using a Web browser. For a list of supported Web browsers, see “Viewing Mercury Business Availability Center Site” in *Deploying Servers*.

The Documentation Library is best viewed from a browser with Java support. If you do not have Java support on your browser, download the Sun Java plug in from the Sun Java Web site (<http://java.com/en/index.jsp>). Note that if Java support is not available, the Documentation Library automatically opens using the JavaScript implementation. The JavaScript implementation provides the same basic functionality as the Java implementation, however does not allow use of the Favorites tab within the navigation pane (for details on the navigation pane, see “Navigating the Documentation Library” on page 102).

All major guides in the Documentation Library are available in PDF format for printing or on-screen reading in Adobe Acrobat Reader.

Post-release updates to documentation are posted to the Mercury Documentation Portal on a periodic basis. For details on downloading updates, see “Updating the Documentation Library” on page 103.

- ▶ Click **Help on this page** in the Mercury Business Availability Center Help menu, click the **Help** button in a dialog box, or click the help icon within a specific context, to open the Documentation Library to the topic that describes the current page or context.
- ▶ Double-click **index.htm** in the **Documentation\doc\_lib** directory on the Mercury Business Availability Center Documentation and Utilities CD-ROM (for versions delivered on CD-ROM).
- ▶ Access the Documentation Library from the Mercury Business Availability Center Documentation Portal area on the Mercury Customer Support Web site ([support.mercury.com](http://support.mercury.com)).

-  ➤ **Show in Contents** button. Click to highlight, in the Contents tab, the entry corresponding to the currently displayed page. Note that this button is only displayed when the navigation pane is open.
-  ➤ **Previous** and **Next** buttons. Click to move forward or backward in the guide currently displayed.
-  ➤ **Send Feedback** button. Click to open your e-mail client and send feedback to Mercury. An e-mail message opens with the **To** and **Subject** fields already completed and a link to the current page in the message body. Make sure to complete the e-mail by entering your feedback. Note that you must have an e-mail client configured on the machine for this function to operate correctly.

## Navigating the Documentation Library

The Documentation Library is an integrated help system that can be navigated in the following ways:

- ▶ **From the home page.** To access the home page, select **Documentation Library** in the Mercury Business Availability Center Help menu. The home page can also be accessed from the Contents tab.

The home page is divided into the following tabs:

- ▶ **Main Topics tab.** The Main Topics tab organizes the various guides contained in the Documentation Library into logical sections.
- ▶ **How Do I...? tab.** The How Do I...? tab provides direct links to the step-by-step process flows, which appear in the chapter “How Do I...? A Task Reference for Administrators” in this guide.
- ▶ **PDFs tab.** The PDFs tab is organized similar to the Main Topics tab, but provides links to the guides in PDF format.
- ▶ **From the Navigation pane.** To access the navigation pane if it is not being displayed, click the **Show Navigation** button.



The navigation pane is divided into the following tabs:

- ▶ **Contents tab.** The Contents tab organizes the various guides in a hierarchical tree, enabling direct navigation to a specific guide or topic.
- ▶ **Index tab.** The Index tab enables you to select a specific topic to display. Double-click the index entry to display the corresponding page. If your selection occurs in multiple documents, a dialog box is displayed enabling you to select a context.
- ▶ **Search tab.** The Search tab enables you to search for specific topics or keywords. Results are returned in ranked order.
- ▶ **Favorites tab.** The Favorites tab enables bookmarking specific pages for quick reference. Note that the Favorites tab is only available when using the Java implementation of the Documentation Library. If your browser does not support Java, the JavaScript implementation is automatically used and the Favorites tab is not displayed.

## Updating the Documentation Library

Mercury may periodically update its product documentation with new information. Mercury Business Availability Center administrators can choose from the following options to gain access to the latest version of the Documentation Library:

- ▶ manually download files. For details, see below.
- ▶ configure Web access. For details, see page 105.

### Manually Download Files

Manually download files from the Mercury Documentation Portal, and update the Documentation Library files located on the local Mercury Business Availability Center server. This option is required if access to the Documentation Library is set to local access (default setting).

#### To update local Documentation Library files:

- 1** Click the **Mercury Documentation Portal** link from the Mercury Business Availability Center Help menu, or in the Customer Support Web site click the **Documentation** link.

- 2** Select the product name.

Note that if the product does not appear in the list, you must add it to your customer profile. Click **My Account** to update your profile.

- 3** Click **Retrieve**. The Mercury Documentation Portal opens to the Downloads page.

The Downloads page lists documentation updates and provides further instructions on how to update the files on your local Mercury Business Availability Center server.

- 4 Click a document link to download the required documentation. Save the files to a temporary location.
- 5 Replace the older files on the local Mercury Business Availability Center server with the newer ones you downloaded. It is recommended that you back up files that you plan to delete to a temporary location until verifying that the newer files can be accessed.

Documentation resources are located in the following directory on the Mercury Business Availability Center server (or Centers server if installed separately):

- ▶ **pdfs.** Contains Mercury Business Availability Center Documentation Library files in PDF format. To update a PDF file, replace it.
- ▶ **whatsnew.** Contains the What's New file. To update, replace the file.

## Configure Web Access

Configure Web access to the Documentation Library. When this option is chosen, the Documentation Library is served via the Web, from Mercury servers. When access via the Web is chosen, the most updated version of the Documentation Library is always displayed.

**To configure Web access to the Documentation Library:**

- 1** In the Mercury Business Availability Center Administration Console, open the Infrastructure Settings Manager from **Admin > Platform > Setup and Maintenance**.
- 2** Select the **Foundation > Business Availability Center Interface** context.
- 3** Change the value of the **Enable Access to Web-based Documentation Library** setting in the **Business Availability Center Interface - Documentation Access** table to **True**.
- 4** Restart the Mercury Business Availability Center servers (Centers Servers in a distributed architecture).
