New Features in this Release

- CSA 3.2 introduces a new feature named "Group Ownership". When ordering a service in CSA 3.2, a subscriber can specify that it is to be co-owned by other subscribers (in a group defined by LDAP). CSC 9.40 P1 is enhanced to properly charge the cloud service cost. If the manager (defined by the managedBy attribute) of the LDAP group exists, the cost will be charged to the billing center of the group manager. Otherwise, the cost will be charged to the billing center of the original requestor. The group manager will be able to see the "co-owned" service when logging on to CSC.
- MOE version 7.2 is now supported.

Installation Notes

- Before you apply this patch to an existing CSC product, you must stop any services that are related to CSC.
- When you apply this patch to an existing CSC product, you are requested to enter the password
 of the built-in Admin account. For more information about the built-in Admin account, refer to
 CSC Installation and Configuration Guide, Chapter Configuring CSC, Section The built-in
 Admin user account.
- We strongly recommend that you back up your CSC database when applying this patch. If you
 are using the built-in SQL Server 2012 Express Edition, you can copy and save the database
 files in the %AppData%\HP\CSC\database\ folder.
- After you apply this patch, the user log-on format is changed from User name to Domain\User name. Therefore, to enable the users to successfully log on to CSC, you must use the built-in Admin account to manually activate the Synchronize Department and Employee From AD Automated Process Manager (APM) task. For more information about this task, refer to Installation and Configuration Guide, Chapter Configuring CSC, Section Configuring automated tasks.

Fixed Defects in this Release

The reference number for each fixed defect is the Change Request (QCCR) number. For more information about fixed defects, visit HP Software Support Online, or contact your HP Support representative directly.

Title: Add and **Delete** buttons are not displayed consistently across different pages. (QCCR1E95965)

Description: When you open the detail page of an organization from **Organization management** > **Organizations**. The **Add** and **Delete** buttons appear randomly.

Resolution: This defect is fixed. The buttons are displayed consistently.

Title: Subscriptions are imported without deployed CIs in CSC for MOE. (QCCR1E97056)

Description: When importing subscriptions to CSC for MOE, the deployed CIs are not imported.

Resolution: This defect is fixed. The deployed CIs are now imported to CSC correctly.

Title: Winns user.scn cannot be run due to a "!" character in the password. (QCCR1E97677)

Description: If a password contains a "!" character, the Winns_user.scn scenario file cannot be run successfully.

Resolution: This defect is fixed, the password with "!" can be correctly recognized.

Title: Long queries in the restright.txt file are truncated when importing to CSC. (QCCR1E98255)

Description: If the length of a query in the restright.txt file is longer than 303, it will be truncated when importing to CSC.

Resolution: This defect is fixed. Queries containing less than 1024 characters can be run without truncation.
