Open Source

Currently, the SNIA has 2 different open source packages available. The SNIA license agreement must be accepted in order to download any SNIA open source code.

A source package that is available is the Java based implementation of a Common Information Model Object Manager (CIM OM). The SNIA implementation provides both client and server CIM/WBEM technologies. (See the SNIA CIM web page for the DMTF website for more information about CIM, CIM OM, and WBEM) Using Java as the implementation language ensures the largest possible audience for this technology and allows vendors to adopt this technology without the need for porting or long running test and integration periods. The first version of this source was available in June of 2000 and was last updated in August of 2000.

There are two source packages that are available for the C based implementation of the SNIA HBA APIs.

1. Definitions.

1.1 "Commercial Use" means distribution or otherwise making the Covered Code available to a third party.

1.2 "Contributor" means each entity that creates or contributes to the creation of Modifications.>

1.3 "Contributor Version" means the combination of the Original Code, prior Modifications used by a Contributor, and the Modifications made by that particular Contributor.

1.4 "Covered Code" means the Original Code or Modifications or the combination of the Original Code and Modifications, in each case including portions thereof.

1.5 "Electronic Distribution Mechanism" means a mechanism generally accepted in the software development community for the electronic transfer of data.

1.6 "Executable" means Covered Code in any form other than Source Code.

1.7 "Initial Developer" means the individual or entity identified as the Initial Developer in the Source Code notice required by Exhibit A.

1.8 "Larger Work" means a work which combines Covered Code or portions thereof with code not governed by the terms of this License.

1.9 "License" means this document.

1.10 "Licensable" means having the right to grant, to the maximum extent possible, whether at the time of the initial grant or subsequently acquired, any and all of the rights conveyed herein.

1.11 "Modifications" means any addition to or deletion from the substance or structure of either the Original Code or any previous Modifications. When Covered Code is released as a series of files, a Modification is:

A. Any addition to or deletion from the contents of a file containing Original Code or previous Modifications.

B. Any new file that contains any part of the Original Code or previous Modifications.

1.12 "Original Code" means Source Code of computer software code which is described in the Source Code notice required by Exhibit A as Original Code, and which, at the time of its release under this License is not already Covered Code governed by this License.

1.13 "Patent Claims" means any patent claim(s), now owned or hereafter acquired, including without limitation, method, process, and apparatus claims, in any patent Licensable by grantor.

1.14 "Source Code" means the preferred form of the Covered Code for making modifications to it, including all modules it contains, plus any associated interface definition files, scripts used to control compilation and installation of an Executable, or source code differential comparisons against either the Original Code or another well known, available Covered Code of the Contributor's choice. The Source Code can be in a compressed or archival form, provided the appropriate decompression or de-archiving software is widely available for no charge.

1.15 "You" (or "Your") means an individual or a legal entity exercising rights under, and complying with all of the terms of, this License or a future version of this License issued under Section 6.1. 2. Source Code License.

2.1 The Initial Developer Grant. The Initial Developer hereby grants You a world-wide, royalty-free, non-exclusive license, subject to third party intellectual property claims:

### 3. Distribution Obligations.

3.2 Availability of Source Code. Any Modification which You create or to which You contribute must be made available in Source Code form under the terms of this License either on the same media as an Executable version or via an accepted Electronic Distribution Mechanism to anyone to whom you made an Executable version available; and if made available via Electronic Distribution Mechanism, must remain available for at least twelve (12) months after the date it initially became available, or at least six (6) months after a

Provisions which, by their nature, must remain in effect beyond the termination of this License shall survive.

8.2 If You initiate litigation by asserting a patent infringement claim (excluding declaratory judgment actions) against Initial Developer or a Contributor (the Initial Developer or Contributor against whom You file such action is referred to as "Participant") alleging that:

### A. HISTORY OF THE SOFTWARE

=====

Python was created in the early 1990s by Guido van Rossum at Stichting Mathematisch Centrum (CWI) in the Netherlands as a successor of a language called ABC. Guido is Python's principal author, although it includes many contributions from others. The last version released from CWI was Python 1.2. In 1995, Guido continued his work on Python at the Corporation for National Research Initiatives (CNRI) in Reston, Virginia where he released several versions of the software. Python 1.6 was the last of the versions released by CNRI. In 2000, Guido and the Python core development team moved to BeOpen.com to form the BeOpen PythonLabs team. Python 2.0 was the first and only release from BeOpen.com.

Following the release of Python 1.6, and after Guido van Rossum left CNRI to work with commercial software developers, it became clear that the ability to use Python with software available under the GNU Public License (GPL) was very desirable. CNRI and the Free Software Foundation (FSF) interacted to develop enabling wording changes to the Python license. Python 1.6.1 is essentially the same as Python 1.6, with a few minor bug fixes, and with a different license that enables later versions to be GPL-compatible. Python 2.1 is a derivative work of Python 1.6.1, as well as of Python 2.0.

After Python 2.0 was released by BeOpen.com, Guido van Rossum and the other PythonLabs developers joined Digital Creations. All intellectual property added from this point on, starting with Python 2.1 and its alpha and beta releases, is owned by the Python Software Foundation (PSF), a non-profit modeled after the Apache Software Foundation. Thanks to the many outside volunteers who have worked under Guido's direction to make these releases possible.
