1 Asset Discovery

Overview of Asset Discovery

Storage Visibility and Automation collects storage information from Storage Essentials (SE) discovery and enables storage information in SA (SA).

- Host server storage information is discovered by the Storage Host Agent Extension in Storage Visibility and Automation—and not by SE discovery.
- Database storage information is discovered by a Storage Scanner in Storage Visibility and Automation—and not by SE discovery.

SE discovers information about the SAN arrays, switches, fabrics, and NetApp filers in your environment. SA obtains information about these storage assets from SE. Storage assets that are enabled in SA include SAN arrays, fabrics, controllers, and zones. Storage Visibility and Automation also provides information about connectivity, such as the relationship of a switch and a managed server. Edge information is also provided; however, not all fabric switches are displayed.

Data Collection

Storage information is discovered in SE and then collected by Storage Scanners in Storage Visibility and Automation.

Information about storage arrays, switches, fabrics, and NetApp filers in your environment is collected by a component in SA called *SE Connector*. SE Connector retrieves data about the SAN infrastructure from SE. This storage data is transferred to the SA core and stored in the Model Repository. See [SE Connector](#) on page 12 for more information.

Information about Oracle storage configurations in a SAN or Network Attached Storage (NAS) is collected by a component in Storage Visibility and Automation called the *Database Scanner for Oracle*. This Storage Scanner retrieves data about Oracle instance, tablespaces, and datafiles. See [Database Scanner for Oracle](#) on page 15 for more information.

Storage Scanners

There are two types of Storage Scanners that collect storage data:

SE Connector



Storage Essentials (SE) version 6.1.1 or later and Server Automation 7.80 or later are required to configure and deploy SE Connector. SE is required to view, report, or perform any Service Automation Visualizer (SAV) and Service Automation Reporter (SAR) operation on SAN objects, such as arrays, switches, volumes, and so on. SAN objects are discovered in Storage Essentials. To enable discovered SAN objects in the SA, SAV, and SAR products, the Server Automation SE Connector component must be installed and configured. See the *HP Server Automation: Storage Visibility and Automation Installation & Administration Guide* for information about configuring and deploying SE Connector.

SE Connector collects data from Storage Essentials (SE) about SAN elements and inventory, and their connectivity. These SAN elements include storage arrays, fabrics, switches, and NAS filers.



In the user interface, SE Connector is referred to as *SE Storage Scanner*.

The frequency of collecting this storage data is configured by the user. By default, SE Connector collects SAN information from SE once every 12 hours. This action is commonly known as *a scheduled full synchronization*. You can adjust the collection frequency by modifying a setting in SE. In SE Connector, you can specify the maximum wait time (in minutes) for a scheduled full synchronization when the Get All Elements Detail (GAED) process in SE is in progress. The following property specifies the maximum default wait time for a scheduled full synchronization task when GAED is in progress:

```
com.creeppath.agent.common.devices.scheduled.full.sync.max.wait.minutes=10080
```

A “GAED IN PROGRESS” value in the Status column on the Storage Scanner Storage Essentials panel indicates that a Get All Elements Details (GAED) discovery process is currently running on the Storage Essentials server.

When Storage Essentials is processing GAED, by default SE Connector will wait 10080 minutes (7days) before it will proceed to collect data from Storage Essentials, even though a GAED discovery process is still running. SE Connector will check SE every 3 minutes (by default) and will run the collection if the SE GAED process finishes sooner or the SE Connector has waited longer than the interval configured for “Full Data Collection Minutes” in SEPlugin.Properties.

Check the Storage Essentials (connection) Status to determine whether the GAED process is still running. Check the Last Scan timestamp for Managed Elements for that Storage Essentials instance to determine when SE Connector last updated the information for those elements.

The following property specifies the maximum default wait time for a scheduled full data collection task when GAED is in progress:

```
com.creeppath.agent.common.devices.full.data.collection.minutes=720
```

The following describes a typical use case:

- You configure SE Connector to collect information from Storage Essentials once a day.
- Storage Essentials is busy processing GAED for 2 days.
- You do not see updated information for Managed Elements for the Storage Essentials instance in Server Automation.
- You can use a combination of the Storage Essentials connection Status value and Last Scan timestamp for Managed Elements to determine if there is a lengthy GAED process running for SE and the SE Connector is not updating information for those Managed Elements. This explains why information for Managed Elements is not getting updated as per the scheduled frequency.

Attaching and Remediating the SE Storage Scanner and SE Connector Update Policies

This section describes the steps to follow when you attach and remediate the SE Storage Scanner and SE Connector Update policies.

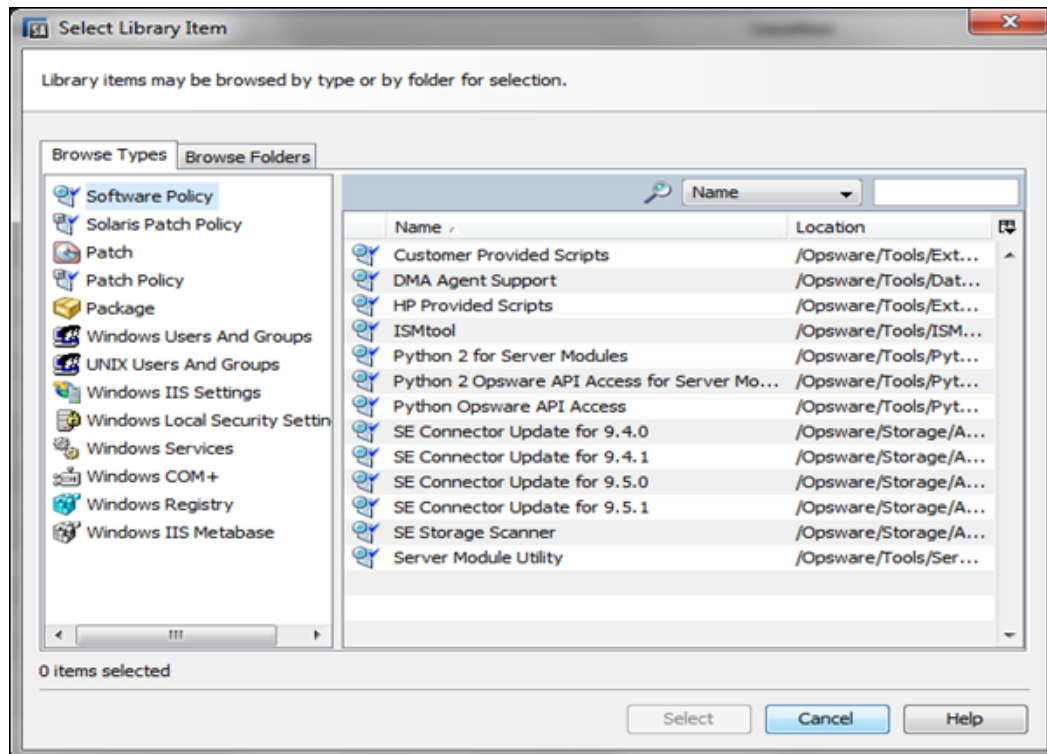
To attach and remediate:

- 1 Attach the software policy SE Storage Scanner to the managed server
- 2 Remediate the server.
- 3 If your HP Storage Essentials management server is version 6.1.1, you do not need to follow any more steps.
- 4 If the HP Storage Essentials management server is version 6.2 or later, attach the software policy SE Connector Update for your version to the managed server.

➤ **Note:** The version of the SE Connector Update must be compatible with the version of the Storage Essentials server, which means that the version numbers of the SE Connector Update libraries must be the same as the version of the Storage Essentials. For example, if you have SE 6.2, installed, you will have to install the SE Storage Scanner first, then install the SE Connector Update for 6.2.

SE Connector Updates

This section discusses SE Connector updates.



SA 10.0 supports the following SE versions: SE 9.4.0, SE 9.4.1, SE 9.5.0 and SE 9.5.1.

➤ **Note:** The SA 10.0 release no longer supports SE 6.x for new managed servers. However, SA 6.x is still supported for existing managed servers.

Viewing the Storage Essentials Connection Status

To view the status of the connection to the Storage Essentials server that is managed by the Storage Scanner:

- 1 From the navigation pane, select **Administration > Storage Scanners**.
- 2 In the content pane, select an SE Storage Scanner and then open its browser.
- 3 From the Views pane, select **Storage Essentials**. Check the Status column.

Multiple Storage Essentials Instances

SE Connector can communicate with multiple Storage Essentials instances.



For scalability and performance reasons, it is recommended that you have *multiple* SE Connectors communicating with *one* instance of Storage Essentials. You can also have *multiple* SE Connectors communicating with *multiple* instances Storage Essentials.



When you have *multiple* SE Connectors communicating with *one* instance of Storage Essentials, each access control must be configured to collect a unique set of devices from the same Storage Essentials instance. See the *HP Server Automation: Storage Visibility and Automation Installation & Administration Guide* for information about modifying access controls.

Since, by default, storage information is collected from SE once every 12 hours, you might need updated data more frequently than twice a day. You can modify this data collection frequency by modifying a setting in SE. See the *Storage Essentials SRM Software User Guide* for information about configuring the schedule for data collection. You can also request an update of SAN information from SE at the storage device level, such as arrays and NetApp filers. See [Update from Storage Essentials](#) on page 16 for more information.

When you are viewing storage information about a SAN array or NetApp filer in Storage Visibility and Automation and would also like to view storage information for the same SAN array or NetApp filer in Storage Essentials, you can launch Storage Essentials to display the data that was discovered. See [Open with Storage Essentials \(Click & Launch\)](#) on page 17 for more information.

Viewing the SA Client Library Version Number

The Storage Scanner properties panel includes the SE Client Library Version number. The SE Client Library version number, such as 6.x.x.xx, is displayed in the Description field.

To view the SA Client Library version number:

- 1 From the navigation pane, select Administration > Storage Scanners.
- 2 In the content pane, select an SE Storage Scanner.
- 3 From the View drop-down list, select Properties. The SE Client Library Version number is displayed in the Description field.

Database Scanner for Oracle

The Database Scanner for Oracle collects data about Oracle storage configurations in a SAN or Network Attached Storage (NAS), such as the Oracle instance, tablespaces, and datafiles.

Storage elements configured for an Oracle instance can be classified as *physical database storage* and *logical database storage*:

- **Physical database storage** includes datafiles and redo logs that directly consume system storage resources (filesystems or partitions) or are built on top of ASM Files.
- **Logical database storage** includes entities such as tablespaces that are created inside the instance consuming different physical and logical storage entities.

This Storage Scanner identifies relationships between the database elements and other storage assets as described in [Table 1](#).

table 1 Database Assets & SAN Relationships

Database Asset	External Storage Asset	Dependency	Description
SAN-based physical database storage	Server assets SAN array assets Fabric assets NetApp assets	Block storage dependency	Provides the dependency chain between the database storage elements and SAN arrays through system (server) resources and fabrics.
NAS-based physical database storage	Server assets NetApp assets	NAS storage dependency	Provides the dependency chain between the database storage elements, server resources, and NetApp.

Update from Storage Essentials



You must have the required SA user permissions to request an “Update from Storage Essentials”. See the *HP Server Automation: Storage Visibility and Automation Installation & Administration Guide* for more information.

“Update from Storage Essentials” is an option in the Actions menu that requests an update of storage information about an individual storage device, such as a SAN array or NetApp filer. SE Connector provides this synchronization of data for a storage system when you request an update at the device level.

SE Connector does not directly communicate with a storage device to collect data about it. SE Connector collects data about an individual storage device from Storage Essentials. This request copies data from the SE repository into the Model Repository.

You can specify the maximum wait time (in minutes) for the “Update from Storage Essentials” action in SE Connector while SE performs GAED for certain storage elements. The following property specifies the maximum default wait time for the "Update From Storage Essentials" action when GAED is in progress:

```
com.creekpath.agent.common.devices.manual.full.sync.max.wait.minutes=10080
```

The Jobs and Sessions user interface displays the status of the update request. A “Success” status indicates that the Model Repository has been updated. The timestamp for the job also provides the following information about the “Update from Storage Essentials” request:

- When the request was made
- What the status of the update job is, such as:
 - **Succeeded**—Request was submitted successfully. SE Connector collected the data for the requested device and sent it to the Web Services Data Access Engine.
 - **Error**—Request could not be submitted. Verify that the SE Connector is running and start it if it is stopped. If there is still a problem, check the SE Connector logs on the managed server to troubleshoot this error. Begin with the `pam-0-0.trace` log file and then check other trace files.

Open with Storage Essentials (Click & Launch)

“Open with Storage Essentials” is an option in the Actions menu that launches Storage Essentials for an individual storage device, such as a SAN array or NetApp filer. You can also launch Storage Essentials for a device by selecting it and then by right-clicking—this is commonly referred to as the *Click & Launch* user interface.

SE Connector supports Click & Launch for storage devices that are managed by Storage Essentials standalone configuration. This option is not supported with Storage Essentials integrated with HP Systems Insight Manager.

Click & Launch requires an SE account login. When you select other storage objects and then Click & Launch from them (while in the same session), the initial SE login will persist. There is no single sign-on capability for HP Server Automation and Storage Essentials.

You can launch SE only from a storage device. You cannot launch SE from a host.

Storage Device

A storage device in the Storage Visibility and Automation model is an entity that represents the volumes, extents, and other things in the real world that contain the actual bits and bytes. A storage device can be any block storage device that has a capacity measured in bytes, such as physical disks, partitions, and database tablespaces.

There are two types of storage devices:

- A **logical volume** is a block storage extent, such as partition, database tablespace, and remote initiator volume.
- A **physical disk** is a physical storage device that provides the raw storage for a storage system, such as storage array disks or spindles.

Deleting a Storage Device

This action only removes a storage device (SAN array, NAS filer, and database) from the Model Repository.

To remove a storage device from the Model Repository:

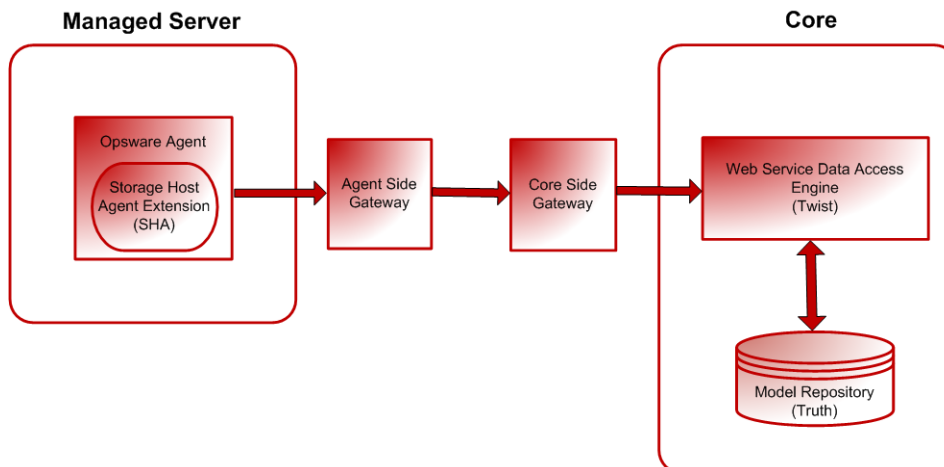
Storage Host Agent Extension (SHA)

A Storage Host Agent Extension (SHA) runs on a managed server to discover storage related data on that managed server, such as Fibre Channel Adapter (FCA) hardware and drivers, filesystem mounts, and so on.

SHA is not an agent. SHA is a C++/Python module that can be executed by scheduled jobs. This module runs on managed servers and produces XML output that is sent back to the SA core. This data (XML output) persists in the Model Repository from where it is then retrieved and displayed in the user interface.

[Figure 1](#) shows the end-to-end process of the SHA that captures storage-related data on a managed server.

Server Assets

This feature provides visibility into the storage configuration in a managed server attached to the Storage Area Network (SAN) or Network Attached Storage (NAS). These configurations can help you understand the dependency on SAN and NAS elements.

Storage elements in a server (server assets) include logical entities, such as volumes and physical hardware. This feature allows you to view and evaluate storage-related information for a managed server, such as FCAs and FCA drivers, volume mounts, volume manager information, and so on.

The discovery of server storage elements is enabled by processes that periodically query the managed server and then push the data to the core.

► Storage Visibility and Automation displays server storage assets after the hardware registration process is successfully completed. Hardware registration typically occurs within the first 24 hours of the SE Connector deployment. See the *SA User Guide: Server Automation* for information about how to initiate the hardware registration process as needed.

You can define the job schedule for capturing storage data. See [Scheduling Server Asset Discovery](#) on page 21.

With this feature, a server administrator can view:



- Storage-related information in each managed server, such as FCAs and FCA drivers, volume mounts, volume manager information, and so on
- Unmounted storage resources that the SAN is making available to the host
- Aggregate information on storage elements (such as volumes used) that are associated with an application in a server


This feature also provides quick navigation to downstream physical or logical storage elements associated with an application or a single managed server. At any level in the storage supply chain, you can drill down to the associated storage entities to view:

- **Physical entities**—fibre switches, filers, disks, and so on
- **Logical entities**—zones, LUNs, and so on

From these entities, you can drill down or drill up to see storage resources that are shared between two or more selected applications or managed servers.

Storage Visibility and Automation captures the following server assets:

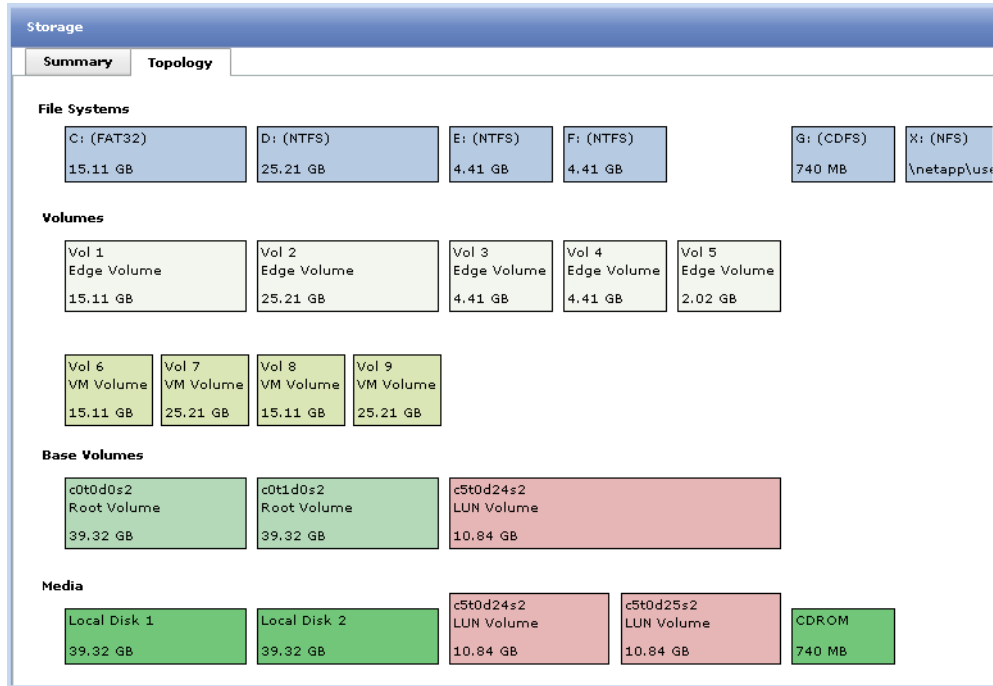
- **Fibre Channel Adapter (FCA)**  —Storage information on the active Fibre Channel Adapter (FCA). In the storage industry, FCA also applies to the hardware interface that uses non-Fabric Channel protocol. Storage Visibility and Automation discovers the Manufacturer, Model, Serial Number, Software Driver Version, Software Firmware Version, and Physical Hardware Version for an FCA.
- **Fibre Channel Adapter Port**  —The port on the FCA to provide access to the outside world—storage information on the active Fibre Channel Port World Wide Name (WWN). See [Fabric Assets](#) on page 49 for information about storage in the connectivity of an FCA Port and an FC Switch Port.

- **Base Volumes**—Basic raw storage capacity (primordial storage). This raw storage may be virtualized and consumed in the layers above (Volume Managers, File Systems). These storage elements include local storage (Root Volumes) based disks, and Direct Attached Storage (DAS).
- **Root Volumes (Local and DAS)**—Storage exposed through disks that are local and are based on DAS as logical Root Volume. Hardware information of the spindles or disk controllers is not captured.
- **Multipath IO (MPIO)**—Information on the MPIO software and all of the Fibre Channel protocol based storage access paths to remote storage volumes. This information includes access path information for each of the LUN bounded to the server. For each path, Storage Visibility and Automation captures the following information:
 - State of the path—active or passive
 - Is Preferred Path
 - FCA Port consumed for each of the path
- **Volume Manager (Logical Volume Manager/Logical Disk Manager)**—Native and third party Volume Manager Software information. This includes information on all aspects of storage, such as capacity and storage layout, that are consumed and produced by the Volume Manager. Storage Visibility and Automation does not provide detailed information on internals of the Volume Manager. However, for each of the volumes produced by the Volume Manager, Storage Visibility and Automation provides dependencies on primordial storage, such as dependency chain that includes consumed storage. SE does not support layered volume managers and layered volumes.
- **Consumed Storage**—Storage that is directly consumed by the Volume Manager from the server primordial storage. SE discovers storage capacity if the applicable volume group (Disk Group) is the source of the consumable storage (server level primordial storage only). Storage Visibility and Automation also captures storage consumed by a volume manager, which consumes external storage. Not all storage resources are virtualized to create volume manager volumes.
- **Produced Storage**—Storage capacity when the applicable volume group (Disk Group) is the type (SIMPLE, RAID5, and so on) for the produced storage (volumes). Produced storage consists of storage units created by a hosted service, such as file systems, volume managers, and databases.
- **File Systems**  —Consumers of the produced storage. This functionality includes capturing the file systems that are based on primordial storage and storage offered by volume manager volumes. Storage Visibility and Automation discovers Block Driver, Cluster Size, Is Remote, File System Size, File System Type (nfs, ufs, vxfs, hfs, ext2, ext3, ntfs, and so on), Mount Point, and Root and Storage capacity information. Storage Visibility and Automation also discovers the dependency chain for the File System based on NetApp. See on page 50 for more information. For this release, Storage Visibility and Automation does not support distributed filesystem.

Storage Topology

Figure 2 shows how storage builds up from physical disks to volumes, through volume managers, to a file system.

figure 2 Storage Layers



Layer 4 shows the physical disks and the LUNs attached to the server. The physical disks are the local disks to the server and the LUNs are the logical units from an external storage systems (Network attached storage or Storage Attached Network).

Layer 3 shows the physical partitions, which are created from one or more physical drives and logical units.

Layer 2 shows the volume groups, which can consist of one or more physical volumes and there can be more than one volume group in the system. These volume groups can be divided into logical volumes of various sizes. A logical volume can span a number of physical volumes in a volume group or represent only part of one physical volume. Logical volumes can contain a file system, swap space or raw data.

Layer 1 shows the file systems that are mounted on the logical volumes.

Scheduling Server Asset Discovery

In Storage Visibility and Automation, the discovery of server storage elements is enabled by processes (jobs) that periodically query the managed server and then push the data to the core. You can define the job schedule for capturing storage data. See the *SA User Guide: Server Automation* for more information about jobs and scheduling them.

Server Storage and SAN Relationships

Storage Visibility and Automation displays relationships between server storage elements and other storage asset discovery features. See [Table 2](#).

Viewing FCAs Attached to a Server

SAN Array Assets

This feature provides visibility into various storage array configurations that are attached to a SAN. This excludes SAN array devices that are directly attached to servers. SE captures generic SAN array assets as well as vendor-specific assets.


Using this feature, a server administrator can view the following:

- SAN array storage utilization and configuration
- SAN Array security configuration
- Storage resources shared between applications or hosts

SE captures the following generic SAN array assets:

SAN Array (Storage Systems)  —SAN array configuration information. SE uses an IP-based network mechanism to access the device or device interface, such as API, CLI, and so on. Storage Visibility and Automation discovers the Manufacturer, Model, Serial Number, Firmware Version, and Storage Capacity for a SAN Array.


Disk Controllers—Disk controllers are discovered for arrays. However, the Storage Visibility and Automation user interface does not display the association or relationship between a disk controller and a disk for any disk controller.

Storage Volumes  —Storage volumes that are carved out of disks. Storage Visibility and Automation discovers the Storage Capacity, Block Size (if available), Storage Type, and Volume ID. Meta volumes (devices) are composite volumes that are created using two or more regular storage volumes.

Composite Volumes—Some SAN arrays support composite volumes. For these types of arrays, Storage Visibility and Automation will capture information for composite volumes. Composite volumes allow individual storage volumes to be concatenated and create a storage volume with larger storage capacity.

Port Controllers—The port controller and a list of fabric ports in the controller.

Fabric Ports—SAN array fabric ports are used to provide FC connectivity between SAN array and fibre switch (standalone or part of a fabric). Storage Visibility and Automation does not capture internal fabric ports in the system. It captures the Port Number, State (Offline, Online), and the World Wide Name.

Storage Pools  —Some SAN arrays support grouping volumes together, based on common characteristics. For example, for an HP XP or Hitachi SAN array, groups of storage volumes are grouped together in an entity called Array Groups. Not all SAN arrays support storage pool concepts. For SAN arrays that do support pool concepts, Storage Visibility and Automation captures the storage type and storage capacity. For supported SAN arrays, Storage Visibility and Automation captures the free extents in the pool. If the storage pool is not supported by the device, HP creates the storage pool for the storage volumes, based on the storage type.

LUN Mapping—Lun Mapping information, such as Storage Volume, SAN Array Port, Lun ID, and Host FC Port/FCA information.

Update from Storage Essentials

Since, by default, storage information is collected from SE once every 12 hours, you might need updated information about a SAN array more frequently than twice a day. Check SE to verify the frequency of its data collection, and configure it if necessary. See the *Storage Essentials SRM Software User Guide* for information about configuring the schedule for data collection.

In Storage Visibility and Automation, you can request an update of SAN information from SE at the device level (such as, the SAN array). Fabric Assets


This feature provides visibility into fabric configurations in a SAN. Storage elements in a fabric include physical entities, such as fabric switches, ports, and security items, such as Zones and Zonesets.

Minimal information about fabrics is displayed in the user interface, such as when there is a connection between the fabric and the server, the Device Explorer displays fabrics. To view detailed information about fabric assets, you must use the Global File System (OGFS) feature. See [Global File System \(OGFS\)](#) on page 91 for more information.

With this feature, a system administrator can view the following:

- Physical fabric configuration
- Security configuration enabled in the fibre channel network
- Servers and SAN storage devices connected to the fibre channel network
- Storage resources shared between applications or managed servers

Storage Visibility and Automation captures the following fabric information in a SAN:

Fibre Switch and Fabrics  —Identifies whether a fibre switch is a principal switch or a subordinate switch of the fabric. After the principal switch is identified, Storage Visibility and Automation gathers information on the connected fibre switches and end devices, such as servers, SAN-based storage devices, and so on. Storage Visibility and Automation lists the switch ports for all switches in the fabric. Storage Visibility and Automation collects the Manufacturer, Model, Serial Number, Firmware, Hardware Version, World Wide Name (WWN), Domain Name, IP, and the number of Ports for each of the switch. Storage Visibility and Automation identifies a physical fabric by the WWN of the principal switch. If the role of a switch changes from subordinate to principal, the identity of the fabric changes—this change is discovered by SE. Storage Visibility and Automation does not collect routing table information in each switch and does not support multiple vendor fabrics that are in an interop configuration.


Switch Enclosure—Information about the switch enclosure includes blades and slots that make up that enclosure. This feature applies to director-class switches. Storage Visibility and Automation collects the Part Number, Serial Number, Manufacturer, and Model.

Switch Blade—Blade information about the enclosure. Storage Visibility and Automation collects the Manufacturer, Model and Serial Number of the blade.


Switch Ports—The fibre channel port World Wide Name (WWN), including information about F_Ports, E_Ports, and G_Ports. For each port, Storage Visibility and Automation collects the WWN, Port Number, Port State, and Port FCID (Fibre Channel ID). If enclosure is captured, Storage Visibility and Automation also collects slot information for the ports. Storage Visibility and Automation does not collect node loop ports attached to an arbitrated loop. However, Storage Visibility and Automation collects fabric switch loop port.

E_Ports/Inter-Switch Links—Inter-Switch Link (ISL) information. SE identifies the E_Ports that participate in the ISLs for each pair of fibre switches.

Ports Connectivity and N_Ports—For each fibre switch port, Storage Visibility and Automation collects the World Wide Name (WWN) of the connected N_Port, such as FCA Port (REF-008) and Storage Array Port (REF-009). This information helps identify the dependency chain from the initiators to the targets through the fabric, and also displays information about the multi-path between the initiators and the targets. Ports that are discovered without any parent device information are marked as Unknown Connected Ports. Storage Visibility and Automation does not collect node loop ports attached to an arbitrated loop.

Zoning Database and Zones  —All active zones configured in the zoning database of the principal switch. Zones contain a list of World Wide Name (WWN) and alias naming. Alias naming may not be supported by all fibre switch vendors. A zoning database may not be synchronized between switches. The administrator should verify that zoning databases across the fabric are synchronized. Storage Visibility and Automation does not capture the zoning information if the list (members) are configured as Domain:Port format.

Alias  —Storage Visibility and Automation collects all alias in a zoning database. Alias is not supported by McData-based fabric switches. Storage Visibility and Automation does not collect the alias information if the list (members) are configured as Domain:Port format.

Zonesets  —Storage Visibility and Automation collects all active zonesets in a fabric. Storage Visibility and Automation also collects all zones that make up a zoneset.

NetApp Assets

This feature provides visibility into NetApp storage configurations in a SAN or IP network, such as File I/O based storage entities (Filer Volumes, Qtrees) and Fabric elements (FCA/Ports).

A NetApp storage administrator can view the following:

- NetApp storage utilization and configuration
- Storage resources shared between applications or managed servers


SE captures the following NetApp information in a SAN:

NetApp Filer—Filer Name, Manufacturer, Model, Serial Number, Firmware Version, Customer, IP Address, Facility, Status, Description, Discovered on, Last Scan, Scan Status, Object ID.

Disks—NetApp disk storage capacity. Storage Visibility and Automation discovers the raw capacity of the disk and discovers whether the disk is consumed by RAID groups.

RAID Groups—NetApp creates RAID groups based on disks. RAID group is an internal entity that is not configured by the user. Storage Visibility and Automation does not display storage information for RAID groups. The storage information is not available through the API. It is derived by the size of the disk and configuration, such as RAID 4 or RAID 4DP.

Plex—NetApp creates Plex based on RAID Groups. Plex is an internal entity that is not configured by the user. Storage Visibility and Automation does not display storage information for Plex. The storage information is not available through the API—it is derived by the size of the RAID Group.

Aggregates —Aggregate is a storage entity that is introduced by ONTAP 7.0. Storage Visibility and Automation discovers aggregate caption and aggregate capacity.

File I/O—NetApp exposes storage resources for File I/O. NetApp volumes, Qtree and Directories are exposed through CIFS or NFS for File I/O. Storage Visibility and Automation collects storage information related to File I/O access.

NetApp Volumes—Filer volume information that includes storage capacity, vFiler that the volumes are associated with, aggregate that the volume consumes, volume type (Traditional or Flex), snapshot reserve, snapshot reserve size, and whether the volume is a target or a source of replication.

Traditional Volumes—Volumes based on ONTAP 6.5 and traditional volumes in ONTAP 7.0 or higher.

Flex Volumes—Flex is a storage entity that is introduced by ONTAP 7.0. In addition to filer volume information, Storage Visibility and Automation also discovers committed capacity and space guarantee (volume, none, file) for flex volumes.

Qtrees—A subdirectory in a volume that acts as a virtual sub-volume with special attributes, such as primarily quotas and permissions.

Quota—The quota against the NetApp volumes. Quota that is applied on the Qtrees is also captured at the volume level. Storage Visibility and Automation discovers the following quota information:

- Caption
- Type (tree, user, or group)
- Qtree (Qtree that is applicable)
- Unix ID (ID of the user or group, whichever is applicable)
- Windows ID (ID of the user or group, whichever is applicable)
- Space threshold
- Space threshold unit (in KB/MB, and so on)
- Quota target (Default targets are discovered as *.)

Quota will also have zero or more QuotaLimit. QuotaLimit captures the following information:


- Limit type (DiskSpace or NumberOfFiles)
- Soft Limit Value
- Soft Limit Unit
- Hard Limit Value
- Hard Limit Unit

Directory—Directory paths that are exported through CIFS share or NFS. Storage Visibility and Automation does not discover all directories that are residing in the NetApp volume.

File I/O Exports—NetApp provides exporting NetApp Volumes using File I/O through CIFS and NFS protocol.

CIFS—Common Internet File System. NetApp shares and the volume/qtree/directory path. Storage Visibility and Automation does not discover the managed servers that are consuming the NetApp resources through CIFS protocol.

NFS—Network File System. Export information for the volumes/Qtree/directory path. HP might discover stale information, based on the data available to it through the API.

NetApp vFiler —vFiler configuration. Storage Visibility and Automation discovers IP addresses and the volume path that is configured for each vFiler. NetApp requires that a MultiStore license is enabled in the filer to support virtual filers. If a MultiStore license is not enabled, Storage Visibility and Automation assumes that a default vfiler0 exists in the system.

Oracle Database Assets

This feature provides visibility into the Oracle storage configurations in a SAN or Network Attached Storage (NAS). These configurations include physical entities, such as fabric switches and SAN Arrays.


A database administrator can view the following:

- Oracle database storage configuration
- System resources available to the Oracle databases in one or more servers in a data center
- Servers and SAN Storage devices connected to the FC network
- Storage resources shared between Oracle Instances and/or hosts
- Network Attached Storage (NAS) resources that the Oracle Databases depends on

Storage Visibility and Automation provides the following Oracle database storage configuration in a SAN or NAS:

Oracle Instance—Storage-related information for the Oracle Instance. Storage Visibility and Automation collects the version of the Oracle database that is running the Oracle instance.


Storage Elements—Storage elements configured for an Oracle instance can be classified as physical database storage and logical database storage. *Physical database storage* includes data files and redo logs that directly consume system storage resources, such as file systems and partitions. *Logical database storage* includes entities such as tablespaces that are created inside the instance that is consuming different physical and logical storage entities.

Data Files —The file path, allocated space, and space used for each data file. Oracle data files can reside directly on the file system or they can utilize raw partitions.

- **Based on File System**—Data files can be created directly in a file system and specified to the Oracle database. Storage Visibility and Automation collect information about the file path of the data file. HP uses this information to calculate the file system that is consumed by the data file.
- **Based on Raw Partition**—Storage Visibility and Automation collects partition information. HP uses this information to calculate the storage supply chain that is consumed by the data file.
- **Based on ASM Files**—For this use case, the storage supply chain includes the following elements: ASM File, ASM Diskgroup, and ASMDisk(s). ASMDisk(s) are created on raw disk partitions, Logical Unit Numbers (LUNs), raw logical volumes (LVM), or NFS files.

Redo Logs—Redo logs information for the Oracle instance, such as file path and allocated space for the redo log.

Logical Database Storage—Storage-related information for the tablespace and its association to the physical storage entities. Storage Visibility and Automation does not collect storage entities, such as data segments, extents, data block, schema, table, and index.

Tablespaces —Storage Visibility and Automation collects tablespace information for each Oracle instance, such as the status, allocated space, and space used for each of the tablespaces.

Automatic Storage Management (ASM)—Storage configuration and utilization of the Oracle database. ASM helps manage volumes that might be composed of block-based devices (SAN) or file-based devices (NFS), with additional data replication inside ASM.

Device Group Assets

The Device Groups feature in Storage Visibility and Automation provides a useful way for gathering storage devices into collections. Grouping storage devices enables you to view all of the devices simultaneously, instead of viewing individual devices, one at a time.

This feature allows you to include storage devices in a device group and view a history of events for a device group. You can view detailed storage device history, such as information in snapshot messages from the synchronization process. Device groups and a history log can help you troubleshoot problems.

The Device Groups feature in Storage Visibility and Automation is modeled after the Device Groups feature in SA. See the *SA User Guide: Server Automation* for more information about managing device groups.

You can create the following types of storage device groups:

- **Static Device Group**—This group contains heterogeneous storage devices, such as any combination of servers, storage arrays, and NetApp filers.
- **Dynamic Device Group**—This group contains a homogeneous set of storage devices, such as servers or storage systems (SAN Arrays and NAS filers). A dynamic device group contains only one type of storage device because it is generated based on device properties. A dynamic device group cannot contain a combination of different types of storage devices.

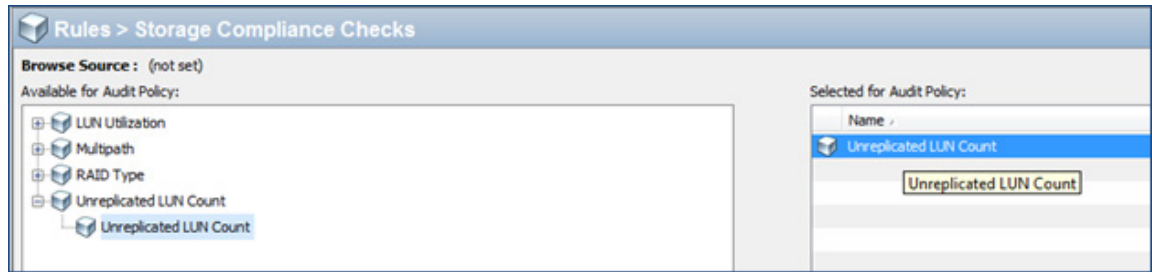

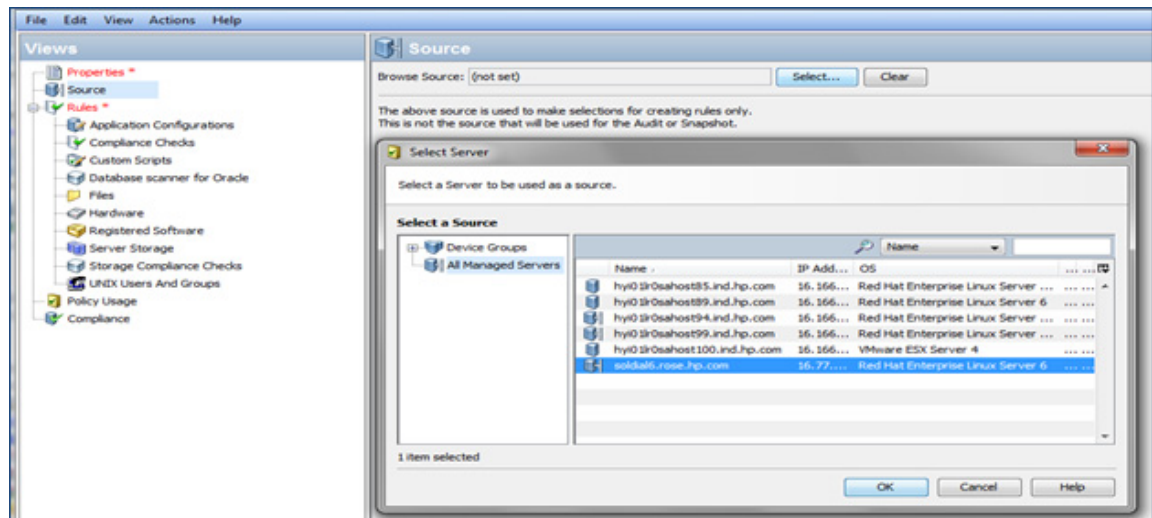

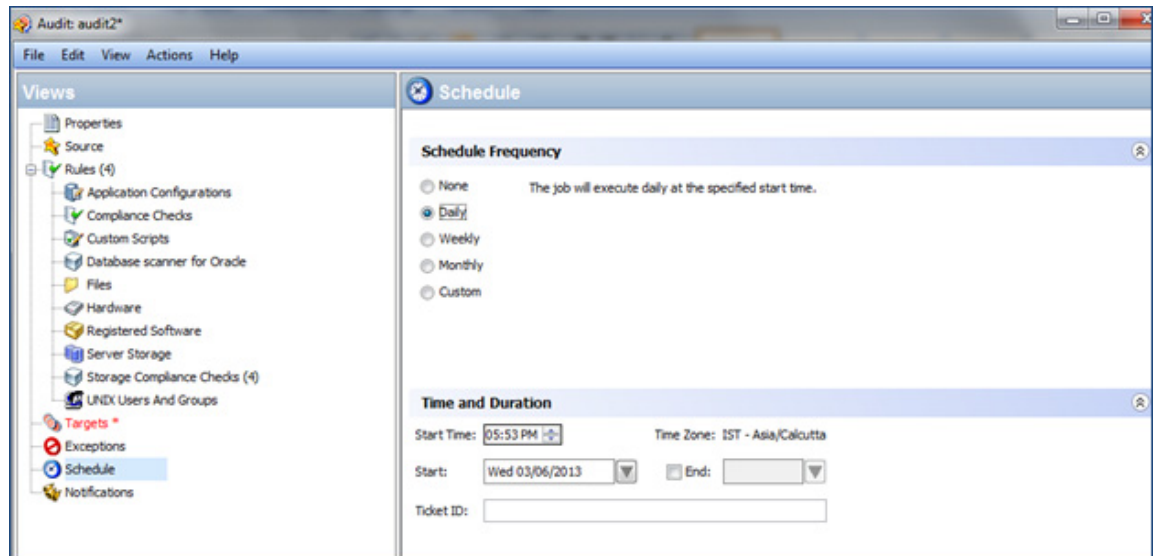

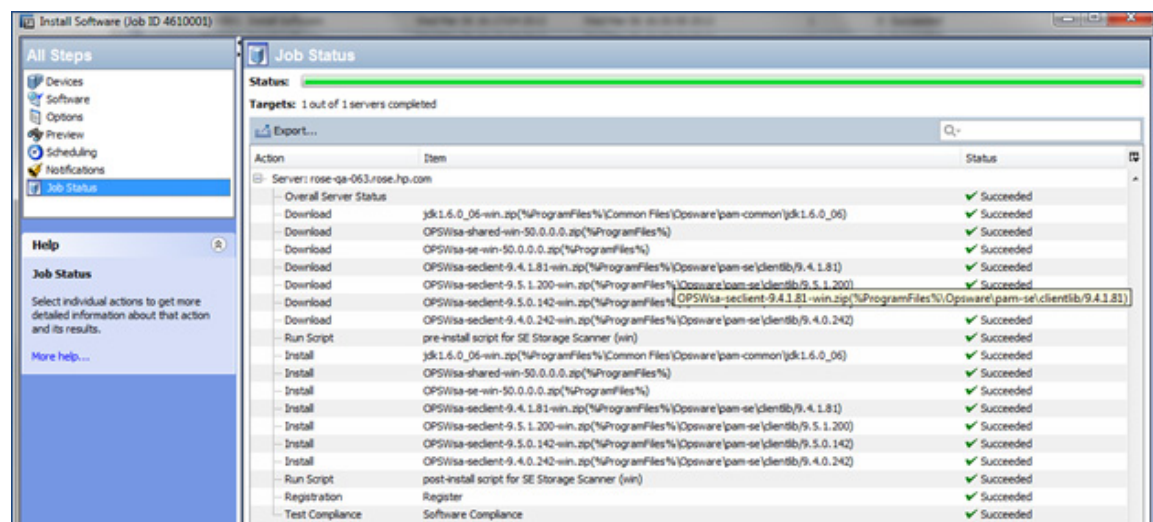

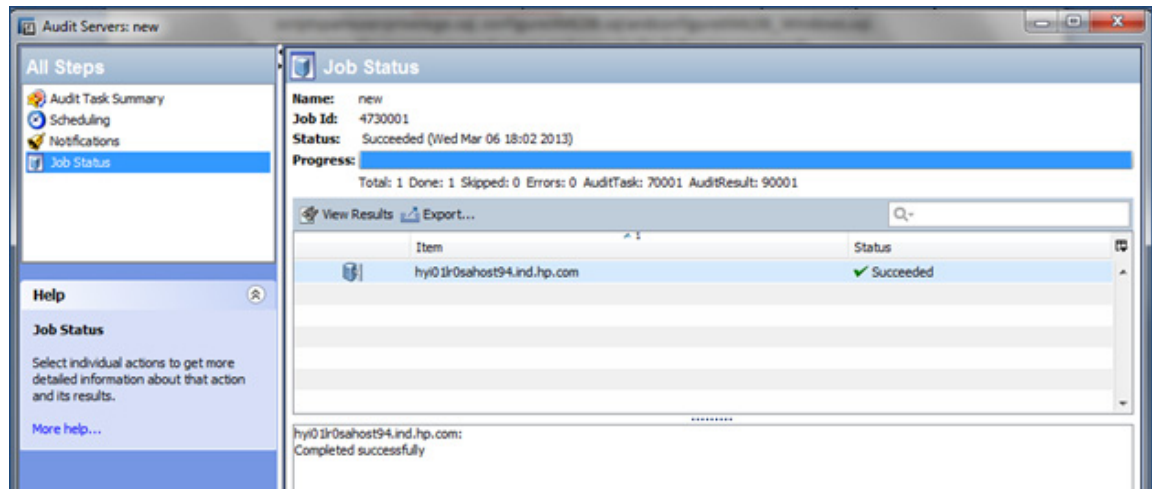

3 Storage Visualization

Overview of Service Automation Visualizer

The Service Automation Visualizer (SAV) feature in Server Automation (SA) allows you to visualize logical storage dependencies and physical storage connections in your data center. SAV displays how these dependencies and connections relate to your business applications in mapping diagrams. These diagrams map out the storage supply chain from servers to spindles—how servers map to the storage devices they are connected to. SAV diagrams also show file systems and their relationships to local and remote storage, FC adapters, FC switches (physical and virtual), connections and ports, disk arrays, NAS filers, LUN mappings, RAID configurations, SAN fabrics, and so on.

- ❑ Storage Essentials (SE) version 6.1.1 or later is required to view, report, or perform any Service Automation Visualizer (SAV) and Service Automation Reporter (SAR) operation on SAN objects, such as arrays, switches, volumes, and so on. SAN objects are discovered in Storage Essentials. To enable discovered SAN objects in the SA, SAV, and SAR products, the Server Automation SE Connector component must be installed and configured.

For more information about SAV, see the *SA User Guide: Application Automation*.

Storage Mapping Features

SAV provides visual maps that display physical and logical drawings of storage devices and connections in your environment—in a Storage Map and a SAN map.

SAN Map

The SAN map shows a superset of the Storage Map, including a graphical view of the SAN involved in a SAV snapshot, all servers and their FCAs (including fibre channel ports), and each adapter's connections to switches in the SAN.

Storage Map

The Storage Map displays storage dependencies for servers, FCAs, NAS filers, SAN arrays, fabrics, switches, ports, and so on, that you have scanned with SAV. This map provides a graphical view that displays servers, the process families running on them, including the file systems and local or remote storage devices these files are stored on and served from, either through local disks, NAS filers, or remote disk arrays. The map shows connections between process families and their open files and where the files are stored.

4 SE Connector

SE Connector is the Storage Scanner that collects data from Storage Essentials (SE) about SAN elements and inventory, and their connectivity. These SAN elements include storage arrays, fabrics, switches, and NAS filers.

The frequency of collecting this storage data is configured by the user. By default, SE Connector collects SAN information from SE once every 12 hours. This action is commonly known as *a scheduled full synchronization*. You can adjust the collection frequency by modifying a setting in SE. In SE Connector, you can specify the maximum wait time (in minutes) for a scheduled full synchronization when the Get All Elements Details (GAED) process in SE is in progress. The following property specifies the maximum default wait time for a scheduled full synchronization task when GAED is in progress:

```
com.creeppath.agent.common.devices.scheduled.full.sync.max.wait.minutes=10080
```

SE Connector will check SE every 3 minutes (by default) and will run the collection if the SE GAED process finishes sooner or if SE Connector has waited longer than the specified interval.



SE Connector can communicate with multiple Storage Essentials instances. For scalability and performance reasons, it is recommended that you have *multiple* SE Connectors communicating to *one* instance of Storage Essentials; however, each Access Control must be configured to collect a unique set of devices from the same Storage Essentials instance. You can also have *multiple* SE Connectors communicating with *multiple* instances Storage Essentials.

Since, by default, storage information is collected from SE once every 12 hours, you might need updated data more frequently than twice a day. You can modify this data collection frequency by modifying a setting in SE. See the *Storage Essentials SRM Software User Guide* for information about configuring the schedule for data collection. You can also request an update of SAN information from SE at the storage device level, such as arrays and NetApp filers. See [Update from Storage Essentials](#) on page 88 for more information.

A “GAED IN PROGRESS” value in the Status column on the Storage Scanner Storage Essentials panel indicates that a Get All Elements Details (GAED) discovery process is currently running on the Storage Essentials server.

When Storage Essentials is processing GAED, by default SE Connector will wait 10080 minutes (7days) before it will proceed to collect data from Storage Essentials, even though a GAED discovery process is still running. SE Connector will check SE every 3 minutes (by default) and will run the collection if the SE GAED process finishes sooner or the SE Connector has waited longer than the interval configured for “Full Data Collection Minutes” in SEPlugin.Properties.

Check the Storage Essentials (connection) Status to determine whether the GAED process is still running. Check the Last Scan timestamp for Managed Elements for that Storage Essentials instance to determine when SE Connector last updated the information for those elements.

The following property specifies the maximum default wait time for a scheduled full data collection task when GAED is in progress:

```
com.creeppath.agent.common.devices.full.data.collection.minutes=720
```

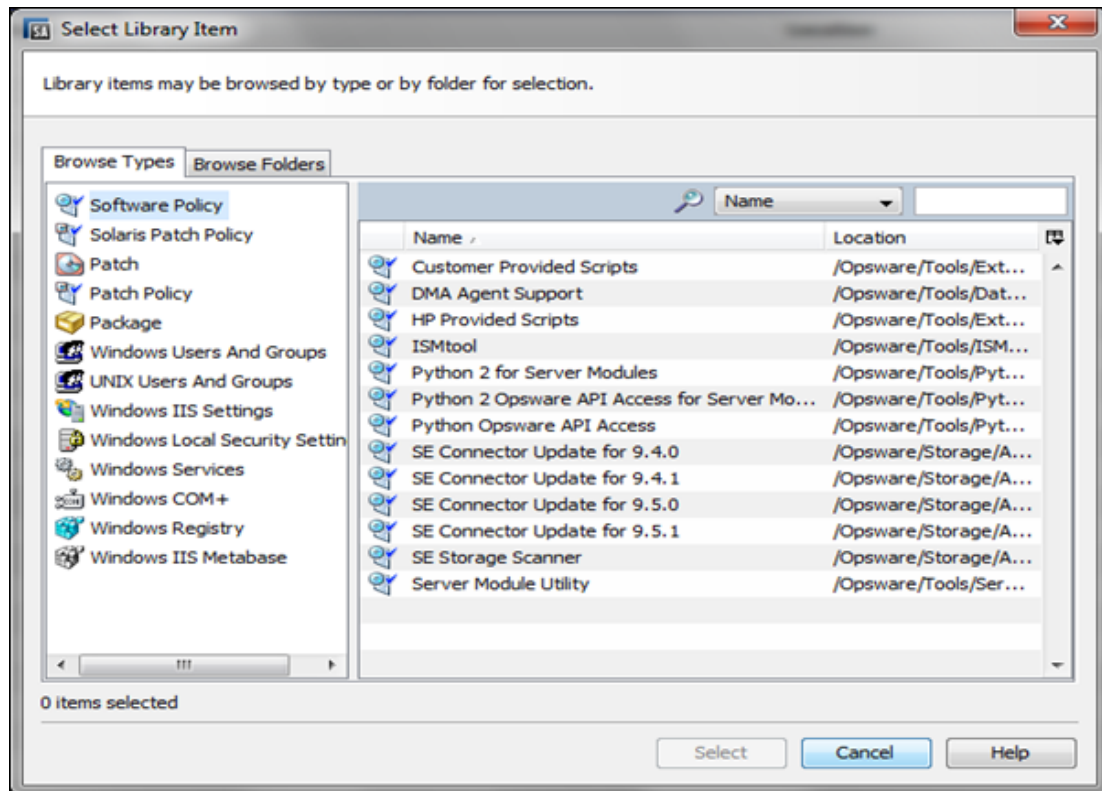
The following describes a typical use case:

- You configure SE Connector to collect information from Storage Essentials once a day.
- Storage Essentials is busy processing GAED for 2 days.

- You do not see updated information for Managed Elements for the Storage Essentials instance in Server Automation.
- You can use a combination of the Storage Essentials connection Status value and Last Scan timestamp for Managed Elements to determine if there is a lengthy GAED process running for SE and the SE Connector is not updating information for those Managed Elements. This explains why information for Managed Elements is not getting updated as per the scheduled frequency.

SE Connector Updates

This section discusses SE Connector updates.



SA 10.0 supports the following SE versions: SE 9.4.0, SE 9.4.1, SE 9.5.0 and SE 9.5.1.

► **Note:** The SA 10.0 release no longer supports SE 6.x for new managed servers. However, SA 6.x is still supported for existing managed servers.

Viewing the Storage Essentials Connection Status

This section discusses how to view the status of the connection to a Storage Essentials server managed by a Storage Scanner.

To view the status of the connection:

- 1 From the navigation pane, select **Administration > Storage Scanners**.
- 2 In the content pane, select an SE Storage Scanner and then open its browser.

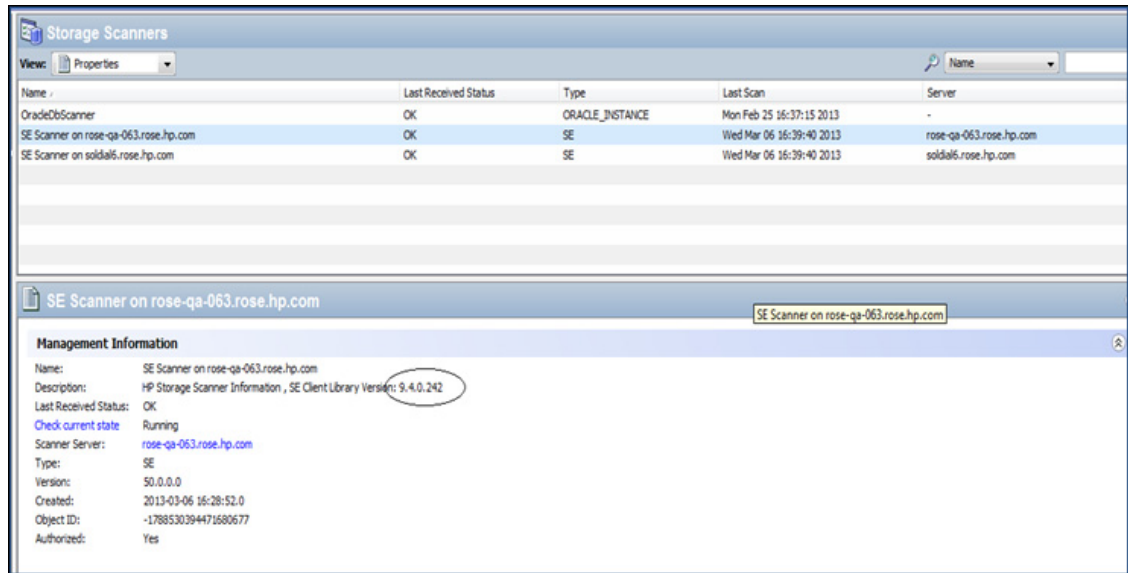

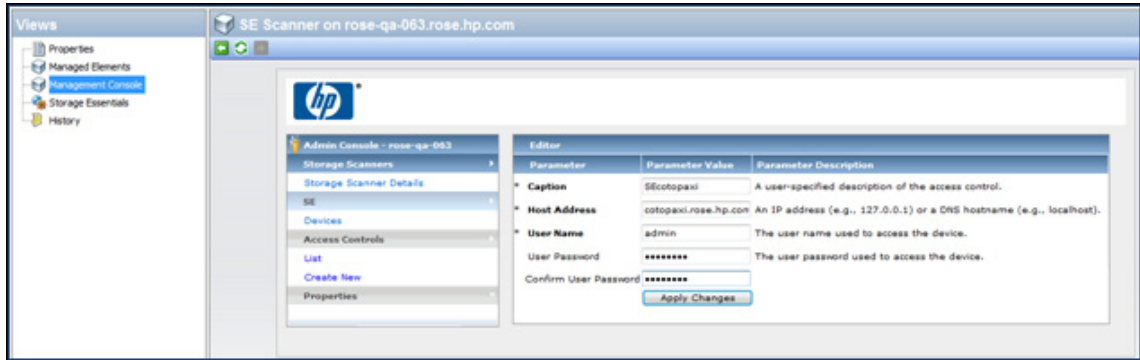

Update from Storage Essentials



You must have the required SA user permissions to request an “Update from Storage Essentials”. See the section on SA permissions in the *SA Administrators Guide*.

“Update from Storage Essentials” is an option in the Actions menu that requests an update of storage information about an individual storage device, such as a SAN array or NetApp filer. SE Connector provides this synchronization of data for a storage system when you request an update at the device level.

SE Connector does not directly communicate with a storage device to collect data about it. SE Connector collects data about an individual storage device from Storage Essentials. This request copies data from the SE repository into the Model Repository.

You can specify the maximum wait time (in minutes) for the “Update from Storage Essentials” action in SE Connector while SE performs GAED for certain storage elements. The following property specifies the maximum default wait time for the “Update From Storage Essentials” action when GAED is in progress:

```
com.creeppath.agent.common.devices.manual.full.sync.max.wait.minutes=10080
```

The Jobs and Sessions user interface displays the status of the update request. A “Success” status indicates that the Model Repository has been updated. The timestamp for the job also provides the following information about the “Update from Storage Essentials” request:

- When the request was made
- What the status of the update job is, such as:
 - **Succeeded**—Request was submitted successfully. SE Connector collected the data for the requested device and sent it to the Web Services Data Access Engine.
 - **Error**—Request could not be submitted. Verify that the SE Connector is running and start it if it is stopped. If there is still a problem, check the SE Connector logs on the managed server to troubleshoot this error. Begin with the `pam-0-0.trace` log file and then check other trace files.

Open with Storage Essentials (Click & Launch)

“Open with Storage Essentials” is an option in the Actions menu that launches Storage Essentials for an individual storage device, such as a SAN array or NetApp filer. You can also launch Storage Essentials for a device by selecting it and then by right-clicking—this is commonly referred to as the *Click & Launch* user interface.

SE Connector supports Click & Launch for storage devices that are managed by Storage Essentials standalone configuration. This option is not supported with Storage Essentials integrated with HP Systems Insight Manager.

Click & Launch requires an SE account login. When you select other storage objects and then Click & Launch from them (while in the same session), the initial SE login will persist. There is no single sign-on capability for HP Server Automation and Storage Essentials.

You can launch SE only from a storage device. You cannot launch SE from a host.

Appendix A: Global File System (OGFS)

Overview of OGFS

The Global File System (OGFS) feature shows storage inventory in a file system-like presentation. The OGFS feature in Storage Visibility and Automation is integrated with the OGFS feature in the SA Client. To use the OGFS feature, you must be familiar with its basic capabilities in the SA Client. See the *SA User Guide: Server Automation* for more information.

The OGFS represents the data model as a hierarchical structure of file directories and text files. For example, in the OGFS, the `/opsw/Server` directory contains information about managed servers and includes subdirectories that represent the contents of the managed servers, such as storage, ports, and disks.

Global Shell

The Global Shell is a command-line interface to the OGFS. This command-line interface is a Unix shell, such as bash, that runs in a terminal window. The default shell in Global Shell is bash.

The OGFS unifies the data model and the contents of storage devices and managed servers, including files, into a single, virtual file system. You open a Global Shell session from within a SA Client or from a direct ssh connection in a terminal client on your desktop. With the Global Shell, you can automate repetitive system administration tasks by running scripts across multiple storage devices and servers in a secure environment. Common scripting languages, such as Perl and Python, are supported.

The OGFS represents the data model as a hierarchical structure of file directories and text files. For example, in the OGFS, the `/opsw/Server/@/e-commerce.example.com/Storage` directory contains details about storage dependencies for the server named `e-commerce.example.com`.

Permissions

The actions that you can perform within the Global Shell are determined by the operations specified by the `aaa` utility. The `aaa` utility grants and revokes permissions for operations that use the OGFS. For example, the `aaa` utility grants permission for the `readServerFilesystem` operation, which allows you to browse a server's file system in the SA Client. To run the `aaa` utility, you must belong to the Administrators user group. The permissions granted and revoked by the `aaa` utility are stored in the `/opsw/Permissions` directory of the OGFS. See the *SA User Guide: Server Automation* for information about how to use the `aaa` utility.



You must have permissions in the Global Shell to view the file systems for storage inventory.

Storage Directory in the OGFS

The following sections describe subdirectories that contain storage content. The directory layout is designed to reflect the natural locations of storage objects, with the intent to facilitate intuitive navigation by OGFS users.

The primary storage directory roots are `/opsw/Storage`, which contains all storage system and storage network content and `/opsw/Server/.../Storage`, which contains storage objects specific to their respective servers.

Additional storage directory trees are provided to scope the content contained within `/opsw/Storage`. Examples include the `/opsw/Customer/.../Storage` directories, which contain storage resources that are assigned to customers, and the `/opsw/Facility/.../Storage` directories, which contain storage resources that are associated with facilities.

Although storage trees exist in multiple scoped locations, each and every object has a single location at which it can be reliably located in the OGFS. These locations are collectively referred to as *canonical locations*. Within each storage directory tree, symbolic links (symlinks) are used to traverse storage topology and reference storage information located in canonical directory paths.

The canonical location for a volume of a server is in the following directory:

```
/opsw/Server/.../Storage/Volume
```

In the following example, the `Volume` directory contains content pertaining to a `raid0` volume on the server:

```
/opsw/Server/@/myserver.opsware.com/Storage/Volume/raid0
```

If a file system is mounted on that volume, this is reflected in the OGFS as a symbolic link to the volume, which is located in its canonical location:

```

```
