Term	Definition

It also means a physical device that runs a client-based hypervisor for client side Virtual Machines running a client class operating system. It does not include a client class computer system, such as a desktop or laptop PC, running a server class operating system.
Device or Dev	means an addressable entity, physical or virtual, including but not limited to router, switch, bridge, hub, server, PC, laptops, handheld device or printer that resides within the range defined for interrogation and asset tracking.
