## Product use authorizations

This document provides Additional License Authorizations for Perfecto Mobile Fully Managed for HP Unified Functional Testing software, distributed by HP.

## Definitions

Capitalized terms not otherwise defined in this Additional License Authorizations document are defined in the governing agreement.

<b>Term</b>	<b>Definition</b>
<i>Cradle</i>	means proprietary hosting devices developed by Perfecto Mobile, Inc. capable of interfacing between you and the mobile phones.
<i>Concurrent User</i> or <i>CC User</i>	means the software is licensed by the amount of users that simultaneously use the software at any one point in time. The software can be installed on any number of computers, provided that the actual usage of the software does not exceed the number of licenses purchased.
<i>E-LTU</i> and <i>E-Media</i>	means products which are electronically delivered only, and as such any reference to FOB Destination or delivery methods that are stated on your purchase order other than electronic shall be null and void with respect to these E-LTU or E-Media products.
<i>Internal Use</i>	means access and Use of the software for purposes of supporting your internal operations or functions.
<i>LTU</i>	means License To Use.
<i>Term License to Use</i> or <i>Term LTU</i>	means a software license to use (LTU) which indicates in its license description that the license is valid for a specific period of time such as One Month (1M), One Year (1Y) etc. Term LTU's are not perpetual licenses.
<i>Term Support</i>	means a fixed period support offering that is only valid during the time period of the associated Term LTU.
<i>Use</i>	means to install, store, load, execute and display one copy of the software.



## Software specific license terms

Software products covered by this additional license authorization (as listed on the first page under Product use authorizations) and not covered in this section do not have software specific license terms.

### Perfecto Mobile Fully Managed for HP Unified Functional Testing

Perfecto Mobile Fully Managed software is licensed by Cradle or by pack of 4 Cradles which can only be installed in Perfecto Mobile Inc's mobile device environment. Each Cradle is licensed per Concurrent User. This software can only be used in conjunction with the HP Unified Functional Testing Mobile Service or accessing the 200 hours of Perfecto Mobile's public cloud that are included as part of the software .
