- Health status of the discovered Data Protector objects
- Automatic and user-triggered actions on the Data Protector objects
- Data Protector events view
- Alarms triggered according to the user-defined thresholds

Installation Problems

Agent installation fails with the Access denied error

Installation of the Data Protector MP agent on the Data Protector Cell Manager fails with the Access denied error, because the signature verification server may be unavailable at the time of installation.

Solution:

Perform the following steps on the Data Protector Cell Manager:

1. Disable signature verification on the Data Protector Cell Manager by creating the MPDPMonitorSvc.exe.config file in the [%ProgramFiles%\Hewlett-Packard\Data Protector MP Agent](#) directory. The content of the new configuration file should be as follows:

  <runtime>
    <generatePublisherEvidence enabled="false"/>
  </runtime>
</configuration>
```

2. Use the Windows Start menu to navigate to **Control Panel > Administrative Tools > Services**. In the Services window, locate the Hewlett-Packard MPDP Agent service and start it.
