



# HP Select Federation Version 6.5 Obsolescence Announcement Frequently Asked Questions

On October 1, 2007, HP announced the version obsolescence of HP Select Federation Version 6.5. This document provides you with answers to frequently asked questions regarding this announcement.

## Product related questions

**Question** When is HP discontinuing this Select Federation Version 6.5 product?

**Answer** Effective October 1, 2007, HP is discontinuing the HP Select Federation Version 6.5. Current customers may continue to purchase additional copies of the Select Federation version 6.5 product through January 1, 2008. As of this date, the product will be removed from HP's Corporate Price List and will no longer be orderable.

**Question** Why is HP discontinuing this Select Federation Version 6.5 product?

**Answer** This is in accordance with the HP Software Support and Obsolescence policy version 4.2. [Definitions of terms](#) are documented in the HP Software product version obsolescence guidelines.

**Question** When is the last date I can order Select Federation Version 6.5?

**Answer** Select Federation Version 6.5 will continue to be available for purchase to current customers through January 1, 2008. As of this date, the product will be removed from HP's Corporate Price List and will no longer be orderable.

**Question** Can I still purchase additional licenses for Select Federation Version 6.5 that is no longer covered by full support or maintenance support? If yes, how?

**Answer** No additional licenses can be purchased after January 1, 2008. Once support has ended, additional licenses are only available for purchase by selected Select Federation customers and partners.

**Question** What product numbers are affected by this version maturity?

**Question** What are the hardware requirements to upgrade to Select Federation version 7.0?

**Answer** Hardware requirements will vary depending on your operating system, please review the appropriate Release Notes, Installation Guide, and/or Migration Guide or otherwise contact your local HP sales representative or HP software business partner for further assistance.

**Question** Where can I find upgrade information for the Select Federation Version 6.5 product?

**Answer** Your local HP sales representative or HP software business partner can help you get this information, alternatively please see the Customer Letter for further details.

**Question** I received this communication but I have already upgraded Select Federation Version 6.5 to Select Federation Version 7.0 Do I need to do anything?

**Answer** Some or all of your support contracts might not have been updated to reflect your upgrade to Select Federation 6.5. Please get in touch with your local HP contract administration representative or your HP Software Services Integrator partner to have your support contracts updated.

### Support contract related questions

**Question** What is the end of support date?

**Answer** The End of Support date is March 31, 2009. As of this date all customer support activities will cease, this includes:

- Telephone support
- Security Rule updates
- Product upgrades

**Question** Are there any other key dates I need to be aware of?

**Answer** Please see Customer Letter Page 1.

**Question** What are my discontinuance options?

**Answer** Customers have the option to continue using Select Federation 6.5. HP will stop providing Support for this version of Select Federation 6.5 on March 31, 2009. Customers are encouraged to begin reviewing their business requirements for Business Process Insight. Customers are also encouraged to contact their local HP sales representative or HP software business partner for help in determining migration options that meet your business needs.

**Question** Can I get a support contract for technical support only, without having to pay for upgrades?

**Answer** No, support contracts include both technical support and software updates.

**Question** Should there be a defect with a version of Select Federation for which no defect fixing is done anymore, can I pay for a fix to be implemented on my request?

**Answer** HP may choose to offer defect fixes at a premium price, depending on available resources.

**Question** If I am on a support contract, what will I be entitled to?

**Answer** You should have received a letter or electronic notification from HP to inform you about the availability of Select Federation Version 6.5 for support customers, what license(s) you were entitled to under your support contract and how to sign up for it. Your local HP sales and support representatives or your HP software business partner can help provide information and assistance to enable your upgrade to be easy and successful.

**Question** When I upgrade from Select Federation Version 6.5 to Select Federation Version 7.0, can I continue my existing support contracts until they expire?

**Answer** Yes, but your support contracts need to be updated as well. Please contact your local HP contract administration representative or HP Software Services Integrator (SVI) partner to get your support contract updated accordingly.

**Question** When I upgrade from Select Federation Version 6.5 to Select Federation Version 7.0, can I expect the same support pricing compared to Select Federation Version

6.5?

Question What migration services are available to help me upgrade?

Answer Customers using Select Federation 6.5 can directly migrate to Select Federation 7.0. Please contact your local HP Software sales representative for assistance in planning the right migration plan for you.
