## Definitions

Capitalized terms not otherwise defined in this ALA document are defined in the governing agreement.

Term	Definition
<i>Application Under Test or AUT</i>	means a software application being tested by software.
<i>Concurrent Test or CC Test</i>	means the number of individual, simultaneous tests that can be run at any point in time.
<i>Concurrent User or CC User</i>	means the software is licensed by the amount of users that simultaneously use the software at any one point in time. The software can be installed on any number of computers, provided that the actual usage of the software does not exceed the number of licenses purchased.
<i>Device or Dev</i>	means an addressable entity, physical or virtual, including but not limited to router, switch, bridge, hub, server, PC, laptop, handheld device or printer that resides within the range defined for interrogation and asset tracking.
<i>E-LTU and E-Media</i>	means products which are electronically delivered only, and as such any references to FOB Destination or delivery methods that are stated on your purchase order other than electronic shall be null and void with respect to these E-LTU or E-Media products.
<i>Floating Instance or Fltg Ins</i>	means an Instance for a Virtual Machine that is not node-locked.
<i>Instance</i>	is defined as each implementation of the application installed on a server.
<i>Internal Use</i>	means access and Use of the software for purposes of supporting your internal operations or functions.



<b>Term</b>	<b>Definition</b>
<i>Load Generator</i>	means a device with the HP LoadRunner or HP Performance Center Load Generator software installed that is used to generate multiple simultaneous Virtual User connections against an Application Under Test.
<i>LTU</i>	means License To Use.
<i>Node Locked Instance</i>	means an Instance which can only be used with a specific node.
<i>Seat User or Seat</i>	means only one device or user is authorized to Use the software at a time.
<i>Server Instance</i>	means an installation of software on only one physical or Virtual Machine at a time.
<i>Suite</i>	means two or more software products combined into a single license offering or a single software product which includes two or more licenses . The specific software products included in a Suite are specified in the software specific license terms below. Software products included in a Suite are governed by the individual authorizations and use restrictions associated with each software product, except where specified in the specific Suite software specific license terms below.
<i>Term License to Use or Term LTU</i>	means a software License To Use (LTU) which indicates in its license description that the license is valid for a specific period of time such as One Month( 1M) , One Year(1Y) etc. Term LTU's are not perpetual licenses.
<i>Term Support</i>	means a fixed period support offering that is only valid during the time period of the associated Term LTU.
<i>Use</i>	means to install, store, load, execute and display once copy of the software.
<i>Virtual Machine(s) or VM(s)</i>	means a computer that does not physically exist but is simulated by another computer.
<i>Virtual User or VU or Vuser</i>	means a software process emulating users executing a Use case interaction against an AUT.

## Software specific license terms

For software products with software specific license terms, these terms are described below. Software products covered by this ALA document (as listed above) and not covered in this section do not have software specific license terms.

### **HP Network Virtualization for HP Loadrunner, HP Network Virtualization for HP Performance Center and HP Network Virtualization for Mobile**

HP Network Virtualization for HP LoadRunner is licensed per Load Generator or per Virtual User and may only be used with HP LoadRunner for the purpose of performance testing and may only be used with the HP software for which it was originally licensed.

HP Network Virtualization for HP Performance Center is licensed per Load Generator or per Virtual User and may only be used with HP Performance Center for the purpose of performance testing and may only be used with the HP software for which it was originally licensed.

HP Network Virtualization for Mobile is licensed by

1. Concurrent Test and Node Locked Instance, or
2. Floating Instance and Concurrent Test.

HP Network Virtualization for Mobile may only be used for the purpose of application development and testing.

## HP Service Virtualization Express Edition, HP Service Virtualization Premium Edition

HP Service Virtualization Express Edition and HP Service Virtualization Premium Edition \*previously called HP Service Virtualization) both consist of two components: Designer and Server. For HP Service Virtualization Express Edition, Designer is licensed per Seat User; for HP Service Virtualization Premium Edition, Designer is licensed per Seat User and per Concurrent User. Server is licensed per Server Instance. Designer and Server may be installed on any physical or Virtual Machine. Designer contains an embedded version of the Server that is limited in Use for design and validation of virtual services within the same desktop environment. Functional and performance tests outside of Designer desktop may be run only against the virtual service deployed in the Server Instance. HP is not liable for any consequences and or damages resulting from use of the software to perform any functions for which it was not originally licensed. The HP Service Virtualization demonstration tutorial software included with HP Service Virtualization may be used only for demonstration purposes.
