## Definitions

Capitalized terms not otherwise defined in this ALA document are defined in the governing agreement.

Term	Definition
<i>Concurrent Access</i>	means simultaneous use of one Device at any point in time.
<i>Cradle</i>	means proprietary hosting devices developed by Perfecto Mobile, Inc. capable of interfacing between you and the mobile phones.
<i>Concurrent User or CC User</i>	means the software is licensed by the amount of users that simultaneously use the software at any one point in time. The software can be installed on any number of computers, provided that the actual usage of the software does not exceed the number of licenses purchased.
<i>Device of DEV</i>	means an addressable entity, physical or virtual, including but not limited to router, switch, bridge, hub, server, PC, laptop, handheld device or printer that resides within the range defined for interrogation and asset tracking.
<i>Mobile Device or Mbl Dev</i>	means a Device running an operating system designed for mobile devices such as but not limited to mobile phones, tablet computers and smart phones that typically connect to a network by means of Wi-Fi or cellular data.
<i>E-LTU and E-Media</i>	means products which are electronically delivered only, and as such any reference to FOB Destination or delivery methods that are stated on your purchase order other than electronic shall be null and void with respect to these E-LTU or E-Media products.
<i>LTU</i>	means License To Use.
<i>Suite</i>	means two or more software products combined into a single license offering or a single software product which includes two or more licenses. The specific software products included in a Suite are specified in the software specific license terms below. Software products included in a Suite are governed by the individual authorizations and use restrictions associated with each software product, except where specified in the specific Suite software specific license terms below.



<b>Term</b>	<b>Definition</b>
<i>Term License to Use</i> or <i>Term LTU</i>	means a software license to use (LTU) which indicates in its license description that the license is valid for a specific period of time such as One Month (1M), One Year (1Y) etc. Term LTU's are not perpetual licenses.
<i>Term Support</i>	means a fixed period support offering that is only valid during the time period of the associated Term LTU.

## Software specific license terms

For software products with software specific license terms, these terms are described below. Software products covered by this ALA document (as listed above) and not covered in this section do not have software specific license terms.

### HP Mobile Center Add-On

HP Mobile Center Add-On is licensed by Concurrent Access for a Mobile Device and requires a license for HP Mobile Center Suite.

### Perfecto Mobile Fully Managed for HP Unified Functional Testing

Perfecto Mobile Fully Managed software is licensed by Cradle or by pack of 4 Cradles which can only be installed in Perfecto Mobile Inc's mobile device environment. Each Cradle is licensed per Concurrent User. This software can only be used in conjunction with the HP Unified Functional Testing Mobile Service or accessing the 200 hours of Perfecto Mobile's public cloud that are included as part of the software. For Term LTU's, two hundred hours are available for each year of the Term LTU. Unused hours will not accumulate toward use in a subsequent year.

### Perfecto Mobile Mobile Cloud Express for HP Unified Functional Testing

Perfecto Mobile Mobile Cloud Express software is licensed by 2 Cradles which can only be installed in Perfecto Mobile Inc's mobile device environment. Each Cradle is licensed per Concurrent User. This software can only be used in conjunction with the Perfecto Mobile Mobile Cloud Express for HP Unified Functional Testing Service. Ten hours of Perfecto Mobile's public cloud are included as part of the software and are available for each year of the Term LTU. Unused hours will not accumulate toward use in a subsequent year.
