Network Requirements

When the NA core server and the NA database server are different systems, the following requirements apply:

- The servers should be in the same data center.
- The connection between the servers should be at least 1 Gb/s Fast Ethernet, full duplex.
- The speed of the network interface cards (NICs) on the NA core server must be at least 1 Gb/s.

Port Utilization

NA communicates with devices using a combination of protocols and ports. If you use a given protocol, NA requires access to the corresponding port. Specifically, if NA communicates with devices protected by firewalls, these ports must be open, or you must use an alternative means of communication, such as an NA Satellite server. For information about allocating ports, see "Ports" in the NA Administration *Guide*.

Note: To switch the locale of an English Windows Server platform to Asian languages, the doublebyte character set (DBCS) support must first be installed.

NA accepts a local language in the following places:

- Comment fields
- Description fields
- Custom data labels
- Custom data fields
- Most name and text fields, such as device location and vendor

You can search on single and multi-byte character sets, as long as the field being searched accepts them. You can also import and export configuration policies that contain single and multi-byte character sets.

Note: On Windows systems, NA does not support installation using directory paths with localized characters. The path name for the NA installation directory can contain English characters only.

Before using Internet Explorer to access the NA console on an NA core that is configured to support an Asian Language, install the East Asian Language as follows:

- 1. In the Control Panel, select **Regional and Language Options**.
- 2. On the Languages tab, select Install files for East Asian Languages, and then follow the instructions.

Oracle Localization Considerations

NA supports UTF-8 non-English Oracle locales.

When using NA globalization support with Oracle, specify the appropriate database character set when creating a new Oracle database. In addition, if the language you select is double-byte encoded, for example Chinese, Korean, or Japanese, you might also want to set the NLS_LENGTH_SEMANTICS initialization parameter to CHAR, so that one double-byte character set (DBCS) character is counted as "one" instead of "two."

SQL Server Localization Considerations

During NA installation, you are prompted to select a collation type for configuring a new SQL Server database.

SQL Server collation dictates the character set that is stored in the database. For example, if you select a Chinese collation, you can only enter Chinese characters, not Japanese, Korean, and so on. You can always enter Latin characters regardless of the collation type.

For SQL Server, NA supports the following collations:

- Chinese_PRC_CI_AS
- Cyrillic_General_CI_AS
- Japanese_CI_AS
- Korean_Wansung_CI_AS
- SQL_Latin1_ General_Cp1_CI_AS

MySQL Localization Considerations

NA in any of the localized languages is supported with MySQL for an English language MySQL database server only. The use of a non-English MySQL database server installation is not supported.

Summary Report Generation

The following error indicates that NA does not correctly interpret the date format of the NA core server:

The Generate Summary Reports tasks fail with : There was a problem generating the Summary Reports: javax.ejb.EJBException: RuntimeException

When this error occurs, the jboss_wrapper.log file contains the following error:

Caused by: java.sql.SQLException: ORA-01843: invalid month

(The string invalid month is written in the localized language.)

In response to this error, configure NA with the date format that the NA core server is using. Follow these steps:

1. Determine the system date format on the NA core server.

(On Windows operating systems, use the Short Date on the Formats tab of the Region and Language control panel.)

- 2. Change to the directory that contains the .rcx files:
 - *Windows*: <NA_HOME>\jre
 - *Linux*: <NA_HOME>/jre
- 3. Back up the reporting.rcx file to a location outside the <NA_HOME> directory.
- 4. In a text editor such as WordPad or vi, open the reporting.rcx file.
- 5. Search for the string TO_CHAR to locate the following lines:

6. Within the identified lines, change each instance of the date format to match the system date format of the NA server. (Change two instances of MM/DD/YYYY and two instances of dd-mon-yyyyy.)

For example, if the system date format is yyyy/MM/dd, update this section to read:

- 7. Reload the .rcx settings by doing *one* of the following:
 - Run the reload server options command from the NA proxy.
 - On the User Interface page (Admin > Administrative Settings > User Interface) of the NA console, click Save.
 - Restart the NA management engine.

Note: Upgrading NA might overwrite the reporting.rcx file. Be prepared to replicate this configuration change after every upgrade.

Entering Non-English Text into the Device Selector from Firefox

If you are using Firefox, you cannot use the Input Method Editor (IME) to enter non-English text into the Device Selector.

Workaround: Enter non-English text into a text editor, and then paste the contents from the text editor into the Device Selector.

Multi-Task Projects Setup

For multi-task projects, if a sub-task completes with a Warning status, you can continue to run subsequent sub-tasks or cancel all of the remaining sub-tasks. This feature enables you to cancel tasks that are running against a device that could be experiencing issues.

To enable this feature:

- 1. On the Admin menu, click Custom Data Setup.
- 2. On the Custom Data Setup page, select Tasks from the Custom Data Setup list.

- 3. Under Tasks, locate the 6th API Name group. For this group, do the following:
 - a. Select the API Name check box.
 - b. In the **API Name** box, enter:

subtask_control

Note: subtask_control must be entered in English.

c. In the **Display Name** box, enter:

Cancel remaining tasks that have warning messages

d. For Values, select the Limit to: check box, and then enter:

Yes, No

Note: Yes, No must be entered in English.

4. Click Save.

If this feature is enabled, when you create sub-tasks for multi-task projects, the following field appears under the Comments field on all multi-task sub-task pages:

Cancel remaining tasks that have warning messages

This field includes the following options:

- Blank— The remaining sub-tasks continue to run.
- Yes— The remaining sub-tasks are canceled.
- No— The remaining sub-tasks continue to run.

QCCR1B98842: Some garbage characters in the Search Results CSV file of a report

NA saves search results as a CSV file encoded in UTF-8. Microsoft Office Excel does not correctly display some non-English characters in the CSV file.

Workaround: Open the CSV files in a text editor that can read UTF-8.

Supported Virtual Servers for NA10.00

If you are running NA in a virtual environment, review the follow guidelines:

- Ensure that the NA environment meets the requirements detailed in "Network Requirements" on page 16.
- Because NA can be network intensive, many virtual machines sharing a virtual switch and network interface card could result in unexpected behavior, including time-outs and failed tasks.
- Each virtual environment is different and could function differently under loads with shared VM guests.

- On a virtual server, it is recommended that the disk I/O be split. The virtual server must have two arrays:
 - One array for the host operating system
 - One array for the virtual machines
- If you plan to use virtual machines for both the NA core server and the database server, ensure that they are running on different guests. It is recommended to host the database virtual machine on a different array to avoid conflicting I/O on the array. Verify that the database is supported in a virtual environment.
- With ESX and an NA database running on Oracle, the maximum number of active NA cores in a Horizontal Scalability environment is five.
- When configuring NA on virtual machines in a Multimaster Distributed System environment, the maximum number of NA cores is two.
- Some virtual guests time drift, which can be an issue and should be corrected. Synchronizing the guests to an external time source can solve this issue.
- Each NA core server guest system must be configured with a set reservation for the CPU and memory requirements described in "CPU, RAM, Swap Space, and Disk Space Recommendations" on page 30.
 - Configure the set reservation as the minimum requirements for the NA core server guest system.
 - Ensure that the resource pool containing the NA core server guest system has adequate resources to consistently deliver the CPU and memory reservations to the NA core server guest system.

Performance Issues

To counter performance issues while running NA in a virtual environment, do the following:

- Increase hardware resources on the physical host.
- Ensure that resources are dedicated to the NA core server guest system.
- Decrease the number of guests running simultaneously.
- Add a network interface card dedicated to NA to the virtual server.

Tip: After any configuration change to the NA core server guest system, restart all NA services.

A large number of concurrent tasks increases NA resource demand. If performance issues arise, reduce the number of concurrent tasks or provide more resources to the NA virtual server. (This suggestion also applies to physical servers.)

Troubleshooting and Support

HP Support will endeavor to support NA in a virtual environment, and HP does not require customers to recreate and troubleshoot every product issue in a non-virtual environment. However, HP reserves the right to request that customers diagnose certain issues in a native, certified operating system environment without the virtual image. HP only makes this request when there is strong indication to believe that the virtual environment is a contributing factor to the issue.

All tests were run with the NA core servers and database servers in the same physical location, resulting in near zero latency. Large scale tests were run with the NA core servers on both physical and virtual hardware using ESX.

File System Layout

This topic describes the NA file system layout.

- Most of the NA core files are installed into the <NA_HOME> directory. This folder size grows as you add device software images to NA and as NA collects log data. The default location of the <NA_HOME> directory is as follows:
 - Windows: C:\NA
 - Linux: /opt/NA
- NA installs a few small files across the operating system. These files do not grow over time, so they do not impact sizing requirements.
- The embedded database is installed into the /opt/MySQL directory. This folder size grows with NA data and MySQL logs.

Approximating Database Size (MySQL only)

For MySQL, the size of the NA database can be approximated as follows:

2 * (average device configuration size) * (number of configuration records)

The average device configuration size must be determined specifically for the managed devices in your network.

The number of configuration records can be estimated by using one of the following approaches:

• The average number of device configurations changed every day multiplied by the number of days in the data retention period:

(average device configuration changes per day) * (days in retention period)

For example, for a network with 3000 devices, five percent of which are updated daily, and a one year retention period, the expected number of configuration records is 54,750. The calculation is as follows:

(5% * 3000) * 365 = 54,750

• The number of devices multiplied by the average number of device configuration changes during the data retention period:

(number of devices) * (average device configuration changes for the retention period)

For example, for a network with 3000 devices, each of which is updated once every three weeks, and a one year (52 week) retention period, the expected number of configuration records is 52,000. The calculation is as follows:

3000 * (52/3) = 52,000
