Introduction

This document provides an overview of the HP Operations Orchestration 10.51 release. It contains important information not included in the manuals or in the online help.

About HP OO

HP Operations Orchestration (**HP OO**) is the industry-leading solution for IT process automation and runbook automation.

HP OO is a system for creating and using actions in structured sequences (called flows) which maintain, troubleshoot, repair, and provision your Information Technology (IT) resources by:

- Checking the health of, diagnosing, and repairing, networks, servers, services, software applications, and individual workstations.
- Deploying applications, patching, and maintaining them by checking client, server, and virtual machines for required software and updates, and, if needed, performing the necessary installations, updates, and distributions.
- Performing repetitive tasks, such as checking status on internal or external web site pages.

For more information about basic HP OO concepts, see the *HP OO Concepts Guide*.

Important notes

Upgrades are cumulative, and include the features included in previous versions of 10.x. Therefore, the upgrade path is from your current version to 10.51.

Note also, that the rollback process (which rolls back an installation to the previous version) can only remove the latest patch that you installed. This means that if you installed 10.00 and then upgraded to 10.10, and then to 10.51, you will only be able to roll back to 10.10.

Caution: Running the rollback twice will not remove the two latest versions. Attempting to do so will make the system unusable.

Important Note: The 10.51 workspace format is not supported by 10.x Studio versions prior to 10.10. For best practices for rolling back from 10.51 to a previous version, see the "Rolling Back Studio" section in *The HP OO Installation, Upgrade, and Configuration Guide*.

Updated Support Matrix

Microsoft Internet Explorer 9.x is no longer supported.

Central Enhancements in HP OO 10.51

Timeout Mechanism

It is now possible to configure a timeout setting, so that if a flow run exceeds a specified duration, it will be canceled and will show the status **Canceled-Timeout Expired**. This helps protect the runtime environment from flows that are stuck in a **Running** state.

You can:

- Set a default timeout duration for all flows in the system, under **System Configuration > System Settings > General**.
- Set a custom timeout duration for specific flows under **Content Management > Flow Library**.

A custom timeout setting overrides the default timeout setting and is applied even if timeout is not enabled for the system.

There is now built-in filtering in the tables under the following tabs in Central:

- **Run Management > Scheduler**
- **System Configuration > Security > Roles**

In the filter boxes at the top of the columns, enter text to filter the display.

For the Scheduler, this replaces the **Filter by Flow Name** box. The schedules no longer span across multiple pages, so you can filter all the schedules at once.

Authoring Enhancements in HP OO 10.51

Duplicate UUIDs

In Studio, if there are items of the same type and subtype with duplicate UUIDs in a single project, in multiple projects (two or more), in multiple custom content packs or between content packs and projects, they appear in the project tree in red and are displayed in the **Problems** pane.

Note: The same type and sub-type means flows with flows, operations with operations, configuration items with configuration items of the same sub-type.

Items with duplicate UUIDs have the following characteristics:

- They are read-only, and you cannot move or rename them.
- They cannot be dragged to the canvas.
- You cannot move or rename the folders containing them.
- They are excluded from an exported content pack.
- You cannot debug flows containing duplicate UUIDs. You will get a validation error.
- You cannot use references. The "What uses this?" and "What does this use?" features are disabled.
- They cannot be committed. The folders and projects containing them can be committed, but you are prompted with an error messages informing you that you are about to commit items with duplicate UUIDs.

To resolve duplicate UUIDs, delete the item with the duplicate UUID and leave the original item.

Working with Multiple Workplaces

There may be cases in which you need to work with more than one workspace—for example, when working with source control.

You can work in SVN in one workspace, and then switch to another workspace to work in Git, without detaching from the SVN workspace and without losing any work you did in SVN, even if you have not yet committed the changes.

Using multiple workspaces in Studio allows you to easily save custom workspace-specific settings such as the proxy settings, debugger connections, the projects you are working on, and the content packs you use.

Additionally, you can work simultaneously on several completely distinct projects and switch between projects as necessary. In this way, you can organize your work more efficiently especially when projects are shared with other authors.

Note: Every workspace contains its own **logs** folder with its own log file.

To use a different workspace, select the new **Switch Workspace** item, under the **File** menu, and browse to the location that you want to use. Studio is automatically restarted using the new workspace.

Alphabetical Sorting of Projects

The list of projects is now automatically sorted alphabetically.

Database Enhancements in HP OO 10.51

The Oracle maintenance stored procedures package now contains a stored procedure for reclaiming LOB space: **hp_oo_db_maint.ForceLobShrink**.

Security Enhancements in HP OO 10.51

Configurable X-Frame-Options Response Header

It is now possible to configure how the **X-Frame-Options** response header is added to outgoing responses from HP OO.

This lets you configure whether or not a browser will be allowed to render a page in a `<frame>`, `<iframe>`, or `<object>`. You can use this to avoid clickjacking attacks, by ensuring that your content is not embedded into other sites.

Note: The default value for this configuration item is **SAMEORIGIN**, which means that only web pages containing iframes that come from the same URI as HP OO will be allowed.

```
set-sys-config --key xframe.options.mode --value SAMEORIGIN
```

If you are using HP OO embedded in a browser, you may need to disable this.

Group Mapping is Case-Sensitive

Group mapping is now case-sensitive. If you have two groups with similar names (for example, QG_Basic and qg_basic), which you assign to two different roles, a user logged in with one of these roles will not have access to the permissions of the other.

Enable HP OO to Read from the Subject Alternative Name Field in a Certificate

You can now enable HP OO to read from the Subject Alternative Name field in a certificate, using the new configuration item `x509.principal.lookup.field`.

This configuration item controls which certificate field is used to extract the username.

Verify that the LDAP Certificate is in the Central Truststore

By setting the property `trustAll.isEnabled` to **false** via OOSH, you can configure Central to verify that the LDAP certificate is in the Central TrustStore. When this configuration item is set to **true**, Central will trust any valid certificate from a secured LDAP server.

For example:

```
oosh> set-sys-config --key ldaps.trustAllCertificates.isEnabled --value false -  
-url <central_url> --user <central_user> --password <central_password>
```

In previous versions, when an administrator configured a secure connection to LDAP (under **Central > System Configuration > Security > LDAP**), this connection would accept any valid certificate from a secured LDAP server, even if it was not in the TrustStore.

What's New in Previous Releases of HP OO 10.x

New Features in HP OO 10.50

Installation/Upgrade Enhancements in HP OO 10.50

Trial License

When you install or upgrade to HP OO 10.50, it is installed with the HP OO **Enterprise Edition Trial** license. This is a temporary license that runs for 90 days. After the trial license is expired, you will need to purchase the HP OO Enterprise Edition license.

If you have purchased an HP OO license, you can install it under the new **License** tab, under **System Configuration > System Settings**. For more information, see "Setting Up Licensing" in the *HP OO Central User Guide*.

Password Strength

During installation, the HP OO Installer checks the strength of the passwords that are entered in the **Database Connection** step. If a password is weak, a warning is displayed in the Installer.

You will be able to proceed with the installation, but it is strongly recommended to replace the password with a strong password, in accordance with your company's security policy.

HTTPS-only Option in Installer

During the installation, the **Disable HTTP port (HTTPS only)** check box is selected by default. This means that, by default, all communications to and from Central will be over TLS (Transport Layer Security), and thus encrypted.

Clearing this check box will send sensitive data over an unsecured channel, and therefore is not recommended.

Content Upgrade Utility Updated

The Content Upgrade report generated by the Content Upgrade Utility contains the following changes:

- Under **Require Action > Referencing a missing item**, the last table column now includes the type of item that is missing.
- There is a new **Flows with multi-instance steps** section under **Warnings**. Multi-instance steps in HP OO 10.x are very different from those in HP OO 9.x, so it is highly recommended to check these after upgrading, even when they were upgraded successfully. For more information on upgrading 9.x flows containing multi-instance steps, see the documentation under the CUU folder (Converting Flows using Multi Instance Steps from OO 9.0x to OO 10.x Format).

SVN 1.8 Installed

During an installation of HP OO 10.50, SVN 1.8 is installed.

During an upgrade to HP OO 10.50, earlier versions of SVN are upgraded to version 1.8.

(Optional) In order to benefit from the enhancements offered with the SVN 1.8 server, it is recommended to manually upgrade your SVN server as well.

Note: If you roll back from HP OO 10.50 to an earlier version, you will need to manually delete the `.svn` folder in the **workspace** folder before rolling back, because HP OO 10.50 works with SVN 1.8 and earlier versions work with SVN 1.7. For more information, see the "Rolling Back Studio" section in the *HP OO Installation, Upgrade, and Configuration Guide*.

Environment Enhancements in HP OO 10.50

RASes Restarted After Recovery

The RAS is automatically restarted during recovery.

In previous versions, when a RAS worker failed, there was a cleanup process. The restart of the RAS replaces this cleanup process.

Updated Support Matrix

Ubuntu 14.04.x LTS has been added to the support matrix. This replaces Ubuntu 12.04.x LTS.

Nashorn JavaScript Support

Support for Nashorn JavaScript scriptlets has been added. This includes running and validating Nashorn scriptlets in Studio and running them in Central.

Oracle JDK Replaced with OpenJDK 8

HP OO 10.50 is delivered with OpenJDK (Zulu) 8 instead of Oracle JDK.

OpenJDK Zulu distribution does not comply with FIPS 140-2. Therefore, to configure HP OO for FIPS compliance, you will need to change to Oracle JDK manually by following the instructions in "Configuring HP OO for FIPS 140-2 Level 1 Compliance > Prerequisites" in the *Security and Hardening Guide*.

Authoring Enhancements in HP OO 10.50

GIT Source Control Management System

In Studio, you can now use Git as a Source Control Management (SCM) system as an alternative to Subversion.

The main Git operations in Studio are:

Repository Handling

- Commit changes
- Push changes to the remote Git repository
- Stash local changes
- Unstash stash commits
- Reset to tag
- Update local files with changes from the remote Git repository
- Resolve conflicts that occur during Update, Rebase or Stash operations in the Conflicts dialog box.

Branch Handling

- Create new branch
- Checkout existing branch
- Merge branch
- Rebase branch

To assist you to perform Git operations, new functionality was added to Studio:

- New Git operations in the SCM menus
- Git Repository Log, that allows authors to see a graphic representation of Git actions and easily see updates from the Git remote repository.
- Support for Git in the SCM Changes pane

New Multiple Studio Instances Functionality

Two different users can now open two separate instances of Studio in parallel on the same machine.

New Properties in Studio.properties File

The following new properties have been added to the **Studio.properties** file:

git.history.page.size=100	Refers to the default number of items in the Git history page.
git.history.changes.length=500	Refers to the default number of changes to show in each category.

New Dialog: Configuration > Options

A new dialog, **Configuration > Options**, has been added. This dialog allows you to set different configuration parameters directly in Studio without having to edit the **studio.properties** file manually.

New Option: Tools > Navigate to flow...

A new option, **Navigate to flow...**, is available in Studio. This option allows you to quickly find and open a flow in your workspace.

New Option: Tools > Navigate to item... option

A new option, **Navigate to item...**, is available in Studio. This option allows you to quickly find and open a configuration item in your workspace.

Jump to a flow step from the Run Tree

You can now jump directly to a step in the flow from the Debugger Run Tree in Studio.

Automatic CP Version Incrementing during Content Pack Creation for Unversioned Projects

When creating a content pack from an unversioned project in Studio, the last digit of the version number is now automatically incremented by 1.

Dependency Management

New functionality for managing dependencies has been added to Studio. This includes the following new features:

- **Manage dependencies in new Dependency Editor**

You can now manage dependencies from the Dependencies Editor. The dependency details are also included in a project's properties. From this pane, you can:

- Edit the name and version number of a dependency
- Add a new dependency using name and version
- Remove selected dependencies

- **Update dependencies from Projects and Problems panes**

You can now update dependencies from the Projects pane and from the Problems pane if an error related to dependencies occurs.

- **Validate range of Dependent Items**

The validation process now checks the range of dependent items of a project and also checks that the version of dependent projects match the project version.

- **Validate Project Dependencies Automatically**

New functionality, Dependency Validation, has been added. Dependency validation is triggered automatically:

- When the dependencies of a project are changed and saved
- When a project is updated from SCM either as individual project or as part of an **Update All** operation
- After a project is imported
- When a project is opened

New Content Pack Wizard

A new wizard has been added to allow you to easily create a content pack.

- You can now manage dependencies during the creation of a content pack in the Dependency Management step of the Content Pack Creation wizard.
- The SCM Synchronization page displays only if the project is not synchronized or changes were made to the project dependencies in the Dependency Management window. If not, you will see the Validation and Progress window after clicking Next.
- All the commit operations that were performed for the current branch are automatically pushed to the main Git repository before the content pack is created.

Validate Ranges of Dependent Items of a Project

The validation process now checks the range of dependent items of a project and also checks that the version of dependent projects match the project.

Sensitive Data

- New functionality for hiding output values has been added. If an operation contains sensitive data that you would like to hide from the end-user, you can define this at the step level using a new check box, **Sensitive Data**. You can also mark a result as sensitive data.
- Functionality for hiding input values has been improved. A new check box, **Sensitive Data**, has been added. When you mark an input as sensitive, the input value is now encrypted.
- Results contain output from the operation and additional information that you want to propagate. You can also mark a result as sensitive data.

Studio Process Files Moved to Home Directory

Several Studio process files have been moved to the user's home directory where all the projects and work data of the user are stored. This directory is generally **\$(user.home)/.oo**.

The following files have been moved:

Studio.log	The log4j Studio log file.
H2 db	The h2 database files for the local engine.

.lock	The file used to enforce a single instance of running Studio. This file prevents the user from starting multiple instances of Studio in the same working folder.
client.truststore	<p>Stores server certificates. When Studio starts, it copies the client.truststore file from the installation folder to the user's home directory. This copy is used to initialize SSL. If the file is deleted, it is not copied a second time, and a warning message is shown in the log.</p> <p>When you change the truststore password, add the client.truststore.password parameter in the studio.properties file (in obfuscated format).</p> <p>For example:</p> <pre>client.truststore.password={OBFUSCATED} 6L9+NqBjKYp5heuvMEzg0g==</pre>

Security Enhancements in HP OO 10.50

Default Roles Can Be Turned Off

In Central, in previous versions, the EVERYONE role was set as the default role by default. This could result in the administrator adding permissions to that role, without realizing that this affects all LDAP users, in addition to those are explicitly associated with the role.

In HP OO 10.50, the default is that there is no default role. This gives the administrator better control of user authorization, because users only get roles that are explicitly assigned either to them or to their LDAP group.

The **Set Default Role** button toggles between selecting a role as the default role and turning this off.

Logged-in User Credentials

It is now possible for an administrator to enable HP OO to capture the credentials of the logged-in user.

- When this option is **not enabled** (this is the default), the flow will prompt for a password at the relevant step.
- When this option is **enabled**:

- If a user starts or resumes a flow that includes logged-in credentials as an input parameter, the credentials of the logged-in user will be captured in the run context and memory (in encrypted form), and used during the flow run. This makes it possible to automate flow runs that require user credentials.

Note: The logged-in credentials that are captured are available to Central only in the context of this session. When the user logs out, the credentials are not saved in the database.

- When a user logs in to Central, a warning message appears, telling the user that their credentials might be captured and used in flows. When you are debugging remotely from Studio, the warning appears in the Remote Debugging login page.

The administrator can enable this option by selecting the **Enable the capture of logged-in user credentials** check box in the new **Security > Security Settings** tab in Central .

It is also possible to enable this option by using OOSH to set the value of the **record.loggedin.user.credentials** system property to **true**, as follows:

```
ssc --key capture.loggedin.user.credentials --value true
```

Domain Name Not Required for Default LDAP

When HP OO has multiple LDAP configurations, if the administrator flags one of these as default, users who belong to it will not be required to select a domain upon login.

Sensitive Data is Encrypted in Scriptlets

HP OO 10.50 secures sensitive data (for example, passwords) during the execution. If you marked a variable as sensitive in Studio, it will be retrieved in an encrypted form when being used in scriptlets. For manipulation on data that is marked as sensitive, it is recommended to use filters instead.

New Security Settings Tab

The **Security > Security Settings** tab in the System Configuration module contains the **Enable the capture of logged-in user credentials** check box.

In addition, the check boxes to enable auditing and authentication, and the security banner configuration have been moved to this tab.


Central Enhancements in HP OO 10.50

Digital Signatures on Content Packs

In Central, the Deploy New Content dialog box and the **Content Packs** tab now display information about digital signatures on content packs.

If a content pack contains a valid digital signature, this verifies that the content pack was created by a known authority and that it was not altered in transit. This helps protect from malicious content prior to deployment.

During the upload process, before deployment, HP OO verifies the signature, and the results are displayed in the Deploy New Content dialog box, next to each selected content pack.



- If a content pack is not signed, you can still deploy it.
- If a content pack is signed, but the signature is not from a known and trusted authority, you can still deploy it.
- If the results show that a signed content pack has been altered, that content pack cannot be deployed.
- If the signature has expired, you need to click the **Ignore expiry of digital signature certification** check box in order to deploy the content pack.

HP OO verifies the following common signature types: .DSA, .RSA, .EC, .SF

All out-of-the-box content packs created by HP are signed with the HP private key.

HP OO authors can add a digital signature to their customized content packs, using an external signing tool, such as Java JarSigner.

Content Pack Validation of Dependencies

During the upload process, before deployment, Central now checks whether the content pack has any dependencies. If you are deploying a content pack that uses elements (for example, operations or properties) that are in a different content pack, the content pack that you are deploying will have a dependencies file that points to this other content pack.

However, what happens if any of these items were deleted from the other content pack, and the new version of this content pack has been deployed in your environment? If this occurs, the content pack that you are now trying to deploy will have missing dependencies, and this could cause the deployment to fail.

If there are missing dependencies, Central displays a warning icon in the Deploy New Content dialog box and displays the expected version of the content pack that contained these dependencies. This gives you an opportunity to add the expected version of this content pack to the deployment, so that the deployment of the content pack that depends on it will be successful.

Validation of Elements During Deployment

During the deployment process, Central now performs a complete path validation for all elements that have a unique path on Central (such as flow, group alias, domain term, system property, system account, and selection list).

If there are any duplications of these elements (either within the deployment unit, or with previously deployed entities), an error message is displayed, listing the duplications.

Empty Content Packs are Displayed in the Content Packs Tab

All deployed content packs are displayed in the **Content Packs** tab, including empty content packs. In previous versions, empty content packs were not displayed.

For example, the HP OO Third Party content pack is empty, with only a **Lib** folder populated.

Note: During an upgrade from an earlier version of HP OO 10.x, all empty content packs are deleted. This helps align Central to your needs.

Note also that if the last deployment action prior to the upgrade was the deletion of a content pack, the rollback will not work.

Content Pack Statistics

It is now possible to view statistical information about the usage of deployed content packs. You can:

- See how many flows were run were using content from a selected content pack. You can see how many flows were run each month since first use. You can compare the number of runs from the selected content pack with the total runs (from all content packs) over the same period.
- See how this content pack usage fits into the percentage of all runs during the current month, previous month, quarter, half year, year, or in total.

On the right side of the **Content Packs** tab, next to the **Changes** tab, there is a new **Statistics** tab. This tab displays the usage statistics of the selected content pack.

In the **Content Packs** tab, there is a new **Statistics**  button in the toolbar. This is used to display and compare statistical information about all deployed content packs.

Source Control Information Displayed in Content Pack Details Pane

When you deploy a content pack that was created in Studio, the SCM tag for the content pack is now displayed in the Content Pack Details pane. This enables you to identify the source control version of the content pack after it has been deployed.

OOSH Enhancements

OOSH now supports redirecting output with ">" (and other similar methods). For example:

```
C:\oo\central\bin>oosh.bat lcp --url http://localhost:8080/oo --user admin > result.txt
```

```
Password: *****
```

```
C:\oo1\central\bin>
```

In this example, the command output is stored in **result.txt**.

Sensitive Data

New functionality for hiding output value has been added. If an operation contains sensitive data that the author wanted to hide from the end-user, and they defined the output as sensitive data, this output is retrieved in an encrypted form.

If you bind a sensitive output to an input that is not sensitive, the data will still be encrypted.

Display Workers Execution Status

The **Topology > Workers** tab in Central now displays information about the worker's status, such as if a worker is idle, working, or so busy with executions that it is unable to process all Central tasks. This information can help with troubleshooting, decisions about scaling out, grouping and resource allocation.

For more information, see "Setting Up Topology – Workers" in the *HP OO Central User Guide*.

Dashboard Excludes Remote Debugger Runs

The Central Dashboard no longer includes flows that were run using the Remote Debugger in Studio. This ensures that the statistics and ROI calculations in the Dashboard will not be affected by test runs.

Flows that were run using the Remote Debugger are still displayed in the Run Explorer.

Multi-select in Run Explorer

It is now possible to select multiple runs in the Run Explorer in order to perform actions on them at the same time. For example, you can:

- Cancel all selected runs
- Pause all selected runs
- Reassign all selected runs
- Resume all selected runs

There are two ways to select multiple runs in the Run Explorer:

- Click in the check box next to each run that you want to select
- Hold down the SHIFT / CTRL keys and click anywhere in the row to select a run:
 - Use SHIFT to select multiple runs that are adjacent. Select the first run, and hold the SHIFT key while you select the last run.
 - Use CTRL to select multiple runs that are not adjacent.

For more information, see "Tracking and Managing Flow Runs" in the *HP OO Central User Guide*.

Hide/Display Columns in Run Explorer and Run Log

It is now possible to choose which columns to display and which to hide in the Run Explorer and the Run Log.

To hide or display columns, click the **Select Columns**  button to display the column picker. Select the check box next to a column name to display that column or clear the check box to hide it.

Extra Columns in Run Log

There is now a wider range of columns that can be selected for display in the Run Log. There are now 22 columns available in the column picker.

The Find dialog box now offers a wider range of search criteria for finding steps in the Run Log.

Go From Run Log Step to the Same Step in the Run Tree and Flow Graph

It is now possible to select a step in the Run Log and jump to see that step highlighted in the Run Tree and Flow Graph.

When you are troubleshooting, you can start by finding the problematic step in the Run Log, and then click the **Go to Run Tree View**  button. The selected step is displayed in the Run Tree and Flow Graph.

In previous versions, it was possible to jump from a selected step in the Run Tree to the Run Log. Now, you can toggle in both directions.

Supporting CloudSlang Workflows

It is now possible to take content that was authored in CloudSlang, and to deploy it in Central. You can add entitlement to CloudSlang flows, run, monitor, and troubleshoot them.

Everything that you can run from the CloudSlang 0.8 CLI can be run in HP OO 10.50.

For more information, see "Integrating CloudSlang Content in Central" in the *HP OO Central User Guide*.

Customizable Central Title Banner

It is now possible to add extra text to the header title of "Operations Orchestration", which appears in the top banner in Central. You can make Central look different in different environments, so that users will be able to identify which environment they are in. For example, you can change the header text to "Operations Orchestration (Dev Environment)".

You can add this extra text to the title under **System Configuration > Settings**. For more information, see "Setting Up the Appearance of HP OO" in the *HP OO Central User Guide*.

ROI Description

It is now possible to add a description of the ROI counter, in order to help users understand the meaning of the ROI values. For example, you can tell them that ROI is calculated in a particular currency or in work days.

You can add the ROI description under **System Configuration > Settings**. For more information, see "Setting Up the Appearance of HP OO" in the *HP OO Central User Guide*.

There is also a new REST API that can be used to add the ROI description. For more information, see the *HP OO API Guide*.

Central Startup Performance

The Central start time has improved by 50-60%.

Documentation Enhancements in HP OO 10.50

Help Search

It is now possible to filter the search within the help. You can limit the search to specific documents, such as those dealing with installation, hardening, Central, APIs, and so on.



Help Navigation Pane Open by Default

When you click the Help button or press F1 to display the context-sensitive help, the help page opens with the navigation pane already opened. In previous versions, this pane was closed and had to be opened manually.

Combined Documents

In 10.50, some of the documents have been merged together:

- The *Security Guide* and *Hardening Guide* have been merged into the *Security and Hardening Guide*.
- The *Installation Guide* and *Upgrading to a New Version of HP OO 10.x* have been merged into the *Installation, Upgrade, and Configuration Guide*.

Note: In the PDFs, *Upgrading to HP OO 10.x from HP OO 9.x* is available as a separate PDF. However, it is included as part of the *Installation, Upgrade, and Configuration help*.

- The five wizard guides have been merged into the *Studio Wizards Guide*.

Installation Help in the Installation Wizard

There are now links in the Installation and Configuration Wizard that open the *Installation, Upgrade, and Configuration Help*. This help includes both the *Installation, Upgrade, and Configuration Guide* and *Upgrading to HP OO 10.x from HP OO 9.x*. Click the links on the **Welcome**, **Upgrade**, and **Clustering** pages to open the relevant help topic in a Web browser.

Image Maps in Installation, Upgrade, and Configuration Help

The *Installation, Upgrade, and Configuration Guide* includes flowcharts describing the major steps in the processes. In the *Installation, Upgrade, and Configuration Help*, these flowcharts are image maps, where you can click on a node to jump directly to the step.

Help for Cluster Installations

The *Installation, Upgrade, and Configuration Guide* includes detailed help about how to install HP OO in a cluster.

New Features in HP OO 10.22.0001

The HPLN Certificate was updated in HP Operations Orchestration 10.22.0001.

A security problem was fixed in version 10.22.0001. For more information, contact HP Support.

New Features in HP OO 10.22

Hotfixes Integrated into HP OO 10.22

The following hotfixes that were provided separately by HP for version 10.21.0001 were integrated into version 10.22:

- Functionality has been added, allowing multi-character delimiters.
- In the Remote Debugger, when breakpoints are set, the server.log and execution.log files are no longer filled with errors.
- A step's session context is no longer passed into subflows, causing particular flow loops to break.
- Flow executions no longer remain in the RUNNING state indefinitely.
- It is now possible to launch flows from BSM containing user prompts.

Database Enhancements in HP OO 10.22

Monitor Database Size


There is now a new **Database Health** tab in the System Configuration workspace. Using the graph, you can monitor the size of your database, comparing the current size to its size over the past month, quarter, half year, year, or total time. You can also see how the data is divided between execution, debugger and auditing usage.

The **Database Health** tab also displays information about how to schedule purging flows, in order to control the size of the database. For more information about the purging flows, see the new *HP OO Tuning Guide*.

It is highly recommended to control the OO database size by scheduling purging flows. To do this, follow these steps: ?

Note: The graph is updated approximately every 24 hours from the time Central was first up. For example, if you run a purging flow to reduce the database size, the updated size will be displayed on the following day.

Set Default Persistence Level for the Run Log

In HP OO 10.x, a very detailed run history is persisted, including much more information than in version 9.x. This makes it easy to troubleshoot, as all the information is available in the Run Log. However, you may want to reduce the information that is persisted:

- If your database size has increased to the limit
- If some of the persisted data is not relevant for you

In HP OO 10.22, you can choose how much data to save. By selecting the persistence level, you control the level of detail that is saved to the Run Log. Two persistence levels are available:

- **Standard** - large input/output values are truncated at approximately 4,000 bytes when logged
- **Extended** - large input/output values are not truncated when logged

Note: The **Extended** level is similar to the behavior of previous 10.x versions.

The top-level inputs and outputs of the launched flow are always logged with their full values (even at **Standard** level).

In the new **Database Health** tab, you can set a default persistence level for the entire system, to be applied to all flows that are run. You can override this default for individual flows in the flow library, or when triggering or scheduling a flow run.

Note: All runs started from the Remote Debugger have the **Extended** persistence level.

Purging of Execution Summary

There is a new API for purging execution records by their status.

API Enhancements in HP OO 10.22

In HP OO 10.22, the permission required for the REST “/steps-log” DELETE has been changed to **dataCleanupManage** instead of **systemSettingsManage**.

Additions to the 10.22 Documentation Set

The following new documents were added to the HP OO documentation set in version 10.22:

- *Tuning Guide* - explains how to set up the HP OO database so that it is the right size for your needs, and so that performance is maximized.
- *Security Guide* - explains how to deploy and manage HP OO instances in a secure manner.

Hotfixes Integrated into HP OO 10.21

The following hotfixes that were provided separately by HP for version 10.20 were integrated into version 10.21:

- New version of the upgrade package, to prevent issues with upgrading an existing HP OO system from version 10.10, when it contains a considerable amount of data.

The new upgrade package also resolves issues with generating an SQL script for the upgrade.

- New versions of the provided SQL scripts for a fresh installation, to prevent issues with creating the HP OO 10 schema.

New Features in HP OO 10.20

Content Management Enhancements in HP OO 10.20

Permissions for System Accounts

It is now possible to grant permissions for system accounts in HP OO. This enables the administrator to control which users can view which system accounts and run flows that use them. This feature is useful for customers with multiple organizations, who may wish to hide some of the system accounts from some users.

Only users with **View and Run** permission on a system account will be able to view it in the Configuration Items tree (described below) and to run (or resume) flows that use it.

Only users with **View and Run** permission on a system account will be able to remote debug a flow that uses it, from Studio.

Notes: After an upgrade from an earlier version of 10.x, any role that has either the **View Configuration Items** or the **Manage Configuration Items** permission will be automatically entitled to view and use all system accounts. You can modify these default permissions in Central once the upgrade is complete.

After an upgrade from 9.x, the ADMINISTRATOR and PROMOTER roles will be automatically entitled to view and use all system accounts. You can remove these default permissions in Central once the upgrade is complete.

Configuration Items Tree

The **Configuration Items** tab in the Central Content Management workspace has been redesigned. Instead of under three tabs (**Group Aliases**, **System Accounts**, and **System Properties**), the configuration items are displayed together in a tree, similar to the tree in the Flow Library. The tree displays the deployed value for each configuration item. If an item was given an override value in Central, this value is also displayed.

- Enter text in the **Filter By** box to filter the display of configuration items.
- Select an item in the tree to display its information in the details pane to the right.
- If you select a system account in the Configuration Items tree, the **Permissions** pane is also displayed. If you have **Manage Content Permissions** permission, you can assign **View and Run** permission for this system account.
- Select a configuration item and use the toolbar buttons to edit, revert, or delete that item, if you have **Manage Configuration Items** permission.

If you override the value of a configuration item in Central, the **Deployed** value and the **Central** value are connected. If you move or rename a configuration item in Studio and deploy it again, the Central value is also moved or renamed.

Note: While you can edit existing configuration items in Central 10.20, including those that were created in earlier versions of Central, it is not possible to create new ones. New configuration items can only be created in Studio.

Configuration items must be unique. If you deploy a configuration item in a folder containing a configuration item with the same name, it will either overwrite that item (if they have the same UUID) or fail deployment (if it has a different UUID).

However, note that it is now possible to have two configuration items with the same name if they are located in different folders. This helps reduce the risk of conflicts between configuration items.

For more information, see "Setting Up Configuration Items for a Content Pack" in the *HP OO Central User Guide*.

Apply Permissions to Multiple Roles

It is now possible to apply permissions to multiple roles in the Edit Permissions dialog box. In previous versions, it was only possible to select one role at a time.

Replace Items in a Deployed Content Pack

It is now possible to delete, move, or rename an item in a deployed content pack, and to replace it with another item (by creating, moving, or renaming that other item) in the same deployment.

Flow Triggering Enhancements in HP OO 10.20

There is a new **Flow Launcher** tab in the Run Management workspace, making it quicker and more convenient to run flows in Central. You can browse for a flow, view the flow information, name the run, enter inputs, and run the flow, all in the same window, without needing to open an additional dialog box.

It is still possible to run a flow from the Flow Library in the Content Management workspace. But it is no longer possible to run a flow from the Run Explorer.

Embedding Central Views in External Web Pages

It is now possible to embed parts of the Central UI into an iFrame in an external web page. You can embed:

- Flow Run view - for running and interacting with flows
- Drill Down view - for advanced tracking of running flows

For more information, see "Embedding Central Views in External Web Pages" in the *HP OO Central User Guide*.

Note: Use the **Run Link** field in the **Flow Information** pane in the **Flow Library** tab for embedding the **Flow Run** view.

Execution Performance Enhancements

HP OO 10.20 has significant improvements in single flow performance of plain flows and sub-flows.

Installation Enhancements in HP OO 10.20

Unregister a RAS in the Uninstall Wizard

It is now possible to unregister a RAS in the Uninstall wizard.

For more information, see "Uninstalling HP Operations Orchestration" in the *HP OO Installation Guide*.

Define a Database Connection to Oracle Using the Database Service Name

When defining a database connection to an Oracle database, you can now use either the service name or the SID.

For more information, see the *HP OO Installation Guide*.

Disable the HTTP Port

It is now possible to disable the HTTP Port during installation. You might want to do this for security reasons, so that the only communication channel is on SSL and encrypted.

For more information, see the *HP OO Installation Guide*.

Updated Trusted Root Certificates

When you upgrade an HP OO installation from an earlier 10.x version, the SSL truststore is updated to include the up-to-date trusted root certificates, as published by Oracle. This includes deletion of expired certificates, and import of new ones.

Note: If the upgrade detects that your truststore is manually managed (meaning you have removed any of the public root certificates), no certificates will be imported.

Authoring Enhancements in HP OO 10.20

Folders for Configuration Items

In previous versions, you could only create a configuration item in a flat list. In HP OO 10.20, it is possible to create and manage folders for configuration items.

New Size Limit for Prompts

The size limit for prompts that you can add to a flow in Studio is now 255 characters. In previous versions, it was possible to create prompts with up to 1024 characters, which caused problems in Central.

Different Behavior for Obfuscated Values

In the Studio Debugger, when you use the "Load Run Inputs" feature, if there are obfuscated inputs from a previous run, these are not reloaded.

Multiple Selection When Importing Projects

It is now possible to import multiple projects into Studio at once.

Copy, Cut, and Paste in Studio

It is now possible to cut, copy, and paste inputs, flow outputs, and step results in Studio.

References Resolved by Path

References to system properties and group aliases now need to be referenced by path. For example, a system property called **myProperty**, in the **/Configuration/System Properties/myFolder** folder, which was previously referenced as **#{myProperty}** now needs to include the path, so it will be **#{myFolder/myProperty}**.

Note: System properties located in the root folder (**System Properties**) are referenced as before.

Updates to the Input Inspector

The Input Inspector has been redesigned for ease of use:

- There is now a new **Inputs** toolbar for moving, adding, removing, copying, and pasting inputs in the Input Inspector.
- There is more information now presented in the Input Inspector's initial view. You can now see the **Assign From**, **Otherwise** and **Assign To** fields directly in the Input Inspector.
- You can now select the **Assign From** and **Assign To** values from a drop-down list.
- You can perform all basic input operations and inspect the basic definition of all the inputs at a glance using the table view.

Updated Default Values for Studio Properties

Security Enhancements in HP OO 10.20

Auditing

HP OO now gives you the option to audit events, so that you can track security breaches. Auditing lets you track actions that took place on Central, such as logins, triggering flows, creating schedules, editing configurations, and so on.

Currently, you can retrieve the audit trail only via APIs. For more information, see the *HP OO API Guide*.

Note: You need to have **View Audit** permission to retrieve the audit trail.

For more information about how to enable auditing in Central, see "Enabling Auditing" in the *HP OO Central User Guide*.

Long Encryption Keys

HP OO now supports encryption keys that are 2048 bits long (and longer). This aligns our cryptography keys with the FIPS 186-4 standard.

XSS Protection

The HP OO client is protected from XSS (cross-site scripting), via a third party security solution (jsoup). The XSS protection is always on and is not configurable.

If you are adding your own client on top of Central's APIs (Portal, and so on), you need to protect it from XSS.

The jsoup XSS protection replaces the AntiSamy XSS protection from previous versions.

Protection from the "POODLE" attack

A new `sslEnabledProtocols` property has been added to the `server.xml` file (located at `<installation_folder>/central/tomcat/conf/server.xml`):

```
sslEnabledProtocols="TLSv1,TLSv1.1,TLSv1.2".
```

This property ensures that only TLS v1, TLS v1.1 and TLS v1.2 are allowed and that SSL 3.0 is not. This prevents vulnerability to the "POODLE" attack (Padding Oracle On Downgraded Legacy Encryption).

Environment Enhancements in HP OO 10.20

Java SE 7 Upgraded to 72

The version of Java SE 7 used in HP OO 10.20 has been upgraded to version 7u72.

Role Enhancements in HP OO 10.20

New Role Permissions

There are two new role permissions: **View Audit** and **Manage Data Cleanup**.

Note: After an upgrade from earlier versions of 10.x, these permissions will not be enabled for any of the roles. You will need to enable them manually.

Wizard Enhancements in HP OO 10.20

Updates to the Web Services Wizard

It is now possible to generate system accounts and properties for common inputs using the Web Services Wizard.

In the content pack, the results can be found in the **Configuration>System Accounts** and **Configuration>System Properties** folders. These system accounts and properties are used by all generated flows to initialize inputs such as **host**, **port**, **username**, **password**, **proxy**, **proxyPort**, and **proxyUsername**.

The flows work the same as previously, but it is much easier to change an input that is common to multiple flows. For example, when the password is changed and the Web Services Wizard is used to generate 100 flows.

Updates to the PowerShell Wizard

PowerShell 4.0 is now supported.

Updates to the REST Wizard

In the **Configuration** page of the REST Wizard, there is now a **Header** text box, which lets you add multiple headers in the generated flows, in the following format:

headerName1=headerValue1\nheaderName2=headerValue2. The headers must be separated by the new-line character.

In the **API Definitions - Swagger** page, there is a new **Resolve relative references according to the RFC3986** check box. If this check box is selected, this ensures that the relative paths

discovered in the Swagger file found at the provided URL will be automatically resolved, and the HTTP requests will be made at the correct resource listening paths.

Database Enhancements in HP OO 10.20

Data Cleanup (Purging)

The data cleanup APIs enable the database administrator to purge flow data such as inputs, outputs, step log, and debugger events. This is useful for customers who run large numbers of flows, which could cause the database to reach the maximum table size. By using the data cleanup APIs, you can purge the tables manually as required, or by scheduling recurrent flows that incorporate these APIs. This helps you to keep the database size under control and maintain optimal system performance.

Note: Data cleanup only affects the data of completed runs.

For more information, see the *HP OO API Guide*.

Database purging flows are also available in the **HP Solutions** content pack under **Integrations/Hewlett-Packard/Operations Orchestration/10.x/Database**. For more information, see the *HP OO Database Guide*.

New Features in HP OO 10.10

Changes to 10.x Documentation

The documentation for HP OO 10.x has been rewritten, so that it is more concise and easier to navigate.

Persona icons have been added to help identify task owners, and flow diagrams provide an overview of processes. In the HP OO help, these flow diagrams link directly to the relevant help topic.

Note: In order for the links in the flow diagrams to work properly, make sure that the browser window containing the HP OO help is expanded. If the browser window is contracted, the links in the flow diagrams may not work correctly.

LDAP Enhancements in HP OO 10.10

Multiple LDAPs

If your organization works with multiple LDAP servers, it is now possible to configure Central to work with all of them. This includes LDAPs with different schemes and from different vendors. For example, you might have an Active Directory (Microsoft LDAP) implementation for one part of the organization and a Sun One (Oracle LDAP) implementation for another part.

If you set up multiple LDAP configurations on different domains, when users log in to HP OO, they will need to select the domain from a drop-down list with the active domains. There will be no drop-down list of domains if only one LDAP is configured and is set as the default.

Note: In HP OO 9.x, multiple LDAP configurations were given an order of priority, so that if an authentication failed, HP OO tried the next LDAP configuration on the list. HP OO 10.x has a failover functionality, in which you can set up multiple LDAP servers in a single configuration. So, if an authentication fails, HP OO tries the next LDAP server, within that configuration.

For more information, see "Setting Up Security – LDAP Authentication" in the *HP OO Central User Guide*.

After an upgrade from HP OO 9.x (9.03 and later), if there are multiple LDAP configurations, these are all upgraded to HP OO 10.10.

Note: If multiple LDAP configurations are identical apart from the host/port information, these are upgraded to a single LDAP configuration in HP OO 10.10, with multiple rows in the host/port section, for failover.

Easier LDAP Configuration

In order to make it easier to enter the LDAP configuration information, the **Security > LDAP** tab comes with default values already loaded. For the **User DN** and **Group DN** fields, it is possible to fetch a base DN from the LDAP, and then refine it for your needs.

LDAP Configurations with Attributes Whose Values will be Used as Groups

It is now possible to set up an LDAP authentication configuration with a list of attribute names that will be used as groups, as an alternative to group filters.

This enables organizations to base the functional groups of users on LDAP attributes, rather than LDAP groups.

Content Management Enhancements in HP OO 10.10

New Content Packs Tab

You can now manage and view your deployed content packs in Central, under a new **Content Packs** tab. In the **Content Packs** tab, you can:

- Deploy and roll back content packs.

The **Deploy New Content**  and **Roll Back Deployment**  buttons have been moved from the **Flow Library** tab to the new **Content Packs** tab.

- Delete deployed content packs
- View a list of all active deployed content packs—non-empty content packs that haven't been rolled back, deleted, or overridden by other content packs.
- View the name, version, deployment date, publisher, and description of each content pack, as well as the user who deployed it.
- Filter the display of content packs by name.
- View the changes that were made to a selected content pack.
- Display the items within a content pack. The contents are arranged in a tree, under **Library** and **Configuration** folders, reflecting the way that the content pack appeared in Studio. The tree nodes can be expanded and collapsed, like in Studio.

Note: In previous versions, the paths of operations were not saved after deployment. So if you have upgraded a previous version with deployed content, you will not see the paths of the operations in the content pack. The operations will be displayed in an **Operations** folder under the **Library** folder. For content deployed in HP OO 10.10 and later, the operations are displayed the folder in which they are located in the deployed content pack. Note that if you redeploy the upgraded content, the operations will be displayed with their paths in the content pack.

For more information, see "Deploying and Managing Content Packs" in the *HP OO Central User Guide*.

Content Integrity Model for Content Pack Deployment

HP OO 10.10 employs a new model for content pack deployment, which preserves content integrity. This affects the workflow for when you make changes to a content pack.

Each entity (flow, operation, and configuration item) in deployed content packs must have a unique UUID. If you try to deploy a content pack with a duplicated entity (with the same UUID as an entity in another deployed content pack), the deployment will fail.

If you move an entity from one content pack to another, this may result in a duplication, which will cause deployment to fail. For example, you have two content packs, A and B. You deploy content

pack A to Central, and then you move entity X from A to B. When you try to deploy content pack B, the deployment will fail because entity X appears in both A and B.

In such a situation, the correct workflow is to deploy **both A and B** together after moving the entity, and not to deploy B on its own. The new version of A, without entity X, overwrites the previous version on Central, so there is no duplication.

When it's time to promote the content from one Central environment to another, you will only need to deploy the latest versions of the content packs that were deployed in the original Central environment. In previous versions, it was necessary to re-create all of the deployment history in the exact order that it was performed in the original environment.

After an upgrade, there may be content deployed in previous versions that does not meet the requirements for uniqueness. If this occurs, there is an indication in the **Content Packs** tab, showing that the content pack may not be valid (some of its contents might have moved to a different content pack without a new version of the first content pack being re-deployed).

If you are upgrading a large repository from HP OO 9.x (9.03 and later), the recommended best practice is to:

1. Upgrade the repository to HP OO 10.10.
2. Import it in Studio.
3. Split it into multiple content packs in Studio.
4. Deploy those content packs together in Central.
5. If you modify, remove, or move entities in these content packs, deploy all affected content packs again.

Filters in the Flow Library

It is now easier to find a flow in the flow library, using a filter.

To filter the flows, enter part or all of the flow path in the **Filter By** text box.

New Tabs in Studio Dependencies Pane

In Studio, two new tabs have been added to the **Dependencies** pane:

- **Content Packs** - Displays multiple trees, for multiple content packs. From this view, it is possible to close, delete, or import a content pack.
- **Library** - Displays a single tree, with all of the content merged together under a general **Library** folder and a general **Configurations** folder. From this view, it is possible to import a content pack.

Studio keeps track of the last view that was selected, so that when Studio is closed and started again, it loads the view was last selected.

Run Explorer Enhancements in HP OO 10.10

Enhancements to the Run Explorer Filters

To help you locate the run that you need, the Run Explorer filters have been enhanced. You can filter the display of runs by visible columns, according to status, start time, user name, run name, or run ID.

You can filter by multiple fields. This may be useful for troubleshooting, for example:

- You can check which runs failed the previous night (by filtering according to time range and status).
- You can filter to see runs that were triggered by a certain user.
- You can filter to see runs that are pending an action from you (by filtering according to user and status).

Changes that you make to the filters are saved in the local cache of the browser. For more information, see "Adjusting the Display of Flow Runs" in the *HP OO Central User Guide*.

Adjust the Appearance of the Columns in the Run Explorer

You can now adjust the appearance of the columns:

- Customize column width, by dragging the edge of a column
- Change the order of the columns, by dragging a column name to the right or left

Changes that you make to these settings are saved in the local cache of the browser. For more information, see "Adjusting the Display of Flow Runs" in the *HP OO Central User Guide*.

Faster Refresh in Run Explorer

The Run Explorer's refresh mechanism has been optimized to prevent overlapping of refresh calls and to achieve a better user experience. The Run Explorer in Central displays up to 200 runs in a single page.

Note: If you have selected a row at the top of the Run Explorer, and another user runs a flow, this new run appears in the Run Explorer under the row that you have selected.

Enhancements to the Display of Run Information in HP OO 10.10

When you run a flow in Central and drill down to see information about the flow run, you can view:

- The flow's steps and transition messages, which are automatically refreshed as the run progresses. This enables you to track ongoing runs.
- Information about a selected step in the flow (start time, end time, step result, duration, inputs,

results, worker group, and so on).

Note: You can drag the slider on the left edge of the **Flow Info** pane to adjust its width.

- A graphical view of the flow, with the selected step highlighted.

Note: You can adjust the way that the flow graph is displayed, by dragging it across the screen to view hidden item, or by adjusting the size of the image.

- The Run Log – a table with information about the entire run (steps, start time, duration, inputs, results, and so on), with the option to search for a specific step. You can export the run log into a SCV file, to help identify the causes of a problem, and you can use a Find functionality to locate a specific step in the Run Log.

Note: If the run includes subflows, the steps in the subflows are indented.

- Information about the flow (UUID, flow name, path, description, flow inputs, flow outputs, and so on).

You can choose which information you want to display.

For more information, see "Testing and Troubleshooting a Flow Run" in the *HP OO Central User Guide*.

Authoring Enhancements in HP OO 10.10

Remote Debugger Enhancements

The Remote Debugger in Studio offers enhanced remote debugging capabilities for connecting to several Central instances (or servers) and debugging a flow using the Central context.

During the troubleshooting and debugging process, there is no need to deploy the selected flow to Central. When you use the Remote Debugger, Studio connects in a volatile manner to Central. Since the debugging process is done from Studio, you can make changes to your flow without affecting the selected Central environment.

Note: Any dependent content packs that are needed for the flow have to be aligned to the same version on both Studio and Central.

There is a new Edit Connections dialog box in Studio, which enables you to configure multiple remote connections. This replaces the configuration of remote connections from within the **Studio.properties** file, which is no longer supported.

In Central, you can assign remote debugging permission to a role, in order to enable a user to use the Remote Debugger.

You can override the values of a run during debugging. For example, you can modify a system property in Central, and this will override the value of that property within Studio. You can modify a value within the Debugger Context Inspector, and this will override both the value in Central and the value in Studio.

The Context Inspector in the Remote Debugger has been enhanced. You can now:

- Filter the display according to selected values
- Sort the display according to columns
- Search for items in the Context Inspector
- See in the **Source** column whether a value originated in the runtime, Central, or Studio
- Easily identify when a value is new or modified, via the color and the appearance of "New" or "Modified" next to a value.

Note: After an upgrade from 10.02 to 10.10, the Remote Debugger configurations need to be reconfigured in Studio, because the information is no longer taken from the **studio.properties** file.

Rerunning Flows

In the Remote Debugger, it is possible to repeat runs that ran previously. For example, if you run a flow that requires you to enter multiple flow inputs, you can repeat that run later, without having to re-enter all the inputs. This functionality can be used when testing flows remotely.

Enforce Locking Policy

This options prevents the flow author from making any changes to an item (flow or configuration item) unless the item is locked. This ensures that only one author can edit an item. See the *HP OO Studio Authoring Guide* for more information.

Searching Content on HP Live Network from Studio

In Studio, you can now search for relevant information and content on the HP Live network based on your HPLN profile access permissions.

Note: If the **HPLN** tab is not visible, select **Reset Layout** from the **Window** menu. This can happen after an upgrade. For more information, see ["Troubleshooting" on page 71](#).

Note that this menu item is only enabled if there is an existing project in Studio.

Manage Description Conflicts for Multi-author Scenarios

HP OO 10.10 saves the description for each flow, operation, configuration item, and folder of a project individually. The flows, operations, and configuration items descriptions are saved in the corresponding XML file, and the folder descriptions are saved in a **<folder name>.properties** file located on the same level as the folder in the file structure.

Opened projects are upgraded to 10.10 format the first time Studio is launched. Studio upgrades projects to 10.10 format when they are opened or imported.

In versions prior to 10.10, descriptions for projects and their content were saved in a single **cp.properties** file. After you upgrade a project to 10.10 format, its **cp.properties** file is deleted. This change affects only projects. Content packs maintain the same structure, having all the descriptions in the **cp.properties** file.

Important! As a best practice, when connected to SCM, only one author should upgrade the projects and should commit immediately after the upgrade.

Note: The upgrade process is time consuming, but it happens only once for a project. For more information on upgrading, see the "Upgrading Studio" section in *Upgrading to a New Version of HP OO 10.x*.

Search for Configuration Items

The Search capabilities in Studio have been extended to include configuration items.

New Video Tutorial about Using the Remote Debugger

In the Studio tutorials page, accessible from within the **Welcome** pane, there is a new video that guides you through the debugging functionality on a remote Central.

Set the Properties for Studio Projects

In Studio, you can now set the description and publisher of a content pack, in the Project Properties window:

- Define the publisher in the **Publisher** box. When you create a content pack, the value will be loaded by default into the Create Content Pack dialog box, where you can also edit it.
- Create a multi-line description of the project in the **Description** box. When you create a content pack, the value will be loaded by default into the Create Content Pack dialog box. You cannot edit the description in the Create Content Pack dialog box, but hovering over it will display the whole description.

Progress Bar for Importing a Project

In Studio, when you import a project, there is now a progress bar indicating the status of the import process.

Studio Files

The files required to start and configure Studio have been reorganized as follows:

- Studio is now launched through the **Studio.exe** file, located under **<installation_path>\studio**. You can pin the new executable file to the task bar.
- Properties that are not required at run time can be added to or edited in the **Studio.properties** file.
- Properties that are required at run time can be added to or edited in the **Studio.14j.ini** file, located under **<installation_path>\studio**.

Updates to Studio Menus

New items were added to the **Studio** menu bar, enabling you to configure the Proxy settings for the Remote Debugger, edit the remote Central connections, set the credentials for HP Live Network

search, and configure the Studio overrides for debugging purposes.

Studio Debugger Watches

In Studio, in the Debugger window, you can now follow the inputs you are interested in, by adding them to watches. The functionality is available in the **Debug Options** pane, in the **Watches** tab.

Installation Enhancements in HP OO 10.10

Installation Wizard for HP OO 10.10

HP OO 10.10 is installed via a single installation wizard.

In previous versions of 10.x, it was necessary to install HP OO 10.00 and then upgrade to the newer 10.x version via a patch.

For more information, see the *HP OO Installation Guide*.

Note: The installation wizard is used for new installations and upgrades from HP OO 9.x. You can also upgrade from an earlier version of 10.x, by using the **apply-upgrade** script and not via the wizard. For more information, see *Upgrading to a New Version of HP OO 10.x*.

Language Support in Installer

In the installer, you can select a supported language for HP Operations Orchestration, in addition to English.

This language support will be used for:

- The Studio UI
- The MS SQL collation language, if relevant
- The **central-wrapper.conf** language for content. This language support may be required if, for example, you need to ping a server that is configured in Japanese.

Note: You can change the language support choice after installation, by editing the **Studio.properties** and **central-wrapper.conf** files.

1. Locate the files in the installation directory under **central/conf** and **studio/conf**.
2. In the **Studio.properties** and **central-wrapper.conf** files, set the **user.language** and **user.region** properties to the desired language:

	user.language	user.region
Japanese	ja	JP
German	de	DE
Simplified Chinese	zh	CN

	user.language	user.region
Spanish	es	ES
French	fr	FR
English	en	US

For example, for Japanese, set the following:

```
user.language=ja
```

```
user.region=JP
```

3. Restart the HPOO Central service for the settings to take effect.

Installer Checks for Available Disk Space

During installation, the installer checks for available space. If there is insufficient disk space for the installation, the **Next** button is not available.

Menu Shortcuts

Menu shortcuts are now created as part of the installation process.

Localization

HP OO 10.10 is localized into five languages: Japanese, Simplified Chinese, German, French, and Spanish. You can select a supported language, in addition to English, during the installation. See ["Language Support in Installer" on the previous page](#).

Central language support is according to the browser language. If the language is not supported by the browser, Central is displayed in English.

Note: Searching in the Run Log is only supported if the storage space taken up by the searched field is no more than 4,000 bytes. Note that Japanese and Chinese take up about 3 bytes per character, while other (non-English) languages take up about 1.5 bytes per character. Also note that in the case of transition descriptions, the 4,000 bytes are shared among all of the locales in which the description is available.

Even if you cannot search in the Run Log, you are still able to see the runs.

Environment Enhancements in HP OO 10.10

Java Runtime Environment Upgraded to 7u55

The version of Java Runtime Environment used in HP OO 10.10 has been upgraded to version 7u55. This includes the latest security fixes from Oracle.

Updated Support Matrix

The following have been added to the support matrix:

- PostgreSQL 9.3
- Oracle 11g RAC
- Microsoft Windows 8 64 bit (Studio)
- Microsoft Windows 8.1 64 bit (Studio)
- Microsoft Windows Server R2 2012 64 bit (Studio)
- Internet Explorer 11.x

Note: We no longer support Studio on Windows 7 32 bit.

SAML Authentication

HP administrators can now configure Central to work with SAML 2.0 authentication. SAML (Security Assertion Markup Language) is an XML-based open standard data format for exchanging authentication and authorization data between an identity provider and a service provider.

For more information, see "Setting Up Security – SAML Authentication" in the *HP OO Central User Guide*.

Multiple RAS Support

HP OO 10.10 can support up to 20 RASes without performance degradation.

Step Log Mechanism

HPOO 10.10 introduce a new step logging mechanism. The new mechanism gives you advanced monitoring and tracking capabilities, such as getting the run execution tree, retrieving inputs and outputs from a step, getting the step duration, getting the details of the worker that executed the operation, and so on. This mechanism replaces the event log mechanism (and the RSS feed), which is deprecated in the current version and will be removed in a future release.

New Features in HP OO 10.02

Status Column in Topology > Workers Tab

The **Topology > Workers** tab now displays the status of every worker. This makes it clear to the administrator whether the worker is running or stopped.

Progress Indication for Deployment

After you deploy a content pack in Central, a progress bar is displayed, indicating the progress of your deployment.

Multiple Selection of Files for Deployment

In the Deploy Content dialog box, it is now possible to select multiple files for deployment, using the **+** button.

In previous versions, it was only possible to select one file.

Lock Indication When Another User is Deploying Content

In HP OO 10.02, it is not possible for two users to deploy a content pack to the same Central at the same time. If you try to deploy content to Central while another user is already deploying content, you will see an error message, indicating that another deployment is currently in progress.

In previous versions, problems could arise when two users simultaneously deployed a content pack to the same Central.

Deployment Performance Improvement

Deployment time in Central is now reduced significantly.

Add Inputs in Scheduler

It is now possible to add extra inputs to a scheduled flow, while setting up the schedule. In previous versions, it was only possible to enter flow inputs, while setting up the schedule.

Central Displays Original Values of Deployed System Accounts

System accounts that existed in deployed content packs have their original value displayed in the **Deployed User Name** column in the **Configuration Items > System Accounts** tab.

If a system account from a deployed content pack is edited, this overrides the default value, and the new value is displayed in the **Override User Name** column.

View Status and Delete Workers in Central

The **Topology > Workers** tab in Central now displays the status of each worker: whether it is **Running** or **Stopped**. The worker path indicates whether the worker is in Central or in RAS. This information will help HP OO administrators with troubleshooting.

It is also possible to delete a selected worker. For example, one that is no longer in use.

Constants in SDK

The classes **ResponseNames**, **ReturnCodes**, **InputNames**, and **OutputNames**, under the **com.hp.oo.sdk.content.constant** package, include commonly used constants, which you can use in **@Actions**. For example, input names such as **HOST**, **USERNAME**, **PASSWORD**, **PORT**, and so on, or response names such as **SUCCESS**, **FAILURE**, **NO_MORE**, and so on.

Adjustable Logging Levels

It is now possible to adjust the granularity of the information that is provided in the log, separately for regular logging, deployment, and execution.

The granularity options are:

- INFO - Default logging information
- DEBUG - More logging information
- ERROR/WARNING - Less logging information

To adjust the granularity in the logging, you can replace **INFO** with **DEBUG** or **ERROR/WARNING** in the following place in the **log4j.properties** file (under **<oo-installation>/central/conf/log4j.properties**).

For example:

```
log.level=INFO
execution.log.level=DEBUG
deployment.log.level=DEBUG
```

System Account Passwords can be Included in Upgraded Content and Content Packs

In previous versions, when content was upgraded using the Content Upgrade Utility, the passwords of system accounts were not included in the upgrade. The Content Upgrade Utility now includes an option to upgrade system accounts with their user names and passwords by adding one of these arguments to the command: `-ip` or `--include-passwords`.

This way, when the upgraded content is deployed on Central, the user names and passwords will also be deployed. Note that the passwords will be obfuscated inside the project/content pack.

Note: HP OO 10.02 can read the encryption from earlier versions, but earlier versions cannot read the new obfuscation for HP OO 10.02. Therefore, if you import a content pack that contains system accounts created in HP OO 10.02 or later into earlier versions (10.00, 10.01, or 10.00.001), these system accounts will not include the user name and password.

Enhancements to Upgrade Report

After content upgrade, the upgrade report now includes sorting and grouping:

- Items are grouped into separate tables according to the type of problem
- Tables are sorted according to path
- All groups are collapsible, via the **Show/Hide items** link

Renamed CUU Argument

In the Content Upgrade Utility, the argument `--rases-dirs` or `-rd` has been replaced with `--rases-file` or `-rf`. This is more consistent with the other arguments and a better description of the functionality. The functionality remains the same.

Notification of Content Pack Creation

After an author successfully creates a content pack in Studio, a dialog box appears, displaying the location where the content pack was created.

SVN Cleanup Functionality

In some cases, you will need to clean up the working copy in the Studio workspace. For example, if a Studio process crashes or if there is an IO error, and the working copy remains locked. A

Cleanup option is now available from the **SVN** menu.

In previous versions, it was necessary to use an external tool for this cleanup process.

Drag and Drop Enhancements in Studio

In Studio, it is now possible to select multiple items in the **Project** pane or **Dependencies** pane, in order to drag and drop them into a project. This functionality works with both the right and left mouse buttons.

- When you drag and drop from the **Dependencies** pane to a project, this copies the item into the project.
- When you drag and drop from one folder to another in the **Project** pane, this moves the item.

Note: It is not possible to drag and drop flows and operations at the same time as configuration items. It is not possible to drag and drop a flow or operation into the **Configuration** folder, and vice versa.

- It is also possible to drag and drop flows and operations from the Bookmarks pane to the Projects pane, to copy them to a project.

Studio Editors Can Stay Open

It is now possible to create a new content pack or a new operation without closing all the editors in Studio. In previous versions, it was necessary to close all tabs before creating a new content pack or operation.

When you create a new operation, the Create Operations dialog box opens, even if there are open editors with unsaved changes.

When you save a content pack, the Saving dialog box gives you the option to save all changes in the currently open editors or to decide whether to save each one individually.

Open Multiple Selected Items in Studio

It is possible to open multiple selected items from the **References** pane, **Problems** pane, **Search** Pane, **Project** pane, or **Dependencies** pane. Select multiple items in the pane, using the SHIFT or CONTROL keys, right-click, and select **Open**.

Adding an Input at Cursor Position

It is now possible to add inputs at the current cursor position, and not just at the end of the input list. This is possible for flow inputs, step inputs, operation inputs, and operation responses.

Step Into and Step Out Actions in the Debugger

The Studio Debugger includes two new buttons: **Step Into**  and **Step Out** .

These actions allow a flow developer to step in and out of the running of a subflow, while debugging a flow. Both actions are available when a debugged flow is paused, waiting for the user's action.

- To step into a step's subflow, click the **Step Into**  button. The debugger will start running the subflow and will pause on the first step of the subflow.

Clicking **Step Into** at the beginning of the parent flow tells the debugger to pause on the first step of the parent flow.

- To step out of the subflow, click the **Step Out**  button. The debugger will run the rest of the steps in the current subflow invocation and will pause on the first step following the subflow (in the parent flow). If the current step is in the parent flow, the action will behave like a resume action.

Go to Step Functionality in Studio Flow Editor

A new **Go to Step**  button in the **Authoring pane** toolbar enables you to jump to a specific object in the flow. Type the name of the object to jump to the object, or the first letters of the object to select it from a list.

Configuration Items Must Have Unique Names

It is now required that configuration items (system accounts, domain terms, selection lists, and system properties) have unique names. If two items of the same type are given identical names in Studio, these items will not pass validation, and will appear in the **Problems** pane. Any flow that uses one of these duplicates will be marked as invalid, and it will not be possible to debug the flow until the duplication is fixed.

Note: This validation only applies to configuration items that were assigned via selection from a drop-down list. It does not apply to configuration items that were assigned dynamically, using the `${..}` notation.

In previous versions, duplicated configuration items were not identified during validation. This could lead to problems with binding, and configuration items would overwrite each other.

Updated About Page in Studio

The **About** page in Studio has been redesigned and now includes a link to the Third Parties document.

Links to HPLN Community and Online Content

The **Welcome** page in Studio contains two new buttons:

- **Community Home Page** – links to HPLN Community page
- **Online Content** – links to the Base Content Pack download page on HPLN

These options are also available from the **Help** menu in Studio.

Displaying the Grid by Default

By default, the grid is not displayed in the authoring pane. If the grid is set to display, via the

Show/Hide Grid button , this state is not persistent after Studio is closed. To change the default behavior, so that the grid is displayed by default, it is possible to open the **Studio.properties** file and set the property `dharmastudio.ui.activegrid=true`.

Changes in Behavior for Empty and Encrypted Values

In HP OO 9.x, when you use `assign-from`, if the variable is empty, the flow will behave as if the variable does not exist. However, if the variable is empty and encrypted, the input on which the `assign-from` is used will be overridden with an encrypted empty value.

The empty encrypted variable remains empty even if it is used in a sub-flow with: `assign-from: variable, otherwise: any non-empty value, assign-to: variable`.

In HP OO 10.x, the inputs are obfuscated, rather than encrypted. The flow will not initialize the empty obfuscated variable. If it uses the values described above, in the end, the variable will have the value that was initialized in the sub-flow.

Importing Plugins Replaces Previously Deployed Plugins

It is now possible to import a single plugin (maven artifact), either by the JAR file or by the POM file. If you import a plugin that was already deployed, the new plugin replaces the existing one.

Java Runtime Environment Upgraded to 1.7.0_45

The version of Java Runtime Environment used in HP OO 10.02 has been upgraded to version 1.7.0_45. This includes the latest security fixes from Oracle.

Tomcat Upgraded to 7.0.47

HP OO 10.02 uses an upgraded version of Tomcat, version 7.0.47.

Changes in File Locations

Some of the upgrade files have been organized into new locations, to make it easier to locate them. For example, executable scripts are now located in the **bin** folder, and the **upgrade.log** file is now located under `<installation>/upgrade/<new-version>`.

Use Maven Archetype to Create a Working Studio Project

Using the Maven archetype, you can create an @Action project and a content pack project that can be opened in Studio to create operations and flows. For more information see the *Action Developers Guide*.

New Features in HP OO 10.01.0001

Performance Improvement

HP OO 10.01.0001 offers a substantial improvement when running a single flow, regardless whether it is executed from the Studio Debugger or from Central.

Track the Progress of Parallel Flows During Execution

It is now possible to see the progress of a parallel lane even before it is completed.

Improved Documentation

The documentation for HP OO has been rewritten, so that it is more concise and easier to navigate.

New Features in HP OO 10.01

Run Explorer Filtering

In HP OO 10.01, it is possible to filter the flows that are displayed in the Run Explorer. You can create filters based on the flow path.

Dashboard

The Dashboard workspace reflects the system's ROI, and analyzed flow aggregation. It provides statistical information about the 10 most popular flows and financial information about the return on investment.

System Properties in Central

System properties can be managed in the Content Workspace under **Configuration Items > System Properties**.

Localization

HP OO 10.01 is localized into five languages: Japanese, Simplified Chinese, German, French, Spanish. You can modify the language in which Studio is presented, even if this is different from the locale set on your computer.

Central language support is according to the browser language. If the language is not supported, Central is displayed in English.

When creating a content pack, the **cp.properties** resource bundle with your locale is created by default. The **cp.properties** files with different locales can be created in order to support multiple languages.

Flow Visualization

Flow visualization gives Central users a graphical view of the steps in a flow as they appear in Studio. This visualization is available when you view a flow's details in the Flow Library. The currently running step is highlighted.

Folder Description

In Studio, authors can add a description to a folder in a project. For example, an author can group together all the flows and operations that were created with the same technology, and provide information about this in the folder description.

New Features in HP OO 10.00

HP Operations Orchestration 10.00 brings the following new features, improvements, and changes to the HP Operations Orchestration platform and content.

New Architecture

The architecture of the product has been upgraded and modernized. The basis of the new architecture is the "task and worker" design pattern. See "Architecture" in the *HP OO 10.00 Concepts Guide* for more details.

Firewall Friendliness

All distributed components now initiate the communication channel. See "Architecture" in the *HP OO 10.00 Concepts Guide* for more details.

Central Look and Feel

The Central Web-based application has a new, more modern design, consistent with the HP Experience style.

The Central UI is organized to reflect the most common OO use cases. Functionalities for the same roles are grouped into the same UI areas:

- **Run Workspace** – used for running flows, monitoring runs, scheduling runs, and troubleshooting runs.
- **Content Workspace** – used for promotion tasks, such as deploying new content, setting permissions on flows, setting up configuration items. It rolls back only to the last content pack deployment.
- **System Workspace** – where the system administrator can configure topology, and set up users, roles, LDAP authentication, and LWSSO.

For more information, see the *HP OO 10.00 Central User Guide*.

Content Packs

Content (flows, operations, configuration items, localization data, and action binaries) is now packaged into "content packs" and deployed to the Central server at run time with zero downtime,

for immediate availability.

See "Content Packs" in the *HP OO 10.00 Concepts Guide* for more details.

Updated Support Matrix

PostgreSQL is now also supported, as well as newer versions of MySQL, Oracle, and MS SQLServer. In addition, more operating systems are now supported. See the *HP OO System Requirements*.

New Features For End Users

Simplified Execution Gateway

In previous versions, end users were sometimes exposed to Central. However, since Central is oriented to administrators, they were exposed to much more information than they really needed and in some cases, this could harm the system.

HP OO 10.00 has a refined permission model, which enables setting the end user permissions accurately. The administrator can set up permissions to allow end users to use Central and only be exposed to the information they need, limiting their ability to harm the system.

In addition, HP OO Central 10.00 provides interactive execution capabilities and UI embedding capabilities, which allow the end user to interact with the system in a much more usable fashion.

New Features for Administrators

Roles and Permissions

The way that permissions are managed has changed in HP OO 10.00.

In HP OO 10.00, user groups for Central can be configured in Central only, and not from within Studio, as in previous versions.

We have separated between permissions for Studio, permissions for Central, and permissions for content.

- **Studio** – Permissions to perform actions in Studio have been removed from the application. Versioning of library items and configuration items is achieved via integration with a standard source control management system.
- **Central** – Permissions to perform actions and to view UI elements in Central are configured via roles.
 - A **Permission** is a predefined ability to perform a task. Central comes ready with a set of permissions that can be assigned to roles.
 - A **Role** is a collection of permissions. The administrator configures the roles (by assigning permissions to them) and then assigns the roles to users.

The administrator can configure both **View** and **Manage** permissions for the different roles. For example, setting up permissions for a **Promoter** role to both view and manage schedules, and for an **End User** role who can run flows but does not even see the Scheduler module.

The increased number of permissions enables the administrator to define exactly which parts of the Central web UI each role sees; thus, creating a dedicated UI experience for each group of users. For more information, see "Setting Up Security – Roles" in the *HP OO 10.00 Central User Guide*.

- **Content** – Permissions to access data (flows and folders) are also configured according to the roles, but this is done for individual flows or content folders, and not system-wide. This is done as part of the promotion of a content pack. The administrator can assign permission to a role to have **View** permission or **Run** permission for a flow or folder. For example, you might want to give users with the role **Promoter** permission to view and run the contents of a selected folder, and give users with the role **End User** permission to view the content only.

For more information, see "Managing the Flow Library" in the *HP OO 10.00 Central User Guide*.

As a result of these changes, there are some features from previous versions that are no longer relevant:

- Setting permissions on system accounts is no longer supported.
- Setting permissions on operations is no longer supported.
- Execution permissions are configured in Central, and no longer in Studio.
- Separate permission for HEADLESS execution is not supported.
- Authoring permissions (read\write\linked to) are no longer managed and configured in Studio.
- The user group terminology has changed: users groups have been changed to roles.

Promotion to the Central Server

Content packs are promoted to the Central server. The aim of promotion is to deploy a new content pack to the Central Production server, to make the flows available to users.

In addition to deployment, the promotion process also includes:

- Setting up the configuration items in the content: aliases, system accounts, and so on
- Setting permissions for the flows in the content pack
- Testing and troubleshooting the flows in the content pack

See "Promoting Content Packs" in the *HP OO Central User Guide* for more details.

Aliases: Separation Between Run time and Authoring

In HP OO 10.00, we understand that the author working in Studio does not always know which environment the content will be deployed upon. Therefore, we have created the concept of an "alias", which is created in Studio, and then mapped to the relevant value after the content has been deployed to Central. If the content is deployed to different Central nodes, the mapping can be done differently on each node, without the need to modify the original alias in Studio.

An author can create an operation in Studio, and give this operation a "group alias". After the flow is deployed in Central, the administrator maps the group alias to a worker group in Central. For more information, see [Configuration of Worker Groups and Group Aliases](#).

Workers

A worker is responsible for executing flows. The worker pulls tasks (executions) from Central and performs steps within these executions. This includes both invoking the actions and navigating between the steps of the flow.

Unlike a RAS in previous versions of HP OO, a worker in HP OO 10.00 processes all types of steps, and not only remote actions. Also, the communication direction of a worker in HP OO 10.00 is reversed from that of a RAS in previous versions. In previous versions, the Central server connected to the RAS server. In this version, the worker initiates the connection to the Central server. For more information, see "Components" in the *HP OO 10.00 Concepts Guide*.

Configuration of Worker Groups and Group Aliases

A worker group is a logical collection of workers. Having a group, rather than a single worker, enables workers to withstand a high action execution load, and increases availability of workers in a data center.

Group aliases let you separate between assigning an operation to a worker during authoring time and in the run time environment. At authoring time, the flow author defines an operation to run on a group alias rather than a group. When the content pack is imported to Central, the administrator maps the alias to a group in the run time environment. There is no need to edit the flows and modify the worker assignment manually. For more information, see "Worker Groups and Group Aliases" in the *HP OO 10.00 Concepts Guide*.

Simpler RAS Management

HP OO 10.00 uses a group mechanism that separates between the logical notion of the target RAS (which is what the author is aware of) and between the physical notion of the target RAS (which is what the administrator is aware of). For every environment, the administrator can map between the logical and physical notions. Therefore, promotion of content between environments does not require adjustment, and the addition of a RAS does not require going back to the author.

In previous versions, the content had to be aware of the target RASes. This meant that when content was promoted between environments (for example Dev, Staging, and Production), it required adjustments. Therefore, the content was not identical between environments and tests results were not definite. An administrator who wanted to promote the content to the Production environment needed to have authoring knowledge or had to go back to the author to make this change. When a RAS needed to be scaled out to allow high availability or improved performance, it had to be added with a load balancer, and the content had to be adjusted again.

Live Scale Out

In HP OO 10.00, you can add a component without restarting the other components. You simply add it to the system in a live manner. Since the Central cluster is no longer based on Terracotta, you just add a new instance and point it to the database. You can scale out RASes via a new grouping mechanism, which means that there is no need for a load balancer for the RASes.

The run time repository was combined into the database, which means there is no need to manage a shared file system for clustering and improving the cluster's stability.

In previous versions, adding a component to the system required a restart of the system components. Terracotta needed to be updated and restarted as well as the Central nodes. If RASes were scaled out, it was required to use a load balancer and adjust the flow.

High Performance

HP OO 10.00 has an improved execution mechanism, which enables you to reach higher performance. HP OO 10.00 is faster than previous versions.

Highly Parallelized Runs

HP OO 10.00 has an asynchronous execution mechanism, which enables large bursts of executions. HP OO 10.00 supports launching 100 flows/second and there is no limit to the number of parallel executions.

In previous versions, the execution mechanism was based on synchronous execution, so the number of parallel executions was limited by the number of the system threads (with a default of 300).

Automatic Content Distribution

In HP OO 10.00, content binaries are automatically distributed to the various RASes. When there is a change in their version, the system automatically distributes them to the relevant RAS upon their first use.

In previous versions, content binaries needed to be distributed manually to the various RASes. You needed to make sure that before executing the content, the binaries of the correct version are in the relevant RASes.

Isolated Content Dependencies

HP OO 10.00 enables you to use a different third party version for every content pack. You can use your own third party versions and this is not affected by HP changing the out-of-the-box version. The only limitation is regarding dependencies that are shared between the plugin and the platform.

Previous versions used a single version of a third party library for all repository operations. This meant that you could not use your own version of the third party library, due to collisions with the out-of-the-box version. In addition, every new HP content pack that was deployed posed a risk, because it could change the out-of-the-box version and break the dependencies of your operations.

Authentication via LDAP Integration

If you have an LDAP service for authentication, you can add the LDAP configuration to Central, in the Central UI. This enables the Central security feature and users will need to be authenticated to use the system. This change is dynamic—there is no need to restart Central for the change to be applied.

When the next user logs in to Central, they will need to enter their user name and password, as required by the LDAP authentication.

The way that LDAP is configured in HP OO 10.00 is different from previous versions:

- In HP OO 10.00, you need to specify the port for the LDAP host.

In previous versions, it was possible not to specify the port for the LDAP host, and Central would use the default port.

- In HP OO 10.00, you can configure multiple LDAP hosts by entering multiple values in the **Host**

and **Ports** fields, with semicolons as delimiters. This saves time, because you don't need to enter the same information into multiple windows.

In previous versions, the way to configure multiple LDAP hosts was by opening multiple LDAP windows with different IP addresses.

- In HP OO 10.00, if the LDAP connection is lost, there is no need to restart Central. If there are multiple LDAP hosts configured, Central will connect again. If the first LDAP host is down, after three seconds, Central will try to connect to the second one that was configured.

In previous versions, Central was bound to the LDAP connection, so if the LDAP connection was lost, it was necessary to restart Central.

Internal Users

As an alternative to LDAP authentication, it is possible to configure internal users in Central. Internal users can log in using their user name and password, and do not require external authentication. When an internal user and user with LDAP authentication with the same role are logged in, there is no difference between them.

Note: Using internal users is considered low security. For example, there is no password policy in place. If you require high security, you should use LDAP authentication.

Dynamic Login

If no authentication is configured, users will be able to enter Central without authentication. If authentication is configured, users will need to log in with authenticated user names and passwords—there is no need to restart Central for the change to be applied.

Modernized Extension Development

Java extension development is now Java annotation-driven and provides classpath isolation. See the *HP OO Action Developers Guide* for more details.

Changes in on-Fail Error Handling

If the **on-Fail** option is *not* selected in a step, when a run time exception occurs in an action or scriptlet, or relating to input or output assignment, the flow will fail to complete

If the **on-Fail** option *is* selected in a step, when a run time exception occurs in an action or scriptlet, or relating to input or output assignment, the flow finishes, and does not terminate in the middle of the flow.

In previous versions, when a run time exception occurred in an operation, the flow finished at the point where the run time exception occurred.

In HP OO 10.00, the **on-Fail** option for a response relates to all exceptions, for example, exceptions relating to input or output assignment, or exceptions that occur in the step scriptlet. In previous versions, it only related to exceptions in an operation.

Scheduling Personas

In HP OO 10.00, the user that creates the schedule is the one that is designated as the schedule owner. When the scheduled flow is run, this user is also the owner of this flow execution (who performs the scheduled run). This means that the same user is both the schedule owner and the executor.

In previous versions, there were two different scheduling personas:

- The **Schedule creator** was the user that created the schedule.
- The **Schedule executor** was configured from within the Administration settings (under **Administration > System Configuration > Scheduler > Scheduler Settings**) and this was the user that performed the scheduled run.

New Features for Authors

Standalone Studio

HP OO Studio functions as a standalone integrated development environment (IDE).

In previous versions, Studio required a connection to a live HP OO Central. The Studio login and many repository operations used this connection, which made it difficult to work in remote teams. In some cases, a cross-site connection was not allowed and in other cases, such operations were very slow.

In HP OO 10.00, Studio is a standalone tool that doesn't require a connection to Central. All of its repository operations are available offline. This results in improved performance and enables distributed work. If a source control interaction is required, you decide when the interaction occurs. Remote teams can use various standalone Studios, and it is possible to author flows outside of the office network.

Standard Source Control Integration

In previous versions, Studio included its own proprietary version control capabilities, which were limited by definition. It was not possible to connect to and use your organization's source control software.

HP OO Studio 10.00 is integrated with a standard source control software. The out-of-the-box solution is based on a commonly used source control application (SVN). This means that the capabilities of source control software are available for Studio, so you can connect to and use your organization's source control software. This also means that the automation code can reside together with other source codes (automation as code).

In HP OO Studio 10.00, the proprietary version control capabilities (check-in and check-out operations) have been removed. These have been replaced by the source control integration. When an author makes local changes, the local history is displayed as it was in previous versions.

For more information, see "Working With Source Control" in the *HP OO Studio Authoring Guide*.

For more information about the differences between source control management between HP OO 10.x and 9.x, see "Differences in Flow Behavior After Upgrading" in *Upgrading to HP OO 10.10 from HP OO 9.x*.

Multiple Authors and Multiple Geographies

In HP OO 10.00, Studio is offline and leverages standard source control software to enable sharing work between multiple and distributed authors.

In previous versions, the capabilities of Studio were limited in regard to multi-authoring and multi-geographies. For example, Studio required a constant connection to Central, and collaboration capabilities were limited by the proprietary version control.

Fine-grained HP Content

The HP OO 10.00, content is broken down into a set of content packs, each for a different area of functionality. You have better control over which content packs to download and which to deploy. You can use only what you really need.

In previous versions, the HP content was provided as one big repository. This meant that you did not have control over what was downloaded and deployed. Content versions included much more content than you needed, and imposed risks on the deployment. Content versions could unintentionally affect your entire content.

Fine-grained Customer Content

In HP OO 10.00, the customer content can be separated into projects and managed separately for each author or author group. This gives you complete flexibility in defining the flows that are grouped together and defining the workspace of each author. In this manner, different authors get a focused development environment just with their relevant flows and don't affect other authors' flows.

In previous versions, the customer content was kept in one big repository. This meant that different groups needed to work simultaneously on the same large repository. This meant having to find ways to avoid collisions and manage permissions. Individual authors didn't get a focused development environment with just their own flows.

Projects Pane and Dependencies Pane

There are two new panes in Studio 10.00:


- **Projects** pane, which shows the projects you're working in, and displays the editable flows, operations, and other objects.
- **Dependencies** pane, which shows the available content packs, and displays the read-only flows, operations, and other objects.

These two new panes replace the **Repository** pane and the **My Changes/Checkouts** pane from previous versions.

See the *HP OO Studio Authoring Guide* for more details.

Renamed check box in the Input Editor

In the Input Editor, the **Encrypted** check box has been renamed to **Obfuscated**. There is no change in the functionality, but the label is a more accurate description.



Credential Type

In HP OO 10.00, inputs of the type **Credentials**, which use a system account, must be defined as referring to either a user name or a password. There is a new field called **Credential Type**, with the options **Username** and **Password**.

New Way of Creating Operations: Soft Copy

In HP OO 10.00, there is a new method for creating new operations.

In previous versions, you could create operations from built-in operations in Studio. This is no longer possible, and there is no **New Operation** menu item. There are no longer operation types—WebOp, SSH, Telnet, and so on.

In HP OO 10.00, you can create operations by copying and modifying existing operations, or by creating an action plugin in Java and importing that action plugin.

When you create an operation by importing a Java action plugin, the copied operation continues to reference the original operation. So if the original operation is updated to link to a new version of the action plugin file, the copied operations are all updated automatically. This is known as a "soft copy".

Note: If you want to have two operations that are based on two separate versions of the action plugin file, you need to create two operations. This cannot be done by copying an existing operation.

For more information about creating an operation, see "Creating Operations" in the *HP OO Studio Authoring Guide*.

No Separation Between Headless Runs and Those Started Within the Central UI

In HP OO 10.00, "headless" runs (which are started outside of Central) and flows that are run from within the Central UI are treated in the same way.

In previous versions, there was a separation between these types of run.

Multi-instance Steps

Multi-instance steps now reside within a multi-instance branch. You simply select the **Multi-**

instance  icon on the **Step** palette and drag it onto the authoring canvas. You then add one or more subflows or operations to the multi-instance branch, and set multiple targets for the step via an input list of values.

Each of the inner steps inside the multi-instance step will run multiple times, once for each target that is set.

The new approach is more consistent with the parallel execution visualization and capabilities. See the *HP OO Studio Authoring Guide*, and the *HP OO Content Upgrade Guide* for more details.

Changes in behavior with multi-instance steps:

- In HP OO 10.00, the multi-instance step inputs behave the same as a regular step. If you remove an input (that was declared in the operation) from the multi-instance step, then it won't be calculated.

In previous versions, you could not remove operation inputs from the inputs of a multi-instance step (unlike a regular step).

- The whole structure of the multi-instance step has changed. There is now a multi-instance branch. So there are also changes in the multi-instance step properties.
- The multi-instance branch step scriptlet and results run N times (as a number of multi-instance instances).
- The results and scriptlet for all the inner steps (inside the multi-instance branch) will run once for each multi-instance branch run, meaning N times at total.
- Using a multi-instance step inside a parallel lane does not work. This cannot be created in HP OO 10.00 Studio, and will not pass migration. It is supported as a subflow step in parallel lane.
- A multi-instance step that has a transition to a parallel step (or another multi-instance step) that is not a "group done" transition, will also not pass migration, and will not work in HP OO 10.00.
- Multi-instance steps no longer support termination of the flow within the multi-instance step.

Two XML Files

The flow XML has been split into two XML files, in order to improve the readability of the files:

- Advanced Flow Language (AFL), which defines the structure of the flow.
- Graphical Hierarchical Language (GHL), which describes the position of the graphical flow components in the Studio layout.

Both languages provide an XML schema (XSD). For an example of the XSD, see the *HP OO Application Program Interface (API) Guide*.

Numeric Values Keep Their Original Form in Scriptlet Context

In HP OO 10.00, the string retains its original form. In previous versions, when a numeric value was put in a scriptlet context and retrieved back, it was changed to a string representation of float, which could lead to unpredictable behavior.

For example, in the following script:

```
var n = 1;
scriptletContext.put("numericValue", n);
```

- In HP OO 10.00, the context holds the original string "1"
- In previous versions, the context held the string "1.0"

Note: Putting a float variable on the context is the same in HP OO 10.00 and in previous versions. In both cases, the float will keep its original form (for example, "1.1").

Scriptlet Context is Read Only

In HP OO 10.00, scriptlet filters have read-only access to the `scriptletContext`. Using `scriptletContext.put/putGlobal` has no effect outside of the script run. This change helps to enforce good practices, so that filters are only used for filtering values.

In previous versions, it was possible to change/add data to the `scriptletContext` in scriptlet filters.

ScriptletContext.get() Looks in Local Context First

HP OO 10.00 looks for the value in the local context first and will only look in the global context if the value is not available. This enables the flow to override variable values at run time and is more intuitive.

In previous versions, when a script called `scriptletContext.get(<paramName>)`, HP OO would first look for the `<paramName>` value in the global context, and would only look in the local context (in the flow or step) only if no value was found.

Automatic Initialization of Variables

In HP OO 10.00, non-existing variable references are initialized with an empty string "", instead of "\${var}".

In previous versions, if `${var}` syntax was used in a value field, and `${var}` was not initialized in the flow, HP OO used the literal string "\${var}" as the value for variable substitution. This literal substitution in the parameter could result in confusion or errors in the flow.

Note: In HP OO 10.00, the \$ symbol is used as an escape character. So that if you previously had a literal string "\${var}", you can add another \$ symbol to maintain the original string. If you use "\$\${var}", this will be "\${var}" in execution.

Updated Script Engine

HP OO 10.00 uses the Rhino 1.7R3 script engine, while earlier HP OO versions used Rhino 1.7R1.

This may affect scriptlets, because Rhino 1.7R3 requires the symbol “;”.

For example, the following scriptlet would work in previous versions, but will not work in HP OO 10.00:

```
if ( (scriptletContext.get("glob1") == "1,2,3") || (scriptletContext.get
("glob1") == "1") || (scriptletContext.get("glob1") == "2") ||
(scriptletContext.get("glob1") == "3") )
scriptletResponse = "success"
else scriptletResponse = "failure"
```

In HP OO 10.00, you would need to change the scriptlet to be as follows:

```
if ( (scriptletContext.get("glob1") == "1,2,3") || (scriptletContext.get
("glob1") == "1") || (scriptletContext.get("glob1") == "2") ||
(scriptletContext.get("glob1") == "3") ){
scriptletResponse = "success";
}
else scriptletResponse = "failure";
```

In addition, error messages thrown by scriptlets may differ slightly from those in previous versions, because of the newer Rhino script engine.

Note that Sleep scripts are deprecated.

Annotation-based Content

HP OO 10.00 adds '@Action' annotations that can be added directly onto your custom code. This means that your code can now be leveraged to be HP OO content and still be tested in the context of the customer development framework.

Previous versions provided an 'IAction' mechanism to create custom content. You had to implement that interface and test it within the HP OO application context.

Changes in Behavior in Studio

Because of the differences in behavior between HP OO 10.00, some flows may not work properly after content upgrade. For more information, and for suggested solutions, see the *HP OO 10.00 Content Upgrade Guide*.

- The Debugger displays only selection lists that are relevant for the flow, rather than all of them.
- The **on-Fail** rule in a response now takes into account exceptions that occur in the step scriptlet, and exceptions relating to input or output assignment.
- There is no longer a **Step Results (Deprecated)** section under the **Advanced** tab in the Step Inspector. After content upgrade, results in this section are moved to under the **Results** tab. See the *Content Upgrade Guide* for more details.
- In previous versions, it was possible to take the name of a selection list or system property and use it in an input title, in the format `${<name>}`. For example, `${Boolean}`. This is no longer

possible for selection lists. After content upgrade, each selection list is copied as a system property, in order to maintain backwards compatibility. See the *Content Upgrade Guide* for more details.

- In previous versions, some types of operations included built-in field values, but these are not supported in HP OO 10.00. For example, in the loop operation in previous versions, there were two inputs, **count** and **reset**, and two fields, **from** and **increment by**, to specify the starting count and increment. After content upgrade to HP OO 10.00, the fields are converted into regular inputs. See the *Content Upgrade Guide* for more details.
- In 10.00, there is a new **Categories** folder in the **Configuration** folder. In previous versions, there was a domain term called **Categories**, which contained different classifications of a flow. After content upgrade, the items that previously appeared as rows in the **Categories** domain term now appear as separate items in the **Categories** folder. See the *Content Upgrade Guide* for more details.
- Non-existing variable references are initialized with an empty string "", instead of "\${var}". See the *HP OO 10.00 Concepts Guide* for more details.
- In selection lists and domain terms, values cannot exceed 255 characters.

Changes in Behavior – Flow and Step Inputs

- The assignment chain has been changed. For example, in the following scenario of flow inputs:

Name	Type	Required	Encrypted	Assign from	Otherwise	Assign to	Value in execution
Input 1	Single Value	false	false	Input 1	Prompt user	Input 2	myhost
Input 2	Single Value	false	false	Input 2	Prompt user	targetHost	localhost

In previous versions, in the flow context, the result would be the variable "targetHost" with the value "localhost".

In HP OO 10.00, the result is the value "myhost".

- Inputs available when triggering a flow has changed. When you ask for the inputs of a flow (using the Rest API), it will show you only the inputs that have the same input name as the input "Assign From" parameter (as declared in Studio).
- Step inputs - assigning outputs with a filter.

In HP OO 10.00, all the output values are processed with their filters, so even if an output is not mapped to a flow result, the flow will fail if the filter throws a run time exception.

In previous versions, if a step output was not mapped to the flow result, its filter would not be processed. For example, if you have an output field filter that can cause a run time exception for some step result values, it won't fail the flow as long as that step output field is not mapped to a flow result.

- The transition of encrypted fields has been changed according to the following logic:
 - If an encrypted field is passed along to a non-encrypted field, it will be shown decrypted.
 - If an encrypted field is passed to the flow result, it will be shown decrypted.
 - If a steps' encrypted field is assigned to another steps' encrypted field, it will remain encrypted.
 - In general, when a field is in a step/operation/property that is marked as encrypted, it will not be shown. Otherwise it will be shown.
- In HP OO 10.00, the author needs to choose which attribute to extract from the logged in user. In addition, the password is never used for security issues, and will always be prompted .

In previous versions, the logged in user was an object consisting of the user name and password, and assignment took place according to the name of the input. For example, if the input name was "user name", the user name would be extracted from the object.

- In HP OO 10.00, the credentials input type does not exist and instead, the user will have to use the regular prompt input (and check it as encrypted).

In previous versions, the credentials input prompt was an object consisting of the user name and password and a message was prompted during run time to insert both.

- It is no longer possible to set the flow input as "not assigned" otherwise "fail". After content upgrade, these inputs will be modified to single value, otherwise "prompt".

Changes in Behavior – Exception Handling

- If an exception is thrown anywhere during flow execution, from an action\scriptlet\internal execution step, then the following logic applies:

If the author checked the **On Fail** flag on one of the operation responses, the flow will continue to run regularly (on all the execution steps) and chooses the transition mapped to this response. This will also be the case if the exception was thrown in the operation scriptlet or the step scriptlet.

If the author didn't check the **On Fail** flag on any response of the operation, the flow will stop its execution at the execution step that threw the exception in any case except for the following:

- If the author checked the **Toggle single response** option on the step, the flow will continue to run to the next step.

- If the exception was in a parallel \ multi-instance step, the branch with the error will stop execution. The other branches will finish (reach the end of the branch), and then the flow will stop execution.
- If the exception was in a sub-flow, the child and parent flows will stop the execution.
- If the **Default** check box is selected on one of the responses, the behavior is now different. In previous versions, the flow would continue to run to the transition mapped to the default response. In OO 10.0, we stop the execution of the flow in the execution step that the exception was thrown from, and end the flow.

In all the cases above for which the flow stops running, it will reach termination in an organized manner with a `FLOW_RESPONSE_TYPE=EXCEPTION`.

Changes in Behavior – Rules

- The following behavior of rules was redesigned in HP OO 10.0 to behave as follows:

Input 1	Rule Type	Input	Result in Previous Versions	10.0 Result
5abc	=	5iop	true	false
Two	>	Two	true	false

In general, if one of the inputs is not numeric, HP OO does lexicographic comparison.

Changes in Behavior – Scriptlets

- HP OO 10.00 uses the Rhino 1.7R3 script engine, while earlier HP OO versions used Rhino 1.7R1. This may affect scriptlets, because Rhino 1.7R3 requires the symbol “;”.

For example, the following scriptlet worked in previous versions, but will not work in OO 10.0, because of the missing “;”:

```
if (scriptletContext.get("glob1") == "1,2,3")
scriptletResponse = "success"
else scriptletResponse = "failure"
```

You can fix the scriptlet like this:

```
if (scriptletContext.get("glob1") == "1,2,3")Unknown macro: {scriptletResponse = "success";}
else scriptletResponse = "failure";
```

- Error messages thrown by scriptlets may differ slightly from those in previous versions, because of the newer Rhino script engine.

- Scriptlet filters have read-only access to the `scriptletContext`. Using `scriptletContext.put/putGlobal` has no effect outside of the script run.
- `ScriptletContext.get()` looks in local context before looking in global context.
- In HP OO 10.0, when a script calls `scriptletContext.get(<paramName>)`, the system first looks for the value in the local context and only if the value is not available, it tries to fetch it from the global context. This is done in order to allow the flow to override variable values at run time. Also, it is more intuitive.

In previous versions, when a script called `scriptletContext.get(<paramName>)`, the system would first look for the `paramName` in the global context, and only if no value was found, it would look for the `paramName` in the local context (flow/step).

- In HP OO 10.0, when a numeric value is put in the scriptlet context and retrieved back, the string keeps its original form. In previous versions, it was changed to a string representation of float. See ["Numeric Values Keep Their Original Form in Scriptlet Context "](#) on page 63.

Changes in Behavior – Filters

In the **XML Get Attribute** filter, you can set the attribute name whose value you want to extract. You can also leave it empty, and then OO returns all the attributes in the given path.

In HP OO 10.0, the attributes are returned in the same order that they appear in the XML. In previous versions, they were returned in the opposite order.

For example:

Working on the following XML, if a user didn't set the attribute name, but only the path: `"tickets/ticket/details/comment/"`.

Changes in Behavior – Non-blocking Steps

- In HP OO 10.00, the flow will wait for all non-blocking steps to terminate. The flow execution will remain in progress until then.
- In HP OO 10.00, a non-blocking step will run in parallel with the rest of the flow. This includes input binding, scriptlets, operation, and filters. The entire step is parallel as opposed to the behavior in previous versions where just the operation was parallel.
- In HP OO 10.00, a subflow with a non-blocking step will not terminate until all its non-blocking steps end.

New Features for Integrators

Complete REST API

HP OO 10.00 provides a complete REST API to the entire set of Central functionalities. Every functionality that is exposed in Central is practically implemented over a public REST API, enabling you to utilize the same set of APIs to integrate your systems with HP OO.

Previous versions provided a sets of APIs (SOAP, REST, and so on) that covered mostly the execution functionalities. Integrators who needed to integrate their systems with HP OO were limited with the API capabilities.

Some of the RESTful APIs and SOAP APIs from previous versions are not supported in HP OO 10.00.

Embeddable

HP OO 10.00 is provided not just as a standalone application but also as a WAR file. You can embed it in your application servers and do not need a separate service and management for HP OO.

Previous versions is installed as a standalone application. If you wanted to OEM the application, you needed to 'bundle' it. This meant that it included its own service and required its own management.

For more information about the differences between HP OO 10.x and 9.x, see "Differences in Behavior After Upgrading" in *Upgrading to HP OO 10.10 from HP OO 9.x*.





The recommended approach to revert to a revision before 10.x is to revert the entire project to that revision.

Load Balancer Troubleshooting

Limitations

Upgrading, Rollback, and Installation Limitations

<p>In some cases, after an upgrade to HP OO 10.5x, it is not possible to remove steps in multi-instance flows, and it is required to create the flow from scratch.</p>
<p>After an upgrade to HP OO 10.5x, if an operation was linked to a custom IAction and you do not provide the IAction, this operation is not found by the search functionality.</p>
<p>After an upgrade to HP OO 10.5x, the following files are deleted:</p> <pre><OO_HOME>\ras\lib\ext\ <STUDIO_HOME>\lib\ext\ <OO_HOME>\central\tomcat\temp\ext\</pre>
<p>HP OO 10.5x uses a different version of Quartz for scheduling than earlier versions. Therefore, if you roll back from 10.5x to an earlier version, you will need to delete all schedules that were created or updated in 10.5x.</p>
<p>If the last deployment action prior to an upgrade was the deletion of a content pack, the rollback will not work.</p>
<p>If you are rolling back from 10.20 and later to an earlier 10.x version, some types of configuration items located under sub-folders will be deleted. This occurs when you have multiple configuration items with the same type and name (in different folders).</p>
<p>HP OO 10.x does not support 32 bit platforms. If you have an earlier version of Studio installed on a 32 bit platform, you will not be able to upgrade this installation to 10.x. You will need to uninstall Studio and install it again on a 64 bit platform.</p>
<p>When upgrading from an earlier version of 10.x or rolling back to an earlier version, you must cancel or finish all paused or running flows and disable existing schedules before applying the upgrade/rollback. If there are flows running or paused when you perform the upgrade/rollback, it will not be possible to resume them and the upgraded executions will be canceled.</p>
<p>If you have upgraded to a certain 10.x version and have Central installed in a cluster, you must upgrade each node of the environment by turn to bring them to the same version. Any nodes that are not upgraded will fail to start.</p>
<p>When upgrading from a remote 9.x Central that has localhost as the database in the Central.properties file using a silent installation, installation and upgrade do not complete successfully. This problem does not exist for wizard installations.</p>
<p>When you run upgrade on a schedule with a simple trigger, the upgraded schedule may have a different time zone.</p>

During historical-data upgrade to HP OO 10.x, flow inputs and outputs are not upgraded from previous versions for historical data. Only the flow result is migrated.

When upgrading a schedule with a start date in the past, the start date will be overridden with "now". This may also affect the number of occurrences.

After an upgrade to 10.x, and rollback to 10.00, the system accounts disappear.

In certain cases it can happen to receive an **Invalid File** message during the installation of the licenses, even if the license file is valid. In this case, you may try again few times until the license is successfully deployed.

Studio Limitations

GIT Limitations

- Renaming a flow deletes all the committed history.
- In GIT, reverting a flow to a previous commit fails for the following scenario:
 - a. Create a project with an empty folder and a folder containing a flow.
 - b. Commit it.
 - c. Move the flow to the empty folder.
 - d. Commit again.
 - e. Go to source folder's history and revert to the commit before the move. The destination folder still contains the flow.
- When you add new flow after deleting a flow from the same folder, Git will mark the added flow as renamed. This occurs if the flow names are more than 50% similar. This is a known limitation in Git. For more information, see <http://stackoverflow.com/questions/433111/how-to-make-git-mark-a-deleted-and-a-new-file-as-a-file-move>
- After deleting an operation from a folder, it is shown in the **SCM Changes** pane with a deleted flow icon and not an operation icon.
- After checking out a branch, you need to manually refresh the imported project. This action has to be done if before the checkout, there was at least one rename action.
- Conflicts with a situation "project deleted by us and flow modified by them" are not handled correctly in Studio.
- After creating a new branch in Git, and committing changes from that branch, when you try to push changes to the remote Git repository, the Push Commits window appears without the list of files to be pushed.

- In some cases, authors may have items with duplicate UUIDs in their projects. In these situations, when the author tries to perform a rebase, the operation may not succeed. In this case, the author will see items in the **SCM Changes** pane with a blank status. In order to end the rebase cycle, the author should skip the commit or abort the rebase.

- Unstash does not work properly if there are changes between the stash and the unstash.

If there are differences between the files of a stash commit and the same files in the workspace when unstashing that commit, then when unstashing, Studio will prefer the stash commit version during a merge operation.

- If you modify a configuration item and then move it to another folder, the item is not recognized in Git as moved, but as deleted and added. This is a limitation of Git.

Subversion Limitations

- When working with SVN source control, it may happen that an item appears as locked in Studio while this is not actually true, in the repository.

This is an SVN error. After being renamed, an item has the status 'replaced'. At commit time, all locks should be released. However, for the replaced item, the lock is released but the status displayed is not accurate.

- By default, SVN has a list of file patterns (shown below) that are ignored when non-versioned files are added to SCM:

```
*.o *.lo *.la *.al .libs *.so *.so.[0-9]* *.a *.pyc *.pyo
```

This means that a non-versioned project or folder that matches one of these patterns is shown as black (as if it is versioned) in the **SCM Changes** panel. However, you can still add the project or folder to SCM and work with them as usual.

- If you rename an item inside a folder and commit it, and after that you rename the folder containing the renamed item and try to commit the folder, an SCM error message will appear. With SVN 1.8, the scenario fails when you try to rename the parent folder, with the following error:

try updating it first.
```

- In some situations, the move functionality doesn't work properly on SCM. For example, when one user moves a folder from one project to another and commits the changes, if a different user moves that folder back to the first project in any path, an error message is displayed.
- In the **SCM Messages** pane, the messages coming from the Source Control Management client tool may contain an encoded URL. This is the repository URL in a standard encoded form. The message is coming from an external SVN client tool used by Studio (SlikSVN).

Note: For information about URL-encoding or percent-encoding, see <http://en.wikipedia.org/wiki/Percent-encoding>.

- Note that a non-encoded version of the URL (the same URL that was entered when the **Checkout** button was clicked) is also logged in the **SCM Messages** pane.
- If you rename an item inside a folder and commit it, and after that you rename the folder containing the renamed item and try to commit the folder, an SCM error message will appear.

This is a limitation of Apache Subversion, which is a third party SCM tool. For more information about the progress of this limitation, please contact Apache.


General SCM issues

In some situations, the move functionality doesn't work properly on SCM. For example, when one user moves a folder from one project to another and commits the changes, if a different user moves that folder back to the first project in any path, an error message is displayed.

In Studio, the € sign is not supported in names of elements, such as flows, configuration items, operations.

Studio SCM does not support conflicts and merging. You need to lock an item before starting to edit it. If a flow is already locked, you must wait for the lock to be released, before editing the flow.

If you try to lock an out-of-date item in an environment with multiple authors, the following dialog box appears:



If you select **Update Item and Perform Lock Action**, inconsistencies may occur in your project. To resolve this issue, you need to manually refresh your project.


If the item was previously moved or renamed by a different author in another Studio, you should also update the workspace. To update the workspace, from the **SCM** menu, select **Update All**.

Note: It is recommended that you always update your workspace before editing existing items.

Note: To refresh a project, select the project and click the **Refresh** button in the toolbar or right-click on the project and select **Refresh**.



In a multi-authoring environment, when you move items between two projects, the following message may appear:



In these cases, it is recommended to manually refresh the destination project.

Note: To refresh a project, select the project and click the **Refresh** button in the toolbar or right-click on the project and select **Refresh**.



In a localized installation, some of the text in the **SCM Messages** pane may appear in English. This is because the message comes directly from the SVN/Git client tool.

Remote Debugger

- When running a flow with multiple steps and increased context in the Remote Debugger, the "GC overhead limit exceeded" message appears in Studio, even though the run completes successfully.
- In the Remote Debugger, if a flow contains a prompt title that is longer than 128 characters, everything past the 128 character limit is ignored.

Localization Limitations

In a Chinese Studio environment, internal users, configuration items, and run names may be sorted incorrectly.

In a Chinese Studio environment, the inputs are sorted using Chinese dictionary sorting. In some cases, this might lead to inaccuracies in sorting.

The date format for the Scheduler and Run Management is wrong in the Chinese and Japanese environments.

The following items may not be translated:

Folders, flows, operations, steps, transitions, callouts, LDAP configuration error messages, and Remote Debugger error messages.

This is due to third party elements that cannot be localized.

If you are planning to localize HP OO to Japanese or Chinese, it is recommended not to use an MS SQL database, but to use an alternative such as Oracle, MySQL, or Postgres.
Foreign languages are not supported in OOSH.
Many Japanese words are not correctly searchable in the Studio Search pane "description" list.
The Read file sample operation in the Base content pack cannot handle the localized characters. For localized files that are sent as inputs (containing special characters for languages such as French, Japanese, Chinese, German, and Spanish), be aware that Studio uses an UTF-8 file encoding. Other file encodings might not be recognized. It is recommended to use UTF-8 encoding for the mentioned files.
Some button items are not translated in the Create Content Pack wizard, due to a third party limitation.
Some items are truncated in the Create Content Pack wizard, due to a third party limitation.
The validation message is not translated when an input cannot be evaluated with System Evaluators.
Some GIT related messages are not localized in the SCM Messages pane, due to a third party limitation.

API Limitations

The APIs Delete flow schedule and Enable flow schedule return 200 for non-existent schedules, instead of returning 404 Not Found (like GET /schedules/123).
The GET/group-aliases REST API returns group aliases that are mapped into groups.
When using the 9.x backward compatibility APIs in SOAP, if an authentication failure occurs and auditing is enabled in the system, there will be more than one record audited for the failure. The types of the records may be AuthenticationFailure and AuthorizationFailure , and the data of the record might not describe the expected operation that was performed. These records may also appear when correct credentials are passed and the operation succeeds.
It is not possible to run CloudSlang flows from the HP OO Shell Utility (OOSH), because OOSH uses an older version of the APIs.

Central Limitations

When cloning or editing schedules, it is possible to save a schedule with an invalid end-by date. For example, if the end-by date is set to the current date.
Canceled steps/flows may appear to be still running in API calls.
If authentication has been enabled in Central, you cannot log in with a user that has a colon as part of the user name. This is also the case when logging into Central for remote debugging.

In the Run Explorer, the **User** filter may return unrelated results, when searching for internal users. This occurs because the user is stored in the database as "domain\user", and the filter also searches for the domain.

For example, if a user stored in the database is "MYDOMAIN\MyUser" and you use a filter of "DOM", the filter will show this user, even though the user name displayed in the Run Explorer is only "MyUser".

When entering extra text to be displayed in the Central header title after "Operations Orchestration", the maximum number of characters that can be entered is 30 for Latin letters and 19 for double-byte letters.

Changing the machine time may cause Central executions to get stuck in the **Running** state. This is due to a limitation in the HP OO timer mechanism.

On MySQL, that the paths of HP OO entities (flows, operations, and configuration items) must be limited to 243 characters, when deployed to Central.

Using paths longer than 243 characters may cause failures during content pack deployment/deletion. Note that the length limit is on the full entity path, starting with "Library" or "Configuration" and ending with the file extension (for example, ".xml").

In the Run Explorer, the **User** column filter considers the domain, (in the following format: domain/user name).

The Central Scheduler does not work when SAML authentication is used.

There is a limit to how many groups an LDAP user can have. Users who are members of more than 1,015 groups may fail logon authentication.

If you are going to embed the Drill Down window into an external HTML page, it is recommended to have an SSO solution in place (for example, SAML 2.0). If an SSO solution has not been configured, an HP OO login screen will appear in the iframe, when it first loads inside the page. On some browsers (for example, IE11), the default privacy settings will need to be updated to allow third party cookies before users will be able to log into HP OO via the iframe .

While you can edit existing configuration items in Central 10.x, it is not possible to create new ones. New configuration items can only be created in Studio.

There are limitations to the way that Central enforces path uniqueness:

- Unlike Studio, Central enforces path uniqueness for certain item types only – namely, flows and the specific configuration item types that are supported by the REST API **/v1/config-items**. For more information, see the *HP OO API Guide*.
- Unlike in Studio, paths are case-sensitive in Central. This means that Central may not detect a conflict between "my item" and "My Item", for example.

<p>In the case of failure, the Central and RAS recovery mechanism will re-run a step that was not completed when the failure occurred. This may cause duplication of the some of the steps' logging, which is reflected as duplicated fields in the UI.</p>
<p>In the Chrome browser, after deployment, it is not possible to delete the folder containing the content pack. This is a limitation in the browser.</p>
<p>Short database disconnections might cause running flows to fail to complete (to end with the status Failed To Complete). If this occurs, run the flow again.</p>
<p>In a clustered environment, the clocks on the different machines must be synchronized using some form of time-sync service (daemon) that runs regularly. The clocks must be within a second of each other. For instructions on how to do this, see http://www.nist.gov/pml/div688/grp40/its.cfm.</p>
<p>SSO Kerberos authentication is not currently supported.</p>
<p>Descriptions (for example, of flows or inputs) that are longer than 4,000 bytes are truncated, so that only part of the description is visible.</p>
<p>When you use the Operations Orchestration Shell (OOSH) to run HP OO commands from the command line, if the trigger command fails, a general message is displayed, instead of a specific one.</p>
<p>Restarting a Linux Central machine does not automatically start Central. Setting a service to start automatically on Linux depends on the Linux flavors.</p>
<p>LDAP group membership is only supported when the group membership field value is a DN.</p>
<p>LDAP referrals are not supported. If a user tries to log in or tests the LDAP configuration with a user that is in a referral LDAP, a message appears, saying that the user was not found.</p>
<p>Note: When you upgrade from a version of HP OO 9.x that contains LDAP configured with referrals, there is no warning about referrals no longer being supported in 10.x.</p>

With Open LDAP, in some cases, user groups are not fetched. This occurs because in Open LDAP, the membership attribute contains the UID and not the DN.

memberUID contains the user's UID while **member** contains the user's DN. This is one of the main differences between RFC2307 and RFC2307bis.

More applications are moving toward support for RFC2307bis, because it offers faster LDAP browsing when retrieving additional attributes.

In LDAP, there are two common ways of grouping users:

- **posixGroup**: Uses the **memberUid** attribute, which contains only the value of the UID of a user's full DN. For example:

```
cn=SomeGroup,ou=Groups,dc=example,dc=com
```

```
memberUID: someuser
```

- **groupofNames**: Uses the **member** attribute, which contains the full DN of the user. For example:

```
cn=SomeGroup,ou=Groups,dc=example,dc=com
```

```
memberUID: uid=someuser,ou=People,dc=example,dc=com
```

The **posixGroup** version is generally used in UNIX environments.

The **groupofNames** version is the more Windows/AD like method. EMC VNX Unisphere expects this method.

The operating system time and time zone of the Central and RAS machines must not be changed after installation.

In a multiple time zone environment, schedules are not triggered at correct times and sometimes do not appear in the Run Explorer.

When the LDAP configuration is not accessible, schedules fail to be triggered with internal users.

When upgrading a schedule with a start date in the past, the start date will be overridden with "now". This may also affect the number of occurrences.

When debugging a flow from Studio remotely on Central, if the run gets to paused state and then the pause is handled from the Central UI, the flow continues to run; however, in Studio it remains at the prompt. Handling the prompt in Studio shows the rest of the flow execution in Studio.

The Remote Debugger does not support features that require user information on the context. This includes logged in user credentials, user data, roles, and gated transitions.

Due to limitations in the SOAP API support in 10.x versus 9.x, some of the operations generated with Web Service Wizard from the HP OO 10.x WSDL may not run in Studio and Central. To check the support status, see the *API Guide*.

If you are using Windows 2012 with Internet Explorer 10, you must install the Desktop Experience in order to view the videos in Central.

If you are applying a filter on runs in the Run Explorer, click the refresh button in order to view the newly added runs.

In some cases, trying to authenticate or search for a user in the LDAP might return multiple results.

- This could happen if, for example, the LDAP configuration is configured using Global Catalog, and the same user identifier exists in a different domain.
- It could also happen if the customer configured the Users Filter string incorrectly, for example, did not use a unique identifier for the user name.

In these cases, HP OO arbitrarily chooses the first result (the first user) returned from the LDAP. The following message appears in the log :

“More than one user was found in the LDAP search. The first one returned in the search results is used. Check your LDAP configurations.”

There are a number of operations related to the getScheduledFlowsHP OO plugins in previous versions. These operations require engine support. Due to the limitations on the platform side, there are out-of-the-box operations and flows that are not supported at this time.

Wizards Limitations

The Invoke2 method array is misordered when other variables are at the same level.

When the invoke2 xmlTemplate has an array and other variables in the same xmlBlock, the soap request is built in the incorrect order:

```
start xml block
  array
  variable
end xml block
```

This produces a soap capture:

```
start xml block
  array 0 values
  variable
  array 1 values
  array 2 values
end xml block
```

In some cases, the PowerShell operation doesn't work in Studio after upgrading from 9.x.

CloudSlang Support Limitations

Every change to CloudSlang content to HP OO requires it to be re-packaged.

CloudSlang content and its libraries are not isolated from the HP OO libraries.

Since CloudSlang lets you develop flows violating the best practices, there could be a flow with name different from its path and the result will be a wrong search in HP OO.

There is no identification of CloudSlang steps in HP OO as operations or subflows. Therefore, no relevant filtering is available in the drill-down and multiple clicks are required to drill into every step.

After rolling back to earlier versions, it is not possible to delete or roll back CloudSlang content packs that were deployed in 10.5x, and CloudSlang flows are shown as folders in the Flow Library. After upgrading back to 10.5x, the CloudSlang content is still not presented correctly.

It is not possible to direct on which worker the CloudSlang content runs.

When CloudSlang content uses third party libraries, they need to be manually placed in every Central and RAS.

The entitlement behavior of CloudSlang content is different from regular content. This must be aligned for hybrid content.

OOSH is not supported for triggering CloudSlang flows.

HP OO doesn't evaluate the default values of expressions in CloudSlang. These are displayed as expressions. For example, `${input2}`

There is no graphical representation of CloudSlang runs.

Backward Compatibility With HP OO 9.x APIs

- Some SOAP and REST APIs from HP OO 9.x are supported by HP OO 10.x, and some are not.

Some of the SOAP APIs from HP OO 9.x have equivalent REST APIs in HP OO 10.x. We recommend using the REST APIs in HP OO 10.x

- The base path for using HP OO 10.x REST API is: `http(s)://<OO Central Server Name / IP>:<PORT>/oo/rest/`.
- The URL for using HP OO 9.x SOAP API while working with OO 10.x Central is the same as in HP OO 9.x. That is, `https:// <OO Central Server Name / IP>:<PORT>/PAS/services/WSCentralService`.
- The URL for using HP OO 9.x REST API while working with OO 10.x Central is the same as in HP OO 9.x. That is, `https:// <OO Central Server Name / IP>:<PORT>/PAS/services/rest`.
- We have restored compatibility with HP OO 9.x in terms of behavior when launching interactive flows using APIs. Flows launched from a backward-compatible SOAP/REST API will fail if they contain required inputs or steps with required inputs, which are set to prompt the user if no value was provided. This is the same behavior as in HP OO 9.x.

In HP OO 10.00, there was an incompatibility and these flows would become paused instead of failing. Since version 10.02, the behavior was restored to be as it was in version 9.x.

Installing HP OO

Upgrading to HP OO 10.51 from an earlier version of 10.x

To upgrade to HP OO 10.51, you can run the **apply-upgrade** script on any existing version of HP OO 10.x.

For more information, see "Upgrading to HP OO 10.5x from an Earlier Version of HP OO 10.x" in the *HP OO Installation, Upgrade, and Configuration Guide*.

Installing HP OO 10.51

HP OO 10.51 does not include an installation wizard. If you have never installed HP OO before, the installation path is:

1. Install HP OO 10.50. See the *HP OO 10.50 HP OO Installation, Upgrade, and Configuration Guide*.
2. Upgrade from 10.50 to 10.51. See "Upgrading to HP OO 10.5x from an Earlier Version of HP OO 10.x" in the *HP OO Installation, Upgrade, and Configuration Guide*.

Upgrading from HP OO 9.x

If you are upgrading from 9.x, the upgrade path is:

1. Upgrade from 9.x to 10.50. See *Upgrading to HP OO 10.x from HP OO 9.x*.
2. Upgrade from 10.50 to 10.51. See "Upgrading to HP OO 10.5x from an Earlier Version of HP OO 10.x" in the *HP OO Installation, Upgrade and Configuration Guide*.

It is possible to upgrade from any version of 9.x, from 9.03 and later, with all content packs that are supported by HP OO 9.03 and later.

Note for those upgrading from HP OO 9.x

If you are upgrading from 9.x, you will also need to upgrade your repository. The Content Upgrade Utility (CUU) is a tool that extracts specified content from an existing 9.x repository, and upgrades the extracted content into a content pack that can be deployed in 10.x. For more information, see *Upgrading to HP OO 10.x from HPOO 9.x*.

Installing the Studio Git Client

After installing or upgrading to 10.51, in order to use the Studio Git integration feature, you must install the Git client version **git-1.9.5-preview20150319**.

1. Download the Git client from the following URL:
<https://github.com/msysgit/msysgit/releases/download/Git-1.9.5-preview20150319/Git-1.9.5-preview20150319.exe>.

2. Save the Git client to **<oo_installation_folder>/studio/Git**, so that the **bin** folder is directly under **<oo_installation_folder>/studio/Git**. In the Git installation wizard, use the default options.

Alternatively, if you already have a Git client installation with version **git-1.9.5-preview20150319** on your local disk, point Studio to use that Git installation by performing the following steps:

1. Close Studio.
2. Go to the user home folder **C:\Users\<user>\.oo** (the Studio workspace location) and locate the **Studio.properties** file.
3. Modify the **Studio.properties** file by adding the following property at the end of the file:

```
studio.git.installation.location=<git-1.9.5-preview20150319_installation_
folder>
```

For example:

```
studio.git.installation.location=C:/Program Files (x86)/Git
```

The **bin** folder should be directly under **C:/Program Files (x86)/Git**. Note that **/** should be used as a path separator.

4. Save the **Studio.properties** file and start Studio.

Note: If you opted for this second alternative, you need to consider the following:

If you are using multiple workspaces and you want the Git location property to be added in each new workspace, you should edit the template properties file located in **Studio\conf\studio.properties.template**. Otherwise, each time you switch to a new workspace, you will have to set the Git location in the new workspace in the **.oo\Studio.properties** file.

If you have another version of the Git client installed, note that you must use the **git-1.9.5-preview20150319** version with Studio. This is the version that was validated with Studio. While other versions might still work correctly, they are not officially supported.

Upgrade and Rollback Notes

Upgrade Notes

- Before upgrading to HP OO 10.51 , you must download and install Microsoft Visual C++ 2010 Redistributable Package (x86). You need to install the version for the x86 platform, regardless of your Windows version.

This package can be downloaded from: <http://www.microsoft.com/en-us/download/confirmation.aspx?id=5555>.

- If you are upgrading from an earlier version of 10.x, make sure to cancel or finish all paused or running flows and disable existing schedules before applying the upgrade.
- Due to database structure optimizations, upgrading from a previous HP OO version to 10.x may involve moving considerable amounts of data inside the database.

To allow the upgrade operation to complete quickly and successfully, perform the following steps before upgrading to HP OO 10.x:

- a. Purge your old data.

This can be achieved using the HP OO 10.x stored procedures available on HPLN.

Keep only the data you really need to be available on the new version.

- b. Back up your database.

Keep a copy of your database (preferably after the old data was purged) in order to protect your data.

- c. Depending on the amount and type of your data, the upgrade may generate a considerable number of database transaction logs (“redo logs”). Make sure you have sufficient space allocated.
- After an upgrade from an earlier version of 10.x, if you start Studio on the same workspace that was used with the previous version, all the workspace settings are retained from the previous version.

If you roll back from 10.51 to the previous version, if you start Studio on the same workspace, any changes made to the workspace in 10.51 are not visible in Studio, but they are saved inside the user workspace. You will see the workspace settings you had in the older version.

At this point, you can modify your workspace settings using the earlier 10.x version. These changes in the workspace are saved.

If you upgrade to 10.51 again, and start Studio on the same workspace, the settings will be those from 10.51 and you will not see the workspace settings that were changed after rolling back to the previous version.

In this scenario, if you want to keep the settings from the earlier version in 10.51, do the following:

- a. Inside the user home directory, locate the **settings.xml** file inside the **.oo** folder (**C:/Users/<username>/.oo**).

- b. Remove the following line:

```
<opstudioSettingsUpgradeVersion>10.51 </opstudioSettingsUpgradeVersion>
```

Rollback Notes

- If you want to roll back HP OO 10.x to an earlier version of HP OO 10.x and you have large amounts of data in the database, perform the following actions before rollback begins:
 - a. Purge your old data.

This can be achieved using the HP OO 10.x stored procedures available on HPLN.
 - b. Back up your database.

Keep a copy of your database (preferably after the old data was purged) in order to protect your data.
 - c. Depending on the amount and type of your data, the rollback may generate a considerable number of database transaction logs (“redo logs”). Make sure you have sufficient space allocated.

Installation Notes

- If you uninstalled a previous version of HP OO and are installing 10.x in the same installation folder, make sure to back up the all the files that were under the installation folder and delete that folder before installing the new version.
- If you want to add a new 10.51 node to an existing FIPS-2 compliant cluster, the FIPS-2 configuration needs to be done both after installing the new node and after upgrading to 10.51; otherwise, the upgrade to 10.51 process will fail.
- If the user used to connect to the database does not have permission to create tables, you will need to choose one of two options:
 - a. Use the installer’s schema creation option, in which two database users are specified: a privileged user (only used to create the schema) and the user for the HP OO application.
 - b. Run an SQL script to manually create the tables and schema. There are SQL scripts located on [HPLN](#) (HP Live Network) and [SSO](#) (Software Support Online), which you can use:
 - **mssql.sql**
 - **mysql.sql**

- **oracle.sql**
- **postgres.sql**

Note: Users with this requirement will also need to use the **generate-sql** script when upgrading to the latest 10.x version (for more information, see the *HP OO Installation, Upgrade, and Configuration Guide*).

- The installation path does not support special characters. Valid characters for the installation path include English letters, digits, spaces, hyphens (-) and underscores (_).
- On Windows, a full installation of Microsoft .NET Framework 4.5 is required for RAS installations and for debugging .NET operations in Studio.
- It is possible to replace the standard JRE that was provided in your HP OO installation with the JRE from the OpenJDK 7 project. For more information, see "Using JRE From OpenJDK 7" in the *HP OO Installation, Upgrade, and Configuration Guide*.
- If you are using Microsoft SQL Server with HP OO, it is required that language-specific database collations are used. Selecting a specific collation also means that an HP OO system that uses SQL Server is limited to the set of languages supported by that specific collation. For example, if the **SQL_Latin1_General_CP1_CS_AS** collation is used, English, German, and Spanish characters may be used, but Japanese characters may not. If **Japanese_Unicode_CS_AS** is used, French accent characters will not be presented properly. For the complete specification of each collation, see the Microsoft SQL Server documentation.
- Some data on the database schema is encrypted and the keys for decryption are stored locally on the file system. If the file system becomes corrupted or deleted, the schema will be useless, because there will be no way to decrypt the data.

Make sure to back up the **central/var/security** folder and the **central/conf/database.properties** file after installing, so that it will be possible to recover from this scenario.

To recover:

- a. Install a new Central with an existing schema. The installation will fail on the **Start Central** step.
- b. Stop the Central service and verify that Central is not running.
- c. Override the **central/var/security** folder with the backed up folder.
- d. Override the **central/conf/database.properties** file with the backed up file.
