On March 01, 2016, HPE announced the End of Sale date and End of Support dates for Comtrade SPI for Documentum.

This document provides answers to frequently asked questions regarding this announcement.

PRODUCT RELATED QUESTIONS

Question	When is HPE obsoleting Comtrade SPI for Documentum?
Answer	Effective March 01, 2016, HPE is announcing the obsolescence of Comtrade SPI for Documentum 3.1x. Current customers may continue to purchase additional licenses of Comtrade SPI for Documentum until May 01, 2016. As of this date, the product will be removed from HPE's Corporate Price List and will no longer be orderable.
Question	What product numbers are affected by this obsolescence?
Answer	Please refer to Appendix B in the customer letter for the list of affected product numbers.
Question	When is the last date I can order Comtrade SPI for Documentum?
Answer	Comtrade SPI for Documentum will continue to be available for purchase to current support customers through May 01, 2016. As of that date, you will no longer be able to purchase additional licenses of the product version.
Question	Can I still purchase additional licenses for Comtrade SPI for Documentum? If yes, how?
Answer	Additional licenses may not be purchased for versions that are discontinued and past their end of sale date
Question	Who can I contact if I have more questions with regards to this product obsolescence?

Question	What is the End of Support date?
Answer	The End of Support date for Comtrade SPI for Documentum is August 31, 2017. As of this date all customer support activities for this version will cease, this includes: <ul style="list-style-type: none">• Security Rule updates• Product updates• Telephone support
Question	Are there any other key dates I need to be aware of?
Answer	Please see customer letter, page 1, for key dates.
Question	What are my discontinuance options?
Answer	You have the option to continue using Comtrade SPI for Documentum. HPE will stop providing support for Comtrade SPI for Documentum on August 31, 2017. You are encouraged to begin reviewing your business requirements for Comtrade SPI for Documentum. You are also encouraged to contact your local HPE sales representative or HPE business partner for help in determining migration options that meet your business needs.
Question	Can I get a support contract for technical support only, without having to pay for updates?
Answer	No, support contracts include both technical support and software updates.
Question	Should there be a defect with a version of Comtrade SPI for Documentum for which no defect fixing is done anymore, can I pay for a fix to be implemented on my request?
Answer	HPE may choose to offer defect fixes at a premium price, depending on available resources.
