Frequently Asked Questions

On July 1, 2016, Hewlett Packard Enterprise announced the product obsolescence for HP Business Process Insight with no replacement product as entitlement.

This document provides answers to frequently asked questions regarding this announcement.

IMPORTANT NOTE: Please be aware this is only about the Business Process Insight product, the other Application Performance Management (APM) products will continue to have new versions and will be supported per the communicated support time lines on [SSO](#).

PRODUCT RELATED QUESTIONS

Question	When is HPE obsoleting HP Business Process Insight?
Answer	Effective July 1, 2016, HPE is announcing the obsolescence of HP Business Process Insight with no replacement product as entitlement. Current Customers may continue to purchase additional licenses of HP Business Process Insight until September 1, 2016. As of this date, the product will be removed from HPE's Corporate Price List and will no longer be orderable.
Question	What product numbers are affected by this obsolescence?
Answer	Please refer to Appendix B in the customer letter for the list of affected product numbers.
Question	When is the last date I can order HP Business Process Insight?
Answer	HP Business Process Insight will continue to be available for purchase to current support customers through September 1, 2016. As of that date, you will no longer be able to purchase additional licenses of the product version.
Question	Can I still purchase additional licenses for HP Business Process Insight? If yes, how?
Answer	Additional licenses may not be purchased for versions that are discontinued and past their end of sale date.

Question	What is the End of Support date?
Answer	The End of Support date for HP Business Process Insight is August 31, 2017. As of this date all support activities for this version will cease, this includes: <ul style="list-style-type: none">• Security Rule updates• Product updates
Question	Are there any other key dates I need to be aware of?
Answer	Please see customer letter, page 1, for key dates.
Question	What are my obsolescence options?
Answer	You have the option to continue using HP Business Process Insight. HPE will stop providing support for HP Business Process Insight on August 31, 2017. You are encouraged to begin reviewing your business requirements for HP Business Process Insight. You are also encouraged to contact your local HPE sales representative or HPE business partner for help in determining migration options that meet your business needs.
Question	Can I get a support contract for technical support only, without having to pay for updates?
Answer	No, support contracts include both technical support and software updates.
Question	Should there be a defect with a version of HP Business Process Insight for which no defect fixing is done anymore, can I pay for a fix to be implemented on my request?
Answer	HPE may choose to offer defect fixes at a premium price, depending on available resources.
