Definitions

Capitalized terms not otherwise defined in this ALA document are defined in the governing agreement.

TERM	DEFINITION
Concurrent Users or CC Users or CCU	means the software is licensed by the amount of users that simultaneously use the software. The software can be installed on any number of computers, provided that the actual usage of the software does not exceed the number of licenses purchased.
Connector or Conn	means an integration element to a certain software, format or function through the use of the HPE and non HPE software product.
E-LTU and E-Media	means products which are electronically delivered only, and as such any reference to FOB Destination or delivery methods that are stated on your purchase order other than electronic shall be null and void with respect to these E-LTU or E-Media products.
Foundation	means a single Instance of the core or primary components of a software application which enable its basic functionality, and without which the additional modules available for the application are unable to operate. Foundation software may be installed on one or multiple servers, depending on the specific architecture required to enable the functioning of the single Instance.
Instance	means each implementation of the application installed on a Server.
LTU	means License To Use.
Named User or Nmd User	means a specific individual authorized by you to access the software regardless of whether they are actively using the software.
Server or Svr	means any designated computer system in which an Instance or Instances of the software is installed.

Software specific license terms

Software products with software specific license terms are described below. Software products covered by this ALA document (as listed above) and not covered in this section do not have software specific license terms.

HPE Propel (previously called HP Propel)

HPE Propel Portal is licensed by Named User and by Concurrent User. A Named User license may not be transferred from one individual to another unless the original Named User no longer requires, and is no longer permitted to access.

HPE Propel Service Exchange is licensed by Foundation. A Foundation license allows installation of Service Exchange on multiple Servers or Instances.

HPE Propel Service Exchange Non HP Connector is licensed based on per production Connector. HPE Propel Service Exchange Non HPE Connector is limited to connection with HPE Propel Service Exchange Foundation.
