On November 1, 2016, Hewlett Packard Enterprise announced the product obsolescence for Turnkey Business Process Testing Accelerator.

This document provides answers to frequently asked questions regarding this announcement.

PRODUCT RELATED QUESTIONS

Question	When is HPE obsoleting Turnkey Business Process Testing Accelerator?
Answer	Effective November 1, 2016, HPE is announcing the obsolescence of Turnkey Business Process Testing Accelerator with no replacement product as entitlement. Current Customers may continue to purchase additional licenses of Turnkey Business Process Testing Accelerator until November 1, 2016. As of this date, the product will be removed from HPE's Corporate Price List and will no longer be orderable.
Question	What product numbers are affected by this obsolescence?
Answer	Please refer to Appendix B in the customer letter for the list of affected product numbers.
Question	When is the last date I can order Turnkey Business Process Testing Accelerator?
Answer	Turnkey Business Process Testing Accelerator will continue to be available for purchase to current support customers through November 1, 2016. As of that date, you will no longer be able to purchase additional licenses of the product version.
Question	Can I still purchase additional licenses for Turnkey Business Process Testing Accelerator? If yes, how?
Answer	Additional licenses may not be purchased for versions that are obsoleted and past their end of sale date.

Question	What are my obsolescence options?
Answer	You have the option to continue using Turnkey Business Process Testing Accelerator. HPE will stop providing support for Turnkey Business Process Testing Accelerator on December 31, 2018. You are encouraged to begin reviewing your business requirements for Turnkey Business Process Testing Accelerator. You are also encouraged to contact your local HPE sales representative or HPE business partner for help in determining migration options that meet your business needs.
Question	Can I get a support contract for technical support only, without having to pay for updates?
Answer	No, support contracts include both technical support and software updates.
Question	Should there be a defect with a version of Turnkey Business Process Testing Accelerator for which no defect fixing is done anymore, can I pay for a fix to be implemented on my request?
Answer	HPE may choose to offer defect fixes at a premium price, depending on available resources.
