End of Sale Announcement

Frequently Asked Questions

On January 1, 2017, Hewlett Packard Enterprise announced the End of Sale for HP Asset Manager 9.4x & 9.5x. The End of Committed Support and End of Extended Support dates were previously communicated via **Software Support Online**.

Key program dates listed below for HP Asset Manager 9.4x & 9.5x are based on HPE's time-based support policy under which end-of-support dates are announced as new product versions are released. Our goal is to provide you with a clear visibility into the support time-line of software products, enabling you to use this information to plan, test, and deploy new product versions. This document provides answers to frequently asked questions regarding this announcement.

PRODUCT RELATED QUESTIONS

Question	When is HPE obsoleting sales for HP Asset Manager 9.4x & 9.5x?
Answer	Effective January 1, 2017, HPE is announcing the End of Sale of HP Asset Manager 9.4x & 9.5x. Current Customers may continue to purchase additional licenses of HP Asset Manager 9.4x & 9.5x until March 1, 2017. As of this date, the product will be removed from HPE's Corporate Price List and will no longer be orderable.
Question	Why is HPE obsoleting sales for HP Asset Manager 9.4x & 9.5x?
Answer	HP Asset Manager 9.4x will reach End of Committed Support in the near future. For this reason, HPE is obsoleting the sales of HP Asset Manager 9.4x. This is in accordance with our Release & Support Policy. Definitions of terms are documented in the Software Support Policy guidelines .
	In addition, as part of the split of Hewlett Packard into HP Inc and Hewlett Packard Enterprise in November 2015, we are not allowed to sell HP branded products anymore. Therefore, we are announcing the End of Sale of all HP Asset Manager 9.4x & 9.5x versions. This doesn't affect the support time lines that were already published on Software Support Online .
	Customers with active support contracts can update to HPE Asset Manager 9.6x.
Question	What product numbers are affected by this obsolescence?
Answer	Please refer to Appendix B in the customer letter for the list of affected product numbers.
Question	When is the last date I can order HP Asset Manager 9.4x & 9.5x?

Answer	HP Asset Manager 9.4x & 9.5x will continue to be available for purchase to current support customers through March 1, 2017. As of that date, you will no longer be able to purchase additional licenses of the product version.
Question	Can I still purchase additional licenses for HP Asset Manager 9.4x & 9.5x? If yes, how?
Answer	Additional licenses may not be purchased for versions that are obsolesced and past their end of sale date.
Question	Do I need to request new license keys when updating to HPE Asset Manager 9.6x?
Answer	No, you don't need new license keys for HPE Asset Manager 9.6x. The HP Asset Manager 9.4x & 9.5x license keys will continue to work.
Question	What version of HPE Asset Manager is currently available and what update plans do you have for the product, if any?
Answer	The latest version is 9.6x. Please check <u>hpe.com/software/home</u> or otherwise check with your local HPE sales representative or HPE business partner for the latest information.
Question	Who can I contact if I have more questions with regards to this product obsolescence?

Question	Where can I find update information for HP Asset Manager 9.4x & 9.5x?
Answer	Your local HPE sales representative or HPE business partner can help you get this information.
Question	I plan to update my HP Asset Manager $9.4x \& 9.5x$ environment using in-house technical resources. Where do I get all the required software?
Answer	All HP Asset Manager 9.4x & 9.5x support customers can download HPE Asset Manager 9.6x media at <u>Hewlett</u> <u>Packard Enterprise Software Licenses and Downloads Portal</u>
Question	What is the concurrent support time period?
Answer	There will be 6 months of concurrent support for updating to HPE Asset Manager 9.6x.

Question	What is the End of Committed Support date?
Answer	The End of Committed Support date for HP Asset Manager 9.4x is June 30, 2017. This date was announced on Software Support Online on August 1, 2013.
	The End of Committed Support date for HP Asset Manager 9.5x is April 30, 2019. This date was announced on Software Support Online on April 2, 2015.
	As of the End of Committed Support date, customer support activities for this version will cease, this includes:
	Security Rule updates
	Product updates

Question	What is the End of Extended Support date?
Answer	The End of Extended Support date for HP Asset Manager 9.4x is June 30, 2019. This date was announced on Software Support Online on August 1, 2013.
	The End of Extended Support date for HP Asset Manager 9.5x is April 30, 2021. This date was announced on Software Support Online on April 2, 2015.
	During the 2 year Extended Support period, you have access to existing patches, fixes and telephone support.
Question	Are there any other key dates I need to be aware of?
Answer	Please see customer letter, page 1, for key dates.
Question	What are my obsolescence options?
Answer	You have the option to continue using HP Asset Manager 9.4x. HPE will stop providing Committed Support for HP Asset Manager 9.4x on June 30, 2017. Extended Support will continue to be available through June 30, 2019. Self-Help Support with Rights to New Versions will continue to be available through June 30, 2023.
	You have the option to continue using HP Asset Manager 9.5x. HPE will stop providing Committed Support for HP Asset Manager 9.5x on April 30, 2019. Extended Support will continue to be available through April 30, 2021. Self-Help Support with Rights to New Versions will continue to be available through April 30, 2025.
	You are encouraged to begin reviewing your business requirements for HP Asset Manager 9.4x & 9.5x.You are also encouraged to contact your local HPE sales representative or HPE business partner for help in determining migration options that meet your business needs.
Question	Can I get a support contract for technical support only, without having to pay for updates?
Answer	No, support contracts include both technical support and software updates.
Question	Should there be a defect with a version of HPE Asset Manager for which no defect fixing is done anymore, can I pay for a fix to be implemented on my request?
Answer	HPE may choose to offer defect fixes at a premium price, depending on available resources.
Question	If I am on a support contract, what will I be entitled to?
Answer	You should have received a letter or electronic notification from HPE to inform you about the availability of HPE Asset Manager 9.6x for support customers, what license(s) you were entitled to under your support contract and how to sign up for it. Your local HPE sales and support representatives or your HPE business partner can help provide information and assistance to enable your update to be easy and successful.
Question	When I update from HP Asset Manager 9.4x or 9.5x to HPE Asset Manager 9.6x, can I continue my existing support contracts until they expire?
Answer	Yes, your support contract will be updated automatically at the next renewal time.
Question	When I update from HP Asset Manager 9.4x or 9.5x to HPE Asset Manager 9.6x, can I expect the same support pricing compared to HP Asset Manager 9.4x or 9.5x?
Answer	Not necessarily. Each product support price is determined independently. Please work with your HPE representative to know the difference in support pricing, if any.
Question	What educational/training packages are available for the HPE Asset Manager 9.6x?
Answer	Your local HPE education specialist can help understand what training packages are available for you. Please email your local contact for more information:
