Answer	Effective March 15, 2017, HPE is announcing the End of Sale of HP Cloud Service Automation Foundation 4.1x, 4.2 4.5x, & 4.6x. Current Customers may continue to purchase additional licenses of HP Cloud Service Automatic Foundation (CSA) 4.1x, 4.2x, 4.5x, & 4.6x until June 1, 2017. As of this date, the product will be removed from HPE Corporate Price List and will no longer be orderable.	
Question	Why is HPE ending sales for HP Cloud Service Automation Foundation 4.1x, 4.2x, 4.5x, & 4.6x?	
Answer	As part of the split of Hewlett Packard into HP Inc. and Hewlett Packard Enterprise in November 2015, we are not allowed to sell HP branded products anymore. Therefore, we are announcing the End of Sale of all HP Cloud Service Automation Foundation versions. Customers with active support contracts can update to the latest 4.8x of HPE Cloud Service Automation Foundation.
