## What's New in This Release

This release of SI SPI contains the following features:

### **SI-ProcessMonitor**

The SI-ProcessMonitor policy monitors a set of processes in a process group. All processes and process groups that you want to monitor using the SI-SPI must be defined in the configuration file, `procmon.cfg` or in the SI-ProcessMonitorConfig File policy.

### **SI-ZombieProcessCountMonitor**

SI-ZombieProcessCountMonitor policy (Measurement Threshold) monitors the number of zombie processes running on a node. If the number of zombie processes exceed the set threshold, it sends an alert to the HPOM console.

### **Configuration Change Monitoring (Change CI Monitoring or CCIMon) policy**

The CCI Monitor policy monitors files, Windows registry settings, and command output for changes. All configuration changes that you monitor can be added to the Config File policy or to the configuration file `ccilist.cfg` located at:

#### On Windows

%OvDataDir%\conf\ccimon\configuration

#### On UNIX

var/opt/OV/conf/ccimon/configuration

The CCI Monitor policy reads the `ccilist.cfg` file at every run and sends alerts when there is a change in files, Windows registry settings, and command outputs.

#### *Desired State Monitoring*

Desired State Monitoring monitors files, windows registry settings, and command outputs in the configuration file `ccilist.cfg`.

After deployment, the Desired State Monitoring checks for `==` in the configuration file `ccilist.cfg` and compares the files, windows registry settings, and command outputs added in the configuration file with the corresponding reference or gold file. Alerts are generated whenever there is a change in the monitored file, windows registry settings, and command outputs.

#### RealTimeAlerts Policy

The RealtimeAlerts policy monitors the bottlenecks in CPU, disk, memory, and networking. The Realtime Configuration policy defines the threshold for these parameters. During a threshold breach, alert messages notify the system administrator with no time delay and reduce the downtime in the production environment.

**Note:** You must enable RTMA license on the HP Operations Agent node for RealTimeAlerts policy to fetch real time data.

#### Security Policies for Monitoring Log Files

- **Bad login policy for Linux:** This policy monitors the `/var/tmp/badlogs.log` file for bad logins and alerts users when an incorrect login occurs.
- **Bad login policy for AIX:** This policy monitors the `/etc/security/fllogin` file for bad logins and alerts users when an incorrect login occurs.
- **Logins policy for AIX:** This policy monitors the `/var/adm/wtmp` file for login history and alerts users when a successful remote login, successful local login, system boot, system shutdown user, or system shutdown occurs.
- **SU policy for AIX:** This policy monitors the switch user history in the `/var/adm/sulog` file. Alerts are sent to users when the SU command is run.
- **Sys Log policy for AIX:** This policy monitors the messages sent to the `/tmp/syslog` file.
- **Bad logins policy for HP-UX:** This policy monitors the `/var/adm/loginlog` file for failed logins and alerts users when an incorrect login occurs.
- **Logins policy for HP-UX:** This policy monitors the `/var/adm/wtmps` file for logins and alerts users when an incorrect login occurs.
- **Switch User policy for HP-UX:** This policy monitors the `/var/adm/sulog` file for switch user events and alerts users when any switch user event occurs.
- **Syslog policy for HP-UX:** This policy monitors the messages sent to the `/var/adm/syslog/syslog.log` file.

- **Sun Solaris Bad logins:** This policy monitors the `/var/adm/loginlog` file for failed logins and alerts users when an incorrect login occurs.
- **Sun Solaris logins:** This policy monitors the `/var/adm/wmptx` file for login details and alerts when a successful remote login, successful local login, system login, system boot, system shutdown, or system shutdown/1 occurs.
- **Sun Solaris snmp log policy:** This policy monitors the `/var/adm/messages` file for SNMP log file entries.
- **Sun Solaris Syslog policy:** This policy monitors the system messages in the system log file `var/adm/messages` and alerts when a required condition matches successfully.

#### FSMON Feature

The FSMON feature monitors filesystems when the `fsmon` flag is set to **True** in the Disk Capacity Monitor policy. Alert messages are sent to the users based on the thresholds defined in the configuration file. The policy reads the filesystems listed in the following configuration files:

- `ossapi_fsmon.cfg`
- `ossapi_global_fsmon.cfg`
- `ossapi_local_fsmon.cfg`

#### Energy SPI Collection

The Energy SPI Collector is a tool used to collect metrics from systems where HP Operations Agent version 12.01 is running. This tool measures the energy utilization of physical machines where multiple virtual machines are installed. The Energy SPI Collector tool is supported only on Windows and Linux platforms and functions only when HP Integrated Lights-Out (iLO) is installed on the physical server.

**Problem:** For Debian and Ubuntu service monitoring policies, place holder should be added in Availability policy group under Linux. For more information, see [QCCR1A153787](#)

---

**Problem:** If you uninstall Infrastructure SPI 12.01 after an upgrade, the inventory for Graphs shows the version as 12.01 instead of 11.xx

**Workaround:** Follow the steps:

1. Before upgrading to Infrastructure SPI 12.01, back up the VPI\_GraphsInfraSPI.txt file located at:

**On Windows:**

/opt/OV/newconfig/OVPM

**On UNIX**

/opt/OV/newconfig/OVPM

2. Downgrade to Infrastructure SPI 11.xx
  3. Replace the backed up file.
- 

**QCCR1A134939:** SI-Discovery reports time out for large number of filesystems.

**Workaround:** You can increase the agtrep time out on the node using the following command:

```
ovconfchg -ns agtrep -set ACTION_TIMEOUT 30
```

---

**Problem:** Some Log monitoring policies do not work on RHEL and SLES systems running agent as non-root user.

**Workaround:** SI SPI supports policies and tools for alternative, non-root users on HTTPS agents. The following policies do not work on RHEL and SLES systems:

- SI-LinuxBootLog
- SI-LinuxSecureLog
- SI-LinuxKernelLog 2

To enable alerts for log monitoring for Infrastructure SPIs on non-root agents, follow these steps:

1. Update the permission of the required log files using the following commands:

**For RHEL:**

```
chmod 444 /var/log/messages
```

```
chmod 444 /var/log/boot.log
```

```
chmod 444 /var/log/secure
```

**For SLES:**

```
chmod 444 /var/log/messages
```

```
chmod 444 /var/log/boot.log
```

2. Update the permission of OVBCCB and OPCLE processes for RHEL and SLES using the following commands:

```
chmod 4555 /opt/OV/bin/ovbccb
```

```
chmod 4555 /opt/OV/lbin/eaagt/opcle
```

3. Switch to non-root user for RHEL and SLES by running the following command:

```
su - <non-root user name>
```

4. Restart ovc for RHEL and SLES by running the following commands:

```
ovc -stop
```

```
ovc -start
```

5. To check the status of all processes, run the ovc command. It displays all the processes which are up and running.

**Problem:** For the SNMP nodes added by Infrastructure SPIs on HPOM, the alert message appears as critical node may be down.

**Workaround:** To manually update the heartbeat polling protocol for the SNMP node to ICMP, follow these steps:

**On Windows:**

1. In the HPOM for Windows management server console, right-click the SNMP node.
2. Choose **Properties** from the pop-up menu.
3. Click the **Network** tab.
4. Under Heartbeat Polling, change the value of **Polling** to **Custom** and the value of **Ping Protocol** to **ICMP Only**.
5. Click **Apply** and then click **OK**.

### On HP-UX, Linux, and Solaris:

Run the command:

```
opcbsp -stop -nodegrp "VI-VMware Guests"
```

---

### For HP Operations Agent:

- **Problem:** `opc1e` aborts when Infrastructure SPIs policies are deployed to the node. For more information, see [QCCR1A153786](#).
- 

**QCCR1A155301:** All process monitoring policies shows default message, `XXX process is not running` even when the CPU utilization/memory usage of the process violates the condition.

**Workaround:** Contact Support.

---

**QCCR1A187171:** The SI-ZombieProcessCountMonitor policy is not supported in Infrastructure SPI version 12.01.

**Workaround:** None

---

**QCCR1A187172:** Direct upgrade from Infrastructure SPI version 11.10 to 12.01 is not supported.

**Workaround:** You must first upgrade from Infrastructure SPI version 11.10 to 11.11 and then upgrade to Infrastructure SPI version 12.01.

---

## Limitations

- The language of the policies auto-deployed on the nodes depends on the locale of the HPOM for Windows management server. It does not depend on the locale of the node.
- SI SPI tools are not localized.
