Zero Downtime (Split-Mirror) Backup

Support Matrix for EMC Arrays

The EMC split-mirror backup integration is supported on the following operating systems:

HP-UX (PA-RISC) : HP-UX 11.11, HP-UX 11.23, HP-UX 11.31
 HP-UX (Itanium) : HP-UX 11.23, HP-UX 11.31
 Windows : Windows Server 2003

The operating system, its version and the hardware architecture must be same on both application and backup hosts. The EMC Symmetrix integrated cached disk array system (ICDA) must run Enterprise Backup Solutions Enabler from EMC. The following is a list of Supported versions:

1. HP-UX (PA-RISC) & HP-UX (Itanium): Version 5.5 or newer.
2. Windows : Version 5.3 or newer.

All versions of TimeFinder and/or SRDF and microcode supported by the above versions of the EMC software are supported. New versions of the microcode or the Enterprise Backup Solution Enabler software will be tested and certified if needed.

In addition, EMC DMX arrays are supported.

For the following matrices, only those combinations of applications and operating systems are supported that are supported by the respective vendors.

Data Protector 6.20 also supports the EMC Geospan product for high-availability clustering using the Microsoft Cluster Server. EMC Geospan needs dual-host TimeFinder. Additionally, the table below contains ZDB support options for EMC Symmetrix on Windows in addition to the ones supported by EMC Geospan.
