# 1 Open Source Licenses

## Introduction

Generically, **open source** refers to a program in which the source code is available free-of-charge to the general public for use and/or modification from its original design. Open source code is typically created as a collaborative effort in which programmers improve upon the code and share the changes within the community. Open source code came about in the technological community as a response to proprietary software owned by corporations.

**Open source software (OSS)** began as a marketing campaign for free software. OSS is computer software for which the human-readable source code is made available under a copyright license (or arrangement such as the public domain) that meets the **Open Source Definition (OSD)**. This permits users to use, change, and improve the software, and to redistribute it in modified or unmodified form. It is very often developed in a public, collaborative manner. Open source software is the most prominent example of open-source development and often compared to user-generated content.

**Open Society Institute (OSI)** dictates that in order to be considered "OSI Certified" a product must meet the following criteria:

- The author or holder of the license of the source code cannot collect royalties on the distribution of the program.
- The distributed program must make the source code accessible to the user.
- The author must allow modifications and derivations of the work under the program's original name.
- No person, group, or field of endeavor can be denied access to the program.
- The rights attached to the program must not depend on the program's being part of a particular software distribution.
- The licensed software cannot place restrictions on other software that is distributed with it.

## Third-Party Software

In computer programming, a third-party software component is a reusable software component that has been developed to be either freely distributed or sold by an entity other than the original vendor of the development platform.
