Software and Hardware Requirements

NOTE: There is no certified migration path for migrating to this release from a previous release. The suggested migration path is as listed below:

• Save and/or note any customizations made to the previous TIBCO SPI installation.

• Uninstall the TIBCO SPI. Instructions for uninstalling TIBCO SPI are described in the section Install and Configure the TIBCO SPI in the User's Guide for HP OpenView Smart Plug-in for TIBCO provided in Adobe Acrobat (.pdf) format.

- Install the new version of the SPI.
- Apply any previous customizations to the new installation.

Enhancements and Fixes

The following defect (identified by error tracking number) is fixed in the current software release.

QXCR1000239249: The EMA agent monitoring feature does not work.

PROBLEM: Monitoring the EMA agent Windows service is not possible as the files required for the same are not copied during installation.

Warnings are generated during installation and uninstallation of the SPI. Also during installation some files not copied to the appropriate destinations and after uninstallation all files are not removed.

- **CAUSE:** Errors in filenames in the file lists used by the install scripts.
- **FIX:** Monitoring the EMA agent Windows service is not possible because TIBCO EMA 2.0 no longer runs as a Windows service, which is prerequisite for this feature to work. However the other problems are fixed.

Known Problems, Limitations, and Workarounds

SPI for TIBCO

• The URL pattern for accessing a root Managed Object (MO) in TIBCO EMA 2.0 and 2.1 is changed.

For EMA 1.0, the root MO WSDL URL was:

http://<host>:8888/?wsdl:objid=tibemi://www.tibco.com/emi/2003/12/mo/identity/Root

For EMA 2.0 and 2.1, the Root MO WSDL URL is:

http://<host>:8888/?wsdl:objid=tibema://www.tibco.com/ema/2005/01/mo/identity/ Root

• Host MO corresponding to an RVD MO is not discovered in the following situation:

You have an RVD process running on a host where no Hawk Agent is running. If RVDs are discovered by Hawk sniffer, only RVD MOs are be created, but there will be no Host MOs corresponding to the machines where the RVDs are running as there is no Hawk Agent running on those machines. As a result the following historical reports will not be available for those specific RVDs:

- TIBCO RVD Retransmissions & Network Interface Errors
- TIBCO RVD & Network Interface Send Rates
- TIBCO RVD & Network Interface Receive Rates

• During failover, the backup TIBCO EMA discovers the managed resources that were already discovered by the primary TIBCO EMA. If new managed resources are introduced in the TIBCO environment after the failover, those resources will not be discovered by the backup EMA. This is due to a limitation in TIBCO EMA 2.0.

If new managed resources are introduced in the TIBCO environment after a failover, the primary and backup TIBCO EMA instances must be restarted. The message browser displays a message during a failover.

• When the log level is set to FINE for frontend tracing, in the

/var/opt/OV/conf/tib/Frontend.properties file, the frontend trace files
/var/opt/OV/log/tib/frontend.trace.* might not be viewable in some editors
such as vi, due to certain trace messages being too long.

• The datacollector collects data for one template at a time. The Frontend Subagent does not support data collections from multiple templates simultaneously. You can have only one monitor template to collect data. The SPI ships with the TIBSPI-Collect-Mon-V1 template in the TIBSPI-Metrics-V1 template group. This template calls the tib-collect-data script. Only one monitor template can call the tib-collect-data script. If it is called by more than one monitor templates, there is a possibility of data not being collected at every interval.

• When TIBCO SPI is running as a Non root user and performance agent is OVPA (OV Performance Agent), then data collection is supported only with OVPA 4.5, data collection is not supported with earlier versions of OVPA.

• Configuration GUI – By default, you cannot use Asian (Japanese, Chinese, Korean) language characters in the configuration Graphical User Interface (GUI). Since the configuration GUI is a Java-based, you can modify the JAVA_HOME variable in the /var/opt/OV/bin/OpC/cmds/tib_config script on the OVO server system to use a Java Virtual Machine (JVM) on the system that is configured to display Asian characters.

• HP Java console and Service Navigator – To display Japanese characters when using Windows, you must install Japanese fonts and set the Windows default language as Japanese.

• The default directory for the templates in the TIBSPI-WIN-HAWK-Agent-V1 template group is incorrectly listed as c:\tibco\hawk\Logs\. The correct default directory is c:\tibco\hawk\Log\. If you have installed TIBCO Hawk in the default directory on Windows, modify the log file location in the templates to c:\tibco\hawk\Log\. If you have installed TIBCO Hawk in a different directory on Windows, modify the log file location in the templates to identify the directory in which you installed Hawk. • During uninstallation of the TIBCO SPI on OVO 8.0, OpenView commands, monitors, and actions are not completely uninstalled. To completely uninstall the TIBCO SPI, you must manually remove the files listed below. Few Sample rm commands are listed below. The locations are different for HP-UX and Solaris.

For HP-UX, you must perform an action equivalent to the following:

• If you are using OVO 8.x, to trouble shoot ECS correlation problems, refer to the section, "ECS Correlation Problems" in the *HP OpenView Smart Plug-in for TIBCO User's Guide*.

Service Effect Analysis Component

• The tag or property representing the type and ID of Objects to be populated as Managed Objects from the TIBCO SPI service map has changed from <code>objType</code> to <code>ObjectType</code> and from <code>objID</code> to <code>ObjectID</code>.

• When multiple subscribers are subscribed to events that impact multiple Managed Objects (MOs), some of the subscribers will not consistently receive the notifications as expected. A resolution for this issue is being investigated.

• SEA will not function properly if the default port used by the SEA component is already in use. In this situation, check for the port number using the SEA config tool (in the TIBCO SPI application bank). Select <OVSBA_CONFIGURATION> (Usually 4444, by default). Check if another process is using the port:

netstat -na | grep <port number>

If the port number is displayed in the output, it indicates that the port is being used. Change the port number and restart SEA.

• To troubleshoot ECS correlation problems as a first step make sure that all the ECS services and the service engines are running:

opcsv -status

Verify that the ECS correlation manager and service engine are running. If they are not, restart OpenView Services:

opcsv -stop and opcsv -start.
