# Dashboard Overview

Dashboard enables your team to monitor the health of business services and applications from the point of view of the consumers of those services—the business, its customers, and its partners.

### **Collecting and Aggregating Data**

Dashboard uses data collected by HP Business Availability Center monitoring components, such as Business Process Monitor, SiteScope, and Enterprise Management Systems (EMS) integration tools, as well as data collected from external monitoring tools. HP Business Availability Center collects metrics about the end-user experience from a range of environments, including ERP, CRM, Web, and Citrix, and about the system performance from a range of back-end infrastructure components, including Web, application, database, and firewall servers.

The collected and aggregated data is used by the Dashboard Key Performance Indicators (KPIs) to provide quantifiable measurements that help you monitor how well your business is achieving objectives. The KPIs provide a real-time assessment of the present state of your business and processes, enable you to track critical performance variables over time, and help you assess the business impact of problems in the system.

At the top level, Dashboard provides an integrated view of critical applications and business processes; from there, you can drill down to the underlying IT infrastructure associated with these critical business processes. This drill-down view can be laid out in any number of ways, such as by data centers, by technology clusters, by geographical locations, and so on.

# Prioritizing IT Operations and Maximizing Business Results

Dashboard helps you to prioritize IT operations and maximize business results by:

- ➤ Presenting global system component data organized into a logical and relevant framework.
- ➤ Providing integrated, scalable, cross-application views that reflect the health of mission-critical services and applications in real time. This enables IT operations teams to continuously manage the health of mission-critical services and applications from one central location.
- ➤ Providing a common view of how IT operations are meeting line-of-business goals. This enables better communication between the teams, and the alignment of management and IT operations around customer-centric values.

- ➤ Providing the ability to assess actual customer impact, so that IT teams can prioritize response according to business impact and optimize resource utilization to meet critical business objectives. The end result is better quality of service for your end users.
- ➤ Providing a big-picture perspective, enabling you to see how a performance issue impacts the availability of any part of your business and to quantify the business impact of a potential failure.
- ➤ Providing operational-level service level management reporting. Dashboard uses Service Level Management data to provide an indication of whether an SLA is in breach of contract, or might be in breach in the near future.

#### **Dashboard Administration**

To access the Dashboard Administration tabs, select **Admin > Dashboard**.

You use Dashboard Administration to enable you to:

- ➤ Edit the KPIs attached to a configuration item (CI), and to attach new KPIs to CIs in the KPIs tab. The KPIs you create are displayed in Dashboard to help the user monitor how well the business is achieving its objectives and assess the business impact of problems in the system. # How Dashboard Works

The physical and logical entities in your system, such as hardware, software, services, business processes, and so on, are represented in Dashboard by configuration items (CIs). The CIs are stored in the HP Universal CMDB, and organized into hierarchical format based on the interdependencies in your organization's IT environment.

Each CI is assigned one or more KPIs showing current operational status or business impact over time by the assignment or propagation mechanism.

The monitor CIs receive real performance metrics from the monitoring data collected by HP Business Availability Center monitoring tools, and KPI status for these CIs is calculated from that data. For more information, see "Statuses or Values" on page 28.

Status propagates up the CI hierarchy, from the monitor CIs, through parent (leaf) CIs, and up to the highest CI. For most parent CIs, KPI status is based on an aggregation of statuses for all child CIs defined by the propagation (the calculation method used for this aggregation varies, according to the KPI's business logic). For details about the propagation, see "KPI Assignment Management Overview" on page 420.

You can view a subsection of the UCMDB CIs in service views in Dashboard. Each service view provides a different aspect of your organization's IT universe, enabling you to focus on the IT area that is of interest.

The child CIs for a CI may not be visible in a view, but the KPI status shown is still based on the status propagated up from both visible and hidden child CIs.

The incoming data is updated every 30 seconds (configurable default value), so that the status information displayed in Dashboard represents the ongoing availability of your organization's infrastructure components.

### **Monitoring Performance Problems**

When a performance problem is identified, you can drill down to locate the source of the problem, view event reports, and track problem handling. You can also move directly to the appropriate pages in HP Business Availability Center to view reports for problematic components, measurement data over time, and general monitoring data.

Dashboard also enables you to view operational status from the viewpoint of geographical locations, so you can see which locations are impacted by problems.

In addition, you can isolate and manage enterprise problems discovered in HP Business Availability Center, and identify likely suspects that are at the root of the problem using the Problem Isolation application.

## **Monitoring Service Level Agreements**

Service Level Management enables you to track applications, infrastructure, and services according to the service contracts you have with internal or external customers.

In Dashboard, you can view an SLA information bar that gives you advanced warning of any potential breaches of contract, and you can act proactively to fix a problem before it causes financial damage.

# 🔥 Impact Modeling

In Dashboard, views show the topology of the CIs that were selected in the UCMDB as being part of the view definition. The views also display the status of the KPIs of the view's CIs.

The status of a KPI is calculated at the monitor CI level and propagated at the group CI level. A KPI's status is propagated from a child CI to a parent CI according to the propagation definition only when the parent CI and the child CI are linked by either an **Impacted By (Directly)** or an **Impacted By (Potentially)** calculated relationship.

For more details about these types of relationships, see "Impact Modeling Overview" in *Model Management*.

# View Components

The CIs and relationships produced by the various CI-generating tools that operate within HP Business Availability Center, are stored in the configuration management database (CMDB).

The service views displayed in Dashboard are built from CIs contained in the UCMDB. These CIs are mapped together to build views that meet your business requirements and objectives, and monitor what is important to you. (For a more detailed explanation of how views are built, see "Working with Views in IT Universe Manager" in *Model Management*.)

## **Topology**

Each view has a specific set of CIs and a topology that provides a hierarchy of CIs. For details, see "Display a View Structure" on page 56.

Each CI has only one instance in the CMDB. Different views can look at the same CI.

The view displays the topology of the CIs, and the statuses of the different KPIs attached to the CIs. For details on how the KPI statuses are assigned to the CIs at the different levels of the topology, see "Impact Modeling" on page 25.

Details on specific views are provided in subject-related documentation; for example Real User Monitor views are detailed in "About Real User Monitor Views" in *Using End User Management*.

**Note:** The OMi-related views only appear if you are using HP Operations Manager *i*. For details, see *Using HP Operations Manager i*.

#### **CIs in Views**

The CIs at the lowest level of the hierarchy represent the monitor CIs, such as SiteScope monitors, Business Process Monitor transactions, or metrics from other external monitoring sources. The upper levels of the hierarchy represent logical groups. CI names are either taken from the external source, or are defined by the administrator as part of the CI properties.

The views may also contain dynamic hierarchies generated by the Dynamic Node Factory definition file. These hierarchies are created in the CMDB at runtime, based on the incoming samples. The parent for a dynamic hierarchy is a Dynamic Node Factory CI. Note that the CIs under the Dynamic Node Factory parent do not generally have option menus. For more information on dynamic hierarchies, see "IT Universe Manager – Dynamic Node Factory" in *Model Management*.

**Note:** The OMi-related views only appear if you are using HP Operations Manager *i*. For details, see *Using HP Operations Manager i*.

### **KPIs in Views**

Factory KPIs and factory business rules that can be associated with the KPIs are provided in the Repositories. Those KPIs and business rules can be combined in assignments and propagations. The factory KPIs and business rules can be customized. For details about the repositories, see "Repositories Overview" on page 473.

KPIs and business rules are assigned, using the KPI assignment mechanism, to monitor CIs. KPIs and business rules are propagated, using the KPI propagation mechanism, up the CI's hierarchy in the view. For details about the KPI assignment and propagation, see "KPI Assignment Management Overview" on page 420.

You can also manually assign additional KPIs to CIs in Dashboard Administration. For details, see "Add KPI to Multiple CIs/Edit KPI/Edit KPI for Child Transaction Dialog Box" on page 397.

For each CI in a view, one or more KPI columns are displayed. For example, Availability, System, Performance, and so on. For a list of the KPIs used in Dashboard, see "List of Dashboard KPIs" on page 510.

For each CI, each KPI column contains status icons or values, representing how the KPI objective is met. For details on KPI status, see "KPI Status" on page 355.

In the case of data coming from the Business Process Monitor, the KPIs and business rules assigned to the CIs are defined in the Business Process Monitoring source adapter. For more information, see "Business Process Monitoring Source Adapter Details" in *Model Management*.

**Note:** The OMi-related KPIs and business rules only appear if you are using HP Operations Manager *i*. For details, see *Using HP Operations Manager i*.

#### **Statuses or Values**

The status or value information displayed in Dashboard views is real-time data calculated by the online Business Logic Engine (using the business rules associated with the KPI). The Business Logic Engine takes data directly from the samples sent by the monitors in the bus.

The status or value information is propagated from the monitoring CIs to the higher levels of the CI hierarchy in the view using specific mechanisms.

The monitoring views (for example End-User Monitors view) display the created CI hierarchies for the monitored sources. When data is received over the Bus for a monitor, you can open the monitoring view in Dashboard and view status information for the CIs. You can use the CI hierarchies created in the predefined monitoring views as the building blocks for defining your own customized views. For more information, see "Working with Views in IT Universe Manager" in *Model Management*.

## Cls and Infrastructure Changes

When changes are made to your organization's infrastructure, they are detected by the discovery process or by monitors monitoring external sources. Dashboard checks the engine every 60 seconds (default setting), for configuration changes received from the external sources. The structure and content of the CI hierarchies are then automatically updated and deployed to the Dashboard application. Some settings of the source adapters may affect the hierarchy of the view; for example, Transactions/locations in the Business Process Monitor source adapter. For more information, see "Business Process Monitoring Source Adapter Details" in Model Management.

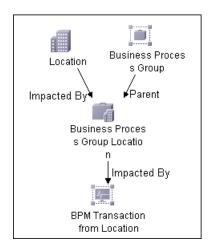
In addition, changes made within HP Business Availability Center, by changing the profiles in End User Management Administration or manually updating CIs in CMDB Administration, are also automatically deployed to Dashboard.

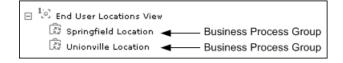
## \lambda End User Monitors View and End User Locations View

The End User Monitors View and End User Location View display the data for the monitor CIs corresponding to Business Process Monitor transactions, or metrics from other external monitoring sources, and for the logical group CIs. The End User Monitors View and End User Location View display the data for the monitor CIs corresponding to SiteScope monitors, Business Process Monitor transactions, or metrics from other external monitoring sources, and for the logical group CIs.

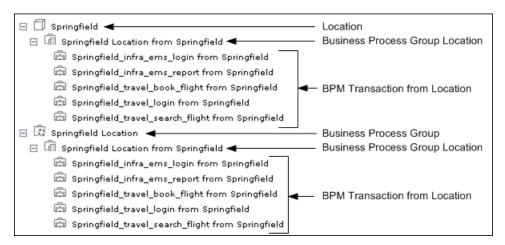

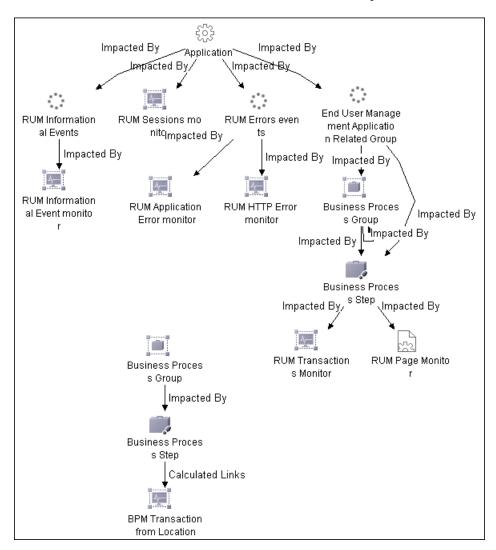

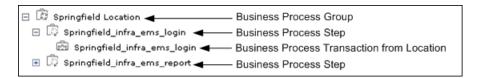

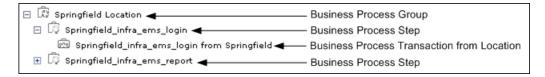

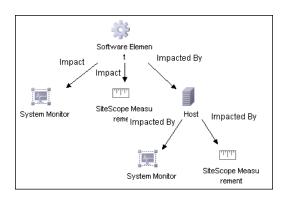

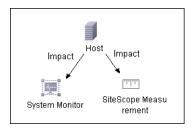

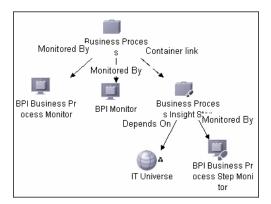


# \lambda Business Processes View for Business Process Insight

Business Process Insight data collectors send data and topology to Business Availability Center. The topology and data are about the business process flows and business process steps that you monitor to obtain meaningful impact data about the health of your business. For more information on defining business processes in Business Process Insight, see *Reference Information for Business Process Insight*.

The HP Business Availability Center templates for Business Process Insight create the processes topology in the CMDB using the Universal CMDB API. The topology includes group CIs and monitor CIs for the monitored Business Process Insight system.

### **Business Process Insight Cls**

The CIs are as follows:

- ➤ The **Business Process** CI represents the Business Process flow in Business Process Insight.
- ➤ The BPI Business Process Monitor CI is a child of the Business Process CI. It represents the Business Process Insight business process.
- ➤ The Business Process Insight Step CI represents an activity (a step) in the Business Process flow in Business Process Insight. The Business Process Insight Step CI is a child of the Business Process CI.

- ➤ The **BPI Business Process Step Monitor** CI monitors the corresponding activity in the Business Process flow in Business Process Insight.
- ➤ The **BPI Monitor CI** monitors as defined by the BPI monitor definer. At the same time as each new monitor definition is created in the BPI database tables, a BPI Monitor CI is created in the UCMDB. The BPI Monitor CI stores the Monitor Name, Description, Type, Units, Collection Interval, Threshold Operator, Server Name and Instance Threshold limits (where specified) as defined in Business Process Insight.

## **HP Business Process Insight KPI Assignment Group**

In Dashboard, the HP Business Process Insight KPI assignments group adds KPIs, rules, context menus, context menu items, and tooltips to those CIs. Status for these CIs can be viewed in Dashboard in the Business Processes view.

**Note:** Service Level Management has its own sets of KPIs and rules that are attached to CIs within agreements.

#### **Topology for Business Process Insight**

All the sample information sent by Business Process Insight data collectors is displayed by the Backlog, Volume, Business Impact, Value, and Duration KPIs attached to the BPI Monitor, BPI Business Process Step Monitor, Business Process Insight Step, BPI Business Process Monitor, BPI Value Monitor, BPI Duration Monitor, and BPI Custom Value Monitor CIs and propagated to the Business Process CI. To display BPI Value Monitor or BPI Duration Monitor CIs, you must define a value or a duration monitor in the BPI Monitor Definer.

In addition, the **Business Process** CI is assigned the **Business Health** and **Operational Status** KPIs. The rules listed in the table below calculate the statuses of those KPIs based on data obtained from Business Process Insight samples.

**Note:** The Business Health KPI in version 7.50 was renamed Business Impact in version 8.0. A new Business Health KPI has been added to the topology.

The Business Process Insight Menu, and the Business Process Monitor Group Menu context menus, Go to BPI context menu item, and the tooltips corresponding to the rules listed in the table below, are preconfigured to provide the appropriate infrastructure to work with the Business Process Insight-related CIs in Dashboard. #### **KPI Assignments for Business Process Insight**

#### Business Transactions View for TransactionVision

In the Business Availability Center Dashboard tabs, you can use the Business Transactions view to monitor the real-time performance and health of your business transactions. For information on setting up business transactions, see "Introducing TransactionVision" in *Using TransactionVision*.

The business transaction KPIs in the view reflect the data received in the latest sample (there is no aggregation of the sample data in Dashboard). For example, if a KPI has a value of \$2000, this value is only for the data received in the last sample, the value from the previous sample was not added to it. #### **Mapping End User Transactions to Business Transactions**

The Business Transactions view provides status information for back-end monitoring from TransactionVision, including CIs representing business transactions, and CIs representing the infrastructure elements that the business transactions are dependant on, as discovered by the TransactionVision sensors. For more information on the creation of the infrastructure CIs, see "CMDB Population Job" in *Using TransactionVision*.

You can add the end-user perspective by mapping end-user transactions from Business Process Monitor and Real User Monitor to the business transactions. As a result of this mapping, the following information is available in Dashboard:

- ➤ the branch for a Business Transaction CI includes KPI status information from the end-user perspective.
- ➤ the Flow Map page displays the Transaction Topology Flow Map for a transaction, including worst status Application and Performance measurements for the Web Clients component. For details, see "Transaction Topology Flow Map" in *Using TransactionVision*.

You set up the mapping in End User Management Administration, when defining Business Process profile and Real User Monitor transactions, or while editing existing transactions. Each transaction can be mapped to only one Business Transaction CI (but multiple Business Process Monitor and Real User Monitor transactions can be mapped to a single Business Transaction CI). 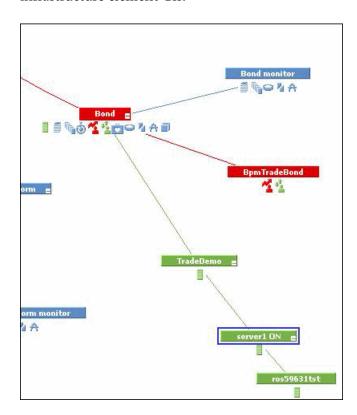

The KPIs and rules used by the TransactionVision data CIs in Dashboard are automatically assigned by the KPI Assignments mechanism, as described in "Edit Group Page" on page 468. **Backlog**, **Delays**, and **Volume** KPIs are always assigned by default to the Business Transaction and TV Monitor CIs; the **Exceptions**, **Failures**, and **Value** KPIs are each assigned by default, only if the corresponding attribute rule is defined for the business transaction in TransactionVision. (You can see which attribute rules are defined in the Properties page for the TV Monitor CI. For more information, see "TransactionVision Data in Business Availability Center" in *Using TransactionVision*.)

The **Duration** KPI must be manually assigned to the CIs.

The rules for the TV Monitor CI are all sample-based, and by default recalculate data for each new sample.

The Business Transaction CIs by default use the Business Transaction Group Rule for each business transaction KPI. This rule assigns value and status to the KPI by taking the value and status directly from the KPI for the child TV Monitor CI.

The business transaction KPIs do not include predefined objective thresholds. (The objective thresholds are used to assign a status to the KPI, based on the KPI value.) As each business transaction represents an individual business event, with individual business objectives, you need to set appropriate objective thresholds for each business transaction KPI, so that it displays a meaningful status. Until objective thresholds are defined, the KPI displays data with **Info** (blue) status in Dashboard.

You can edit the default KPIs and rules assigned to the CIs, and define objective thresholds for each KPI, in the **Admin > Dashboard > KPIs** tab.

# Dashboard Application Components in the Service Report

You can build Service Reports based on data from data sources from the Dashboard application. You can add Service Reports as portlets in My BSM or in Report Manager. After you have added Service Reports to the Report Manager, you can add the reports as custom report components to benefit from all the custom report capabilities. For details, see "Service Report Overview" or "Report Manager Overview" in *Reports*.

### About Menu Options

From the Top View, Console Hierarchy, and Filters tabs in Dashboard and from View Explorer in other tabs, you can access context menu options.

You access menu options by right-clicking a CI in View Explorer or by clicking the grey arrow button to the right of the CI in Top View, Console Hierarchy, and Filters tabs.

Depending on the selected view and selected CI, you can, among other possibilities, drill down to other HP Business Availability Center applications or to SiteScope, or open standalone reports or views. For example, you can view a trend report on the End User Management page, including measurement data for the CI over a specified time period.

The menu options that are displayed depend on the selected view and the selected CI. They can be a subset of the available options.

### Dashboard General Notes and Tips

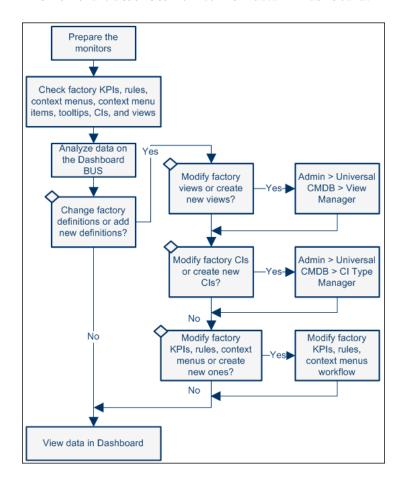
Note the following when working with Dashboard:

- ➤ It is recommended that you use Microsoft Internet Explorer as your browser when using the Dashboard application.
- ➤ User access to Dashboard views is limited by the viewing permissions specified for the user. If you cannot see a view, contact your administrator. For details, see "Permissions Overview" in *Platform Administration*.
- ➤ The first time you access Dashboard, you may experience a short delay while Dashboard compiles the page.
- ➤ Dashboard uses the timestamp of the database machine hosting the HP Business Availability Center database. The times displayed in the tooltips reflect the time zone setting on that computer. If you customize the time zone setting in HP Business Availability Center using the Admin > Personal Settings > General Settings option, then the customized time zone is also used in Dashboard.
- ➤ When Dashboard does not receive data for a Business Process profile because a Business Process Monitor is stopped (while the profile itself is not stopped), this is not specifically indicated in the tooltip. In this case, after a while the tooltip **Status** parameter displays **Not up to date**, and the **Warning** parameter displays the number of seconds during which no data has arrived.

### View Data in Dashboard – Workflow

To display data in views specific to your organization, create SiteScope monitors, Business Process and Real User Monitor monitors and run Discovery and Dependency Mapping on your system. The discovery process populates the CMDB. HP Business Availability Center collects data about end-users, business processes, and systems, and displays the data in topologies (views) relevant to your organization. Views display system performance data about your network and applications.

#### 1 Prepare the Monitors

To import data into HP Business Availability Center you must set up monitors as follows:

- **a** Create SiteScope Monitors. Create SiteScope Monitors to collect network and system data about your system for use in HP Business Availability Center. SiteScope monitors information is displayed in System views. For details, see "Configure SiteScope for Monitoring Workflow" in *Using System Availability Management*.
- **b** Create Business Process and Real User Monitor Profiles and Monitors. Create Business Process and Real User Monitor profiles and monitors to collect performance data for HP Business Availability Center. Business Process and Real User Monitor monitors information is displayed in End-User Monitor views. For details, see "General and Administration" in *Using End User Management*.

**Note:** You can map Business Process Monitor and Real User Monitor transactions in End User Management Administration, to business transactions from TransactionVision. For details, see "Map End-User Transactions to TransactionVision Business Transactions" in *Using End User Management*.

**c** Configure Diagnostics Servers and Probes to Monitor Your Applications. Configure the servers and probes that are going to be used by Diagnostics to monitor your applications. For details, see *HP Diagnostics Installation and Configuration Guide*.

You must also specify the Diagnostics server details in **Admin** > **Diagnostics**. For details, see "HP Diagnostics and HP Business Availability Center Integration" in *Solutions and Integrations*.

**d** Customize KPI Assignments – Optional. You can customize the appropriate KPI assignment rules. KPI assignment rules are designed to automatically assign to a specified CI, the appropriate KPIs, rules, and context menus when a specified condition occurs. The condition is usually when one of the CI's attributes has a specified value in the sample that is sent to HP Business Availability Center. For details on customizing KPI assignments, see "Manage KPI Assignment Groups" in *Using Dashboard*.

If required, you can customize the SiteScope KPI Assignments. For details, see "Work with the SiteScope Assignment Group" in *Using Dashboard*.

- **e** Customize the Source Adapters. If required, customize the Business Process Monitor, or Real User Monitor source adapters. For details, see "Configure a Source Adapter Workflow" in *Model Management*.
- **f** Run Discovery and Dependency Mapping. Collect information about your system by running Discovery and Dependency Mapping to enable you to discover the IT infrastructure resources and their interdependencies, such as applications, databases, network devices, servers, and so on. Each discovered IT resource is delivered to, and stored in, the configuration management database (CMDB) where the resource is represented as a managed configuration items (CIs).

Discovery is an ongoing, automatic process that continuously detects changes that occur in the IT infrastructure and updates the CMDB accordingly. You do not need to install any agents on the devices to be discovered. Discovery and Dependency Mapping processes have corresponding views that are automatically correlated with the CIs discovered during discovery and displayed in views. For details, see "Discovery and Dependency Mapping Content – Overview" in *Discovery and Dependency Mapping Guide*.

#### 2 Analyze Data on the Dashboard Bus

You can also define your own pattern, perspective, or template-based views to display only the information that is relevant to your organization's business needs. 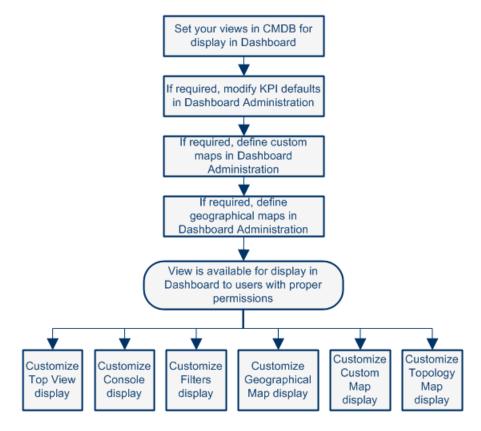

#### 1 Set Your Views in CMDB For Display in Dashboard

HP Business Availability Center provides several default views. If required, you can create custom views (pattern, perspective, or template views) in CMDB Administration.

For details on pattern, perspective, or template views, see "Create a Template Based View" in *Model Management*.

#### 2 Modify KPI Defaults in Dashboard Administration – Optional

Monitor CIs associated with default sources generally have default KPIs. For example, Business Process Monitor, Real User Monitor, and SiteScope monitor CIs that you configure in End User Management Administration or System Availability Management Administration, all have default KPIs.

Note that CIs with default KPIs that are placed under other CIs in a view generally propagate their KPIs upward to the parent CIs.

You can:

- ➤ Change the default business rule assigned to a KPI.
- ➤ Change the properties of the default business rule.
- ➤ Modify or delete a KPI associated with a higher level CI in a view if the KPI has the following characteristics:
  - ➤ It originates from a lower level CI.
  - ➤ It was propagated upward.

- ➤ It is not appropriate for the higher lever CI (for example, if you want to only see performance and not availability).
- ➤ Add a new KPI to a higher level CI. Proceed as follows: select **Admin** > **Dashboard**, select a view, and click the **KPIs** tab. For details, see "KPIs Page" on page 408.
- ➤ Save historical data for a KPI if you want to see the associated data in the KPI over Time report. For details, see "Persistent Data and Historical Data" on page 366.

## 3 Specify the Time Format Used in a CI Last Status Update Time – Optional

You can modify the default time format (am/pm hh:mm:ss) used in a CI Last Status Update Time. A CI Last Status Update Time information is usually displayed in tooltips. The time format is specified using a key. The key is translated into a localized format in the LocaleDate\_<locale>.properties file.

To modify the time format, select a valid key from <Gateway server root directory>\AppServer\resources\
LocalDate\_<locale>.properties, select Admin > Platform > Setup and
Maintenance > Infrastructure Settings, choose Applications, select
Dashboard Application, and enter the selected key in the Time Format Key
of Cl Last Status Update Time entry in the Dashboard Application - Filtering
Properties table.

#### 4 Define a Custom Map in Dashboard Administration – Optional

You can add status indicators to a custom image. The status indicators display the real time status for specified CIs. Each status indicator displays the worst status from all KPIs associated with that CI. For example, if you place on the image a status indicator for a Line of Business CI, the status indicator displays the worst status of all KPIs associated with the Line of Business CI.

The custom image can be useful for representing data centers, geographical distribution of IT resources, and so on. To add a custom image, select **Admin** > **Dashboard**, select a view, and click the **Custom Map** tab. For details on creating a custom map, see "Display a View in a Custom Map" on page 225.

## 5 Configure Geographical Map in Dashboard Administration – Optional

You can specify a geographical location in the location parameters for a CI in CMDB Administration. To define geographical locations for CIs, select **Admin > Universal CMDB > Modeling > It Universe Manager**. Select a CI in View Explorer. In the Information Pane, select the **Properties** tab and click **Edit**.

Those status indicators automatically appear, at the defined location, on the geographical map corresponding to views that include those CIs. When there are multiple CIs with the same defined location, one status indicator is displayed for the location, showing the worst status for all KPIs associated with all CIs at that location.

You can zoom and center the geographical map to focus on the parts of the map relevant to the associated view. To zoom and center the geographical map, select **Admin > Dashboard**, select a view, and click the **Geographical Map** tab. 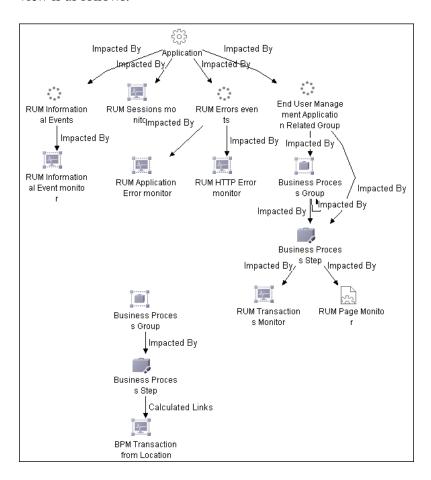

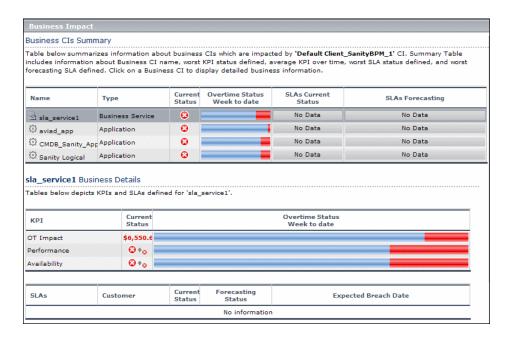

## 2 Modify the Default KPIs and Rules Used to Display Data in Business Impact

The system derives the parameters needed to get the data displayed in Business Impact from default KPIs and rules. For example, from the **Number of Open Incidents Rule** the system derives the state and severity of tickets to be counted in the over time number of open incidents.

If you change the KPI or rule to be used in the Business Impact report, you must configure the new KPI ID in Infrastructure Settings.

To modify the settings, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and locate the relevant entries in the Dashboard Application - Business Impact table. Modify the value of the following parameters:

- ➤ Number of Open Incidents KPI. Sets the ID number of the KPI that defines open incidents in the report. The default is 2600 for the Open Incidents KPI.
- ➤ Number of Open Incidents Rule. Sets the ID number of the rule that defines open incidents in the report. The default is 2600 for the Open Incidents rule.

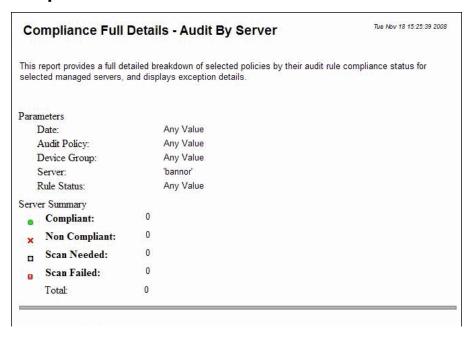

#### **Example**

You might have the situation where, in a specific view, the **Availability** KPI's status of the parent CI's is Critical while the **Availability** KPI's status of the CI's child CIs are OK. The Find Visible and Hidden Child CIs page displays the following information:

# Set Up Sound Notification When KPI Status Changes to Critical

You can set up Dashboard to play an alert sound when the status of a KPI changes to **Critical** in the Console or Filters tab.

When the view is loaded for the first time, no sound is played for the KPIs that are loaded at Critical status.

When the sound is switched on, a sound alert is played:

- ➤ In the Console tab. When the Console tab is currently displayed, and a KPI in the view changes status to Critical (red). The Critical status icon flashes until the next screen refresh. If a CI in a hidden part of the view has changed to Critical but does not change the status of any of the CIs in the currently displayed branches, no sound is heard.
- ➤ In the Filters tab. When the Filters tab is currently displayed, and a KPI in the view changes status to Critical (red). The Critical status icon flashes until the next screen refresh.

To change the default length (40 characters) of the CI name, select **Admin** > **Platform** > **Setup and Maintenance** > **Infrastructure Settings**, choose **Applications**, select **Dashboard Application**, and in the Dashboard Application - Dashboard Layout Properties table, modify the **CI name maximum character length** entry. When the CI name is longer than this value, it is shortened in the display and a tooltip displays the complete name.

## 2 Modify the Maximum Number of CIs to Be Displayed in Dashboard

To change the default number of CIs that can be displayed in Dashboard Console and Filters pages, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and in the Dashboard Application - Dashboard Layout Properties table, modify the Displayed CI limit entry. Default is 3000.

#### 3 Modify the Dashboard Tabs Refresh Rate

When you open a Dashboard tab for a view tree with a large infrastructure, you may experience a short delay while Dashboard builds the view.

The tab is refreshed every 30 seconds. If no change is made to the view, the display remains the same. If changes have been made to a view, or if CIs have been deleted from the view, that view's information in the tab is automatically reloaded after 30 seconds and displays the changes.

While reloading, the following message is displayed in the top right corner of the screen: **The model has changed. Reloading...** After reloading is complete, the following message is displayed in the top right corner of the screen: **Top view has been updated with model changes. Last Update** in the bottom left corner of the screen indicates the last time an update of the top view was reloaded.

The refresh rate of the view can be modified. To modify the refresh rate, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and locate the UI Refresh Rate entry in the Dashboard Application - Business Impact table. Change the default.

#### 1 Use Dashboard Administration Logs

To facilitate the creation of troubleshooting logs, you must enable Debug mode. For details, see "About HP Business Availability Center Logs" in *Reference Information*.

The logs are located in the <Data Processing server root directory>\log\EJBContainer folder:

- ➤ bam.app.rules.log. To verify the status of a KPI, scan the log file manually or use a script for errors in the rule calculations. The log should not contain any errors, such as Java exceptions.
- ➤ **TrinitySamples.log.** To verify that samples have reached the HP Business Availability Center bus, scan the log file manually or use a script for samples coming from SiteScope or Business Process Monitor.

You can use the BusDiscovery utility to search for samples transmitted on the bus. The utility is available under the **<Gateway server root directory>\tools\BusDiscovery** directory.

Use the following command to activate the utility:

D:\Temp\drv.log: sprinter -dc\_attach localhost -dc\_print\_format sample per line -drv log file

The utility dumps the arriving samples into the following directory: **D:\Temp\drv.log** 

#### 2 Monitor Usage in the System

You can monitor usage of the Dashboard application in a sessions log file. A line stating the number of users is added to the <HP Business Availability Center Gateway server root directory>\log\EJBContainer\bam.sessions.log file for each time period. For example, if a user accesses Dashboard, then closes HP Business Availability Center, then accesses Dashboard again, this counts as two user sessions in the log file.

To change the default time period, open the <**HP Business Availability** Center Gateway server root directory>\conf\settings\BACAppSettings.xml file, look for the keys: session.log.interval.0, session.log.interval.1, or session.log.interval.2., and change the key to match the required time period as follows:

Key	Represents:
session.log.interval.0	a 6 hour period
session.log.interval.1	a 12 hour period
session.log.interval.2	a 24 hour period

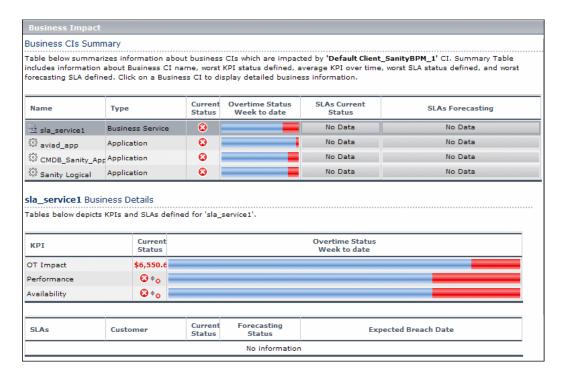

### **Loss of Data after Renaming Transactions**

If you rename a transaction in an HP Virtual User Generator script, Business Availability Center considers it as a new transaction. A new BPM Transaction from Location CI is created in the CMDB using the new name, and the CI with the old transaction name is removed after it stops receiving samples. In Dashboard, the new CI does not display trend and history status data from the period before the transaction name change.

### 1 Display/Hide the Ack Column in the Console Tab - Optional

By default, the Ack column is displayed. The Ack column can be hidden by users with administrative permissions. To hide/display the Ack column, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, click the Applications context, select Dashboard Application, and locate the Show CI Acknowledgment column in the Business Console area, and select false (hide the Ack column), or true (display the Ack column). The change takes effect immediately.

**Note:** When you hide the **Ack** column, the Acknowledgment-related context menu options remain available. For details, see "Menu Options" on page 75.

#### 2 Display/Hide the Ack Column in the Filters Tab - Optional

By default, the Ack column is displayed. The Ack column can be hidden by users with administrative permissions. To hide/display the Ack column, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, click the Applications context, select Dashboard Application, and locate the Show CI Acknowledgment column in the Filtering Properties area, and select false (hide the Ack column), or true (display the Ack column). The change takes effect immediately.

**Note:** When you hide the **Ack** column, the Acknowledgment-related context menu options remain available. For details, see "Menu Options" on page 75.

#### 3 Acknowledge a Problem

You can acknowledge a problem by clicking the **Ack** check box for a CI in the Console, and Filters tabs (you can clear the acknowledgment by selecting the check box again). For details, see "Acknowledgments Details Dialog Box" on page 109.

The acknowledgment icon is displayed in Top View for CIs corresponding to acknowledged problems.

You can unset the acknowledgement by clicking the icon, in the Console and Filters tabs.

You can also set/unset acknowledgment and view the CI acknowledgment history by using the context menu in the Top View, Console, and Filters tabs.

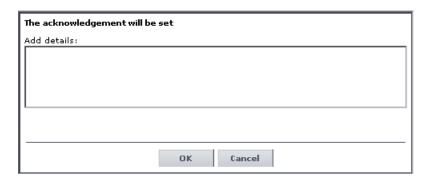
**Note:** The **Ack** check box is enabled only if there is at least one KPI defined for the CI, and at least one of the KPIs has a status other than **OK** (green).

#### Example - Set an Acknowledgment



To acknowledge a problem, click the down arrow to the right of a CI and select **Acknowledgement** > **Set/Unset Acknowledgment** (you can unset the acknowledgement by selecting the same option and clicking **OK**).

In the **Add details** box, enter information about the acknowledgment.



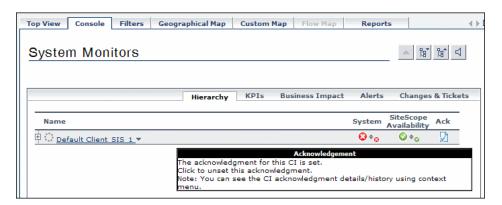
Click **OK** to set or unset the acknowledgment depending on the previous status of the dialog box.

#### 4 View a Problem's History

#### **Example – View Acknowledgment Details**

A tooltip for the **Ack** icon displays the current status of the CI's acknowledgment.



- To view the details of the current acknowledgment or the acknowledgment history of the CI, click the down arrow to the right of a CI and select **Acknowledgment > Acknowledgment Details**. You can then select one of the following options:
  - ➤ **Acknowledgment details.** Displays the details of the currently opened acknowledgment in the **Acknowledgment details** box.

➤ CI history. Displays the details of all of the acknowledgments over time in the Acknowledgment details box.



The **Acknowledgment details** box displays the date and time when the acknowledgment status was modified, the name of the user who modified the status, and the type of action that was performed. For details, see "Acknowledgment History and Details Dialog Box" on page 108.

You can add information about the actions you are going to perform to solve the problem in the **Add details** box and then click **Add** to add the information you entered to the acknowledgment history.

## Switch Off the Alert Sound When CI is Acknowledged

If you set up for sound notification when a KPI's status changes to **Critical**, you can select to turn the sound off when the KPI's CI is acknowledged. This way, you do not get sound notification when any of the acknowledged CI's KPIs status changes to **Critical**.

### 1 Set Up Sound Notification

### 2 Set Up Mute When Acknowledge Option

Select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and locate the Mute When Acknowledged entry in the Dashboard Application - Sound Notification table. Modify the value to true to mute the alert or to false to hear the alert. The change takes effect immediately.

## Monitoring Changes in Dashboard Overview

You can monitor changes made to CIs using the following capabilities:

- ➤ You can monitor the changes to CI properties in Dashboard by selecting the properties you want to monitor for changes for up to 20 CITs. Change icons displayed for the appropriate CIs, in the Console tab and in the Filters tab, indicate that changes were made to their change-monitored properties, in real time. You can view changes made to the monitored properties of additional CIs in the Change report. For details, see "Analyze Real-Time Change Information" on page 112.
- ➤ You can monitor the detailed changes logged by Change Control Management for a selected CI, if you are working with Change Control Management. For details, see "View Changes for a Specific CI" on page 115.

### 1 Set the CIT to Monitor Changes to Its Properties

Configure up to 20 CIs that you want to monitor for changes to a specific property. The significant properties vary for each CIT.

When the monitor changes option has been set for a CI, Dashboard continuously monitors that CI and all its child CIs, to see if a change occurs in one of the significant properties defined for the CIs.

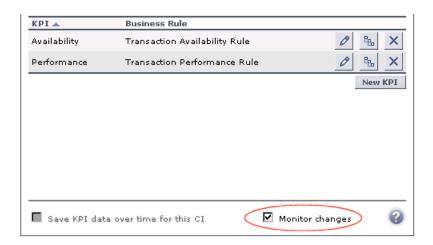
You can set the monitor changes option for up to 20 CIs. After you configure 20 CIs, a message is displayed when you try to set the option for another CI, stating that the limit has been reached.



For each configuration item type (CIT) properties you want to monitor, select Admin > Universal CMDB > Modeling > CIT Type Manager, click the Attributes tab, select the CIT, click the Add button, and select Change Monitored in the Advanced area in the Add/Edit Attribute dialog box. For details, see "Add/Edit Attribute Dialog Box" in Model Management.

### 2 Set Dashboard to Monitor Changes

To display real-time changes for a CI and its children, select **Admin** > **Dashboard** > **KPI**, select the appropriate CI and select the **Monitor changes** check box.



If you clear the option for one or more of the configured CIs, the option becomes available for all CIs, until the 20 CIs limit is reached.

### 3 Customize the Change Period

By default the Change icon is displayed for 24 hours (default value) after a change occurs. To modify the default time period (set at 1440 minutes (24 hours)) select Admin > Platform > Setup and Maintenance > Infrastructure Settings, click Applications context, select Dashboard Application, locate the Changes period in the Change Impact Properties area, and enter the time period (in minutes) in the Value box. The recommended value is the default: 1440 minutes.

**Note:** The change takes effect after the server has been restarted.

### 4 Customize the Number of CIs Monitored for Real-Time Change

In the Console tab and in the Filter tab, a limited number (20 by default) of CIs and their child CIs can be monitored for real-time changes at any one time. This number can be customized.

**Note:** You can increase the default number of CIs that can be monitored but be aware that this might overload HP Business Availability Center.

To modify the default number of CIs that can be monitored for change in real-time, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, click Applications context, select Dashboard Application, and modify the value of the Maximum monitored CIs parameter in the Change Impact Properties area. The recommended value is 20.

**Note:** The change takes effect after the server has been restarted.

### 5 View Real-Time Changes

If a change occurs in one of the significant properties of the CI or the CI's child CIs, you can view real-time changes as follows:

- ➤ Changes made to the first 20 CIs set to display real-time changes are displayed with change icons in the Console tab or in the Filters tab. To access the tabs, select **Applications** > **Dashboard**, select a view and click the **Console** or **Filters** tab.
- ➤ Changes made to other CIs are displayed in the Change report. The Change report enables you to view the changes made to CI's properties for all properties that were selected to keep this information. For details, see "Change Report Page" in *Model Management*.

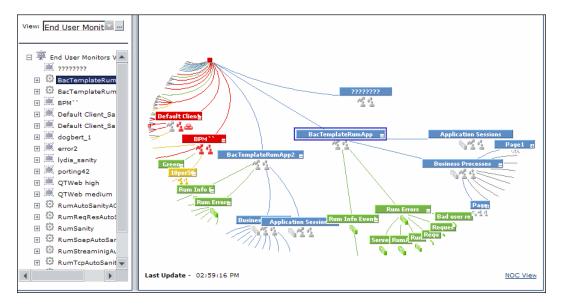

## **A** Top View Overview

Top View enables you to see the business availability of your system components at a glance. The CI bars in the tab provide a visual representation of real-time IT performance metrics mapped onto business applications, based on the hierarchy tree structure defined for each view. The connecting lines between the bars define the relationships between the CIs. For a detailed description of Top View, see "Top View Page" on page 136.



By presenting an integrated, single view of essential applications and business processes, Top View provides you with an overall perspective on the health of your business services, and enables you to instantly assess how a performance issue impacts the availability of any part of your business. Each CI in the active view is color coded to indicate the worst status held by the CI's KPIs.

### **Interactive Map**

The Top View tab presents an interactive map of the CIs that can be intuitively manipulated using the mouse, enabling you to drill down to specific branches of the tree and to focus on particular business areas or problem areas.

By default, the Top View tab displays four levels of CIs. The rest of the CIs are collapsed. You can expand CIs from the fourth level and see their child CIs.

The lines connecting the bars represent the branches of the tree. The bars and lines can be manipulated to change the amount of information displayed and the overall layout of the diagram, as described in "Top View Page" on page 136.

### **Understanding the Colors and the Icons**

Each CI contained in the view is displayed as a bar, color-coded according to the current worst operational status for that CI. For details on color coding, see "KPI Status" on page 355.



The icons displayed under a CI bar identify the relevant KPIs for the CI. These icons are also color coded to indicate the status of that KPI.

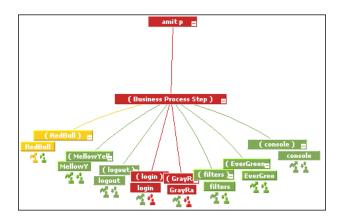
**Note:** The root CI does not display KPI icons because it is a container and not a real CI.

### **Virtual Containers**

Virtual container CIs are displayed in Top View in regular CI bars, but their names appear between brackets. The bar is color-coded according to the current worst operational status for the group CI's children CIs. You cannot right-click the bar to display context menu options.

Virtual containers are created by selecting the attribute by which you want to group the CIs in pattern views. For details, see "Node/Relationship Grouping Dialog Box" in *Model Management*.

### 1 Access Top View and Display the View Information

Select **Applications** > **Top View** to display the CIs of the selected view in a top-down, graphical diagram. Select the required view from View Explorer. The name of the selected view is displayed in the central bar of the diagram.

The configuration items (CIs) in the view are displayed in hierarchical format within a single, interactive graphical interface.

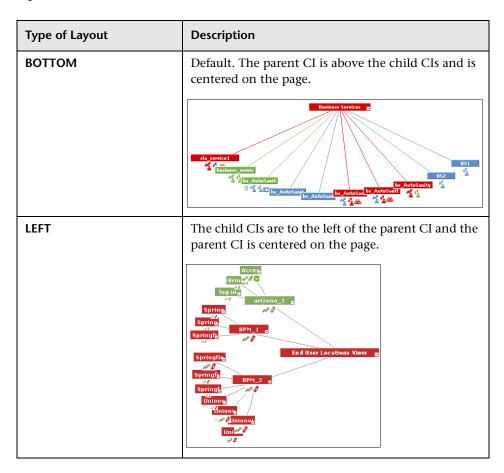

### 1 Customize the Layout of the Hierarchy in Top View

You can customize the layout of the hierarchy in the Top View page. By default, the parent CI is displayed above the child CIs and the child CIs are close to the bottom part of the Top View tab.

To customize the layout of the hierarchy, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and locate the Top View Graph Layout entry in the Top View Properties area. Select the type of layout (listed below in alphabetical order).

### 2 Modify the Default Refresh Rate of Top View

The default refresh rate for Top View is 30 seconds. To modify the default refresh rate, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and enter the required refresh rate in the Top View data refresh rate entry in the Dashboard Application - Top View Properties table.

### **3 Change the KPI Status Icons**

### 4 Viewing Chinese or Japanese Characters in Top View

### **5 Change the Text Color in Top View Bars**

You can improve readability or customize Top View by changing the color of the text in Top View bars.

Select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and locate the Top View Text Color Property entry in the Dashboard Application - Top View Properties table. Enter the appropriate color in the Value box, using the #RRGGBB format. Default is white (#FFFFFF).

You must close all browser instances for the change to take effect.

**Note:** The setting affects both Top View in Dashboard and the Top View portlet in My BSM.

### **6 Change Fonts in Top View**

To change the font displayed in Top View for all locales, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and locate the Top View Font Name entry in the Dashboard Application - Top View Properties table. Enter the appropriate font name in the Value box.

You must close all browser instances for the change to take effect.

### 7 Change the Caption Font Size in Top View

By default the size of the fonts used for Top View CI names (in the bars) is 9.

To change the default size, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and enter the required value in the Top View caption font size entry in the Dashboard Application - Top View Properties table.

The change is immediate.

### 8 Modify the Number of CIs Displayed in Top View

The maximum number of CIs displayed in Top View is 3000 by default.

To change the default value, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and enter the required value in the Maximum number of nodes entry in the Dashboard Application - Top View Properties table.

The change is immediate.

### 9 Specify the Maximum Length of the Line Between Two Cls

The default percentage by which you can extend the line between two CIs is 1.5. This is a parameter of the applet that displays the view tree.

To modify the default percentage, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and enter the required value in the Top View Line Extension Percentage entry in the Dashboard Application - Top View Properties table.

The change is immediate.

### 10 Change the Number of CI Levels Displayed in Top View

By default, the Top View tab displays four levels of CIs. The rest of the CIs are collapsed. You can then expand a CI at the fourth level and see its children.

To modify the number of levels displayed when you open the Top View tab, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and locate the Top View Number of Levels entry in the Dashboard Application - Top View Properties table. Modify the value. Valid values are 2 to 100. This change is performed during the next log in. If you select 2, the name of the view and the top level CIs are displayed.

## 11 Change the Number of CI Levels That Can Be Expanded in Top View

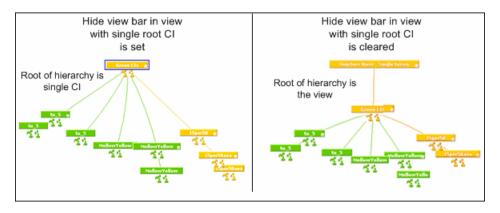
To change the default setting (7) for the number of levels of CIs that are displayed when you select the **Expand more levels** context menu item, on the Infrastructure Settings page, select **Admin > Platform > Setup and Maintenance > Infrastructure Settings**, choose **Applications**, select **Dashboard Application**, and locate the **Top View expand levels** entry in the Dashboard Application - Top View Properties table. Modify the value. Valid values are 2 to 12. This change is performed during the next log in.

## 12 Hide or Display the View Bar in Top View When the View has a Single Root CI

You can select to hide or display the view bar in the Top View tab, when the view has a single root CI.

To hide or display the view bar in Top View when the view has a single root CI, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and locate the Hide view bar in Top View entry in the Top View Properties table. Set the parameter to:

- ➤ true. The view bar is not displayed as the root of the hierarchy, the root of the hierarchy is the single root CI.
- ➤ **false**. The view bar is the root of the hierarchy.



## 13 Change the Color of the CI Bar in Top View When the CI Status is OK

You can modify the default green color (#66CC00) of the CI bar when the CI status is OK to another color or a different green.

To modify the color, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and enter a different color in the Top View Green Color Property entry in the Top View Properties table.

### 14 Customize the Background Image for Top View

To change the background color or add a background image to the Top View tab or to the NOC standalone page, select **Admin > Platform > Setup and Maintenance > Infrastructure Settings**, choose **Applications**, select **Dashboard Applications**, and locate in the Dashboard Application - Top View table:

- ➤ Top View Background Color Property. Modify the default value to change the color of the Top View tab background or of the NOC standalone page background. For example, you can display the Top View tab with a black background (#000000). You must close all browser instances for the change to take effect.
- ➤ Top View Background Image. Enter the name of the image you want to use as a background image for the Top View tab or the NOC standalone page and put the appropriate image in the following location:
  - <Gateway server root directory>/AppServer/webapps/site.war/bam/

You must close all browser instances for the change to take effect.

### **15 Customize Top View Tooltips**

You can:

### ➤ Limit the number of lines displayed in the tooltip

If the tooltip includes more lines than the default number of lines, **More...** is displayed on the last line.

To change the default number of lines (8) displayed in the tooltip, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and enter the required number of lines in the Max lines in tooltip entry in the Dashboard Application - Top View Properties table.

### ➤ Modify the tooltip font size

The size of the fonts in Top View tooltips is 8 by default.

To change the default font size, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and enter the required font size in the Top View Tooltip font size entry in the Dashboard Application - Top View Properties table.

### > Display the weight information in the tooltip

You can add the weight of a CI's KPIs to the CI's tooltip for any CI in Top View.

Select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and locate the Show weight property in tooltip entry in the Dashboard Application - Top View Properties table. Modify the value to true. Default is false (weight is hidden).

#### Note:

- ➤ The setting affects both Top View in Dashboard and the Top View portlet in My BSM.
- ➤ Using this option might affect the performance.
- ➤ Adding a weight to a CI is explained in "Relationship Page" in *Model Management*.

### 16 Set Up the Top View Debugging Mechanism

To debug Top View, set the debug mode. Log messages are printed to the Java console.

To debug Top View, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and set the Top View Debug entry in the Dashboard Application - Top View Properties table to true. Default is false.

## Access an External Application from Top View

You can configure Dashboard Top View so that a user can open an external application from the right-click menu.

### 1 Specify the URL of the External Application

The **Open in New Window** option calls the specified URL in another window and supplies it with the values of the parameters you specified in the URL. The URL page uses the values of the parameters to display what is necessary.

To specify the URL of the external application, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and locate the Top View URL to Open entry in the Top View Properties table. Enter the appropriate URL:

- ➤ Enter the URL of the application.
- ➤ Enter a dynamic URL that can be used, for example, to integrate external tools with HP Business Availability Center.

Use the following syntax (HTTP GET format):

http://<URL>?nodeName=NODE.NAME&nodeId=NODE.ID &nodeStatus=NODE.STATUS&nodeParentId=NODE.PARENTID &nodeChildId=NODE.CHILDIDS

Use only the parameters you need in any combination. For details about the parameters, see "Dynamic URL Parameters" on page 134.

For example:

http://<URL>?nodeName=NODE.NAME&nodeParentId=NODE.PARENTID adds the CI name and the ID of the parent CI to the URL.

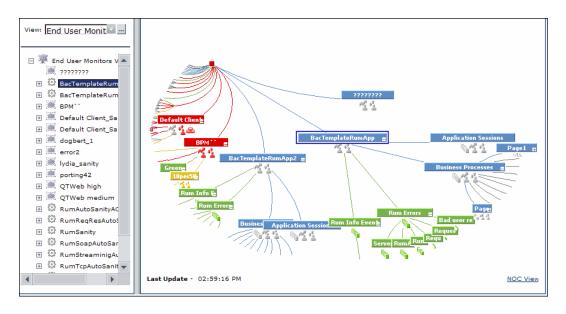

This tab enables you to see child CIs and their KPI statuses. If you select a view in View Explorer, the top level CIs in the view are displayed. If you select a CI in View Explorer, this tab shows its child CIs. For each CI, the tab shows its assigned KPIs and their statuses.

### **KPIs**

This tab enables you to see KPI status over time for the CI selected in View Explorer.

### 1 Rename or Delete Tabs Displayed in the Console Page

To rename or delete a tab on the Console page, locate the **View Console tabs configuration** entry in the Dashboard Layout Properties table.

➤ Within this XML file, each of the title fields shows a resource string key found in the <**HP Business Availability Center home directory**> \**HPBAC\AppServer\resources\BamResources.properties** file. If you edit the title field so that it no longer shows a valid resource string key, the text in the title field is used as the tab name.

For example, to rename the Hierarchy tab as the Child CI tab, replace the text <title>view360.tab.title.hierarchy</title> with <title>Child CI</title>.

➤ To delete a tab, delete the section within the XML file beginning with <**TabConfig>** and ending with </**TabConfig>**, which contains information on the tab you want to delete.

### 2 Modify Duration Settings for Console Tabs

By default, the Alerts tab displays KPI over time data for the previous day, and the KPIs, Business Impact, and Changes and Incidents tabs display data for the previous week.

For each of these tabs, you can change these settings to previous week, day, or hour (up to the current time).

To modify the KPI over time setting, locate the **View Console tabs configuration** entry in the Dashboard Layout Properties table. Modify the **TimeRange** entry value in the **View Console tabs configuration** entry. The possible values are:

- > Scorecard.Portlet.Edit.TimeRange.PastHour
- ➤ Scorecard.Portlet.Edit.TimeRange.PastDay
- ➤ Scorecard.Portlet.Edit.TimeRange.PastWeek

### 3 Modify Refresh Rates of the Tabs Displayed in the Console Page

By default, the Hierarchy tab is refreshed every 30 seconds, and the other Console tabs are refreshed every five minutes.

To modify refresh rates, locate the **View Console tabs configuration** entry in the Dashboard Layout Properties table. Modify the value of the **refreshRate** field in the **View Console tabs configuration** entry. Refresh rate is a value in seconds.

If you leave the refresh rate field blank, the default refresh rates apply. However, the **<refreshRate**/> field must exist in the xml to enable data display.

### 1 Modify the Number of Levels Displayed in the Hierarchy Tab

By default, when you select a CI or view in View Explorer, the Hierarchy tab displays the CI's children (or the parent CIs in the view), which can be expanded to show their children. This represents two levels of hierarchy display.

To modify the number of levels that can be displayed in the Hierarchy tab, locate the **Business Console - Number of display levels** entry in the Dashboard Layout Properties table. You can select a value between 1 and 4. If you specify 1, the child CIs are displayed but cannot be expanded.

### 2 Display Children Expanded in the Hierarchy Tab

By default, when you select a CI (or view) in View Explorer, the Hierarchy tab displays the CI's children (or the parent CIs in the view), collapsed.

To display the children expanded when accessing the Hierarchy tab, change the **Business Console - Default state** in the Dashboard Application - Dashboard Layout Properties table to **expanded**.

### 3 Display Hierarchy Information in Columns

By default, the Hierarchy tab displays a single table. To display the Hierarchy tab information in two or three columns, open the **Business Console** - **Number children sections** in the Dashboard Application - Dashboard Layout Properties table, and specify the number of columns you want to display. You can select a number between 1 and 3.

### 4 Add a Details Link to CIs in the Hierarchy Tab

You can add a Details link to the CIs displayed in the Hierarchy tab, to display CMDB details such as CMDB ID, CMDB Property names and values, and KPI calculation results.

In the Dashboard Application - Dashboard Layout Properties table, modify the **Show element CMDB details link in UI** entry. Default is false. For a list of the details displayed in this link, see "Node Details Dialog Box" on page 94.

## $oldsymbol{\widehat{r}}$ Customize the Business Impact Tab

By default, the Business Impact tab can show the following CI types (CITs), if they are have an Impact relationship with the selected CI: Business Services, Business Processes, and Applications.

The following section describes how to modify which CITs can be displayed in the Business Impact tab, or which relationships are monitored in this tab.

**Note:** If you make changes using the following procedure, these changes are also reflected in the Business Impact Report. To modify which CITs are displayed in the Business Impact tab:

- 1 Select Admin > Universal CMDB > Modeling > Query Manager, and select the SearchForBusinessImpact query.
  - Within this query, the **ITU\_Triggered** node represents the CI selected in a view, and the **Business\_Impacted** node represents the CITs which can be impacted by this CI.
- **2** Right-click the **Business\_Impacted** node and select **Node Properties** to open the Node Properties dialog box. Within the **Attribute** tab, modify the query to add or remove CITs. For details, see "Create a TQL Query" in *Model Management*.

**Important:** Do not change the name of the **SearchForBusinessImpact** query, or the name of the **ITU\_Triggered** node.

When modifying the query, note the following:

- ➤ Use an **Or** relationship between CIs, rather than an **And** relationship.
- ➤ Use the actual name of the CIT, rather than the display name. To see the actual name, select Admin > Universal CMDB > Modeling > CI Type Manager, and select a CIT. On the Details tab, the Name field displays the actual name.
  - For example, to add the CI type Business Process Step, use the name bp\_step, as it appears in the **Name** field on the **Details** tab.
- **3** After adding or removing CITs from the query, you must add or remove them in View Manager from the **view360\_BusinessImpact** view.
  - Select Admin > Universal CMDB > Modeling > View Manager, and select the view360\_BusinessImpact view.
- **4** Add or remove CITs to the view, so that it corresponds to the query you defined in Query Manager.

### To modify the relationships monitored in the Business Impact tab:

By default, the relationship type monitored in the Business Impact tab is the Impact type relationship. Use the following procedure to modify which relationships are monitored.

- 1 Select Admin > Universal CMDB > Modeling > Query Manager, and select the SearchForBusinessImpact query.

### Filters Overview

The Filters tab enables you to view operational status for specific segments or components of your business. The Filters tab displays (in a flat non-hierarchical way) the configuration items (CIs) that match the following criteria: they belong to the selected view, and at least one of their Key Performance Indicators (KPIs) has the status specified in the active filter.

### 1 Select a View in View Explorer

The data displayed in the Filters tab depends on the view you have selected. For details, see "Filters Page" on page 187.

#### 2 Set the Active Filters

You use the **Active Filters** capability to create filters that enable you to filter the CIs displayed in the Filters tab, enabling you to focus on the specific view, on specific CI types or statuses, or on problematic areas. For details, see "Filters Page" on page 187.

### 3 Add a Details Link to CIs in the Filters Page – Optional

To add a Details link for every CI in the Filters page, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, choose Applications, select Dashboard Application, and in the Dashboard Application - Dashboard Layout Properties table, modify the Show element CMDB details link in UI entry. Default is false.

The Details link enables you to view CMDB information about the CI. For details, see "Node Details Dialog Box" on page 94.

### Search for Specific CIs and Filter the Results

You can search for a specific CI using the View Explorer search function to filter the list of CIs that HP Business Availability Center displays. For more details on the Search feature, see "View Explorer" in *Model Management*.

You can locate CIs by their name, by related CIs, by their CITs, in the current view, or in all views. If, in addition to using the Search feature in View Explorer, you display the Filters tab in the right pane of the Dashboard, the resulting filtered report displays only the CIs that have been located by the search filtered by the selected filter in the Filters tab.

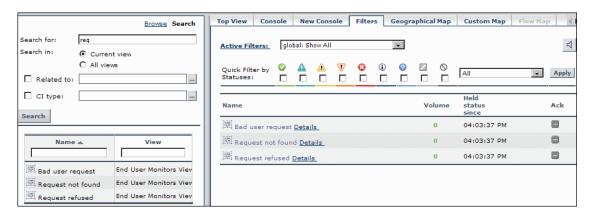
#### Example – Searching for CIs in the Current View

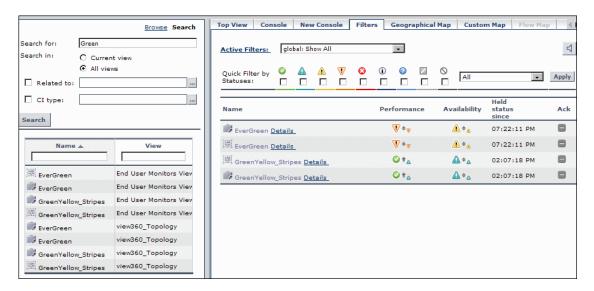

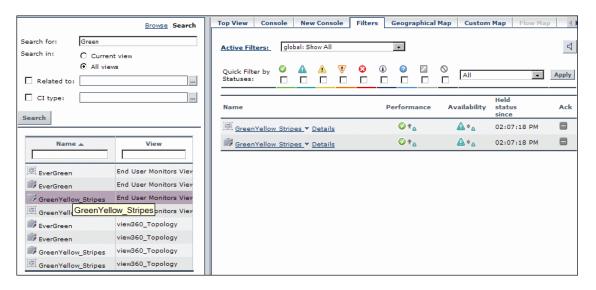
### **Example – Searching for CIs in More Than One View**

You can search for CIs in all views by name, related CIs, or their CITs.

➤ The result is a list of all of the CIs and the views that include them, corresponding to the search criteria listed in View Explorer. The Filters tab displays a filtered list of the CIs corresponding to the search criteria, filtered by the active filter and the current operational status in each KPI for each of the CIs.



➤ You can click a specific CI in the results of the search list to display in the Filters tab a filtered list of the CIs corresponding to the search criteria and to the selected view, filtered by the active filter and the current operational status in each KPI for each one of those CIs.



### Create or Customize an Active Filter

**Active Filters** enable you to focus on a specific view, CI type or status, or problematic areas.

The currently active filter is displayed in the **Active Filters** box in the Filters tab. You can select a different filter from the **Active Filters** list.

The **Active Filters** list contains the Dashboard predefined filters (shown as gray text strings) and any additional filters you defined (shown as black text strings).

To define or customize filters, access the Filters tab, and select one of the following options:

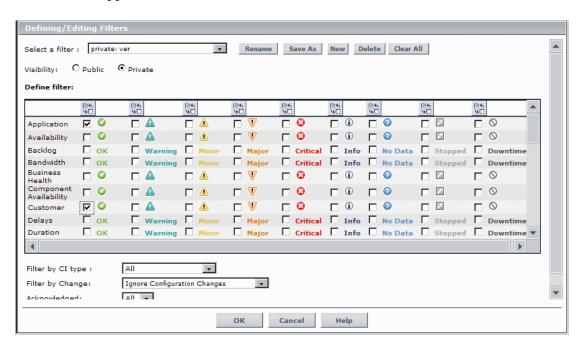

## 🦒 Create a Temporary Filter Using Quick Filter

Quick Filter enables you to display the selected view's CIs whose KPIs have at least one KPI with the selected statuses. The filter is a temporary filter that persists until you log off, change its selection of statuses, or select another filter.

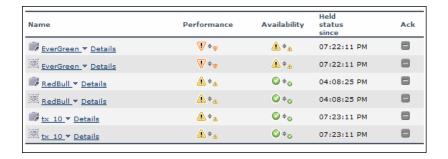

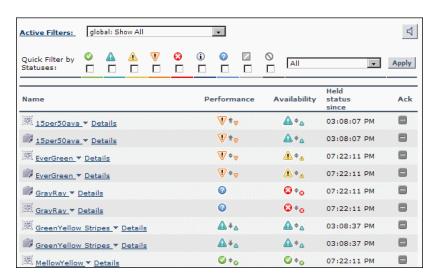

# \lambda Geographical Maps

In Dashboard, you can associate a geographical map with a view. If you have specified geographical locations for the view's CIs, real-time status indicators representing the CIs statuses are displayed on the map at those locations. For details on the geographical map user interface, see "Geographical Map Page" on page 212.

In Dashboard Administration, in the geographical map, you can shift the map's focus and enlarge or shrink the map to fit the view it represents. When you save the changes, the modified map is automatically displayed when you select the view in the Geographical Map tab in Dashboard Application. For details, see "Geographical Map Page" on page 212.

If you have an Internet connection, geographical maps can be displayed using Virtual Earth. For details, see "Understanding Virtual Earth" on page 198.

If you do not have an Internet connection, geographical maps can be displayed using a maps applet. For details, see "Understanding the Maps Applet" on page 199.

**Note:** The Virtual Earth map is only available in English and cannot be translated. For localization, use the maps applet. The Maps Applet does not display the names of cities or countries.

### **Location Status Information**

The map displays color-coded status indicators that represent the worst KPI status for all CIs attached to the location at each geographical location. The color coding is the same as for other icons in Dashboard. For more information about color coding, see "KPI Status" on page 355.

The location is defined individually for group or leaf (monitor) CIs in a view. You can specify the CI location when you define a new CI or when you edit a CI's properties. For details, see "Configuration Item Properties Dialog Box" in *Model Management*. You can also specify geographical locations for enduser groups in "New/Edit End-User Group Page" in *Using End User Management*. If you do not specify a geographical location for at least one CI in the view, the Geographical Map tab displays only the map.

Each status indicator in the map can represent one or more CIs from the view with the same location. If you select a CI in View Explorer, the geographical map is redisplayed automatically and shows only the selected CI and the CI's children status indicators if a location is specified for them. If you select another view, the geographical map reloads automatically to show the view's CI status indicators in the appropriate locations.

If you search for a specific CI in View Explorer and you click the result of the search, the geographical map is not automatically redisplayed. The map is redisplayed only when you go back to browser mode. It shows only the selected CI and the CI's children status indicators if a location is specified for them.

### **Understanding Google Earth**

**Note to HP Software-as-a-Service users:** This feature is not available when working with HP Software-as-a-Service.

You can view the geographical map information in a three-dimensional map using the Google Earth feature. This feature is available only to the administrator.

**Note:** The integration of CI locations with your Google Earth installation is at the beta stage.

### **Understanding Virtual Earth**

If you have an Internet connection you can display the geographical map using Microsoft MSN Virtual Earth. HP Business Availability Center integrates Virtual Earth online mapping functionality, available over MSN, to enable you to use the geographical map of a view. If the view's CIs are assigned geographical locations, real-time status indicators are displayed on the map at those geographical locations.

Virtual Earth geographical maps are based on Microsoft Network (MSN) technology and use dynamic HTML.



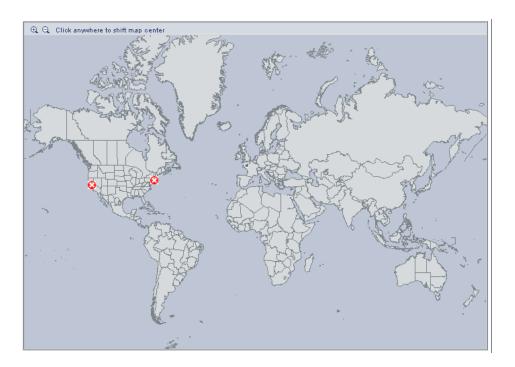
The Virtual Earth geographical map presents a flat geopolitical view of the planet where you can display the country borders, the geographical features, or both.

When you magnify the view, the main cities appear for the part of the map that is displayed on the screen.

### **Understanding the Maps Applet**

The maps applet presents a flat geopolitical view of the planet.

You can use the maps applet to display the geographical map of a view. The map displays the worst status at each geographical location and detailed information about the CI's KPIs.

### 1 Setup Requirements for the Map Applet

The maps applet requires that Sun JRE plug-in 1.6.0\_x (latest version recommended) be installed on the client machine.

The city names use UTF8 format. If HP Business Availability Center is working with a Microsoft SQL Server, or an Oracle Server that is not configured for UTF8 support, non-English characters (for example, é) are displayed as empty square brackets [].

### 2 Assign a Geographical Location to the Appropriate Cls

To view the real-time status indicators corresponding to a view's CI on the map, you must assign a geographical location to the relevant CIs in the view.

Select Admin > Universal CMDB > Modeling > It Universe Manager. Select a CI in the topology map or View Explorer. In the Information Pane, select the **Properties** tab, click **Edit**, enter the country, state, and city information in the Properties dialog box, and click **Apply**.

### 3 Select the Display Technology

You can display a geographical map using Virtual Earth, a maps applet, or Google Earth. You must select the display technology as follows:

- ➤ Virtual Earth. If you have an Internet connection, use Virtual Earth to display the geographical map. To enable Virtual Earth, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, click Applications, select Dashboard Applications, and locate the Use Virtual Earth entry in the Dashboard Application Maps Management Properties table. Set the property value to true. This is the default.
- ➤ Maps Applet. If you do not have access to Internet, use the maps applet to display the geographical map. To enable maps applet, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, click Applications, select Dashboard Applications, and locate the Use Virtual Earth entry in the Dashboard Application Maps Management Properties table. Set the property value to false.
- ➤ Google Earth. The Google Earth display technology is available only in Dashboard Administration. If you have access to Internet, you can use Google Earth to display the geographical map. You must specify that you want to display the Export to Google Earth button in the Geographical Map tab in Dashboard Administration. To display the Export to Google Earth button in the Geographical Map tab in Dashboard Administration, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, click Applications, select Dashboard Applications, and locate the Enable Export to Google Earth button entry in the Dashboard Application Maps Management Properties table. Set the property value to true (false hides the Export to Google Earth button).

**Note to HP Software-as-a-Service users:** The **Export to Google Earth** button is not available when working with HP Software-as-a-Service.

**Note:** Google Earth is available only in Dashboard Administration and only to users with administrative permissions.

### 4 Assign a Geographical Map to a View

Assign a map to a view by selecting a view in the Geographical Map and saving the map.

To assign a geographical map to a view, select **Admin > Dashboard**, click the **Geographical Map** tab to open the Geographical Map Administration page, select the appropriate view in the **View** list in View Explorer, and click **Save**.

If you assigned geographical location to a view's CIs, the corresponding status indicators are displayed on the map as soon as you assign a map to the view.

**Note:** To remove CI icons from the map, you must delete their geographical location.

### 2 Import Location Status into Google Earth

You can import the location status information shown in the geographical map for the current view into a local Google Earth application. After importing the information, Google Earth displays all the CI status indicators in the appropriate geographical locations.

To list all the views you create in the same folder, create a new folder (for example, an HP Business Availability Center folder) in the **Places** folder in Google Earth, and then add to that folder all the views you create.

You can create a view in Google Earth by creating a network link using the view's URL. This creates a container folder and a sub-folder.

To import location status into Google Earth:

For example, in the End User Locations view, the bpm\_profile\_1 CI is located in New York, New York, USA, the tx\_10 CI is located in Baden-Baden, Germany, while the tx\_10 from wall\_sanity1 is located in Rome, Italy.

To view the connecting lines:

- **a** In Google Earth, select the view you want to display.
- **b** Select **Connecting Lines** in your view folder to display the connecting lines in Google Earth.

If you select **Connecting Lines** in more than one view, you can see all the lines of all the selected views at the same time.

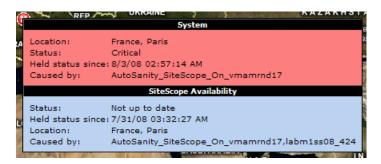

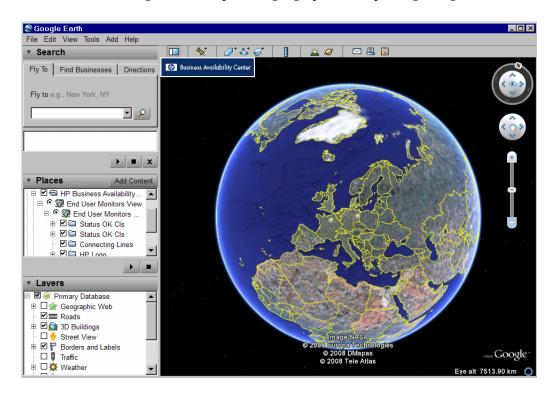

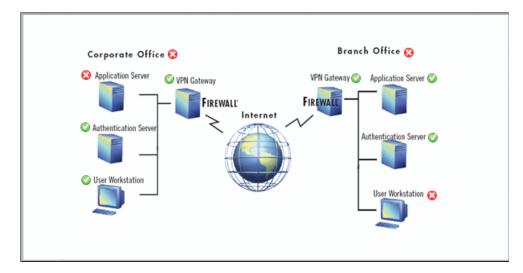

# Custom Maps

The Custom Map feature enables you to associate a view's CIs represented by real-time status indicators with a custom image that describes the real world that your view represents. The graphical representation of a view used by your organization can be a logical network diagram, business logic, or any other graphics. For details on the custom maps user interface, see "Custom Map Page" on page 230.

For example, you can associate a graph representing your company's network with real-time data coming from the different parts of the network.



One custom map can be defined for each view. The image shown in the Custom Map tab is the one defined for the active view. When you select a different view, the corresponding image is automatically displayed in the tab. If you do not define a custom map for a view, users accessing the Custom Maps tab, when that view is active, see a message stating that there is no defined image for the view.

You can create a custom map by adding CI icons from the view and associating them with elements of the custom image. The status indicator shows the worst status (worst of all KPIs) for that CI.

When you place the cursor over the status indicator, a tooltip shows the name of the associated CI, and KPI details. For details, see "Custom Map Page" on page 230.

When you click a status indicator, the corresponding CI in the View Explorer is highlighted. If necessary, the View Explorer automatically expands to show the selected CI.

When your site does not have an Internet connection, you can upload an image or the URL of an image to be used as the background image.

#### Note:

- ➤ The tab displays the image centered in the image pane. If the image is larger than the image pane, use the scroll bars.
- ➤ When a CI is removed from the IT universe model, the corresponding CI icon (in Dashboard Administration) and the corresponding status indicators (in Dashboard) are automatically removed from the relevant custom maps.

### 1 Create a Custom Map for a View

You can create a custom map by selecting a view and attaching the URL of the custom image or the image itself to that view. For details, see "Custom Map Page" on page 230.

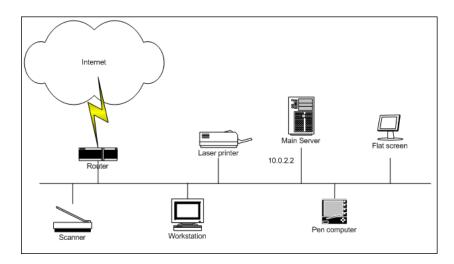
Any type of image supported by the browser can be loaded from any URL (including HTTP protocol and HTTP authentication) but then you must ensure that the URL is available at all times.

You can also upload a file system image if you want the image to be available at all times.

The ideal image to select depends on the customer's environment. The custom map feature does not resize the image, so it might look different in different resolutions. Additionally, you can view the Custom Map tab with or without View Explorer which influences the size of the image you want to display.

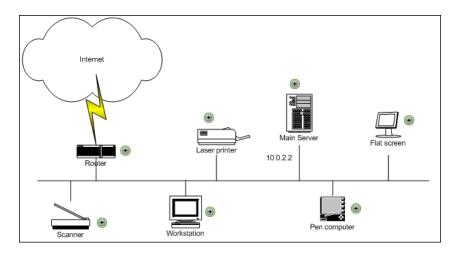

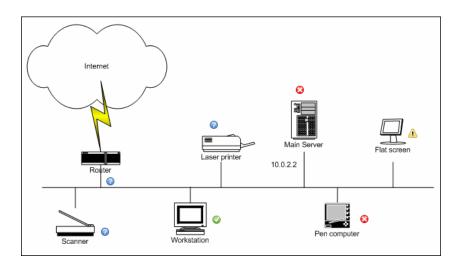

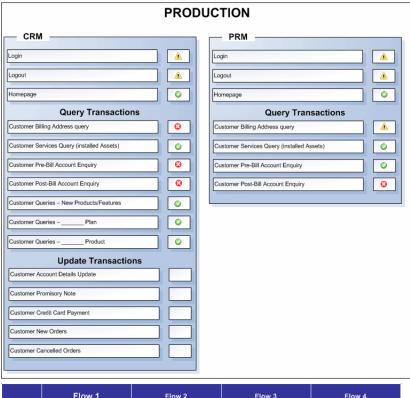

# Flow Map Overview

The Flow Map tab displays a flow map for specific CIs related to Business Process Insight or to TransactionVision.

In the Business Processes view, the flow map displays pre-configured flow map information about specific CIs, according to the level of the CI in the topology (monitor or group CI). For details, see "Business Process Insight Flow Map Overview" on page 245.

# Mapping of Other CI Types

The **def.xml** file defines the links between the CI types and the relevant flow map diagram resources. A link is expressed as a pre-processor class and a set of parameters for the class instance. The pre-processor class is used to specify the URL of the flow map diagram resource.

2 In the def.xml file, create new links or edit existing links between a CI Type and the URL of the corresponding flow map resource using the following format:

Use the following parameters to define the links:

- > ci type is the name of the CI Type. To find the internal name of a CIT, select Admin > Universal CMDB > Modeling > CI Type Manager, select the appropriate CIT in View Explorer and click the Details tab, and view the name of the CIT in the Name box.
- ➤ dashboard auto refresh state represents the auto-refresh feature of the mapping mechanism. If it is set to:

# \lambda Business Process Insight Flow Map Overview

The Business Process Insight Flow Map gives you a visual overview of the overall status of the health of your Business Process.

Specifically, the Flow Map provides you with visibility into the health of the Business Processes that are running over your IT infrastructure. Using this information, you can assess the business impact of delays or blockages in a Business Process due to an IT performance problem or other incident such as an IT outage.

**Note:** Flow Map is referred to as a Process Diagram throughout the Business Process Insight Server documentation.

You create a Business Process using the Business Process Insight Modeler and you link individual Steps in the Business Process to CIs, which represent information held for your business and its IT infrastructure.

A Business Process is a high-level model that represents a key business activity within your business or organization, for example, an order processing process, or an insurance claim process. Using the Business Process Insight Modeler, you can model your Business Process, or Processes, and link information held for your business and its IT infrastructure, in the form of CIs, to Steps in the process.

Business Process Insight then checks for changes in the state of the IT infrastructure CIs and presents the change in status as a process diagram located on the Flow Map. As a result, if there is an IT operational resource failure, and a Step in your Business Process relies in this resource, the process diagram provides a visualization of the impact of the IT failure on your Business Process and thus the impact of this failure to your business activity.

For information about how to construct a Business Process using the Modeler, see the *Business Process Insight Integration Training Guide - Modeling Processes* guide. There is also information available within the Modeler from the Modeler **Help** menu option.

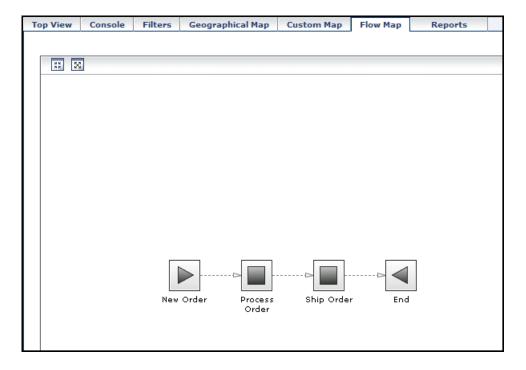

### **Business Process Insight Server**

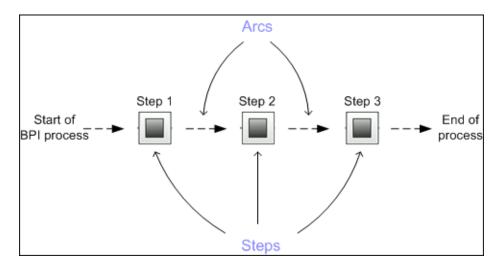
If you have installed the Business Process Insight Server, you are able to model Business Processes and also individual instances of Business Processes (an instance might be a specific customer order with a unique customer identifier). As a result, there is additional information available on the process diagram. This is information that provides data relating to the individual instances of the Business Process; for example, the current value of all orders at a particular Step in the process, or how many orders are currently being processed at a particular Step. The Business Process Insight Server might be maintaining many processes instances, for many customers, at any particular time.

Installing the Business Process Insight Server provides additional features that enable you to visualize and track the state and business health of Business Processes within your organization; this is in addition to monitoring the IT infrastructure. For more information, see the *Reference Information for Business Process Insight* guide.



## **Structure of a Business Process Insight Business Process**

Within Business Process Insight, a Business Process is presented as a series of Steps, and connectors that are called Arcs. The Steps represent the business activities and the arcs connect the Steps to show the expected direction of flow within the Business Process; this is shown in the following diagram.



Business Processes and Business Process Steps are represented as CIs within the UCMDB as follows:

Business Process	Stores the Process Name and Process Description as entered using the Business Process Insight Modeler.
	A Business Process CI is created for each Business Process.

There are no CI types for arcs.

When you install the Business Process Insight Server, additional CI types are defined for Business Process Insight, these additional types are listed in "Enhancing BAC with Process Instance Monitors" in *Using Business Process Insight*.

# Business Process Insight Licensing Options

The detail presented on the Flow Map varies according to whether or not you have purchased a suitable license for the Business Process Insight application:

- ➤ You do not have a license for the Business Process Insight application.
  - In this case, you can model Business Processes, map process Steps to IT operational resource CIs and monitor the impacts of the IT operational resources using the Flow Map. A Business Process might be the definition of an order processing procedures where individual steps in the procedure rely on IT systems within your organization, for example, an order processing database, or a customer database.
- ➤ You do have a license for the Business Process Insight application and have installed the Business Process Insight Server.

In this case, additional information is presented on the Flow Map; this information enables you to monitor business and operational data related to individual process instances. As an example, you can monitor and track the progress of an individual customer order and view the business data associated with this particular order. This business data might be the value of the order, or the number of customer orders currently being processed at a particular Step in the process.

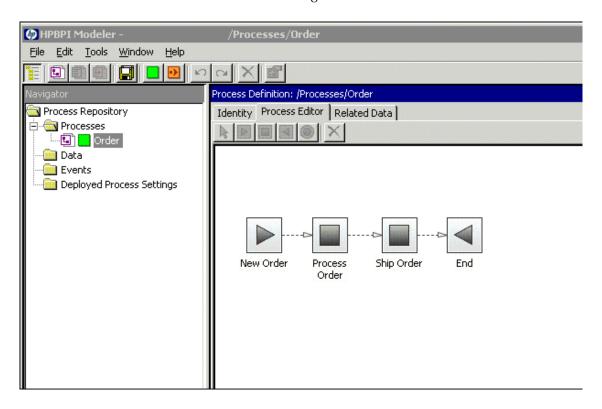
In order to view a Business Process within the Flow Map, you must first create and deploy a Business Process using the Business Process Insight Modeler. To access the Business Process Insight Modeler, select **Admin** > **Business Process Insight** > **Modeling**, click the icon for the Modeler on the page, or the Modeler label, and wait for the Modeler to launch as a Java Web Start application.

You might be asked to confirm that you want to download the files to open the Modeler within your Web page. If required, confirm that you want the download to proceed.

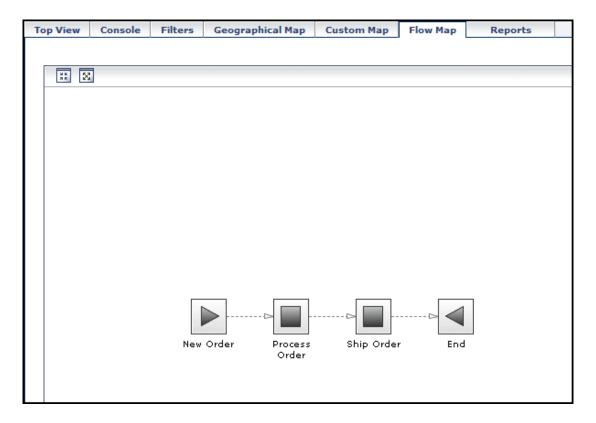
The amount of detail shown on the Flow Map depends on whether you:

- ➤ have the Business Process Insight Server installed and configured.
- ➤ are viewing a Business Process that has been created to enable you to monitor the status of business events, in addition to the status of the IT infrastructure.

If this is a standard HP Business Availability Center installation and you have not installed a Business Process Insight Server, the Flow Map shows details of the Business Process and its dependencies on the IT infrastructure CIs that you have configured.

### Example

The following is an example of the Order process as viewed within the Flow Map for a HP Business Availability Center installation where there is no Business Process Insight Server installed and configured.



If you have installed a the Business Process Insight Server and deployed a Business Process to additionally enable you to monitor individual instances of Business Processes, the Flow Map shows additional information. This information shows additional information that relates to the business health of your process.

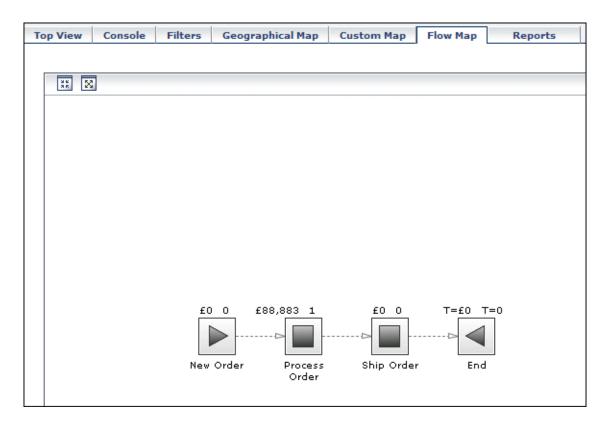

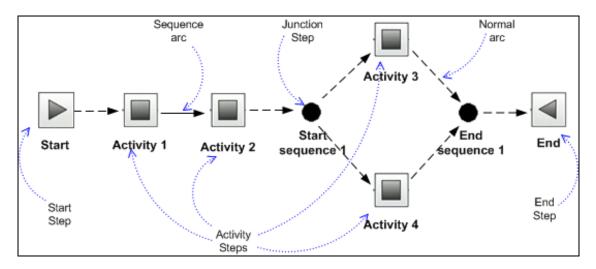

### Dashboard Reports Overview

Dashboard reports enable you to view and analyze performance data collected by HP Business Availability Center data collectors and stored in the HP Business Availability Center database.

The Dashboard reports are:

- ➤ KPIs Summary. Displays a summary of KPI status distribution over time for each selected KPI. For details, see "KPIs Summary Report" on page 291.
- ➤ **KPIs Trend.** Displays the trend for changes in KPI status over time, for selected statuses. For details, see "KPIs Trend Report" on page 294.

- ➤ KPIs Distribution Over Time. Displays KPI status distribution over time for selected statuses. For details, see "KPIs Distribution Over Time Report" on page 273.
- ➤ KPIs Over Time. Displays the status or value, over time, of selected CIs and KPIs that are accessible from the Dashboard application. For details, see "KPIs Over Time Report" on page 277.

You can print the generated report, send the report by email, open the report in different formats, publish the report in different formats, or save the report to the report repository. For details, see "Working in Reports - Overview" in *Reports*.

#### Note:

- ➤ Data is displayed in a report starting from the point that data was collected for the selected CIs. For example, if you set the report to show data every week for the past month, but data was collected only for the past two weeks, the report shows data starting from two weeks ago to the present date.
- ➤ The KPI Summary, KPI Trend, and KPI Distribution Over Time reports are generated only for CIs of type **Application**, **Business Process**, **Business Service**, and **Line of Business**; in addition, the CIs must be flagged to save KPI data over time (historical data). For details, see "Persistent Data and Historical Data" on page 366. (Contact HP Software Support if you need to change the supported CITs.)
- ➤ HP Business Availability Center records in a reports log errors that occur when generating reports. The reports log can also include the following activities: creating a new report, generating a report, modifying the report filters, drilling down in reports, and so on. For details on the reports log, see "Reports Log" in *Reports*.
- ➤ HP Business Availability Center enables you to generate Dashboard reports automatically, and to specify a header and a footer for those reports. For details, see "Customizing Reports" in *Reports*.

#### 1 Save KPI Status Information for the KPIs Over Time Reports

Persistent data is used to produce KPIs Over Time reports with status information, as described in "KPIs Over Time Report" on page 277. Set the **Save KPI data over time for this CI** option to save the calculated measurement for each of the CI KPIs, at 15 minute intervals (default value). This is done by activating the **saveValuesToPersistency** global attribute in the Business Rule Repository. For details, see "Persistent Data and Historical Data" on page 366.

This option is selected, by default, for Business Services, Applications, Business Processes and others. This option is not available for Monitor type CIs.

#### 2 Access KPIs Over Time Reports

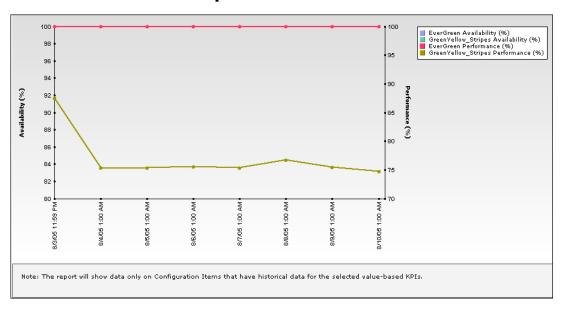

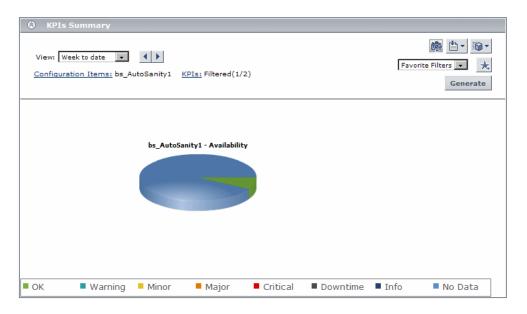

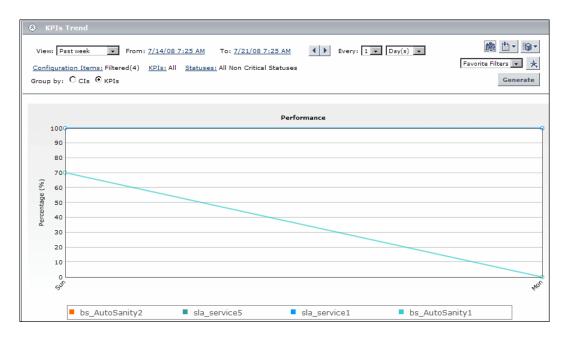

### Dashboard Ticker Overview

HP Dashboard Ticker enables you to monitor a selected view in a nonintrusive manner on your desktop in a Ticker Window or in a Message Window without opening HP Business Availability Center.

Using HP Dashboard Ticker, you can, without opening HP Business Availability Center, select a view, select the server where HP Business Availability Center is installed, adjust the rate and the scrolling speed of the Ticker Window, and open the Message Window.

### **Understanding Dashboard Ticker**

After you install HP Dashboard Ticker, one of HP Dashboard Ticker's icons appears in the desktop tray bar. The type of icon displayed indicates different situations. A tooltip is available for each icon to describe HP Dashboard Ticker's status.

Status Icon	Description	Tooltip
€	Online. The ticker has connected with the server and is monitoring status.	Connected with <server-url> where server-url is the URL of the server.</server-url>
⊗	Message. An incoming message was received. A KPI has turned to Critical state.	Incoming message

HP Dashboard Ticker attempts to connect with the server using the supplied server address after the period of time specified in the **Update interval** parameter in the Preferences. If the server cannot be found or a connection cannot be established, the tray icon changes to **Offline**. For details on the **Update interval** parameter, see "Ticker Preferences Dialog Box" on page 312.

The tray icon changes to **Connecting** if Dashboard Ticker is trying to connect to the server.

The tray icon changes to **Online** when the server has connected successfully.

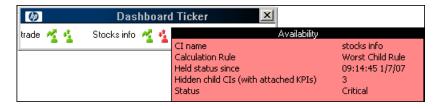
Every KPI in the selected view is checked. Any KPI with an error status is checked against the information already in HP Dashboard Ticker. If it is the first time this KPI appears in the view, or if the KPI's status has changed to an error status, it is displayed in the Message Window and/or the Ticker Window. As soon as a message is put in the queue, the tray icon changes to Message, indicating that there is a message to be viewed. HP Dashboard Ticker's internal message queue can contain an unlimited number of messages.

#### **Ticker Window**

The Ticker Window displays a scrolling list (from right to left) of the **top level** CIs monitored by Dashboard along with icons that display the status of each one of the CI's KPIs.



Move the mouse above any icon in the Ticker Window to display a tooltip that includes the name of the KPI.

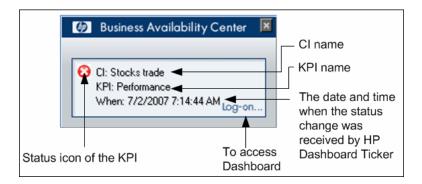

**Note:** HP Dashboard Ticker 7.5 is compatible with HP Business Availability Center 8.0.

#### 2 Launch Dashboard Ticker

After HP Dashboard Ticker is installed, you must launch it to configure its behavior.

To launch HP Dashboard Ticker, select **Start > Programs > HP Dashboard Ticker > HP Dashboard Ticker** to launch the application and open the Preferences page. For details, see "Ticker Preferences Dialog Box" on page 312.

#### 4 Control Ticker Behavior

You can control the behavior of HP Dashboard Ticker using the options that are displayed by right-clicking the icon in the tray bar. Depending on the icon, a subset of the capabilities described in this section is displayed.

#### 5 Set the Ticker Preferences

You can set the Ticker preferences so that you can view messages automatically or you can click the **Message** icon to display the Message Window. The Message Window fades out after 5 seconds.

If you select to display the Message Window automatically and you do not click that window, the Message Window fades out after 5 seconds, and the message is considered unread. It is not removed from the queue.

#### Tip:

- ➤ In the mobile device, you can add the URL to your Favorites at any stage (login, view, or drill down). Depending on the stage, clicking the **Back** button might not access higher hierarchy levels or the view selection page.
- ➤ You must click **Refresh** to refresh the display as the refresh feature is not automatic and the data becomes obsolete.

#### 3 Change Display Characteristics – Optional

The display characteristics of the mobile console are controlled by an XSL file. To modify any aspect of the display using non-Latin characters (for example, displaying the view and button names: **Back** and **Refresh**), contact HP Software Support for help in writing an XSL to support this feature.

**Note:** The characters used for KPI names depend on the user's locale and not on the browser's locale.

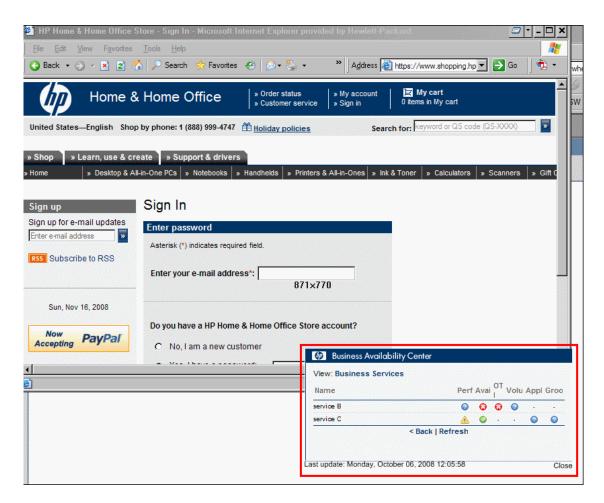

### Dashboard Widget Overview

HP BAC Dashboard Widget enables you to continuously monitor the operational status of your business, without having Business Availability Center Dashboard open on your screen. The Dashboard Widget runs on the Yahoo! Widgets application, and displays CI status for a selected Dashboard view.

The Dashboard Widget is a small window that can be positioned anywhere on your screen, enabling you to display it in a non-intrusive manner while working in other applications. You do not need to have Business Availability Center open to display view information in the Dashboard Widget.



The Dashboard Widget presents a flat list of the CIs in a selected view, together with KPI status for the CIs. This is the same status information that you see in the **Applications** > **Dashboard** > **Console** > **Hierarchy** tab. You can drill down from a parent CI to see its child CIs.

To install and display the Dashboard Widget, see "View Data in Dashboard Widget" on page 325.

#### 1 Prerequisite

The Dashboard Widget runs on the Yahoo! Widgets application. If you do not have it installed, download the Yahoo! Widgets application from the Yahoo! Widget page: http://widgets.yahoo.com/download.

After installing, you can click the Yahoo! Widgets icon in your toolbar to view the Widgets Dock at the right edge of the screen.

#### 2 Install Dashboard Widget

In Business Availability Center, open Admin > Platform > Setup and Maintenance > Downloads. Click the HPDashWidget\_v1.0\_win.zip link and extract the contained file (HPDashWidget\_v1.0\_win.widget) to your local machine.

To start the Dashboard Widget, double-click the HPDashWidget\_v1.0\_win.widget file. The file is automatically moved to the My Documents\My Widgets folder, created by Yahoo! Widgets on your primary local drive.



**Note:** The HPDashWidget\_v1.0\_win.widget file must be located in the **My Documents\My Widgets** folder, so that it is displayed by the **Show All Widgets** button on the Widgets Dock (top right corner). This button opens all widgets in the **My Widgets** folder.

#### 3 Configure Dashboard Widget

After installing the Dashboard Widget, it is automatically added to the list of widgets available from the Widgets Dock on your machine, and Yahoo! Widgets displays the Dashboard Widget introductory window.



**Note:** If the Dashboard Widget introductory window is not displayed, either double-click the installed **HPDashWidget\_v1.0\_win.widget** file, or perform the following steps:

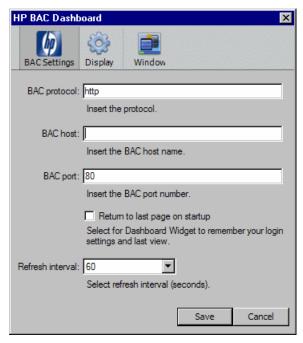
➤ Open Yahoo! Widgets from the **Start** > **Programs** menu.



- ➤ In the Widgets Dock, click the **Options Menu** icon.
- ➤ In the Options menu, select Open Widget.
- ➤ In the Open dialog box, open the HPDashWidget\_v1.0\_win.widget file.

Configure the Dashboard Widget to access data from the relevant Business Availability Center application as follows:

**a** In the introductory window, click **Use Widget**. A message is displayed warning you that a host must be defined. Click **OK** to open the HP BAC Dashboard preferences window for the Dashboard Widget.



- **b** In the **BAC Settings** tab, modify the parameters as required.
  - ➤ **BAC protocol.** Enter the protocol that your Business Availability Center application is using. For example, http.
  - ➤ **BAC host.** Enter the host name for the Business Availability Gateway server, including the DNS domain.
  - ➤ **BAC port.** Enter the port number used by the Business Availability Gateway server. Default is 80.
  - ➤ Return to last page on startup. Select the check box to have the Dashboard Widget remember your user name and password after login, and the last view you selected. When you next access the widget, it opens directly to the last view.

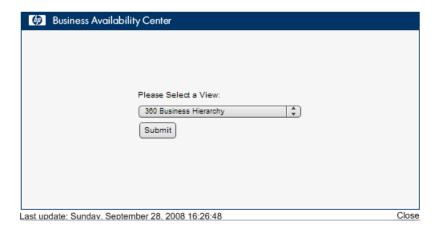
➤ **Refresh interval**. Select the refresh interval from the dropdown list. Default is 60 seconds.

**Note:** You can modify the settings at any time by right-clicking in the Dashboard Widget window, and selecting **Widget Preferences** > **BAC Settings** tab.

#### 4 Log in to Dashboard Widget

After configuring parameters for the Dashboard Widget, the login window is automatically displayed. (If the login window is not displayed, open the HP BAC Dashboard Widget from the Widgets Dock.)

Enter your Business Availability Center login information and click **Submit**. The Select View window is displayed.



#### 5 Select a Dashboard View

In the Select View window, click the arrows to the right of the displayed view name to open an alphabetical list of the available Dashboard views in Business Availability Center.

Select the required view and click **Submit**. The selected view is displayed in the Dashboard Widget.

### \lambda KPI Configuration Overview

The Dashboard KPIs (Key Performance Indicators) provide quantifiable measurements that help you monitor in real-time how well your business is achieving its objectives. The KPIs provide real-time status for the CIs representing your business and processes, enabling you to assess the business impact of problems in the system.

Each KPI works with a predefined set of values, against which the incoming metrics are measured. The resulting measurement for the KPI is translated into a color-coded status indicator, displayed in the Dashboard Console, where the color represents a more desirable or less desirable condition for the KPI. You can learn more about KPI functionality in "How Dashboard KPIs Work" on page 338.

CIs can have multiple KPIs attached. KPIs can be attached to a CI as follows:

- ➤ KPIs may be attached to the CI as part of the CI creation.
  - ➤ For CIs created in the Universal CMDB using the source adapters in Source Manager all CIs are automatically assigned default KPIs, according to the nature of the CI. For example, a CI for a Business Process Monitor profile has default KPIs for availability and performance. You can edit a source adapter to define additional KPIs that you want added to the created CIs.
    - For more information on the source adapters and how they define the default KPIs, see "Source Manager Overview" in *Model Management*.
  - ➤ For CIs created in the Universal CMDB directly from the monitors, all CIs are automatically assigned default KPIs, according to the nature of the CI using the KPI Assignment mechanism or the KPI Propagation mechanism. You can edit a KPI assignment to define additional KPIs that you want added to the CIs.
    - For more information on the KPI assignments and how they define the default KPIs, see "Assignments" on page 421.
  - ➤ CIs that are added manually or by Discovery and Dependency Mapping do not have automatically assigned KPIs. For information on how Discovery and Dependency Mapping creates CIs, see "Discovery and Dependency Mapping Overview" in *Discovery and Dependency Mapping Guide*.
- ➤ KPIs may be attached to a CI as a result of propagation from child CIs. Most KPIs propagate up through the hierarchy, so that parent CIs have the same KPIs as all their child CIs.
- ➤ KPIs may be manually attached to a CI in the Dashboard Administration KPIs tab. You may want to attach new KPIs to a CI, in addition to the default/propagated KPIs, to broaden the information derived from the monitoring measurements. For example, you can add an OT Impact KPI to assess the ongoing cost of an application that is not available.

In the KPIs tab, as well as attaching new KPIs to a CI, you can edit existing KPIs and delete attached KPIs. For details, see "KPIs Page" on page 408.

#### How Dashboard KPIs Work

HP Business Availability Center provides a selection of predefined KPIs to work with Dashboard. The definitions for the KPIs are contained in an XML file, which contains the default parameters for creating each KPI instance.

Note: You can edit the KPI definitions, or create customized KPIs, in the KPI Repository, as described in "List of Dashboard KPIs" on page 510.

Each CI has its own attached KPIs (that define what is being monitored for that specific CI). Each attached KPI generally defines:

- ➤ The business rule (for example, Performance rule) to be used with the collected metrics, to calculate a measurement for the KPI.
- ➤ The source for the metrics to be used for the KPI: either from data samples (for monitoring CIs), or from other KPIs. In the latter case, the KPI metrics may be taken from the child CIs (when using, for example, the Summary of Values rule), or from another KPI attached to the same CI (when using, for example, the Impact Over Time rule).
- ➤ The thresholds (objective values) that the KPI measurement is compared against; and the status (color) allocated to the KPI, based on the defined thresholds.
- ➤ Where and how to display the status indicator for the KPI in Dashboard, and where to store the KPI measurement.

For most KPI types, the KPIs propagate up to all parent CIs (there are exceptions to this, for example, the PNR (Service Level Management) KPI). This means that if you attach a KPI, for example, Volume, to a child CI, then a Volume KPI is also added to each parent CI for that child, up to the top of the subtree.

Each KPI added by propagation has its own KPI instance definition, with its own business rule and properties. For example, the Volume KPI for a child CI may use the RUM Page Monitor Volume Rule, while the Volume KPI for the parent CI (added by propagation from the child CI) may use the Worst Child Rule.

The calculations required by the KPI business rule are made by the Business Logic Engine. When a data sample arrives on the bus and is identified (by means of the KPI selector) as relevant for a specific monitoring CI, the required metrics are passed to the relevant KPI instance for that CI, for example, an Availability KPI. At regular intervals (default 15 seconds) the Business Logic Engine recalculates the measurement for the KPI using the metrics received for the KPI since the last calculation.

If the new measurement causes a change in the status of the KPI, the new status is passed to the parent CIs. The Business Logic Engine then recalculates the measurement for the corresponding KPI of each parent CI, using the new received status information. If the new measurement causes a change in the status for that KPI, the new status is again passed up the hierarchy to the corresponding KPI instances for the parent CIs, and so on.

You can change the default Business Logic Engine calculation time interval in the Infrastructure Settings page. For details, see "Change the Default Business Logic Engine Calculation Time Interval – Optional" on page 368.

#### **Notes and Limitations for KPIs and CIs**

- ➤ Any change you make to the KPIs for a CI—adding new KPIs, deleting KPIs, or editing KPI properties—changes the CI in the HP Universal CMDB, meaning that the changes are seen in any view that includes the CI.
- ➤ You must create at least one HP Business Availability Center profile database for Dashboard to receive data samples. For details, see "Profile Database Properties MS SQL Server Page" in *Platform Administration*.
- ➤ There are no restrictions on the type of KPI that can be attached to a CI, or on the type of business rule that you can select from the allowed rules list for a KPI. You must ensure that you select KPIs and business rules that are appropriate for the CI type.
- ➤ The Application KPI is only applicable for CIs corresponding to HP Diagnostics (and is attached automatically to HP Diagnostics CIs when HP Diagnostics is supported in HP Business Availability Center). For more information, see the HP Diagnostics User's Guide.

- ➤ KPIs added to a CI as part of a SLA definition in Service Level Management Administration have no relevance to the Dashboard KPIs and do not appear in the KPIs tab. Conversely, KPIs added to a CI in the KPIs tab have no relevance for the CI when it is included in an SLA, and do not appear for the CI in Service Level Management.
- ➤ Deleting a KPI may impact on other KPIs that are dependent on the first KPI. For example, OT Impact is calculated based on the status of another KPI, such as Availability; in this case, deleting the Availability KPI would prevent calculation of OT Impact.
- ➤ KPIs created for CIs by the source adapter templates frequently have objective values that differ from the default ones used by the business rule. However, when editing one of these KPIs, if you select a different rule and then revert to the original rule, then the original objective values are replaced with the rule default values.
- ➤ The **Edit KPI for child transactions** button is enabled for all KPIs, but:
  - ➤ It is relevant **Transaction** and **Availability** KPIs (an error message is displayed for other KPIs).
  - ➤ It is valid only when there are Business Process Monitor transaction CIs contained in the subtree.

Changes made in the Edit KPIs for Child Transaction window have no effect on KPIs other than **Transaction** and **Availability**, or on CIs for which the option does not apply.

- ➤ After applying the Edit KPI for child transactions option, a KPI was saved successfully message is displayed in the top-right corner of the page, even if no changes were made to any CIs.
- ➤ If a transaction CI in the subtree is using a business rule other than the default monitor rule for the KPI (**Transaction Availability** rule or **Transaction Performance** rule), then when you apply the Edit KPI for child transactions option, the existing rule is replaced with the default rule.
- ➤ The **Objectives** area in the Edit KPIs for Child Transaction window displays the default **Operator** for the rule. When you apply your changes, the displayed default operator is updated to all transaction CIs (regardless of which operator they were using previously).

### **About Business Rules**

A KPI must always have an associated business rule that defines the logic to be performed (by the Business Logic Engine) to calculate the measurement for the KPI. The properties and objectives that are assigned to the KPI depend on the selected rule.

HP Business Availability Center provides predefined rules for use with the KPIs. The rules are defined in the Business Rule Repository, where you can edit the rules, or create customized rules. For information on the business rules available in Dashboard, the roles they play, and how to edit them, see "List of Dashboard Business Rules" on page 578.

Some business rules are specific to a particular KPI, while others can be used for a variety of KPIs. In the KPI Repository, each KPI has a defined default rule, and a list of rules that can be used with that KPI. (If required, the default rule and the allowed rule list can be modified.) In addition, if the KPI's CI is a monitor CI, the rule assigned to the KPI is a monitor rule and if the KPI's CI is a group CI, the rule assigned to the KPI is a group rule. For details on the types of rules, see "Monitor Rules and Group Rules" on page 557.

When a KPI is added manually to a CI in the KPIs tab, it is assigned the default business rule defined for the KPI (the default rule is usually a rule for groups). For example, for the **RT Impact** KPI, there are two applicable rules: **Real Time Impact Rule** and **Sum of Values Rule**. When you add a new RT Impact KPI to a CI, the default rule for the KPI, **Sum of Values Rule**, is automatically assigned. You can change the assigned rule when adding or editing the KPI in the KPIs tab, by selecting a new rule from the list of allowed rules for the KPI.

#### No Data Timeout for Transaction Cls

When a KPI is using a monitor rule (for example, the Transaction Availability Rule), the **Business Rule Parameters** area includes the **No data timeout** property. This property defines the number of seconds from the time the last sample was received for the KPI, until the KPI is timed out—at which point the KPI changes to decay status (gray).

The default value for the **No data timeout** property is generally taken from the monitor rule definitions (as defined in the Business Rule Repository). However, for Business Process Monitor transaction CIs, Dashboard calculates a new **No data timeout** value, based on the schedule for running the transaction. The calculation takes the schedule interval (defined in End User Management Administration) for the business process profile that contains the transaction (default value = 15 minutes) and adds an additional 90 seconds. For example, for a transaction with a schedule interval of 15 minutes, the **No data timeout** value is 990 seconds. (For details on defining the profile schedule, see "Data Collectors Page" in *Using End User* Management.)

This calculation method means that the timeout value is automatically adjusted to align with changes made to the profile schedule interval in End User Management Administration, so that the KPI is not incorrectly timed out. If there is more than one scheduling scheme in effect, the following rules are used for the calculation:

- ➤ If multiple schedules are defined for a profile running on a Business Process Monitor instance, the largest schedule interval is used (all schedules are treated equally, whether they apply to the whole week or part of the week).
- ➤ If the profile is assigned to several locations, each with a different schedule, then smallest interval from amongst the locations is used (after first applying the rule above).

### KPI Objectives

The KPI objectives define the standards for allocating business status to the KPI.

The following sections describe objectives and how to define them for a KPI.

#### **About Status and Objectives**

The status displayed for a KPI in Dashboard provides an indication of how well a business process or system is meeting your business objectives. Based on traffic light colors (with additions), the Dashboard shows you if the KPI measurement is meeting the objective requirements (green), or is critically failing (red), or is at some business risk level between the two.

Five statuses are available in Dashboard (for active status), each representing a different level of business performance:

- ➤ **OK** (green)
- ➤ Warning (teal)
- ➤ Minor (yellow)
- ➤ Major (orange)
- ➤ Critical (red)

Depending on the CI and KPI types, active status may be represented in Dashboard using from two to all five of these status levels. In most cases (not for SiteScope measurements), the KPI is assigned a status as follows:

- ➤ The business rule calculates a measurement for the KPI.
- ➤ The calculated measurement is compared with defined objective values.

➤ The KPI is assigned a status according to where the measurement falls within the objectives. For example, a KPI measurement of 50% may fall within the definition for the **Minor** objective, so the KPI is assigned Minor status (yellow).

The objective values used for each KPI can originate from various sources:

- ➤ The business rule definitions in the Business Rule Repository provide default objective values for every rule that uses objectives. The business rules generally define different objective values for each of the five statuses used in Dashboard. You can define new default objective values for a business rule, as described in "Rule Details Dialog Box" on page 654.
- ➤ The source adapter may specify specific objective values to be used with the business rule for a KPI. These values override the values from the Business Rule Repository. You can modify the template for a source adapter to define custom objective values, as described in "Modify an Adapter Template" in *Model Management*.
- ➤ The source adapter may specify reference values for the objective parameters, so that the objective values are taken from the threshold values defined in End User Management Administration. These values override the values from the Business Rule Repository.
- ➤ You can modify the objective values for an individual KPI in the Dashboard Administration KPIs tab, while adding or editing a KPI. The new values override values from the source adapter or from the business rule. For details, see "No Data Timeout for Transaction CIs" on page 342.

#### **SiteScope Monitoring Cls**

For SiteScope monitoring CIs, KPI status is based on the status received from SiteScope (calculated according to the thresholds defined in SiteScope). Three status levels are used in Dashboard:

- ➤ **OK** (green) in Dashboard corresponds to **Good** or **OK** status in SiteScope
- ➤ Minor (yellow) in Dashboard corresponds to Warning status in SiteScope
- ➤ Critical (red) in Dashboard corresponds to Error status in SiteScope

The SiteScope status definitions cannot be changed in Dashboard, so the business rules for SiteScope KPIs do not include objective values.

#### **End User Monitoring Cls**

For end user monitoring CIs (from Business Process Monitor, Real User Monitor), KPI status is calculated by comparing the KPI measurement with objective values.

- ➤ For **Business Process Monitor** transaction CIs, the KPI objective values are either taken from End User Management Administration or the rule definition:
  - ➤ For CIs using the **Transaction Performance Rule** (ID# 13), the Business Process Monitoring source adapter references the transaction thresholds defined for the corresponding monitoring object in End User Management Administration. The threshold values map to KPI objective values for three status levels in Dashboard: **OK**, **Minor**, and **Critical**.
  - ➤ For CIs using the **Transaction Availability Rule** (ID# 5), KPI objectives are taken from the default values for the rule in the Business Rule Repository. The rule defines objective values for all five status levels in Dashboard.
- ➤ For **Real User Monitor** monitoring CIs, depending on the rule used, the KPI objective values are taken from the Real User Monitor source adapter, End User Management Administration, or the rule definition. For example:
  - ➤ For RUM Application Error Monitor CIs using the RUM Event Monitor Volume Rule (ID# 73), the objective values are defined directly in the source adapter. The objective values defined for this rule use four of the Dashboard status levels: OK, Warning, Minor, and Critical.
  - ➤ For RUM Page Monitor CIs using the RUM Page Monitor Availability Rule (ID# 49), the source adapter references the Availability threshold defined in End User Management Administration for the page. This is a single value, so two status levels are used in Dashboard: OK and Critical.
  - ➤ For RUM Sessions Monitor CIs using the RUM Session Monitor Availability Rule (ID# 52), the source adapter does not define objective values, so KPI objectives are taken from the default values for the rule in the Business Rule Repository. The rule defines objective values for three Dashboard status levels: OK, Minor, and Critical.

For all end user monitoring CIs, you can edit the objective values in the KPIs tab to use as many of the status levels as you require, as described in "Defining Logical Objectives" on page 346.

**Warning:** KPIs created for CIs by the source adapter templates, frequently have objective values that differ from the default ones used by the business rule. However, when editing one of these KPIs in the KPIs tab, if you select a different rule and then revert to the original rule, the original objective values are replaced with the rule default values.

#### **Defining Logical Objectives**

The objectives values for a KPI should cover the whole spectrum of possible active measurements for that KPI, which correspond to the **OK**, **Critical**, **Major**, **Minor**, and **Warning** statuses. The objectives do not include the KPI values corresponding to the **No Data**, **Downtime**, and **Info** statuses.

The KPI measurement is evaluated against each objective level, starting from **OK** (green), and continuing (in order) to **Critical** (red). This process stops at the first objective level into which the KPI measurement fits.

To define where the boundaries of each objective level falls, each objective from **OK** to **Major** is associated with an **Operator**. (The **Critical** objective definition is always **Otherwise**, meaning that this status is applied to all measurements that fall beyond the **Major** objective limit.) You can select the operator that matches your requirements; the same operator is applied to all objective levels.

The available operators are:

>

>=

<

<=

You must ensure that the objectives contain logical values (according to the data type) and are correctly ordered, and that the operator is logical for the order. For example:

- ➤ If you enter descending objective values, such as 70, 55, 40, 20, you must use operator > or >=, so that the **OK** objective covers all measurements greater than 70.
  - For a KPI measurement of 88: **88** >= **70** is true, so assigned status is **OK**. For a KPI measurement of 18: evaluation of the KPI measurement against every objective is false, so status falls into the **Otherwise** category and be assigned status **Critical**.
- ➤ If you enter ascending objective values, such as 10, 25, 35, 40, you must use operator < or <=, so that the **OK** objective covers all measurements less than 10.

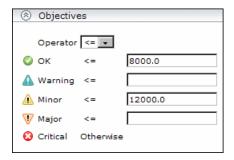
For a KPI measurement of 7: **7** <= **10** is true, so assigned status is **OK**. For a KPI measurement of 50: evaluation of the KPI measurement against every objective is false, so status falls into the **Otherwise** category and be assigned status **Critical**.

#### **Excluding Statuses**

Not all the statuses need be used for a KPI; for example, the OT Impact KPI by default uses only **OK** (green) and **Critical** (red) status. There are two methods used in Dashboard to exclude statuses, as described in the following sections.

#### **Blank Objective Value**

When the objective value for a status is left blank, Dashboard ignores that status during KPI status calculation. For example, the Performance KPI for a transaction may have the following objectives defined (taken from the threshold settings for the transaction in End User Management Administration):



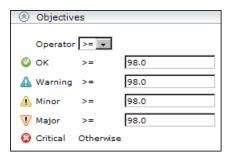
In this case, if the measurement for the KPI does not fall into the **OK** objective level, then **Warning** is skipped and the measurement is evaluated against the **Minor** objective level. If it does not fall into that level, **Major** is also skipped, and the KPI is assigned **Critical** status.

If you want to exclude statuses when editing the objective values for a KPI, it is recommended that you use this method.

#### **Repeated Objective Value**

Dashboard allocates status by starting at **OK** status, and evaluating the KPI measurement against each objective level until the right level is found. When an objective value is repeated for two or more statuses, the repeat occurrences are passed over and those statuses are not used.

For example, the Availability KPI for a RUM page monitor may have the following objectives defined (by using the Availability threshold setting in End User Management Administration for all four defined objective values):



In this case, if the measurement for the KPI is greater or equal to 98%, then it is given **OK** status. If it is less than 98%, then evaluation against the **Warning**, **Minor**, and **Major** statuses also does not give any result and these statuses are not used; the KPI is then assigned **Critical** status.

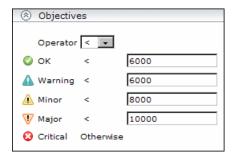
#### **Example of Defining Objectives**

A specific transaction monitor CI is using the Transaction Performance Rule. For this transaction, the required objectives are as follows:

- ➤ The objective for acceptable performance time is under 6000 milliseconds. An average performance time that reaches 6000 milliseconds is already of concern.
- ➤ Performance time of 8000 milliseconds is considered seriously problematic.
- ➤ Performance time of 10000 milliseconds is considered critical.

In addition, Warning status is not required for this KPI.

In the Edit KPI window for the transaction's **Performance** KPI, the objective levels and operator are modified as follows:

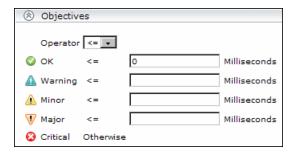


When a measurement is calculated for the KPI from the incoming performance data, the measurement is compared with the objectives assigned to the KPI as follows:

- ➤ For a measurement under 6000 milliseconds, status = **OK**
- ➤ For a measurement of 6000 milliseconds or more, but under 8000 milliseconds, status = **Minor**
- ➤ For a measurement of 8000 milliseconds or more, but under 10000 milliseconds, status = **Major**
- ➤ For a measurement of 10000 milliseconds or more, status = Critical

#### **Units of Measurement for Objectives**

The objectives use a unit of measurement, shown after the objective value box in the KPI **Objectives** area:



The unit is part of the business rule definition, and indicates the format of the calculated measurement. This format may reflect the units used by the incoming data (for example, **milliseconds** for performance time data), or it may be a new format applied as a result of the business rule calculations (for example, **dollars** for a financial loss calculation). If required, the default unit for a rule can be changed in the rule definition (as described in "Rule Details Dialog Box" on page 654).

For details about the available default units, see "Units of Measurement for Objectives" on page 542.

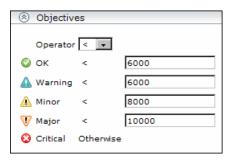
#### **Example of Defining Objectives**

A specific transaction monitor CI is using the Transaction Performance Rule. For this transaction, the required objectives are as follows:

- ➤ The objective for acceptable performance time is under 6000 milliseconds. An average performance time that reaches 6000 milliseconds is already of concern.
- ➤ Performance time of 8000 milliseconds is considered seriously problematic.
- ➤ Performance time of 10000 milliseconds is considered critical.

In addition, Warning status is not required for this KPI.

In the Edit KPI window for the transaction's **Performance** KPI, the objective levels and operator are modified as follows:



When a measurement is calculated for the KPI from the incoming performance data, the measurement is compared with the objectives assigned to the KPI as follows:

- ➤ For a measurement under 6000 milliseconds, status = **OK**
- ➤ For a measurement of 6000 milliseconds or more, but under 8000 milliseconds, status = **Minor**
- ➤ For a measurement of 8000 milliseconds or more, but under 10000 milliseconds, status = **Major**
- ➤ For a measurement of 10000 milliseconds or more, status = Critical

### Selectors for KPIs

Monitoring CIs are CIs that are intended to receive real-time data from the data samples sent by the external system (purely logical CIs do not receive data samples). The data samples, containing information collected by a monitoring system (either HP or third-party), are supplied to HP Business Availability Center over the bus.

When a monitoring (leaf) CI has a KPI and associated business rule that are intended to be applied to actual data samples, the KPI properties include a **selector**. A selector is a filter definition that defines which samples are relevant for the KPI.

The Business Logic Engine filters the data samples arriving on the bus using selectors, which are set using Dashboard Administration. A selector is defined as part of the monitor rule for a KPI attached to a monitoring CI. The selector identifies and catches the data that is relevant for the CI and the KPI.

A different selector can be used by each KPI with an associated monitor rule, enabling (when required) the use of different samples for each KPI.

You can define selectors as explained in the following sections:

### **Monitoring CI in HP Universal CMDB**

When a monitoring CI is added to the HP Universal CMDB by a monitoring adapter, a selector is automatically defined for each of the default KPIs for the CI. For details, see "Predefined Monitoring Views" in *Model Management*.

#### **Dynamic Node Factory Cls**

The selector is defined directly as part of the CI definition, not in a KPI. The selector used by a Dynamic Node Factory can be defined and/or edited in the IT Universe Manager tab of CMDB Administration, as described in "Working with Dynamic Node Factory Overview" in *Model Management*. The functionality and definitions for a Dynamic Node Factory selector are the same as for a KPI selector, as described in this section.

#### **KPI Assignments**

You can create or customize a KPI assignment rule for each CI type. An assignment rule includes a condition and a task. The condition describes specific characteristics of a CI. The task describes the context menus, KPIs, rules, rule parameters, and selectors that are to be assigned automatically to the CI when the condition occurs, if the assignment is running. For details, see "Define Assignment Configuration Dialog Box" on page 451.

#### **EMS**

The mechanism used to integrate EMS (Enterprise Management Systems) software into HP Business Availability Center, includes an assignment rule mechanism. The assignment rule mechanism is triggered when a specific monitor CI attribute is updated. An assignment rule includes a condition and a task. The condition describes specific characteristics of a CI. The task describes the context menus, KPIs, rules, rule parameters, and selectors that are to be assigned automatically to the CI when the condition occurs, if the assignment is running. The task description includes a selector. For details, see "Define Assignment Configuration Dialog Box" in *Solutions and Integrations*.

#### **Source Adapters**

For information on editing selector definitions in the source adapters, see "Define Selectors" in *Model Management*.

#### **KPI Definition in Dashboard**

If required, you can edit the default KPI selectors in the KPIs tab. You can also attach new KPIs to a monitoring CI, assign a monitor rule and manually define the selector. For more information about defining selectors, see "Define Selectors" on page 379, "Set Up User Mode Functionality" on page 386, or "Set Up User Mode Functionality" on page 386.

### & KPIs for User Modes

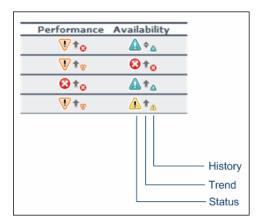
HP Business Availability Center provides the option to define Dashboard KPIs for two different user types (modes): **operations** and **business**. This option enables the creation of two versions of a single KPI, where each KPI version is geared towards the particular viewing requirements of one of the user types. Each user type sees the appropriate version of the KPI in the Dashboard views.

For example: You might want to create two versions of the Availability KPI, so that the Availability KPI for an operations user shows Critical status (red) when transaction availability is below 30%, and the Availability KPI for a business user shows Critical status when transaction availability is below 20%.

### 🚜 KPI Status

For each CI, Dashboard displays real-time status in one or more KPI columns in the view.

Each KPI can include three icons: Status, Trend, and History.



A color-coded icon is displayed for each KPI in a view, representing the status assigned to that component for its current performance level. In addition to the main status icon for a KPI, the KPI column can contain additional icons showing trend and history for the CI under that KPI.

The status of a KPI in Dashboard provides an indication of how well a business process or system is meeting your business objectives. Based on traffic light colors (with additions), the Dashboard shows you whether the KPI measurement is meeting the objective requirements (green), is critically failing (red), or is at some business risk level between the two (teal, yellow, orange). For more details on objectives, see "KPI Objectives" on page 343.

The status of each KPI is calculated using a business rule. A different business rule may be used for a parent CI and a child CI with the same KPI attached. The business rules are defined for the KPI in Dashboard Administration. For details on the rules, see "List of Dashboard Business Rules" on page 578.

#### **Types of Cls**

There are two types of CIs whose status is calculated differently:

#### ➤ Monitor CI

Monitor CIs receive real data from data samples. These data samples are used to calculate the status of the KPIs attached to the monitor CIs.

The foundation of status definition for all monitor CIs is a comparison of performance metrics with objective values.

#### ➤ Group CI

For group CIs (all CIs except monitor CIs), Dashboard displays a status icon that represents a "summary" of the status for the child components (that is, the CIs that belong to the lower level in the hierarchical structure).

The Details tooltip for each status icon provides additional information regarding the calculation method in use for the KPI: the KPI name, the CI name and the KPI status, the time and date when the status was changed to its current value, and a warning that states that no update was received.

**Note:** The color displayed for a CI icon in Dashboard represents a summary of interim status values for a predefined duration (the default duration value is generally 300 seconds). The calculation of status values is an ongoing process, using samples collected every 60 seconds (default granularity value), thus the interim status may actually change several times over the duration without causing any change in the color of the icon. For example, if the icon for a transaction is red at the beginning of a duration, and during the duration the interim status changes from red to green and back to red, at the end of the duration the icon is still red.

#### **Colors of KPI Statuses Used in Dashboard**

The following shows the main status levels that are used to show status for KPIs in Dashboard (note that some of the Dashboard KPIs use text in place of icons, but use the same color coding to indicate status as shown here):

- ➤ The numerical code is used in HP Business Availability Center files to perform calculation instead of the corresponding status.
- ➤ To change the color of the icons used at each status level, you can customize some of the icons, or complete sets of icons. For details, see "Change the KPI Status Icons" on page 394.
- ➤ Change icons indicate when a change was made to a specific static attribute of a specific CI in the HP Universal CMDB. For details, see "Monitoring Changes in Dashboard Overview" on page 111.

#### **Status Scores**

This section describes how statuses are assigned to KPIs when only three main statuses (0, 10, and 20) are used instead of five statuses.

The five real-time statuses and their values are listed in the **Value** and **Real-time status** columns of the table.

In most rules, only the main three statuses (0, 10 and 20) are used to calculate the status. The calculations are assigned statuses according to the values listed in the **When using only three values** column. The colors assigned to the values and statuses are listed in the **Colors** column.

Value	Real-time status	When using only three values	Colors
0	worst	0	red
5	bad	0 < score < 7.5	orange
10	middle	7.5 to 12.5 (inclusive)	yellow
15	good	12.5 < score < 20	teal
20	best	20	green

**Note:** Only relevant statuses (0-20) are taking into consideration ("gray" statuses are ignored).

#### **Statuses and Group Rules**

Some group rules select the worst or best status for child CIs according to the following groups:

Groups	Statuses
first group	OK, Warning, Minor, Major, Critical

Groups	Statuses	
second group	Info	
third group	No Data, Downtime, Stopped	

There is a priority between the groups. The first group of statuses has the highest priority, the second group the second priority and the third one the last priority.

The child CIs of a specific CI may have statuses in different status groups. The status of the parent CI is taken from the group with the highest priority. The statuses of the child CIs in the other groups are not taken into consideration.

### For example:

- ➤ The child CIs of a specific CI have the **Critical**, **Info** statuses; the status for the parent CI, when calculated using the Worst Child rule is: **Critical**.
- ➤ The child CIs of a specific CI have the **Critical**, **Warning**, and **No Data** statuses; the status for the parent CI, calculated using the Worst Child rule is: **Critical**.

### Influence of Must and Weight on Status

When **Must** and **Weight** properties have been defined for the relationship between a parent CI and a child CI, these properties have an impact on the status calculations for the KPIs of the parent CI.

**Must** and **Weight** can be used to qualify a relationship. **Weight** is used for weighted percentage status calculations. **Must** is used for dominant child status calculations.

The dominant and/or weight information affects only the status of the group to which this CI belongs, and does not affect the status of the CI itself. The status of a group CI is based on its child CIs, and the status of a monitor CI is based on the information received from the monitoring source.

For more details on **Weight** and **Must**, see "Understanding the Percentage Rule" on page 560.

## Trend and History

The following status levels are used to show historical and trend status for monitor CIs in Dashboard:

### ➤ Trend Status

The trend status has three positions: up, down, and no change. It shows the trend of the real-time status.

+	Small gray downward arrow	Downward trend	Real-time status shows a downward trend.
<b>\$</b>	Small gray double-sided arrow	Stable trend	Real-time status shows a stable trend.

### ➤ History Status

The history status can display the worst status or the average status over a time period.

#### Note:

- ➤ When a CI has no history or trend data (for example, the CI status is uninitialized or stopped) or when history or trend data is not relevant for the CI's KPI, the history or trend icons are not displayed
- ➤ If a transaction in an HP Virtual User Generator script is renamed, Business Availability Center considers it as a new transaction. A new BPM Transaction from Location CI is created in the CMDB using the new name, and the CI with the old transaction name is removed after it stops receiving samples. In Dashboard, the new CI does not display trend and history status data from before the transaction name change.

### **History Calculation**

The history status icon displays either the worst status or the average status for the CI's KPI during a specified time period.

The calculation method for history status is determined by the value set for the **HistoryType** parameter (one of the global parameters in the Business Rule Repository, described in "List of Dashboard Business Rules" on page 578). The possible calculation methods are **Worst** (default value) or **Average**. Whichever calculation method is used, only status scores that have meaning (scores 0 to 20—the non-gray icons) are taken into consideration.

➤ Worst. Takes the worst status over the period of time specified in the HistorySize parameter (also one of the global parameters).

For example: if HistorySize is 60 minutes (default value) and the KPI's values for the last 60 minutes are: 10, 10, 5, 0, -2, 20, the worst status is 0, so the history icon is red.

➤ Average. Takes the average status over the period of time specified in the HistorySize parameter (Simple Moving Average). The calculation result is rounded to the nearest of the following values: 0, 5, 10, 15, or 20.

For example: if HistorySize is 60 minutes and the KPI's values for the last 60 minutes are: 10, 10, 5, 0, -2, 20, the Average status is 10 (rounded from (10+10+5+0+20)/5=9), so the history icon is yellow.

### Trend Calculation

The trend status icon shows the trend in real-time status for the CI KPI, using three directions: up, down, and no change.

Trend analysis is performed by comparing the Simple Moving Average (SMA) value for a long window with the SMA for a short window. If the short window SMA is higher than the long window SMA, the trend is considered to be up. If the long window SMA is higher, the trend is considered to be down. The SMA is calculated only on status scores that have meaning (scores 0 to 20—the non-gray icons).

- ➤ Long window SMA. Based on the mean status of a KPI over the period of time specified in the **HistorySize** parameter (default = 60 minutes), one of the global parameters in the Business Rule Repository, described in "List of Dashboard Business Rules" on page 578.
- ➤ Short window SMA. Based on the mean status of a KPI over the period of time defined by (TrendRate \* HistorySize). The TrendRate parameter (default = 0.3) represents the time rate between the long and short window, and is defined in the hidden parameters described in "Modifying the Trend and History Status Calculations" on page 365.

### **Modifying the Trend and History Status Calculations**

You can modify the way the trend and history statuses are calculated and displayed, by editing certain rule parameters. A rule parameter can be set in three places:

- ➤ As part of the global rule parameters that apply to all rules and affect all CIs. For details on editing global parameters, see "Global Attributes Dialog Box" on page 648.
- ➤ Directly for a rule, so that it affects all CIs that use this rule. For details on editing rule parameters, see "Rule Details Dialog Box" on page 654.

Some parameters for trend and history statuses are predefined and can be viewed and edited in the Business Rule Repository page; others are hidden, but can be manually added on the Repositories tab if you want to override the parameter default value.

### Persistent Data and Historical Data

A KPI whose data is persistent is attached to a CI whose **Save KPI data over** time for this CI option has been selected. For details, see "KPIs Page" on page 408. This option is selected by default for Business Process, Line of Business, and Monitor Application CIs. This option is not available for Monitor type CIs.

For each CI with the **Save historical data for this CI** option, the following information is stored in the database:

- ➤ Every status change for each KPI
- ➤ The current calculated value for each KPI, read at regular time intervals (the default time interval is 15 minutes)

When the option is first selected, the current status for all of the CI KPIs is written to the database. As long as the settings remain the same, each time there is a change in status for one of the CI's KPIs (for example, from Critical to OK), the status change is written to the database.

**Note:** Saving historical data for long periods of time or for many CIs and KPIs can require a lot of database memory, so this option should be used with care. When you no longer require data to be saved for a CI, clear the Save historical data for this CI check box for that CI.

This capability is used in the Dashboard reports. For details, see "Dashboard Reports" on page 265.

Select Admin > Platform > Setup and Maintenance > Infrastructure Settings, click Foundations, select Online Business Logic Engine, and locate the Model calculation interval entry in the Calculation Related Settings table. Edit the value as required.

## 5 Change the No Data Timeout Value for Transaction Cls – Optional

When a KPI is using a monitor rule (for example, the Transaction Availability Rule), the **Business Rule Parameters** area includes the **No data timeout** property. This property defines the number of seconds from the time the last sample was received for the KPI, until the KPI is timed out—at which point the KPI changes to decay status (gray). For details, see "No Data Timeout for Transaction CIs" on page 342.

### **6 Modify the Number of Cls Monitored for Change in Real-Time**

For a limited number of CIs, Dashboard can monitor for changes to the CI properties (or changes to the properties of the CI's child CIs) in real-time.

This information is in addition to the Dashboard Change Report, which shows a historical report on changes to properties for CIs over a period of time. (For details on the Change Report, see "Change Report Page" in *Model Management*.)

You can set the monitor changes option for up to 20 CIs. Once 20 CIs have been configured, a message is displayed when you try to set the option for another CI, stating that the limit has been reached.

If you then clear the option for one or more of the configured CIs, the option becomes available again for all CIs, until the 20 CIs limit is again reached.

Note: To change the 20 limit, select Admin > Platform > Setup and Maintenance > Infrastructure Settings, click Applications, select Dashboard Application, and locate the Maximum monitored CIs entry in the Change Impact Properties table. Modify the value as required. However, change this value with caution to avoid too much load on the system.

When the monitor changes option has been set for a CI, Dashboard continuously monitors that CI and all its child CIs, to see if a change occurs in one of the significant properties defined for the CIs.

The significant properties vary for each CIT, according to the CIT definition in **Admin > CMDB > CI Type Manager**. In CI Type Manager, in the **Attributes** tab for the CIT, the **Change Monitored** column must be selected for a property, in order for that property to be significant and therefore monitored. For more information on CIT definitions, see "CI Type Manager" in *Model Management*.

If a change occurs in one of the significant properties for the CI or the CI children, an icon is displayed in Dashboard beside the CI name. For more information, see "Monitoring Changes in Dashboard Overview" on page 111.

After a change occurs, the change icon is displayed for 24 hours (default value). You can change the default value, as described in "Customize the Change Period" on page 113.

### 7 Monitor CI Property Changes in Real-Time

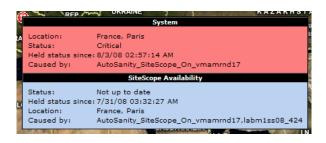

Users who are not assigned a user mode (undefined) see KPIs for both modes, as do system administrators:



In the Geographical Map and Custom Map tabs, status at a location is based on whichever KPI versions the user sees in Dashboard:



### TATE ATTACH A PNR KPI to a CI - Scenario

The PNR (Point of No Return) KPI enables you to view how well agreement objectives are being met. When the PNR KPI is defined for a CI, a bar is displayed in Dashboard indicating how much more time (in percentages) the CI can be unavailable before the agreement is in breach of contract. 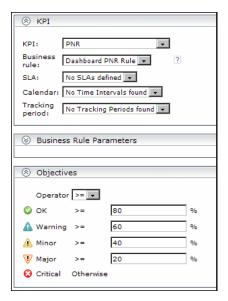

### To set up Dashboard to display Service Level Management data:

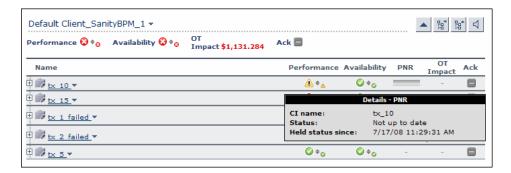
The agreement must include a CI with an attached Availability KPI and/or a System Availability KPI, for the Dashboard PNR KPI to show data in reports. If both KPIs are attached to the CI, the PNR KPI is calculated by using only the Availability KPI. If only the System Availability KPI is attached to the CI, the PNK KPI is calculated using the System Availability KPI.

**2** In Dashboard Administration, attach a PNR KPI to the same CI. For details on attaching a KPI, see "No Data Timeout for Transaction CIs" on page 342. During KPI creation:

### 1 Edit a KPI Properties

You can modify all properties for a defined KPI (apart from the KPI type), whether it is a default KPI for the CI, or a KPI attached by a user.

### 2 Edit the KPI Properties for Multiple Transaction Cls

The KPIs tab has a multiple edit function, enabling you to modify the Availability or Performance KPIs for all BPM Transaction from Location CIs in a group. This function enables you to define new business rule parameter values and/or objective values for all child transactions CIs that appear in a subtree of a view, in one operation.

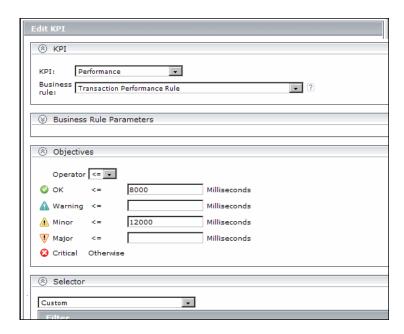
You can define the new values in the Edit KPI for Child Transactions window. Every new value you define replaces the previous value for that property, for each transaction CI in the subtree. Property boxes left blank in the Edit KPI for Child Transactions window do not affect the CIs. For details, see "How Dashboard KPIs Work" on page 338.

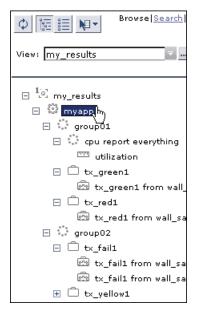

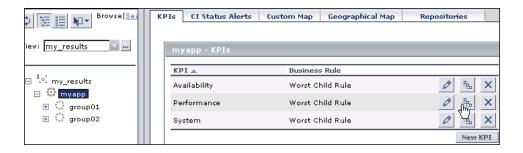


For this example, two additional objective values are added, to include **Warning** and **Major** status levels for each transaction CI, and the **Minor** objective value is modified.

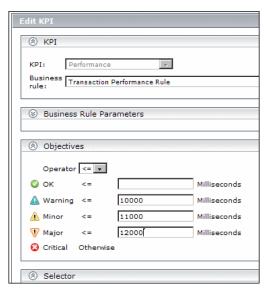
**b** In View Explorer, select the parent CI for the subtree—in this case, the Application CI myapp:



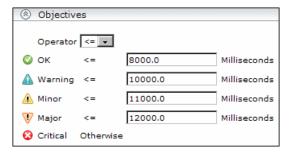
**c** In the right pane, click the **Edit KPIs for child transactions** button for the required KPI—in this case, the Performance KPI.



**d** In the Edit KPI for Child Transactions window, enter the required values—in this case, 10000 for **Warning** objective, 11000 for **Minor** objective, and 12000 for **Major** objective.



**e** After applying the changes, all transaction CIs in the myapp subtree have the following objective values defined:



### Define Selectors

In the selector **Filter** area, you define selector expressions to filter the data samples, to target only those samples that are relevant for the KPI. A selector expression requires a **Field**, an **Operator**, and a **Value**, defined in that order. For more information, see "Selector Area" on page 403.

## 1 Define a Selector Expression Using Predefined Sample Parameters

Define the selector expressions by selecting from metadata—predefined sample types and sample parameters in the database.

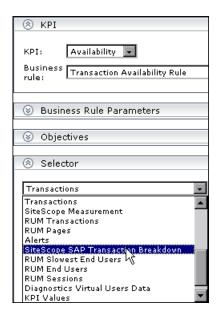
**Note:** You can also build a custom selector as explained below.

When defining or editing a selector using predefined sample data, you can select **Field** and **Operator** values from predefined lists. This definition method validates the field names and operators, and prevents errors that might occur when manually entering field names. It also simplifies the process of defining a selector.

The predefined fields use metadata, information on sample types collected from data samples arriving from various data sources (including HP data collectors and third-party data sources) and stored in the database. For explanations of the data samples and their fields, see "Data Samples" in *Reference Information*.

### Example

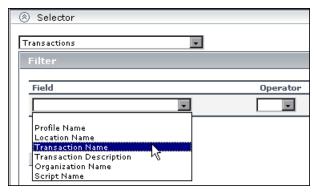
**a** Define the sample type that applies for this KPI. Select the sample type from the list at the top of the **Selector** area in the New KPI or Edit KPI window. The list is based on the sample types currently in the database.



For example, for a KPI that relates to transaction measurements, select sample type **Transactions** from the list.

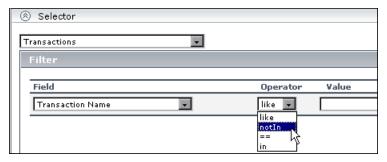
When you select a sample type from the list, all previously defined expressions for the selector are overridden, so the contents of the **Filter** box are automatically deleted.

The **Field** box in the first selector expression converts to a dropdown list, containing all valid options for the selected sample type. The **Field** box defines the required reference property in the data samples.



**b** Select an option from the **Field** list.

The **Operator** list is automatically updated so that it contains only those operators that are valid for the selected field. For example, if the selected field always contains a text string, then only the operators that are used with text are included in the list, such as **like**, **notIn**, ==, **in**.



**c** Enter a value for the selected field in the **Value** box.

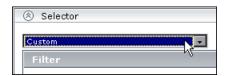
**Note:** The **Value** property is case sensitive and must be entered precisely as used in the data samples from the data source, or the selector fails. The recommended method is to take the values from the samples published on the bus.

#### 2 Define a Custom Selector

Define the selector expressions by manually defining the sample type and sample parameters. You can build a custom selector using any field name, and, if required, can combine fields from two or more data types.

**Note:** You can have HP Business Availability Center automatically assign the default selector for the monitoring CI, by leaving the selector expressions blank in the New KPI/Edit KPI window. After clicking **OK** to close the window, HP Business Availability Center assigns the KPI the default selector for the CI, as used by the default KPIs attached to the CI.

When defining or editing a selector, you can build a custom selector by manually defining all information for the selector. Ensure that no sample type is defined in the list at the top of the **Selector** area in the New KPI or Edit KPI window (the box should display **Custom**).



If a sample type was previously selected in the list, and you then select **Custom**, all previously defined expressions for the selector are overridden and the contents of the **Filter** box are automatically deleted.

Every selector must include the definition of the sample type required for the KPI, so when manually defining a selector, at least one selector expression must contain this information. For example, for a KPI that relates to transaction measurements, the selector must catch transaction samples, which are defined by the sample type **trans\_t** in the selector.



**Note:** The **Field** and **Value** properties are case sensitive and must be entered precisely as used in the data samples from the data source, or the selector fails. The recommended method is to take the values from the samples published on the bus. For details, see "Data Samples" in *Reference Information*.

To define a custom selector expression, enter the required reference property in the **Field** box, select an operator from the **Operator** list. You can select from any of the operators used in Dashboard, and enter the required value for the property directly in the **Value** box.

For details on samples, see "Sample: Transactions (trans\_t)" in *Reference Information*.

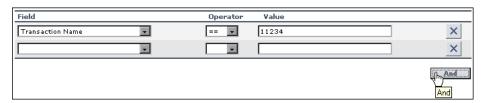
### 3 Build Complex Filters

You can use metadata to build a complex filter, by defining blocks of selector expressions that together form a complex logical expression:

- ➤ Narrow the filter by using a logical **And** operator to attach additional selector expressions to an expression block.
- ➤ Widen the filter by using a logical **Or** operator to add alternative expression blocks (each containing one or more selector expressions).

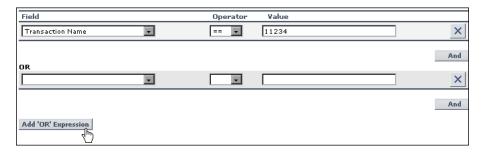
You can define as many selector expressions and blocks of selector expressions as required:

➤ To define an additional selector expression within a block, click the **And** button for that block. An additional empty selector expression row is displayed in the block.



For example, you can define a filter that looks for transaction samples that contain both profile name X *and* transaction name Y.

➤ To define an alternative expression block, click the **Add 'OR' Expression** button. A new block is created, with an empty selector expression row.



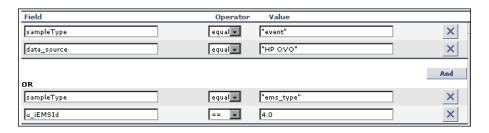
### Example

You can define a filter that looks for transaction samples that contain either transaction name X *or* transaction name Y.

You can add additional selector expressions to the new block using the **And** button for the block.

A data sample qualifies for the selector if all the selector expressions in a single expression block are TRUE for the data sample. For example, either selector expressions  $\bf a$  and  $\bf b$  and  $\bf c$  in block 1 are all TRUE, or selector expressions  $\bf d$  and  $\bf e$  and  $\bf f$  in block 2 are all TRUE.

### Set Up User Mode Functionality

You can set up user mode functionality in HP Business Availability Center by defining the mode for users, defining the KPI versions for each mode, and attaching the KPI versions to the CIs.

### 1 Assign a User Mode

There are two ways to assign a user mode to a user:

- ➤ The system administrator, when defining new users in the **Admin** > **Platform** > Users and Permissions > User Management page, can set User Mode to **Undefined**, **Operations User**, or **Business User**. By default, all new/existing users are set as **Unspecified** (meaning that they see KPIs for both modes in Dashboard).
- ➤ Users can change their own user mode in the Admin > Personal Settings > **General Settings** page. In the **User Mode** area, select the required mode from the **Select user mode** list.

After changing the mode in the General Settings page, you must log out of HP Business Availability Center and log in again to see the mode filtering work.

### 2 Define KPI Versions for the User Modes

The following steps describe how to define different versions of a KPI to use with each user mode. You can assign user modes to a new KPI that you define, or to an existing KPI by cloning or overriding the KPI. For more information, see "KPI Repository page" on page 535.

If you want one of the KPI versions for a user mode to automatically replace an existing KPI, then you must override the existing KPI and edit the new version.

It is recommended that you give a name to each KPI that is assigned a user mode that easily identifies the KPI with the appropriate user version. For example, you can add an appropriate suffix.

### **Example – Define KPI Versions For User Modes**

- **a** Access the Admin > Dashboard > Repositories > KPIs page.
- **b** Define the business user version of the KPI:
  - ➤ Add the required KPI to the Custom KPIs area by cloning or overriding a KPI, or creating a new KPI. Open the KPI for editing.
  - ➤ In the displayed KPI Details window, give the new KPI/copied KPI an appropriate name. For example, add the suffix \_biz (as in Availability biz).
  - ➤ Select **Business** in the **Applicable for User Mode** list.
- Define the operations user version of the KPI:
  - ➤ Add the required KPI to the Custom KPIs area by cloning or overriding a KPI, or creating a new KPI. Open the KPI for editing.
  - ➤ In the displayed KPI Details window, give the new KPI/copied KPI an appropriate name. For example, add the suffix \_ops (as in Availability\_ops).
  - ➤ Select Operations in the Applicable for User Mode list.

**Note:** If you override a KPI, the overridden version of the KPI replaces the original KPI throughout Dashboard, so all CIs that are assigned the original CI (for example, Availability) are automatically updated to the new version (for example, Availability\_ops).

**d** Edit the details for each KPI version, according to your requirements. For example, you might want different business rules to apply to each version. For more information, see "KPI Details Dialog Box" on page 537.

**e** To use a different version of a business rule with each KPI version, you must define the rule versions in the Business Rule Repository. For example, for two versions of the Availability KPI, you may require two versions of the Transaction Availability Rule, each with different default objective values.

For details on defining business rules, see "Customize a Business Rule" on page 566.

#### 3 Attach KPI Versions to Cls

You can manually attach the KPI versions to the CIs to which you want them to apply.

- ➤ If the original KPI is already attached to CIs (for example, the Availability KPI is automatically attached to transaction CIs), then the KPI version that overrode the original (for example, Availability\_ops) is automatically attached to the CIs instead. You can manually attach the second KPI version (for example, Availability\_biz).
- ➤ If there are two new KPI versions, one for business and one for operations then for every applicable CI you manually attach the two versions (and delete the original KPI if it is not required).

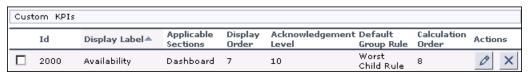
To attach the KPI versions to CIs, select **Admin > Dashboard > KPIs** page, add the KPI versions to each CI where they are required, so that the CIs have both versions of the KPI. You can add the KPI to multiple CIs in one operation. For example, you might want to define different objective values for the KPI. For KPIs that require selectors: Do not define anything in the **Selector** area, leave the selector expressions empty. Click **OK** to save the KPI details. The KPI version is added to each selected CI, and propagates up the hierarchy to the parent CIs. After you click **OK** to add the KPI to the CIs, HP Business Availability Center automatically replaces each blank selector with the default selector defined for the other KPIs attached to each CI. For details, see "How Dashboard KPIs Work" on page 338.

### **Example – Scenario of KPI Versions for User Modes**

In the following example scenario, two versions of the Availability KPI are set up, one for each user mode. The Availability\_ops version uses the default objective values; however, when the Availability\_biz version is attached to CIs, different objective values are defined.

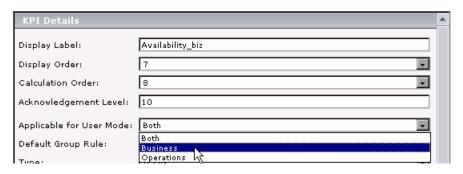
Proceed as follows to set up and use Availability KPI versions for user modes:

- **a** Access the Admin > Dashboard > Repositories > KPIs page.
- **b** In the **Factory KPIs** area, select the check box for the **Availability** KPI and click **Clone**. The cloned KPI is displayed in the **Custom KPIs** area.





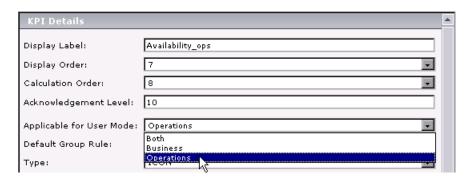
- **c** Click the **Edit** buttonfor the cloned KPI. In the displayed KPI Details window, edit the KPI properties as follows:
  - ➤ In the **Display Label** box, add the suffix \_biz to the **Availability** label.
  - ➤ Select Business in the Applicable for User Mode list.



- ➤ Click **OK**.
- **d** In the **Factory KPIs** area, select the check box for the **Availability** KPI and click **Override**. The old Availability KPI is shown as overridden, and the new version of the KPI is displayed in the **Custom KPIs** area.

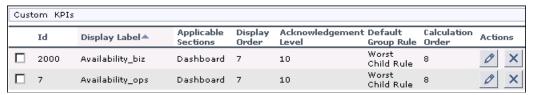


- **e** Click the **Edit** button for the new KPI. In the displayed KPI Details window, edit the KPI properties as follows:
  - ➤ In the **Display Label** box, add the suffix **\_ops** to the **Availability** label.
  - ➤ Select Operations in the Applicable for User Mode list.



➤ Click OK.

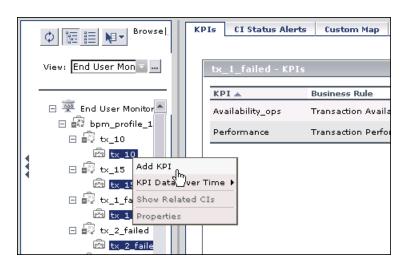
The KPI names are displayed in the **Custom KPIs** area.



**f** Access the **Admin** > **Dashboard** > **KPIs** page and open the End User Monitors View. For all BPM Transaction from Location CIs, the Availability KPI has been replaced with the Availability\_ops KPI.



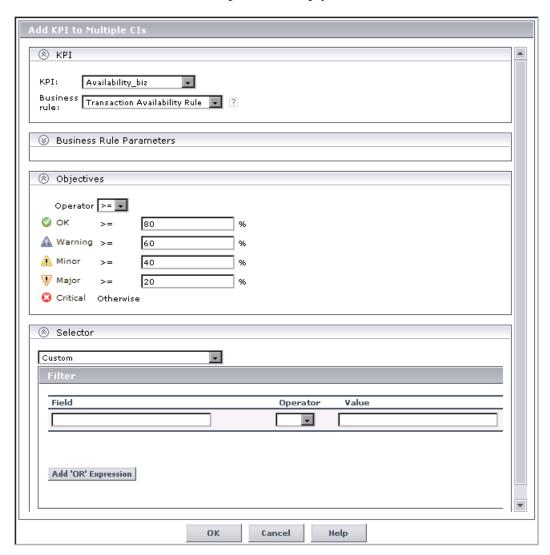
**g** Add the Availability\_biz KPI to all BPM Transaction from Location CIs. Use the keyboard CTRL key to select all the CIs, then right-click one of the selected CIs and select **Add KPI**.



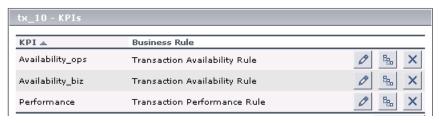
The Add KPI to Multiple CIs window opens.

- **h** Edit the properties in the Add KPI to Multiple CIs Window as follows:
  - ➤ Select Availability\_biz in the KPI list.
  - ➤ Select Transaction Availability Rule in the Business rule list.
  - ➤ In the **Objectives** area, enter the objective values required for Availability KPI in business user mode: 80, 60, 40, 20.

➤ Leave the selector expressions empty.



➤ Click **OK**. The **Availability\_biz** KPI is added to the KPIs list for each selected CI.





The appropriate selector is automatically defined for each new KPI, by copying the selector definitions for the other KPIs attached to the BPM Transaction from Location CI. (You can click the **Edit** buttonfor the **Availability\_biz** KPI to view the selector.)

The **Availability\_biz** KPI also propagates up to the CI parents, using the default group rule for the KPI.

A CI can display different status for each Availability KPI version (although each KPI has the same Availability score), because of the different objective levels defined for each version.

## Change the KPI Status Icons

Different icons are used for the KPI status for each range specified in the **From/To** fields in the Parameter Details dialog box. For details, see "Parameter Details Dialog Box (KPIs)" on page 550.

If you want to customize the KPI status icons, create a new set of icons and, where applicable, add your icons to the appropriate directories and redirect the KPI's status parameters to those icons or replace the default icons with your customized icons using the same names.

**Note:** The recommended size for an icon should be 16x16 pixels.

### To change the Dashboard KPI status icons:

You can do one of the following:

- ➤ Add your icons to the appropriate directory and specify their names in each one of the status parameters for the KPIs. For details on the user interface, see "KPI Details Dialog Box" on page 537.
- ➤ Replace the icon or icon set with the customized icons and give them the names of the default icons.

To find the location of the icon you want to replace, right-click the icon in the appropriate tab in Dashboard, select **Properties**, and view the icon's location in the **Address (URL)** field.

### To change the Dashboard Trend and History status icons:

### To change the Dashboard Top View status icons:

#### KPI Assignment Management Overview

When a new CI is added to the CMDB, the assignment mechanism assigns the appropriate KPIs to the CI. When you assign a KPI to a CI or when you attach a CI to another CI, the propagation mechanism propagates the appropriate KPIs to the parent CIs.

The assignment mechanism assigns KPIs and context menus to CIs at the monitor CI level. Then the propagation mechanism starts running, propagating by default the KPIs assigned at the monitor level to the higher levels in the hierarchy of the view or attaching other KPIs to the CIs in the higher levels of the hierarchy. The propagation is performed for each KPI separately.

An assignment assigns KPIs according to the cmdb class attribute of the CI type. A propagation assigns KPIs to the parent CI, according to the triplet defined by the parent CI Type (using the parentCIClassName attribute), child CI Type (using the childCIClassName attribute), and KPI of the child CI.

KPIs and business rules are assigned to CIs using the assignment mechanism at the monitor CI level. For details about the assignment mechanism, see "Assignments" on page 421.

KPIs and business rules are assigned to CIs using the propagation mechanism at non-monitor CI level. For details about the propagation mechanism, see "Propagations" on page 423.

For a scenario which includes assignment and propagation, see "Define Repository Elements and KPI Assignments to Monitor Mobile Terminals – Scenario" on page 482.

**Note:** If you are using HP Operations Manager *i* with HP Business Availability Center, then the KPI Assignment tab contains OMi-related assignment groups. For more information, see *Using HP Operations Manager i*.

### Assignments

KPI assignment are mechanisms that are activated under certain conditions to incorporate specific data into Dashboard, at the monitoring level.

An assignment includes a condition and a task. The condition describes a CI or sets conditions on the attributes of a CI. The task describes the context menus, KPIs, and business rules that are automatically assigned to the CI, in the CMDB, when the condition occurs, and the assignment is running. An assignment is a rule that is saved using the Dashboard Repositories mechanism. You can view the assignments only in the KPI Assignment user interface. For details, see "Assignment Groups Page" on page 450.

Factory KPI assignment groups are pre-defined sets of assignments. They work together to cover all the sets of conditions for monitoring level CIs needed to incorporate data from the corresponding monitored system into Dashboard. For details on groups, see "Groups" on page 422.

#### **Assignment Mechanism**

The assignment mechanism receives notification from the Universal CMDB about the creation of monitor CIs. The KPI assignment mechanism is activated when a specific attribute of the monitor CI is updated and the KPI assignment conditions for that CI are based on the updated attribute. The KPI assignment mechanism performs the following actions in the Universal CMDB:

- ➤ Creates the KPIs attached to the monitor CI.
- ➤ Assigns the business rule to the KPI with parameters that can be based on attributes of the monitor CI.
- ➤ Assigns thresholds that can be based on attributes of the monitor CI.
- ➤ Assigns selectors that can be based on attributes of the monitor CI.
- ➤ Adds the context menus.

The KPI assignment mechanism is a HP Business Availability Center service that can be managed by HP Service Manager. For details, see "System Health Setup Wizard" in *Platform Administration*.

A service completes the missed KPI assignments as soon as HP Business Availability Center is restarted, after it has been stopped.

The KPI assignment mechanism is deployed on the Data Processing server.

For details on creating assignments, see "Define Assignment Configuration Dialog Box" on page 450.

For general information on KPI functionality, see "KPI Configuration Overview" on page 336. For details on Dashboard KPIs, see "List of Dashboard KPIs" on page 510.

#### Groups

A group is a logical feature that enables you to group KPI assignments (assignments and propagations).

Some assignments are grouped together to cover all the conditions that can be applied to a specific CI. The conditions are set on the sample's field values.

For example, a group can assign different KPIs to a CI when the value of a CI attribute equals or is different from a certain value.

➤ An assignment that deals with the KPIs and business rules to be applied if the sample's field, corresponding to the CI, has a specific value:

➤ An assignment that deals with the KPIs and business rules to be applied if the sample's field does not have that specific value:

Some groups also include assignments that are applied to different CIs.

For details about the assignments user interface, see "Assignment Groups Page" on page 450.

## Propagations

Propagations are mechanisms that are activated under certain conditions to incorporate specific data into Dashboard, at all CI levels except for the monitoring level.

A propagation is defined per triplet (parent CI type, child CI type, and KPI attached to the child CI type), and specifies the business rules, KPIs, and thresholds propagated to the parent CI type from the child CI type.

A propagation includes a condition and a task. The condition describes the KPIs to be propagated, the child CIs, the parent CIs, and the type of propagation (**explicit** or **samekpi**). The task describes the KPIs, and business rules that are automatically propagated to the parent CI. The task may include thresholds to be used to set the status of the KPI. For details, see "Thresholds" on page 425.

A propagation definition is a rule that is saved using the Dashboard Repositories mechanism. You can view propagation information only in the Propagation user interface. For details, see "Define Propagation Configuration Dialog Box" on page 463.

If a parent CI is already assigned a specific KPI, and the propagation is defined as propagating the same KPI from the child CI, the KPI is not propagated from the child CI.

Some limitations apply when the same KPIs are propagated to the parent CI from multiple child CIs. For details, see "Propagation Limitations" on page 434.

The parent CI must be a logical group CI and the business rules that are propagated must be non-leaf rules.

Factory propagations are pre-defined sets of propagations. They work together to cover all the possible configurations of child CIs and parent CIs needed to propagate data from the relevant monitoring level CIs to the non-monitoring level CIs. For details about groups, see "Groups" on page 422.

#### **Default Propagation**

The default propagation means that:

- ➤ Each KPI attached to any child CI of any parent CI is automatically propagated to the parent CI.
- ➤ The KPI is assigned the KPI's default group business rule as defined in the KPI definition in the KPI repository. For details, see Default Group Rule in "KPI Details Dialog Box" on page 388.
- ➤ The thresholds are defined in the business rule repository, if they exist.
- ➤ The default propagation is not visible in the user interface. You cannot modify it.

The default propagation rule is used for a triplet only if no other factory or custom propagation rule matches the triplet.

#### When is the Propagation Mechanism Activated

The propagation mechanism is triggered when:

- ➤ A link between two CIs is added or removed, in the CMDB.
- ➤ You assign a KPI to a CI or you detach a KPI from a CI in Dashboard administration.

#### **Thresholds**

Each child CI can have a different KPI propagation definition that includes the KPIs and the business rules to attach to the parent CI as well as the thresholds that determine the KPI status. For details about the KPI propagation, see "Define Propagation Configuration Dialog Box" on page 463.

This section describes the different ways you can use to specify the propagated business rule objectives.

#### **Default Thresholds**

Default thresholds are defined in the repository business rules. If you do not enter an <objective> section in the task, the thresholds defined in the business rules are used. If thresholds are not defined in the business rules, then empty thresholds are assigned to the KPI.

#### **Non-Default Thresholds**

To use non-default thresholds for the business rule, you can specify the thresholds in the task (after specifying the KPI and the rule):

#### **Types of Propagation**

The propagation mechanism supports different types of propagation.

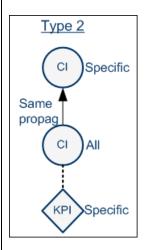

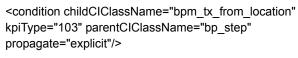

#### **Recommended Procedure**

You create a set of propagations for a topology, meaning that for each level of parent CI in the hierarchy, you must create a set of propagations. A lot of the propagations are repetitive so the correct procedure is to:

- **1** Create a set of general propagations of **Type 1** for a specific parent CI.
- **2** Create a set of more specific propagations of **Type 2** for a specific KPI and a specific parent CI.
- **3** Create a set of more specific propagations of **Type 3** for a specific KPI, a specific child CI, and a specific parent CI.
- **4** Create a set of non-propagations of **Type 4** for a specific KPI, a specific child CI, and a specific parent CI.

The propagations are then sorted and applied to each parent CI. For details, see "Selecting the Appropriate Propagation" on page 430.

#### **Selecting the Appropriate Propagation**

The matcher of the propagation mechanism considers all the propagation definitions and sorts them before applying them to the different triplets.

All the customized propagations that you define are added to a list of existing propagations that is already sorted.

The matcher sorts the complete list of propagations according to the algorithm described below.

#### 1 Parent sorting:

- ➤ A comparison triplet parent CI that is equal to the propagation parent CI (the number of hierarchy levels is 0 in the model hierarchy) is better than a comparison triplet parent CI that is derived with a larger number of hierarchy levels from the propagation parent CI.
- ➤ A comparison triplet parent CI that is derived, in the class model, from the propagation parent CI with a smaller number of hierarchy levels is better than a comparison triplet parent CI that is derived from the propagation parent CI, with a larger number of hierarchy levels.

#### **2** Child sorting:

The mechanism performs the same type of sorting as the parent CI sorting on the child CI.

#### **3** KPI sorting:

The sorting is performed on the KPI where the KPI corresponding to the triplet KPI is better than **kpiType=all**.

For each KPI that is propagated from a child CI type to a parent CI type (comparison triplet), the matcher scans the list of sorted propagations to find the propagation that most closely matches the triplet. A propagation is considered a match when:

➤ The parent CI type and the child CI type in the propagation correspond exactly to the comparison triplet parent CI or child CI, **OR** the child CI class in the comparison triplet is derived (in the class model hierarchy) from the child CI type in the propagation and the same for the parent CI type.

#### AND

➤ The propagation KPI has the same ID number as the comparison triplet KPI **OR** the propagation condition specifies kpiType=all.

The first propagation in the sorted list is used.

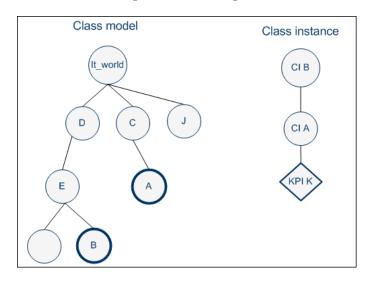

The class model is provided in the picture below.



The result of the sorting procedure is as follows:

- **1** Propagation 6 is at the top of the list as its parent CI type is E (most specific), child CI type C (most specific) and KPI type is K (explicit type).
- **2** Propagation 5 comes after propagation 6 as its only difference with 6 is its generic KPI type.
- **3** Propagation 4 comes after as its child CI type (it\_world) is more generic than propagation 5's child CI type (C).

- **4** Propagations 3, 2, and 1 are listed afterwards (in this order), as their parent type is less specific (higher in the hierarchy) than type E.
- **5** Propagation 1 goes to the bottom of the list as it is the most generic propagation.

When the propagation mechanism tries to find the closest matching propagation definition to the triplet (parent=CI B, child=CI A and KPI=KPI K) propagation 6 is at the top of the list and is therefore selected.

### **De-propagation**

The de-propagation mechanism is activated:

- **1** When a CI is deleted from the impact model.
- **2** When a link between two CIs is deleted from the impact model.
- **3** When a KPI is deleted from a CI of the impact model.

For details on the impact model, see "Impact Modeling Overview" in *Model Management*.

There are two cases of depropagation:

- ➤ Case A: KPI is deleted.
- ➤ Case B: CI is deleted OR the link between two CIs is deleted.

In case A, the de-propagation mechanism performs the following steps:

- **1** Finds the matching propagation for the deleted KPI according to its triplet (child CI, parent CI, and KPI type). For details, see "Selecting the Appropriate Propagation" on page 430.
  - The selected propagation includes the set of KPIs that might have been previously propagated by the deleted KPI.
- **2** Retains from the potential KPIs only the KPIs that are currently attached to the parent CI.
- **3** Finds the propagations that match the KPIs attached to the child CI and its siblings.
- **4** Builds a set of the KPIs that might have been previously propagated by the matching propagations from step 3.

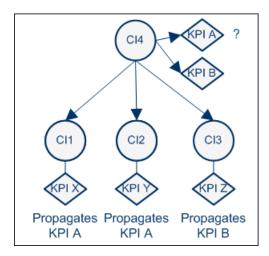
- **5** Removes the KPIs of step 4 from the set of KPIs of step 2.
- **6** The remaining KPIs are deleted from the parent CI.
- **7** The de-propagation mechanism is then applied to the next level of the impact model topology for each one of the KPIs deleted in step 6.

In case B, the de-propagation mechanism performs the following steps:

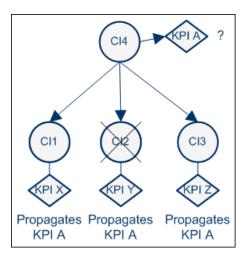
- **1** Finds all the matching propagations for all of the KPIs attached to all of the siblings of the deleted (or detached) CI.
- **2** Builds a set of KPIs attached to the parent CI that were not propagated by any of the propagations from step 1.
- **3** Deletes from the parent CI all of the KPIs from step 2.
- **4** Activates the de-propagation mechanism described in case A starting with the parent CI and the set of KPIs deleted from it in step 3.

### **Propagation Limitations**

➤ If you propagate the same KPI A from different child CIs (CI1 and CI2) with a different propagation, the propagation that affects the parent CI (CI4) regarding KPI A can be either one of the propagations (from CI1 or CI2). Because of this uncertainty, it is recommended to avoid specifying different propagations that propagate the same KPI with different rules and/or thresholds.



➤ According to the previous limitation, if you propagate the same KPI A from different child CIs (CI1, CI2, or CI3), the propagation that affects the parent CI (CI4) regarding KPI A can be either one of the propagations. If you delete one of the CIs (CI2) or one of its KPIs, the configuration of KPI A (rule and thresholds) is updated and propagated from either CI1 or CI3. The update is not performed if the KPI was customized by the user.



### **♦** Validation

The validation mechanism for assignments and propagations checks that for:

#### ➤ KPI assignments:

- ➤ The CMDB class used in the condition of a Dashboard KPI assignment should be of monitor type.
- ➤ The task of a Dashboard KPI assignment should contain at least one KPI that specifies a selector.
- ➤ The task of a Dashboard KPI assignment should contain at least one KPI configuration.

#### ➤ KPI propagations:

- ➤ The business rule assigned to a KPI is applicable to the KPI and is a non-leaf rule
- ➤ When you use the **same-kpi** propagation in a Dashboard KPI propagation, you must specify a global rule (it can be the default rule); and you should not specify KPI configuration elements.

## SiteScope KPI Assignment Group Overview

**Note:** The feature described in this section is available to users working with SiteScope 9.50 and later. If you are working with SiteScope 9.0 and earlier, see "SiteScope Source Adapter Details" in *Model Management*.

The SiteScope Assignment group is a logical group of KPI assignments. The KPI assignments assign specific KPIs, business rules, and context menus to the appropriate CIs in the Universal CMDB, under specified conditions usually related to the samples sent by SiteScope to HP Business Availability Center.

SiteScope sends the topology information and builds the hierarchy, including the hosts, SiteScope groups, monitors, and additional topologies corresponding to specific SiteScope monitors, needed to incorporate data (collected by SiteScope data collectors, or supplied by other external resources) directly to HP Business Availability Center. The KPI assignments mechanism, analyzes the samples, and adds the KPIs, business rules, and context menus at the monitoring level of the topology.

Siebel, SAP, and SOA topology and their measurements also use the KPI assignments mechanism to add the KPIs, business rules, and context menus needed to incorporate data (collected by the appropriate SiteScope data collectors) into HP Business Availability Center, at the monitoring level.

The information is then used to build views for the HP Business Availability Center applications. Those views present the real-time monitoring data received from the data sources in Dashboard.

The SiteScope Assignment group is preconfigured to work immediately with the data collected by the SiteScope data collectors.

**Note:** All topologies created by SiteScope and stored in the Universal CMDB are subjected to the aging process. To prevent aging, see "Aging of CIs in CMDB" in *Using System Availability Management*.

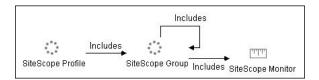
### **Predefined Monitoring Views**

Predefined views display the created CI hierarchies for the SiteScope monitors. When data is received over the bus for a defined source, you can open the relevant view in Dashboard and view status information for the CIs. You can use the CI hierarchies created in the predefined monitoring views as the building blocks for defining your own customized views.

### **Hierarchies**

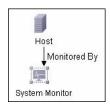
The default topology corresponding to the SiteScope monitors is included in the following views:

The curved arrow indicates that the hierarchy element is recursive; the CI type is the child of the level above in the hierarchy, but it can also be a child of the CI type itself. For example, a SiteScope Group CI type is the child of a SiteScope Profile CI type, but can also be the child of a SiteScope group CI type. The view also supports the legacy hierarchies (**Depends on** and **Monitored by** relationships and **Include Measurements** and **Include Machines** options). The legacy hierarchy is not shown in the picture of the view displayed above.

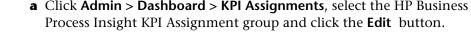

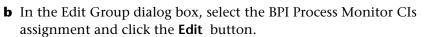

If you have the **Superuser** role, you have full viewing and editing rights for all of the Dashboard Administration, including the KPI Assignments. If you have the **Administrator** role, you can only view/edit views for which you have permission and you cannot edit, add, or view KPI Assignments. Depending on when you set SiteScope to report to HP Business Availability Center, the default logging options are set as follows:

➤ If you defined monitors in SiteScope before SiteScope was set to report to HP Business Availability Center, the logging option of each SiteScope monitor is automatically changed to **Disable reporting to BAC** when you set SiteScope to report to HP Business Availability Center.

You must select another logging option for the monitors whose information you want to display in HP Business Availability Center. Use the Global Search and Replace mechanism to modify the logging option of the selected monitors. For details, see "Global Search and Replace" in *Using System Availability Management*.

Use the **Disable reporting to BAC** option when you do not want the SiteScope monitors and measurements for the subject monitor to be transferred to HP Business Availability Center.

➤ If you define monitors after you have set SiteScope to report to HP Business Availability Center, the monitors have, by default, the **Report everything** option selected.

### Repositories – Overview

HP Business Availability Center repositories provide definitions for objects in the HP Business Availability Center system. Many of these definitions can be customized as required by your organization.

The Repository page provides a convenient user interface for viewing and customizing the definitions contained in the repository XML definition files. These files define the templates that are used throughout HP Business Availability Center to determine how source data is imported and handled, and to determine appearance and functionality for the CIs in the presentation layer.

#### Repositories

The Repository page enables you to access the following repositories:

- **KPIs.** Provides definitions for the Key Performance Indicators (KPIs) used in Dashboard. For details, see "KPI Repository Overview" on page 507.
- **Rules.** Provides definitions for the business rules used with the KPIs in Dashboard. For details, see "Business Rule Repository Overview" on page 554.
  - The Rules API can be used to create new rules; for details see "Rules API" on page 657.
- ➤ Context menus. Provides definitions for the Configuration Items (CIs) menus used in Dashboard. For details, see "Context Menu Repository Overview" on page 693.
- **Context menu items.** Provides definitions for the CI menu items that are used in the context menus. For details, see "Context Menu Item Repository Overview" on page 718.
- ➤ **Tooltips**. Provides definitions for the tooltips used to display CI information in Dashboard. For details, see "Tooltip Repository Overview" on page 812.

#### **Permissions**

To view the repositories you must have the **Add permission for Sources** permission. To set up the permissions, select Admin > Platform > Users and Permissions > Permissions Management.

#### **Advanced Users**

Advanced users can modify existing repository objects and create new ones. This may be necessary when you want to customize the way information is presented in Dashboard to fit the needs of your organization; or when you need to create new objects when integrating data from a new external system into Dashboard.

#### **Dashboard and Service Level Management Repositories**

Dashboard and Service Level Management use two separate, independent sets of repositories. Dashboard has repositories for KPIs, rules, context menus, context menu items, and tooltips. Service Level Management has repositories for KPIs and rules. These repositories contain different KPIs and rules; changing KPIs or rules in Dashboard has no effect on Service Level Management (and vice versa).

For details on the Service Level Management repositories, see "KPI Repository" and "Business Rule Repository" in *Using Service Level Management*.

### Customizing Repository Elements

Within the Repository page, preconfigured repository elements are labeled **Factory** elements (for example Factory KPIs), and modified elements are labeled **Custom** elements.

There are three ways to customize elements in the Repository page:

- ➤ New Item. Creates a new repository element that is not based on an existing element. You customize the new element to fit your needs.
  - Note that tooltips can only be modified; you cannot create a new tooltip.
- ➤ Clone. Creates a new repository element by cloning an existing factory or custom element. The original element is still available, and the new cloned element can be modified. The cloned element is automatically assigned a new ID number.

➤ Override. Overrides an existing factory element. The original element is labeled overridden (disabled) in the Factory area, and an editable copy appears in the Custom area. Both the custom element and the original element have the same ID number. If you delete the custom element, the original factory element is automatically restored.

**Note:** HP Professional Services offers best practice consulting; it is recommended that you use this service before making any changes to the repositories. For information on how to obtain this service, contact your HP Software Support representative.

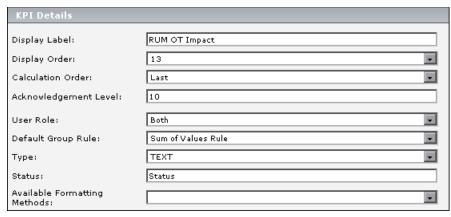

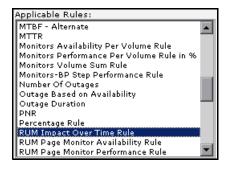

## P Define Repository Elements and KPI Assignments to Monitor Mobile Terminals – Scenario

A hospital uses Mobile Terminals (MTs) to view and update patient records. Each MT includes a terminal and a battery mounted on a cart, which is moved between rooms. When the batteries run out of power, the MTs are often pushed into a corner rather than recharged, and the hospital is unable to track which MTs are offline.

To track offline MTs, SiteScope Service monitors are configured to monitor the Windows Server Service; if it is not available (if u\_iQuality = 3) the MT is offline. A View is created in Modeling Studio to represent the hospital, the floors, the MTs on each floor, and the SiteScope Service monitors which indicate if an MT is offline.



This scenario describes how Jane, the Dashboard administrator, works with the Dashboard repositories and the KPI Assignment mechanism to display the following information in Dashboard: which MTs are offline, how many are offline on each floor and in the entire hospital, and what percentage are offline on each floor and in the entire hospital.

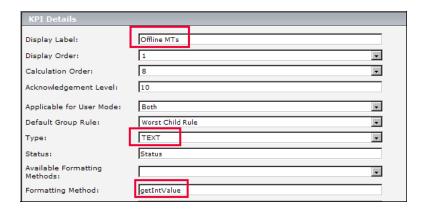

#### 1 Clone and Edit the System KPI

By default, the System KPI uses the Percentage business rule. This KPI will be used for the floor level CIs, to indicate what percentage of MTs are offline. Using the Dashboard KPI Repository, Jane creates another KPI to count the number of offline MTs per floor.

Jane clones the System KPI, and opens the Custom KPI for editing. She renames the KPI to **Offline MTs**, changes its Type to **TEXT**, and its Formatting Method to **getIntValue**, to display a number rather than status icon.

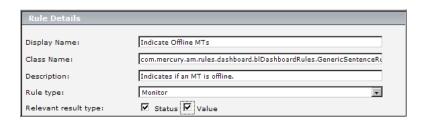


#### 2 Clone and Edit the Generic Formula Rule to Identify Offline MTs

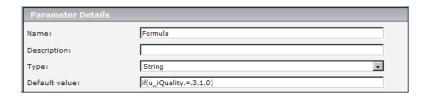
Within the sample fields collected from the MTs, if the value of the  $u_iQuality$  field is 1, the MT is online; if  $u_iQuality = 3$  the MT is offline.

Jane uses the Generic Formula rule to change the value of this field to 1 or 0 depending on the MT's online or offline status. This enable the floor level CIs to sum the 1s and 0s, and count how many MTs are offline.

Within the Dashboard Business Rule Repository, Jane clones the Generic Formula rule, and opens the Custom rule for editing. She changes the name of the rule to **Indicate Offline MTs** and adds a rule description. She defines the Rule Type as **Monitor**, and selects **Status** and **Value** for the rule's Relevant result type.



Within the Rule Parameters area, Jane edits the **Formula** parameter. She sets the formula Type as **String**, and defines the formula's Default Value as **if(u\_iQuality,=,3,1,0)**. This means that if the value of u\_iQuality is equal to 3 (offline), its value is set to 1; otherwise it is set to 0.



#### 3 Clone and Edit the Sum of Values Rule to Count the Offline MTs

Within the Business Rule Repository, Jane clones and edits the Sum of Values rule to sum the values (1s and 0s) of the MTs on each floor, to count how many are offline. She changes the name of the cloned rule to **Count Offline MTs** and adds a rule description. By default, the Sum of Values rule calculates a sum of child CI values in dollars. Jane removes the dollar sign (\$) from the **Units** text box.

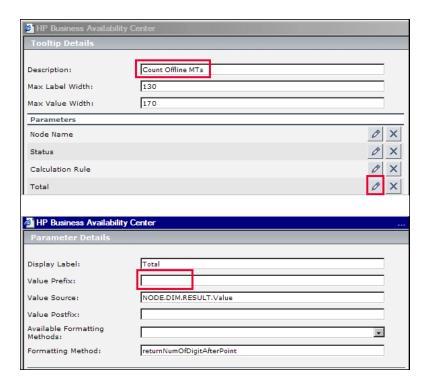

When Jane cloned the Sum of Values rule a new tooltip was automatically created, but its units are in dollars. Jane edits the new tooltip to correspond to the new rule.

Within the Tooltips Repository, Jane opens the tooltip **Summary of values for kpi** in the Custom Tooltips area. She changes the name of the cloned tooltip to **Count Offline MTs**. In the Parameters section, she edits the **Total** parameter, removing the dollar sign (\$) in its **Value Prefix** field.



#### 5 Attach the Two New Rules to the New KPI

Jane now attaches the new rules to the new KPI. Within the KPI Repository, she opens the **Offline MTs** KPI for editing. In the **Applicable Rules** list, she selects both **Count Offline MTs** and **Indicate Offline MTs**, while pressing the CTRL button. (If she does not press the CTRL button, all of the preselected rules are disabled when she selects the new rules.)

#### 7 Propagate KPIs and Rules to the MT, Floor, and Hospital CIs

Jane now uses the Dashboard KPI Assignments tab to define propagation of the Offline MTs KPI and the Count Offline MTs rule to the MT, Floor, and Hospital CIs.

She also defines the propagation of the System KPI with Percentage rule to the Floor and Hospital CIs.

**a** Within the **Hospital KPI Enrichments Group**, Jane adds a propagation named **Count Offline MTs Propagation**. This propagation attaches the Offline MTs KPI (2000) and the Count Offline MTs rule (2001) to the MT CIs.

The condition for this propagation is that the parent CI type is logical\_group (which includes the MT CIs), and the child CI is a SiteScope monitor assigned the Offline MTs KPI (2000).

She types the following in the propagation's **Condition** box:

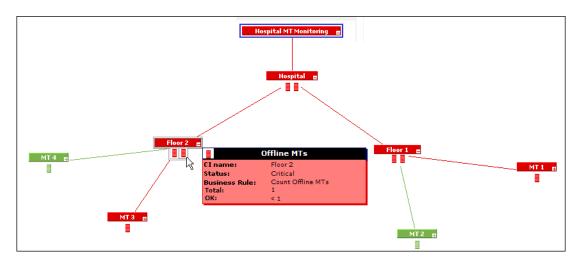

Unv08nnm is the Network Node Manager 8i (NNM 8i) server in the Business Service Management (BSM) hosted solution.

The first part of the URL – before the question mark – is the static part of the dynamic URL used to create the context menu option and the second part of the URL consists of parameters used by the dynamic URL. Each parameter and its value is separated from the others by &.

To create the context menu item in the Dashboard Repositories, you can either add a completely new menu item, or clone an existing one that is similar to what you need and edit its properties. The new menu option (NNMi) is added to the context menus used for the NNMi CIs.

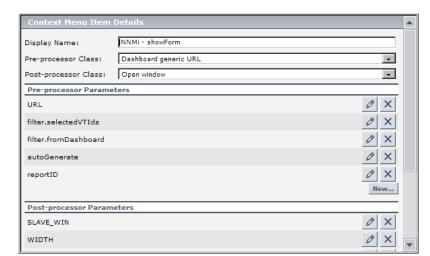

**NODE.PROPS.display\_label** returns the name of the CI that you right-click to use the NNMi context menu item. It searches for the CI (NODE) where the cursor is located, and then for the CI Property (PROPS) that corresponds to the CI name (data\_name). The name of the CI that you right-click is then changed into the **nodename** parameter that is used by the URL to access the correct information.

#### You can also use:

- ➤ NODE.ID to return the CI ID Symbol in the view.
- ➤ NODE.CMDB.ID to return the CI CMDB ID.
- ➤ NODE.PROPS.data\_name to return the CI name.



#### c In the Post-processor Parameters area:

- ➤ Click the **Edit** button for **WIN\_NAME** to open the Post-processor Parameter Details dialog box. In the **Value** box, enter a name for the window opened by the menu item, for example, NNMi. Click **OK**.
- ➤ Click the **Edit** button for **SLAVE\_WIN** to open the Post-processor Parameter Details dialog box. Make sure that the value of the **SLAVE\_WIN** parameter is 0 to open a new window. Click **OK**.
- **d** Click **OK** to close the Context Menu Item Details dialog box. The new context menu item is displayed in the **Custom Context Menu Items** area of the Repositories Context Menu Items page.

#### 1 Prepare Customization Requirements

A cruise ship company wishes to define the following unique business elements to see in Dashboard: a logical CI called Cruise Ship to add to views; a custom KPI to monitor the dollar impact of down time of monitored ship systems; a customized context menu for Cruise Ship CIs that includes a URL link to its fleet intranet site.

#### 2 Create Custom CIT to Represent Unique Business Entity

In CI Type Manager, the company's HP Business Availability Center administrator adds a new logical CI type called Cruise Ship to the Business folder. In the Attributes page, the administrator adds a new editable attribute, ship\_serial\_number, and marks the data\_name attribute as the key attribute (since it serves as a unique identifier for each ship).

#### 3 Create a Customized Rule in the Business Rule Repository

In the Business Rule Repository, the administrator creates a customized rule to handle the dollar impact of ship system non-availability by cloning the Impact Over Time Rule, renaming the cloned rule to Ship Impact Over Time Rule, and editing the DollarImpactFactor parameter to 1000 (to represent a dollar loss of \$1,000 per hour).

#### 4 Create a Customized Tooltip in the Tooltip Repository

In the Tooltip Repository, the administrator edits the description of the new tooltip associated with newly created Ship Impact Over Time Rule that appears in the Custom Tooltips section to say: Dollar loss due to no availability on ship system.

#### 5 Create a Customized KPI in the KPI Repository

In the KPI Repository, the administrator creates a customized KPI to monitor the dollar impact of ship system non-availability by cloning the OT Impact KPI, renaming the cloned KPI to Ship OT Impact, and modifying the selected applicable rules—clearing Impact Over Time Rule and selecting Ship Impact Over Time Rule.

#### **6 Create a Customized Context Menu Item**

In the Context Menu Item Repository, the administrator clones the Go to Report item, renames the cloned item Go to Ship, selects the Dashboard generic URL pre-processor class, edits the value of the URL parameter to the desired URL address, and selects the Open window post-processor class.

#### 7 Create a Customized Context Menu

In the Context Menu Repository, the administrator clones the Group Menu, renames the cloned item Ship Group Menu, and edits Ship Group Menu to add Go to Ship as a new item in the Go to Report menu item list.

#### **8 Create Views Using Custom CIT and Attach Monitors**

In IT Universe Manager, the administrator creates a new perspective view called Cruise Ship Fleet, and adds a Cruise Ship CI for each ship in the fleet. The administrator attaches relevant SiteScope and Business Process Monitors that were previously configured to monitor ship systems.

# 9 Assign the Custom Context Menu to Cls Created Using the Custom CIT

When adding Cruise Ship CIs to views, the administrator assigns the Ship Group Menu as the context menu for the CIs. The menu is then visible in Dashboard views.

### 10 Assign the Custom KPI to CIs Created Using the Custom CIT

After creating views that include the Cruise Ship CIs, in the Dashboard Administration KPIs tab the administrator assigns the new KPI Ship OT Impact to the Cruise Ship CIs. This KPI is then visible in Dashboard views to users with appropriate permissions on the views.

# KPI Repository Overview

The KPI Repository page displays the list of factory (predefined) and customized KPIs. Those KPIs are available throughout HP Business Availability Center to determine how source data is imported.

The Dashboard KPI Repository includes all of the KPIs that can be used in the Dashboard application. For details on the Dashboard KPIs, see "List of Dashboard KPIs" on page 510.

Each KPI is defined by an ID number in the adapter templates, and is assigned a default business rule (a business rule is built on business logic). For more information about KPIs, see "KPIs Page" on page 408.

For details on creating or editing KPIs, see "KPI Repository page" on page 535.

**Note:** If you are using HP Operations Manager *i* with Business Availability Center, then the KPI Repository page contains OMi-related KPIs. For more information, see *Using HP Operations Manager i*.

#### **Dependent KPIs**

A KPI is dependent on another KPI when the rule that calculates the value of the first KPI uses the results of the second KPI's rule. For example, if an Outage KPI and a Number of Outages KPI are attached to a specific CI, the value of the Number of Outages KPI depends on the values of the Outage KPI. The KPIs are calculated in a specific order.

There are three ways to customize repository elements:

➤ New Item. Creates a new repository element that is not based on an existing element. You customize the new element to fit your needs.

To create a new KPI, click **New Item** in the KPI Repository page.

➤ Clone. Creates a new repository element by cloning an existing factory or custom element. The original element is still available, and the new cloned element can be modified.

To clone a KPI, select a factory KPI and click **Clone** in the KPI Repository page.

➤ Override. Overrides an existing factory element. The original element is labeled overridden (disabled) in the Factory area, and an editable copy appears in the Custom area.

To override a KPI, select a factory KPI and click **Override** in the KPI Repository page.

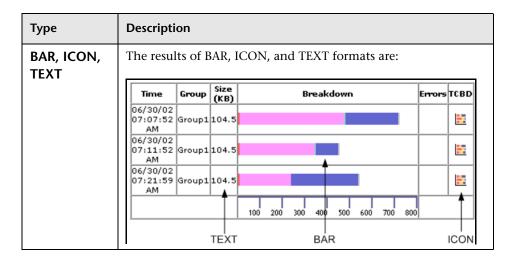

Service Level Management KPIs are assigned a positive trend (the higher the better or the lower the better).

- ➤ the Availability KPI is given a positive trend. This means that it becomes critical when its value is small because it means that the page whose availability is being measured is not available most of the time. The Availability KPI performance is best when its value is large.
- ➤ the Outage Duration KPI is given a negative trend. This means that its performance is best when its value is small.

### Business Rule Repository Overview

The Business Rule Repository page displays the list of factory (predefined) rules available throughout Dashboard to determine how source data is handled by Dashboard Administration.

A business rule is used to calculate the value and status of a Key Performance Indicator (KPI). Every KPI can hold three icons: real time status, trend, and history. The way status is determined for these icons is described in "KPI Status" on page 355.

A rule is the basic object that receives events (either samples or application messages), deals with processing the data, and holds the process results. To receive the events, the rule uses input filtering criteria called selectors. For details, see "Attach KPIs to CIs and Configure the KPIs" on page 374.

For details on editing rules, see "Business Rule Repository page" on page 646. If you add a rule, a matching tooltip (with the same ID number) is automatically created. For details, see "Tooltip Repository page" on page 879.

In the adapter templates, the business rule for each KPI is identified by a logic ID (the rule ID). For a list of the rules defined for Dashboard, see "List of Dashboard Business Rules" on page 578.

The Rules API can be used to create new rules; for details see "Rules API" on page 657.

#### **Advanced Users**

You can modify existing repository objects and create new ones. You modify existing repository objects when you want to customize the way information is presented in Dashboard, to fit the needs of your organization. You may create new repository objects when integrating data from a new external system into Dashboard.

#### **Parameters**

Each rule's parameters are used to define input for the rule. The values used for the parameters can be fixed values (defined within the parameter definition) or referenced values taken from the samples.

The rule parameters are defined in the Business Rule Repository, as part of each rule definition.

Depending on the type of rule, some rule parameters may be defined in an adapter template for a data source (as part of the KPI definition). The values set for these parameters override the definitions in the Business Rule Repository. For a list of rule parameters, see each rule parameter description in "List of Dashboard Business Rule Parameters" on page 639.

#### **Business Rule Repository Global Parameters**

You can modify various global parameters for trend and history status in the Business Rule Repository, as follows:

- ➤ You can specify whether or not you want trend status and/or history status displayed for CIs.
- ➤ You can change the window of time used for trend and history calculations.
- ➤ You can specify the calculation type for history status.

Note that the global parameters can be overridden by defining a different value for the relevant parameter within a specific rule.

# Rules in Source Adapters, KPI Assignments, and KPI Enrichments

In the adapter templates, which are used to map the entities in the data source to the configuration items (CIs) used by HP Universal CMDB, or in the KPI Assignments and KPI Enrichment Tasks, which are used to assign KPIs, rules, context menus, context menu items, and tooltips to a CI, the business rule for each KPI is identified by an ID number. For a list of the rules ID numbers, see "List of Dashboard Business Rules" on page 578.

To access adapter templates, click **Admin > Universal CMDB > Source Manager**.

To access KPI assignments, click **Admin > Dashboard > KPI Assignments**.

To access KPI enrichment, click **Admin > Integrations > EMS Integrations**.

### Monitor Rules and Group Rules

A KPI must always have an associated business rule that defines the business logic. The business logic determines how the data is handled to obtain a single status rating.

There are two categories of business rules, monitor rules and group rules, as described in the following sections. Most KPIs work with at least one rule from each category.

This section includes the following topics:

#### **Monitor Rules**

Monitor rules (also called leaf rules) are business rules that are applied to monitor (leaf) CIs. Monitor rules are used to calculate a measurement for the KPI based on original sample data that is caught by the KPI selector. For example, the **Availability Rule** calculates the Availability KPI for BPM Transaction from Location CIs, based on the sample data received from Business Process Monitor.

A monitoring CI is intended to receive incoming metrics, generally received using one of the data collector, such as SiteScope, Business Process Monitor, or Real User Monitor. Monitoring CIs are automatically added to the HP Universal CMDB by the source adapters in Source Manager, according to the monitoring definitions. These monitoring CIs have default KPIs that use a monitor rule, and predefined selector.

In general, the leaf CIs in a subtree (the CIs that form the lowest level of the hierarchy) should always be one of the monitoring CIs. When creating new subtrees in your views in IT Universe Manager, you attach monitoring CIs created by the source adapters as leaf nodes, and these CIs then pass KPI status up the hierarchy.

#### **Group Rules**

Group rules are business rules that determine KPI status based on data received from other KPIs, rather than from original sample data. The received data can come from the KPIs of child CIs, or from another KPI associated with the same CI.

**Note:** Even though this category are called group rules, some of them are also applicable for monitoring/leaf level CIs. For example, the **Impact Over Time Rule** (used with the **OT Impact KPI**) can be used with a group CI or a monitoring CI. What all rules in this category have in common is that their status calculations are contingent on data received from other KPI instances, rather than from the samples.

The group rules vary in the type of logic they use to arrive at a status result. For example:

- ➤ The rule may select a KPI status held by one of the child CIs, and apply that status to the parent, as done by the **Worst Child Rule**.
- ➤ The rule may aggregate the received data to calculate a measurement, and compare the measurement with defined objectives, as done by the **Sum of Values Rule**.
- ➤ The rule may calculate a measurement based on the status of another KPI for the CI, and compare the measurement with defined objectives, as done by the Real Time Impact Rule when receiving status from the Availability KPI.

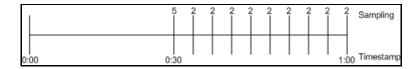
Each KPI has been assigned a default business rule that is used when you attach a new KPI to a CI; the default is generally one of the group rules for that KPI. When editing a KPI or attaching a new KPI, you can select a different rule, from the list of rules that are applicable for that KPI.

If a KPI is associated with a logical CI then the rule that calculates the status and value of this KPI is probably a group rule – it uses the KPIs of other CIs in order to calculate its own status and value (for example: Worst Child rule).

### 🚜 Sample-Based and Time-Based Sampling

Monitor rules are time-based or sample-based. The time-based sampling is more accurate than the sample-based sampling when samples are not taken regularly; for example, SiteScope sampling accelerates when a problem occurs. When samples are taken regularly, time-based and sample-based sampling provide the same results.

If you have the following sample:



The result of the first part of the sampling period is 5. After that the result of each sampling period is 2.

The sample-based result is calculated as follows:

(5+8x2)/9=2.33

The samplings are as follows: 1 sampling with the value 5 and 8 samplings with the value 2. The total number of samplings is 9.

The time-based result is calculated as follows:

(30x5+30x2)/60=3.5

During 30 seconds the value was 5. During the next 30 seconds the value was 2. The total sampling time was 60 seconds.

**Note:** There is also a time and amount-based calculation method that works on the same basis as time-based, but takes into account the amount (value) received in the sample as a proportion of the total amount.

## \lambda Understanding the Percentage Rule

The Percentage rule is listed in the list of Dashboard rules at "Percentage Rule" on page 608.

When the Percentage rule is defined as the KPI rule for a parent group, the group is assigned a KPI status based on a percentage calculated from the child CIs in the group. If required, significant relationships between CIs (usually between the parent CI and one of the children CIs) can be weighted (Weight option), so that they have more impact on the percentage calculation. You can also define dominant status (Must option) for a relationship between CIs (usually between the parent CI and one of the children CIs), so that a child CI with low status in the dominant relationship influences the status of the group.

**Note:** For all percentage calculation methods, the number of gray child CIs (Info, No data, Stopped, or Downtime statuses) is ignored in the final calculation of the parent group score.

The different applications of the Percentage Rule are described in the following sections.

#### **Basic Percentage Rule**

When using the Percentage Rule, parent group status is based on a percentage (the **score** for the group), calculated from the number of child CIs with red, orange, olive, green, or yellow status. Gray statuses are not taken into consideration. (Note that if any of the child CIs are weighted, this influences the percentage calculation, as described in Weighted Percentage, below.)

Each status has a value, as follows:

Status	Value
red	0
orange	5

Status	Value
yellow	10
olive	15
green	20

Each value is multiplied by the number of children in the group that have that status, and the results are totaled and divided by the number of children in the calculation, to give an average result. For example, in a group of four CIs, two with red status and two with yellow status, the calculation would be as follows:

```
2 x 0 (red)
2 x 10 (yellow)
Total = 20/4 (number of red and yellow children) = 5 (average result
```

The average result is then divided by 20 (corresponding to the green status value) and multiplied by 100, to give the percentage score for the group:

```
(5/20) x 100 = 25% (score)
```

The score determines the status for the parent group according to objectives defined for the KPI. For details, see "KPI Objectives" on page 343.

When you assign the Percentage rule to a KPI, the tooltip for the KPI in Dashboard, displays the percentage score for the group and the Percentage rule objectives.

#### **Weighted Percentage**

By default relationships are not weighted (weight = 1). You can change the default weight for a relationship in the weight box, accessed in the Define Configuration Item Relationship window (described in "New CI Dialog Box" in *Model Management*).

When a child CIs in a group, is in a relationship with a weight greater than 1, then the percentage calculations described in Basic Percentage Rule, are adjusted to take the weight into account. Each CI status value is multiplied by the weight assigned to the CI, and the total is divided by the total weight values, to give the average result.

For example, taking the same group that was used for the basic percentage example (four CIs, two with red status and two with yellow status), if one of the red CIs has a weight of 4 and one of the yellow CIs has a weight of 2, then the average result calculation looks like this:

```
1 x 4 x 0 (red with weight=4)

1 x 1 x 0 (red with weight=1)

1 x 2 x 10 (yellow with weight=2)

1 x 1 x 10 (yellow with weight=1)

Total = 30/(4+1+2+1) (total weight values for red and yellow children) = 3.75
```

(average result)

The percentage score for the group is then calculated in the same way as for the basic Percentage Rule: average result is divided by 20 and multiplied by

```
(3.75/20) x 100 = 18.75% (score)
```

Note that CI weights are relevant only when the parent group status is calculated using the Percentage Rule.

**Note:** You can display the weight information in the KPI tooltip in Top View. For details, see "Customize Top View Tooltips" on page 130.

#### **Dominant Child**

By default, all CIs are in non-dominant relationships (**must** is cleared). You can change the setting for a relationship to dominant in the Define Configuration Item Relationship window (described in "New CI Dialog Box" in *Model Management*).

When a child CIs in a group is in a dominant relationship, then status is calculated for the group by comparing the results from the following two status calculation methods:

- ➤ Dashboard determines the lowest status held among all dominant CIs.
- ➤ Dashboard determines group status according to the percentage rule calculation (as described in Basic Percentage Rule above).

The worst status from the two calculations becomes the status for the group.

When the group status has been taken from the lowest status held by a dominant CI, the tooltip for the parent group displays **Score**: n/a (Using dominant child).

#### Note:

- ➤ Dominant CIs are only relevant when the group is using the Percentage Rule to calculate status.
- ➤ When a CI has both dominant and weighted child CIs only the dominant CI is taken into consideration when calculating the status of the parent CI using the Percentage rule.

## 👶 Understanding the Generic Formula Rule

The Generic Formula rule is listed in the list of Dashboard rules at "Generic Formula Rule" on page 601.

This rule can be used to add new business logic behavior to Dashboard. You can use the rule to create a set of calculation methods (sum, count, average, and so on) that can be applied to every type of sample: legacy (SiteScope, Business Process Monitor, and Real User Monitor) and Enterprise Management Systems (EMS) samples.

In Dashboard, the rule is time-based and the formula calculates a single aggregated result of all of the specified data collected during the period specified in the **duration** parameter.

#### Note:

- ➤ Using the Generic Formula rule might have an impact on performance as the rule parses and evaluates string expressions. Using this rule should be considered carefully only when no other rule answers the requirements and when the application does not include large amounts of monitor nodes.
- ➤ There is no automatic validation to check if the formula supports the collected sample structure. There is no automatic validation for the correctness or syntax of the formula. If there is a mistake in the formula, the status of the KPI appears as a gray icon in Dashboard.

For example, use this rule to calculate the average of a sample field over a period of time multiplied by 2, or the sum of the values of a sample field over the specified period of time, divided by the number of values of another field.

#### **Using the Generic Formula Rule**

To use the Generic Formula rule, clone it and give the clone a meaningful name. You can then customize the cloned rule, attach the rule to a KPI, and attach the KPI to a view. The KPI automatically propagates the rule selected in the Default Rule list to all of the CI parents.

To edit the formula, click the Edit button for the Formula parameter, and enter the formula that you want the rule to use in the **Default Value** field. For more details, see "Parameter Details Dialog Box (Rules)" on page 653.

The formula is based on operands, operators, functions, constants, and sample field values. The formula must use only fields from the selected samples; you must know the name of the variables in the sample on which you want to run the formula. The samples for the rule depend on the specific KPI's selector, therefore the formula must support the collected sample structure.

The rule takes values from the specified samples during the time period specified in the **duration** parameter, puts those values in the aggregated formula, and compares the result with the specified objectives.

Any valid Dashboard sample is valid for this rule.

The formula language is based on the Generic Data Engine (GDE) parser language to be consistent with the open formula writing. For more information, see "Working with the Generic Reporting Engine API" in *Solutions and Integrations*.

The formula must always be an aggregated formula. It should contain aggregation functions and mathematical operators between them. The operands can either be constant numbers or aggregation functions.

The formula elements are:

- ➤ supported operators: \*, +, -, /, ()
- supported aggregation functions: sum, min, max, avg, count, stddev, sumofsqr
- > supported manipulation function: if

#### Chapter 19 • Business Rule Repository

The rule calculates a single numeric value based on the samples collected during the duration. The value is then evaluated according to the given objectives and the status is set accordingly.

#### 1 Create a Customized Business Rule

There are three ways to customize repository elements:

- ➤ **New Item.** Creates a new repository element that is not based on an existing element. You customize the new element to fit your needs. To create a new business rule, click **New Item** in the Business Rule Repository page.
- ➤ Clone. Creates a new repository element by cloning an existing factory or custom element. The original element is still available, and the new cloned element can be modified. To clone a business rule, select a factory business rule and click **Clone** in the Business Rule Repository page.

➤ Override. Overrides an existing factory element. The original element is labeled overridden (disabled) in the Factory area, and an editable copy appears in the Custom area. To override a business rule, select a factory business rule and click Override in the Business Rule Repository page.

#### 2 Edit Rule Details



Click the **Edit** button corresponding to the custom business rule, and change its values as required. For details on the possible values, see "Rule Details Dialog Box" on page 654.

**Note:** If you are creating a customized Generic Sample rule, a Generic Sum of Values Over Time rule, or a Generic Two Arguments rule, and the name of the time stamp field in the sample is not time\_stamp, in the Rule Parameters area of the Rule Details dialog box, click **Edit** for the **Time Stamp Field** parameter. In the **Default Value** box, enter the name of the sample time stamp field. The type of the sample time stamp field must be time. Click **OK** to save the change.

#### Example - Write a Generic Formula Rule

For details on the Generic Formula rule, see "Generic Formula Rule" on page 601.

➤ The following formula calculates the average of the dResponseTime sample field value over the specified period of time, multiplied by 2:

Avg(dResponseTime)\*2

➤ In the following formula, you want to sum only the response time of the successful transactions, therefore only the response time for samples with u\_iStatus=0 is taken into consideration. u\_iStatus=1 when the transaction fails, and u\_iStatus=0 when the transaction is successful.

The formula calculates the sum of the values of the dResponseTime sample field value over the specified period of time, where the value of dResponseTime is set to 0 every time the value of the u\_iStatus sample field equals 1. This sum is divided by the sum of values calculated as follows: the value is equal to 1 when the u\_iStatus field value is 0, and the value equals 0 when the u\_iStatus field value is different from 0. This formula calculates the performance of a certain transaction by aggregating the response time of all of the successful transaction and dividing it by the number of successful transactions:

sum(if(u\_iStatus,=,0,dResponseTime,0))/sum(if(u\_iStatus,=,0,1,0)

#### 3 Modify Rule Parameters or Global Rule Parameters

You can modify existing information or enter new information about the rule parameters and the Objective parameters for a specific rule. For details, see "Parameter Details Dialog Box (Rules)" on page 653.

To globally edit a parameter for all factory rules, access, from the **Rules** page, the Global Attributes Details dialog box and modify the appropriate parameters. For details, see "Global Attributes Details Dialog Box" on page 652.

**Note:** To override the global parameters values for individual rules, you must add the relevant parameter to the relevant rule and then modify its value.

#### 4 Attach the Rule to a KPI

If you have created a new rule, you must add it to the rules already attached to the relevant KPI. For details, see the Applicable Rules GUI parameter in "KPI Details Dialog Box" on page 537.

#### 5 Set a Rule and its Parameters Back to Default – Optional

If you have modified a rule or its parameters, you might need to return the rule and its parameters to their defaults.

To set a rule and its parameters back to default, select Admin > Dashboard > **Repositories** > **Rules**. In the **Custom Rules** area, delete the copy of the rule you want to return to default and click **OK**. The rule and its parameters are returned to their defaults.

# Treate a Customized Generic Sample Rule – Scenario

You want to display the comparison between the value of a selected value field in the event sample and specific objectives, so the status of the KPI to which the customized Generic Sample rule is attached is grey when the value of the sample field is less than 1 and larger than 5. To display the comparison you must clone the Generic Sample Rule, attach the cloned rule to a cloned KPI, and attach the cloned KPI to the appropriate CI.

#### To attach the customized rule to a KPI for a CI:

- 1 Select Admin> Dashboard > KPIs.
- Select a view.
- **3** Select the appropriate monitor level to which you want to attach the KPI.
- Click **New KPI** to open the New KPI window.
- In the **KPI** list, select the KPI (Sum\_Connect\_DNS\_Time) you just created.
- In the **Business rule** list, select the generic rule (Sum\_Connect\_DNS\_Time rule) you just created.
- Click **OK** to save the changes.

# Set Up Rules to Display the Last Sample Details

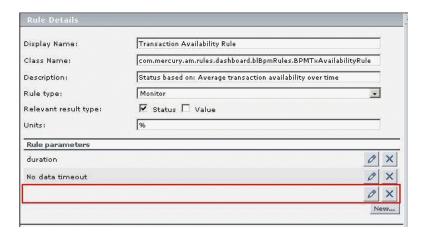
You can set up rules to save details from the last sample received for a CI, so that these details can be viewed in the Event Details window for the CI or in tooltips in Dashboard. For details on how to display the last sample information, see "View Sample Details" on page 57.

**Note:** Storing last sample details may require use of a large amount of memory, slowing down Dashboard performance.

Last sample details are kept in memory using the **saveLastSample** property. You can use this property to store sample details only for specific CI KPIs, or for all KPIs.

To save the last sample details, you can:

➤ Set the property for an individual business rule. Override the rule in the Business Rule Repository. In the Rule Details window for the new custom rule, add the parameter saveLastSample with Type=Boolean and Default Value=true. (Note that this property need only be defined for rules that apply to monitor CIs and that the parameter does not appear in the Rule parameters list.)



> Set the property for all business rules. Click the Edit Globals button in the Business Rule Repository to view the Global Attributes list. Edit the saveLastSample attribute to change its value to true (default setting is false).

## 🦒 Save Measurements Data

If required, the **Save KPI data over time for this CI** option in the Global Attributes Details dialog box can also be used to save the calculated measurement for each of the CI KPIs, at 15 minute intervals (default value). This is done by activating the **saveValuesToPersistency** global attribute in the Business Rule Repository. You can also change the default interval by modifying the value of the **saveValuesToPersistencyInterval** option. For details on the user interface, see "Global Attributes Details Dialog Box" on page 652.

## Example

To activate Dashboard to save measurements data:

- 1 Access the Dashboard Administration > Repositories > Business Rules page.
- **2** Click **Edit Globals** (in the **Factory Rules** area).
- **3** In the **Global Attributes** list, click the **Edit** button for **saveValuesToPersistency**.
- **4** In the displayed Global Attributes Details window, change the **Value** parameter from No to **Yes**.
- 5 Click OK.
- **6** To change the default interval (900 seconds) for collecting measurements data, in the **Global Attributes** list, click the **edit** button for the **saveValuesToPersistencyInterval**, and modify the value.

**Note:** To avoid overloading the database memory, it is recommended that you do not define a shorter default interval value.

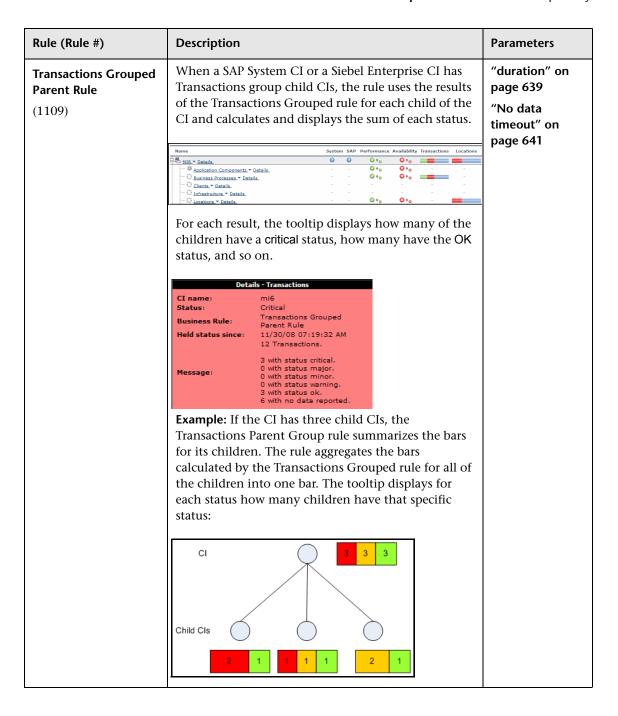

### Rules API Overview

This chapter describes how to use the Rules API to create new business rules. Business rules are used to calculate Key Performance Indicators (KPIs). A KPI must have an associated business rule that defines how the KPI is calculated. The default Dashboard rules appear in section "List of Dashboard Business Rules" on page 578.

The recommended way to create new rules is with the Rules API. The Rules API enables you to create rules using the Groovy scripting language. Users of the Rules API should be familiar with Groovy and Java, and with HP Business Availability Center administration and applications.

#### **Dashboard API Rules**

There are three types of Dashboard API rules:

- ➤ **Group and Sibling Rule**. This rule calculates KPIs based on data received from other KPIs, rather than from original sample data. For details, see "API Group and Sibling Rule" on page 659.
- ➤ Sample Rule. This rule calculates KPIs based on original data taken from sample fields. The number of samples included in the calculation is limited by a maximum number of samples rule parameter. For details, see "API Sample Rule" on page 663.

➤ Duration-Based Sample Rule. This rule calculates KPIs based on original data taken from sample fields. A duration parameter defines which samples are included in the calculation. For details, see "API Duration-Based Sample Rule" on page 665.

#### **Creating API Rules**

Rules can be created using the Rules API in three ways:

- ➤ Using the KPIs tab to create a rule for a specific KPI.
- ➤ Using a text file to create a new rule for multiple KPIs.
- ➤ Using a clone of an API rule in the Rule Repository to create a new rule. These methods are described in "Creating Rules with the Rules API" on page 667.

### API Group and Sibling Rule

An API Group and Sibling Rule calculates KPIs based on data received from other KPIs, rather than from original sample data. The received data can come from the KPIs of child CIs, or from another KPI associated with the same CI.

**Note:** If you are creating a sibling rule, make sure that the KPI is calculated after its sibling KPIs, as defined by the KPI's Calculation Order field. For details, see "KPI Repository page" on page 535.

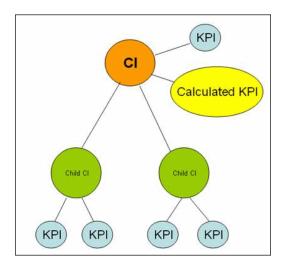
#### **Group and Sibling Rule Methods and Fields**

The Group and Sibling rule implements the Rules API Interface **GroupAndSiblingCalculator**, using the following guidelines:

- ➤ In this interface, the only method is **calculateKPI**. The method signature is: public void calculateKPI(CI ci, KPI kpi)
- ➤ The **calculateKPI** method includes the parameters **ci** and **kpi**, which represent the current CI, and the KPI whose value the API rule calculates.
  - ➤ The ci parameter type is Cl, and is used as an accessor to KPIs of child CIs or sibling KPIs.
  - ➤ The **kpi** parameter type is **KPI**, and is used to set calculation results.

In the following illustration, the Calculated KPI is calculated based on the sibling or child KPIs, and it is represented by the **kpi** parameter.

The CI to which the Calculated KPI is assigned, is represented by the **ci** parameter, and it is an accessor to the other KPIs.

# Defining a Group and Sibling Rule in the KPIs tab or Rule Repository

To define a Group and Sibling rule using the KPIs tab or within the Rule Repository, enter the **calculateKPI** method implementation in the **KPI Calculation Script** area.

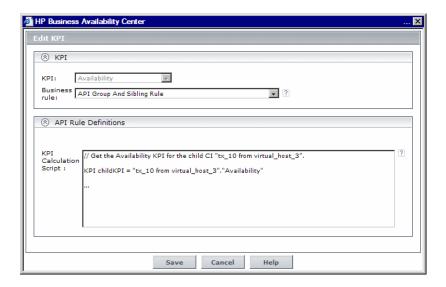

#### Accessing a Specific Child KPI in the KPIs Tab

When creating a Group rule for a specific KPI in the KPIs tab, to access a specific child KPI, the API includes a mechanism to simplify the code. When defining your KPI Calculation Script, you can enter the format "<CI name>"."<KPI name>"."

### API Duration-Based Sample Rule

A Duration-Based Sample rule calculates KPIs based on original data taken from sample fields; the duration rule parameter defines which samples are included in the calculation. For example, if duration is defined as fifteen minutes, all samples collected during the last fifteen minutes are included in the calculation.

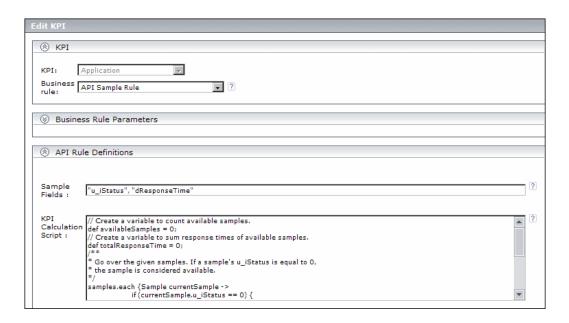

In the Name field type Maximum number of samples. In the Type field, select Integer. In the Default Value field, type 1.

Click **OK** to Save.

➤ For API Duration-Based Sample rules:

In the **Name** field type **duration**. In the **Type** field, select **Long**. In the **Default Value** field, type **990**.

Click **OK** to Save.

Repeat these steps to add the **No Data Timeout** rule parameter (Type: Long; Default Value = 990).

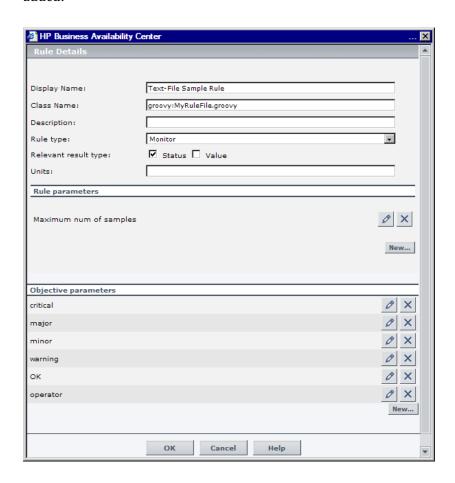
- **e** Create Objective parameters: critical, major, minor, warning, informational, and operator. (Skip this step if you are defining a Group and Sibling rule that does not have Objectives, where status is calculated by the rule code.)
  - ➤ In the **Objective parameters** area, click **New**.
  - ➤ In the Name field, type critical. In the Type field, select Float.
  - ➤ Click **OK** to save.

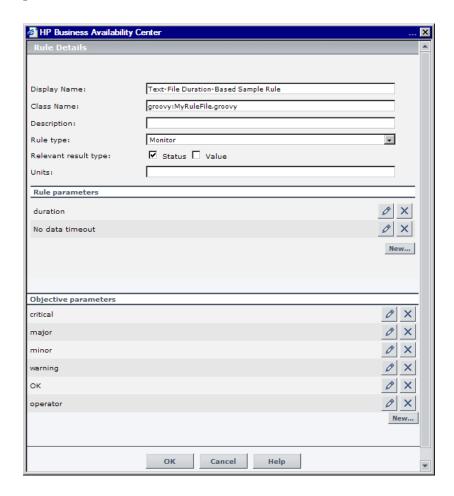

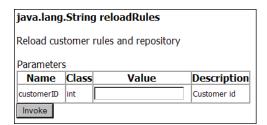

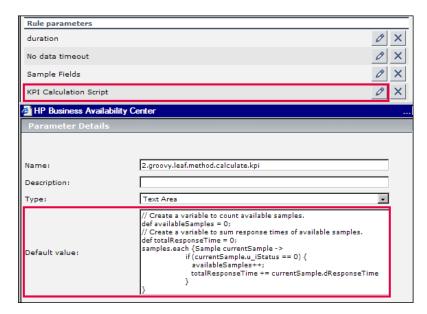

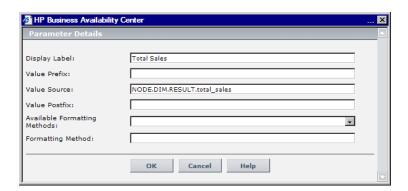

**2** If you have used the **kpi.setTooltip** method, you must set a corresponding tooltip entry in the Tooltip Repository as described above. In the **Value Source** field, type the name of the tooltip entry exactly as used in the code, and leave the **Formatting Method** field empty.

For example, if your code contains the method invocation kpi.setTooltip("total\_sales", value), type NODE.DIM.RESULT.total\_sales in the Value Source field.



### Write to Log Files From the Rules API Code

Within your API rules, you can write to log files from rule methods using a **logger** object. There are five log levels: debug, info, warn, error and fatal. Each of these uses a specific logger method.

By default, only log method invocations of error and fatal severity are written to the log files. You can modify this within the log configuration files.

#### To write to log files using the Rules API:

- **1** Within the rule method, implement one of the following methods (listed in ascending order of severity):
  - logger.debug("<API rule name> : log message");
  - ➤ logger.info("<API rule name> : log message");
  - ➤ logger.warn("<API rule name> : log message");
  - ➤ logger.error("<API rule name> : log message");
  - ➤ logger.fatal("<API rule name> : log message");

Type the name of your API rule inside the log message to identify each log message with its source rule.

**2** The Rules API log files are found in the **<Data Processing server root directory>\log\mercury\_online\_engine\RulesAPI** directory.

Open one of the following files to view the log messages (depending on your rule type):

- ➤ groupAndSiblingRule.log (for API Group and Sibling rules)
- ➤ sampleRule.log (for API Sample rules)
- ➤ durationBasedSampleRule.log (for API Duration-Based sample rules)

#### To modify the severity level written to a log file:

- 1 By default, only log method invocations of error and fatal severity are written to log files. To modify this setting, open the log configuration file located in <Data Processing server root directory>\conf\core\Tools\log4j\mercury\_online\_engine\dashboard\_rules.properties.
- **2** In the line corresponding with your rule type, replace the string **\${loglevel}** with the severity level you want logged (either DEBUG, INFO, WARN, ERROR, or FATAL). Edit the following line, depending on your rule type:
  - ➤ Group and Sibling rules: log4j.category.com.mercury.am.rules.dashboard.blDashboardRules. simplifiedRule.groupAndSiblingRule.DashboardGroupAndSiblingRule = \${loglevel}, bam.app.rules.api.group.appender
  - ➤ Sample rules: log4j.category.com.mercury.am.rules.dashboard.blDashboardRules. simplifiedRule.leaf.DashboardSimplifiedSampleBasedRule = \${loglevel}, bam.app.rules.api.leafsample.appender
  - ➤ Duration-Based Sample rules: log4j.category.com.mercury.am.rules.dashboard.blDashboardRules. simplifiedRule.leaf.DashboardSimplifiedTimeBasedRule = \${loglevel}, bam.app.rules.api.leafduration.appender

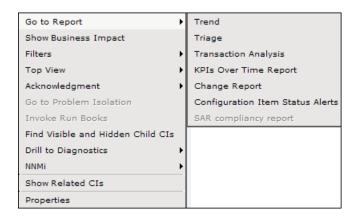
### Context Menu Repository Overview

The Context Menu Repository page displays the list of factory (predefined) context menus available throughout Dashboard to determine appearance and functionality for the CIs in the presentation layer.

A context menu defines the menu options that are available in the menu for a KPI or a CI in the Dashboard application. The adapter template assigns every configuration item type (CIT), a default context menu.

The actions required by each menu option are defined in "Context Menu Item Repository page" on page 806.

For example, in the Console tab of the Dashboard application, the menu: **Go to Report** > **Trend** is displayed:

#### 1 Create a Customized Context Menu

There are three ways to customize repository elements:

- ➤ New Item. Creates a new repository element that is not based on an existing element. You customize the new element to fit your needs. To create a new context menu, click New Item in the Context Menu Repository page.
- ➤ Clone. Creates a new repository element by cloning an existing factory or custom element. The original element is still available, and the new cloned element can be modified. To clone a context menu, select a factory context menu and click Clone in the Context Menu Repository page.
- ➤ Override. Overrides an existing factory element. The original element is labeled overridden (disabled) in the Factory area, and an editable copy appears in the Custom area. To override a context menu, select a factory context menu and click Override in the Context Menu Repository page.

In the **Custom Context Menus** area, delete the copy of the context menu you want to return to default and click **OK**. The context menu and its parameters are returned to their defaults.

#### 1 Create a Customized Context Menu Item

There are three ways to customize repository elements:

- ➤ **New Item.** Creates a new repository element that is not based on an existing element. You customize the new element to fit your needs. To create a new context menu item, click **New Item** in the Context Menu Item Repository page.
- ➤ Clone. Creates a new repository element by cloning an existing factory or custom element. The original element is still available, and the new cloned element can be modified. To clone a context menu item, select a factory context menu item and click Clone in the Context Menu Item Repository page.
- ➤ **Override**. Overrides an existing factory element. The original element is labeled overridden (disabled) in the Factory area, and an editable copy appears in the Custom area. To override a context menu item, select a factory context menu item and click **Override** in the Context Menu Item Repository page.

### Tooltip Repository Overview

The Tooltip Repository page displays the list of factory (predefined) tooltips available throughout Dashboard to specify how source data is imported and handled by Dashboard Administration, and to determine appearance and functionality for the CIs in the presentation layer.

Each KPI under a CI has a Details tooltip to display additional information for the CI.

Most of the tooltips used in Dashboard correspond directly to a rule. Each tooltip class has the same ID number as the rule it is associated with. For example, for the rule ID #2, Best Child Rule, there is a corresponding tooltip with ID #2, Best Child sentence.

Tooltips are assigned to CIs according to the rule used for the KPI. Most rules have an associated tooltip (referred to as the rule sentence), that is connected to the associated rule. Note that if you add a new rule to the Business Rule Repository, a new tooltip is automatically created for it. To delete a tooltip that is connected to a rule, you must delete the rule. For more information on the Tooltip Repository or about creating or editing tooltips, see "Tooltip Repository page" on page 879.

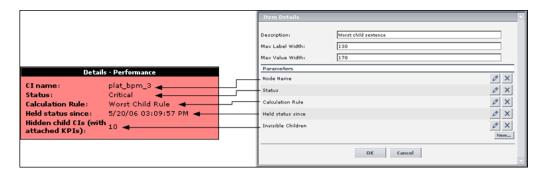
- ➤ To delete a customized tooltip, you must delete the corresponding rule.
- ➤ A tooltip and its rule have the same ID number and the same name.
- ➤ The order of the parameters in the Tooltip Parameters Details page reflects the order of the corresponding information in the tooltip in the application.
- ➤ The last sample time is not necessarily the same as the last update time because the last sampling might not have any impact on the status.
- ➤ If you are using HP Operations Manager *i* with Business Availability Center, then the Tooltip Repository page contains OMi-related tooltips. For more information, see *Using HP Operations Manager i*.

#### **Tooltip Parameters**

Each tooltip definition includes parameters. The parameters correspond to the type of information displayed in the tooltip in the Dashboard and Service Level Management applications. The order of the parameters in the tooltip definition corresponds to the order of the information in the displayed tooltip. For information on defining/editing tooltip parameters, see "Tooltip Repository page" on page 879.

The tooltip parameters correspond to the information displayed in the tooltip.

For example, the parameters of the Worst Child Sentence tooltip are displayed as entries in the tooltip and are listed in the same order as the order of the parameters in the tooltip definition.



#### **Advanced Users**

You can modify existing repository objects and create new ones. This may be necessary when you want to customize the way information is presented in Dashboard, to fit the needs of your organization; or you may need to create new objects when integrating data from a new external system into Dashboard.

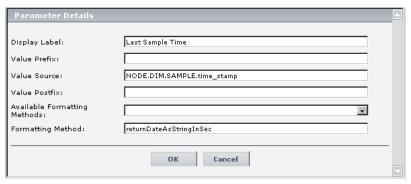

- **e** Click the relevant **Edit Entity** button , to open the Tooltip Details dialog box.
- **f** Click **New** to open the Parameter Details dialog box.
- g In the Display Label box, enter Last Sample Time.
- **h** In the Value Source box, enter NODE.DIM.SAMPLE.time\_stamp.
- i In the Available Formatting Method list, select returnDateAsStringInSec. The value is automatically entered in the Formatting Method box.

#### 3 Change the Color of the Tooltip Border and Header

A KPI tooltip border and header has a default color, specified in the **Color** box of the KPI's appropriate parameter, for each one of the ranges specified in the **From/To** boxes. For example: when the **Performance** KPI has the OK status, the tooltip would display the following colors C9E7B2;78B24A:

Details - Performance

CI name: siebel 7.7 whistle echannel
Status: OK
Calculation Rule: Worst Child Rule
Held status since: 5/28/06 10:50:09 PM

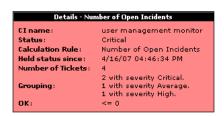
